In the absence of Mayor Akerley, Deputy Mayor King assumed the chair.

A report of the Water Committee was read; advising that the Committee had considered a report prepared by Engineering Service Company dealing with inadequate water supply in the Glenwood Avenue -Celtic Drive area of Westphal.

The Committee recommended to Town Council the extension of the high service system into the Glenwood Avenue - Celtic Drive area. By the extension of this high service system, this would transfer the area from the low service system to the high service. The most direct method of implimenting this change would be by a further extension westward of the 8" Main presently programmed for installation along Sarnia Avenue. The distance involved in this extension would be a maximum of 715 feet. The estimated cost being in the vicinity of \$6,500.

It was moved by Councillors Hollis and Beazley, and carried; that the report of the Water Committee be adopted.

On motion of Councillors Hollis and Crook, the following resolution was unamiously adopted.

(20) RESOLVED that the Town Council in the name of and on behalf of the Town of Dartmouth enter upon the private lands as outlined on the attached plan, prepared by Paul Wendt Limited dated January 24, 1961, being lands within the Town of Dartmouth for the purpose of opening and excavating the same and laying a water main thereunder and occupy such lands and use the same so long and in such manner as may be necessary for such purpose or for the purpose of repairing, maintaining or replacing such water main.

FURTHER RESOLVED that the Town Engineer be and he is hereby designated as the Officer to carry out the foregoing on behalf of the Town.

Report of the Public Works Committee was read, advising that the present garbage unit is not being used because of its faulty and unsafe condition. The Works Committee recommended to Town Council the purchase of a packer-type unit from the Phil Wood Industries Limited -- this unit to have a divided body; the purchase price being \$6,683., less a trade unit allowance on the old unit in the amount of \$275., making a net price of \$6,408. WATER SERVICE GREENOUGH SUB-DIVISION Report of the Water and Sewer Committee was read regarding water extension to the Greenough Subdivision. The installation of water distribution lines in this subdivision requires, in addition, the installation of a transmission line which must be constructed from the Reservoir at Mount Edward Road to run eastward along Mount Edward Road to a point opposite the entrance to the Subdivision. Eventually this transmission main could be extended toward the eastern boundary and service further subdivisions in that direction. The estimated cost of constructing these watermains is as follows:-

- A. Construct transmission line from Reservoir to Greenough Subdivision - 1,350 lin. ft. of 12", cast iron pipe ------ \$11,988.
- B. Construct distribution lines in Greenough Subdivision - 2,800 lin. ft. of 8" cast iron pipe ------ \$20,166.

The report recommended that because Atlantic Air Survey Company Limited is a local firm with head office in Dartmouth, the work of this company being well known to Town officials, the easy accessibility and availability of the staff of this firm, the definite delivery date, that the tender of Atlantic Air Survey Company Limited, in the amount of \$14,520.50, be accepted.

It was moved by Councillors Granfield and Gurholt, and carried, that the recommendation be adopted and that the tender of Atlantic Air Survey Company Limited be accepted; Councillor King voting against.

MOBILE RADIO EQUIP. TENDERS Report of the Clerk-Administrator was read advising that in the presence of the Chief of Police, the Fire Chief and the Town Engineer, tenders for the supply and installation of mobile radio equipment in the Police, Fire and Works Departments, were opened. ADDITIONS .TO DARTMOUTH HIGH AND MICHAEL WALLACE. SCHOOLS

DOWNTOWN PARKING LIMITED

Dartmouth, N. S., April 4, 1961.

His Worship, Mayor I. W. Akerley, and Members of City Council, City Hall, Dartmouth, N. S.

Gentlemen:

Downtown Parking Limited is a body corporate formed by members of the Downtown Retail Merchants Association for the purpose of acquiring land for offstreet parking in the downtown area of Dartmouth to alleviate the present traffic congestion in that area and to assist the merchants in providing parking space for prospective customers.

The problem of downtown parking is one that is not peculiar to Dartmouth and has caused grave concern in most urban centres, and in most cases the solution has been worked out by cooperation by the City or Town Councils and the merchants.

In this submission it is attempted to set out who the Downtown Parking Limited represents, the problem created by inadequate parking facilities and its effect on the merchants, what the merchants have done in an attempt to alleviate the situation, and assistance requested from the City.

WHO THE COMPANY REPRESENTS. Downtown Parking Limited was formed after meetings were held by the Downtown Retail Merchants Association, and its Shareholders and Debenture, holders are business and professional people in the area which will be served by the parking area which embraces Portland Street, Queen Street, Commercial Street and Ochterloney Street.

. 1. The area is bounded by Wentworth Street, Ochterloney Street, the water front of Halifax Harbour, and the rear line of lots fronting on Portland Street.

 This area, we are advised by the Town Assessor, has an assessed value of nearly Five Million Dollars (\$5,000,000 g 3. The merchants and professional men in this area practically all reside in the City of Dartmouth, and, in addition to their places of business, have established homes and numerous other tax producing properties in the City.
When the contributions of its members to the City by way of taxation, and by service work and charitable work, are compared, it is felt that full consideration should be given to assisting them in their endeavours to maintain a prosperous business centre in the downtown area. <u>PROBLEM OF PARKING IN THE DOWNTOWN AREA.</u> The problem may be briefly stated in that there just is not enough parking provided to accomodate customers of the downtown area, particularly during peak hours of trade. At the present time, parking is restricted to: (1) Parking meter areas of which there are one hundred and fifty-two (152) in the area to be serviced; (2) Free parking on Ferry Hill which will accomodate seventeen (17) vehicles; (3) Private parking lots which, in most cases, are primarily for persons employed in the building which the private lot services.

The parking meter system, although of assistance, is not adequate as they are too few in number and limit parking to a period of one hour, and the use of the meters is abused by persons parking their cars at the meters and adding coins each hour in order to have continuous extended parking.

The situation in the downtown area of Halifax has become most acute with vacant stores and offices and reduced turnover of business being definitely attributable to lack of parking, and the City of Halifax has acquired land and is in the process of building a multi-level parking garage. Although the situation in the City of Dartmouth is not presently as acute as it is in the City of Halifax, there have been cases of empty stores and inability to sell properties over an extended period of time, and there can be no doubt that the situation is becoming increasingly difficult with more cars on the streets and more and more people desiring to use their vehicles when shopping.

The effects of inadequate parking will be as follows as the problem increases: (a) Loss of revenue because shoppers being unable to find suitable parking, are doing their shopping in other areas; (b) Loss of revenue by store owners moving to areas where parking is more readily available; (c) Loss of revenue which might be anticipated from expansion of present businesses because additional business cannot be gained unless parking space for additional shoppers is provided.

An indication of the present trend of non-expansion in the downtown area is the construction of stores in the Westyhal, Woodside and Tufts Cove areas, in addition to the shopping centre on Wyse Road. The main reason for the development in these outlying areas is the inability to provide parking in the downtown area. The providing of ample free parking space in these newly developed areas can only have the effect of drawing trade away from the downtown area.

The development of individual businesses and shopping centres in the outlying areas rather than in the downtown area must result in less taxation for the City because of lower assessed values on land in the new areas as compared with the downtown area.

It is greatly feared that as people note the inadequacy of parking in the downtown area and move to other areas to do their shopping; it will establish a trend that will seriously affect the merchants and their businesses, resulting in increased lack of desire to establish or purchase businesses in that area which will have the ultimate effect of lowering property values and tax revenues for the City.

WHAT THE MERCHANTS HAVE DONE IN AN ATTEMPT TO ALLEVIATE THE SITUATION. On January 2, 1961, the the Downtown Retail Merchants Association incorporated a company known as Downtown Parking Limited in which shares and debentures were allotted by subscription to property owners and merchants in the area on a zone basis whereby those nearest the proposed parking lot paid an amount greater than those further removed, but in the area to be affected by the parking lot.

To date the company has acquired, or is in the course of acquiring, properties on Queen Street having a total frontage of two hundred and ten feet (210') and an average depth of one hundred and twenty feet (120') at a cost of approximately One Hundred Thousand Dollars (\$100,000,00 and may be able to acquire a further property with a frontage of approximately sixty feet (60") and a similar depth.

From the parking lot two rights of way will be available for pedestrians to travel directly from the lot to Portland Street.

Attached hereto as Appendix "A" is a plan showing property acquired or being acquired by Downtown Parking Limited. It is believed that the space acquired by the company will accomodate approximately eighty (80) vehicles and it should be pointed out that this is more than are presently accomodated at the parking meters on both sides of Portland Street.

ASSISTANCE REQUESTED FROM THE CITY OF DARTMOUTH. The way in which parking areas were dealt with in the downtown areas of Halifax and Vancouver have been investigated and these, in brief, are as follows:

Re: <u>City of Vancouver</u>. The City of Vancouver arranged for One Million Dollars (\$1,000,000.00) to be restricted to the purchase of land for parking sites, and the lands when acquired were leased by tender, and, in all cases except one, the lowest tender was submitted by a company set up by the Downtown Businessmen's Association.

The Association then developed the parking lots and garages and from their operation have been able to pay taxes to the City on a business basis, and a further sum to the City by way of rental under the leases, and applied the balance to defray a special levy made on the Downtown Businessmen to pay the bond interest.

In the past seven (7) years, the capacity of the Downtown Corporation Parking increased from eighty-two (82) to thirteen hundred (1300) berths. The public in Vancouver have taken to the idea of downtown parking with enthusiasm and the entire program has been most successful, both financially and in alleviating congestion of traffic, and resulting in increased business and expansion of the downtown area.

Re: <u>City of Halifax.</u> The City of Halifax acquired land for the provision of a parking lot on Grafton Street containing ninety-two (92) spaces, and it is often necessary to deal with an overflow of vehicles. This has also been a successful business enterprise, and over a period of years, Ten Thousand Dollars (\$10,000.00) per year has been handed over to the City of Halifax. It is interesting to note that of a total revenue for 1959 of Sixteen Thousand Nine Hundred and One Dollars and Seven Cents (\$16,901.07), the sum of Seven Thousand Eight Hundred and Sixteen Dollars and Twenty-five Cents (\$7,816.25), or about Fifty Per Cent (50%) of all revenue received, was paid by merchants for vehicle owners who had made purchases in their stores.

The City of Halifax recently acquired land on #

Granville Street on which will be built a multi-level parking garage by a company to whom the land has been leased.

Downtown Parking Limited hereby requests from the City of Dartmouth that they be granted a loan not exceeding Twenty-five Thousand Dollars (\$25,000.00) to be interest free, and to be repaid to the City of Dartmouth before any dividends shall be paid on the shares of the company, this sum of money to be used for grading, levelling, paving and lighting of the parking area. Perhaps the possibility of the City carrying out this work by its own Works Department under the <u>Winter Work Program</u> might be investigated.

<u>CONCLUSIONS</u>. It must be evident to anyone who drives a car in the downtown area that a serious parking problem exists. People who find they must spend time circling City blocks in order to find a space to park are not likely to continue to try to shop in that area.

C)

Fewer cars coming to the downtown area means fewer customers and the trend will be to shop in outlying areas and a gradual deterioration of the downtown area.

If new business cannot be attracted to the downtown area and deterioration does occur, it will result in serious tax losses to the City.

It is felt that the merchants have made a fine effort in organizing the company, providing funds and acquiring the large area of land they now own.

It is felt that the protection of the investment of the downtown merchants has a direct bearing on the City's potential tax receipts and progress in the future.

It was moved by Aldermen Hart and Beazley, and carried, that the report of the Finance Committee be adopted.

VOCATIONAL TRADES SCHOOL

Report was read from Mr. I. K. Forsyth, Superintendent of Schools, submitting, on behalf of the Board of School Commissioners, information in reply to a request from the Ward 7 Ratepayers Association dealing with the establishment of a vocational trades school in Dartmouth; this matter having been referred to the Board of School Commissioners for study. Mr. Forsyth reported as follows:-"Item 1 (a) We have always been able to accomodate all the qualified applicants from Dartmouth for training in the Halifax County Vocational High School. We have never turned away a qualified applicant. Applicants are refused admission for the following reasons:

I may add that at the present time the City of Dartmouth has one hundred and five (105) students at the Halifax County Vocational High School and that this represents 15.6% of the total enrolment."

It was moved by Aldermen Hart and Granfield, and carried, that the report of the Superintendent of Schools be received and filed and a copy of same forwarded to the Secretary of the Ward 7 Ratepayers Association.



Report was read from the Clerk-Administrator recommending that the following resolution, authorizing the expropriation of property from the Alice Hershey Estate for street purposes be adopted. On motion of Aldermen King and Hart the following resolution was unanimously adopted:-

(51) "RESOLVED that the City Council of the City of Dartmouth deems it necessary for the purpose of laying out, constructing and maintaining a street, to enter upon and take the lands described in Schedule 'A' hereto attached and shown on the plan also hereto attached. Reports from the Planning Engineer and the Chief of Police, respecting these billboards, were summarized, advising that they see no objection to the proposed locations. It was moved by Aldermen Hart and Granfield, and carried, that this request be referred to the Finance Committee for consideration and report. Letter was read from Mr. J. J. MacIntosh submitting his resignation as Director of Civil Defence for the City of Dartmouth effective immediately. This application was recommended to City Council for approval by the Planning Board with the recommendation that the garage portion of the extension on the basement floor level be of fireproof construction.
