Due to the recount in Ward 5 and the fact that Aldermen have not yet been sworn in for that ward, no members are recorded as being present. Mrs. Stubbs and Mr. Greenwood, the candidates with the highest number of votes on election day, were present in the Chamber, however, for the meeting.

Mayor Brownlow welcomed the new Council to their first regular meeting, and he also welcomed to the meeting, the 17th Dartmouth Scout troop and their leaders.

On motion of Ald. Crawford and Withers, Council approved the minutes of meetings held on September 28th and October 5th.

OCAL PORT

MINUTES

A letter was before Council from the Chairman of the Halifax Port Authority on the subject of legislation recently enacted by the Federal Government, providing for the establishment of a Canada Ports Corporation and local Port Corporations in the major Canadian ports. The letter details the structure and functions of these proposed new bodies, and Mr. Simmons, Chairman of the Halifax Port Authority, was present to provide a further explanation and respond to questions from members of Council. He clarified the basic difference between a local Port

Corporation for the Halifax/Dartmouth area and the

Provincial body being recommended. The former body will

be responsible for the operation and management of the port, while the emphasis of the latter one is directed toward marketing.

The Mayor has recommended that Council endorse

the establishing of a local Port Corporation, as outlined in the letter from Mr. Simmons and detailed in his presentation to Council. The recommendation was adopted, on motion of Ald. Greenough and Hawley.

Ald. Hawley, in presenting his motion, made reference to recent instances where docks have been constructed in City lakes, specifically Lake Charles, without the knowledge of the Lakes Advisory Board and without any opportunity for the Board to have an input before the projects got underway. He also referred to development that can take place just outside City boundaries and affecting City lakes, without the plans ever having come to the Board for review and recommendation.

Ald. Crawford felt that the function of the Lakes Advisory Board as a body that makes recommendations only,

should be kept in mind. He questioned whether in fact the motion is redundant since the procedures and policy being proposed appear to be already in place.

Ald. Greenough suggested that the reference in the motion should be more specifically to those developments that are likely to affect lakes and watercourses, rather than the general application now indicated. He moved in amendment, seconded by Ald. Hawley, that the words 'lakes and watercourses' be added to the first sentence, after the present wording '. . . City of Dartmouth'. The amendment carried.

Mr. Bayer was available to respond to questions raised about the present policy being followed with respect to development applications and their referral to the Board for consideration and comment. There is no problem in the case of applications that have to come to the Planning Dept. and Council, but Ald. Hawley noted that his motion is intended to cover those situations outside the present policy provisions. When the vote was taken on the amended motion, it carried.

MOTION: Resolution re the Lakes Advisory Board, as set out on page 8 of these minutes and moved by Ald. Hawley, seconded by Ald. Greenough.

<u>AMENDMENT</u>: Moved in amendment by Ald. Greenough and Hawley that the words 'lakes and watercourses' be added to the first sentence of the resolution, after the present wording '... City of Dartmouth'.

2) Ald. Hawley introduced his second resolution, seconded by Ald. Crawford, as follows:

BE IT RESOLVED that the City of Dartmouth set aside four parking spaces, in a convenient location, in or near the Aldermanci parking area. These areas to be designated as 'free parking spaces' during regular business hours, for a fifteen-minute period, and designated only for the use of citizens who have need

to do business at City Hall.

Ald. Hawley felt that it is unfair for citizens to

have to put money in parking meters when they are required

to be in City Hall on business, such as paying their taxes,

water bills, etc., an opinion also shared by Ald. Crawford

who supported the motion. Ald. Withers questioned possible

problems in policing this kind of parking arrangement,

pointing out that it will be difficult to know whether or not people parked in the designated spots are really at City Hall on business or shopping on Portland Street. Mr. Moir said the parking spaces, if so designated, will have to be monitored on a regular basis by the Commissionaires on duty in the City Hall area.

When the vote was taken on the motion, it carried with Ald. Withers voting against.

MOTION: Moved by Ald. Hawley and Crawford that parking spaces be designated for people doing business at City Hall, as per the resolution presented on page 9 of these minutes.

Ald. Hawley's third motion was to have dealt with plans that the N. S. Housing Commission may have for future low-cost housing to be located in Dartmouth. He expressed concerns about the present lines of communication with the City when such units are being planned for development by the Housing Commission, and felt that the various points that have been raised in Council during past debate (such as avoiding ghettoized developments) should be emphasized to the Commission. Mr. Bayer explained the efforts that are being made by his department to communicate these concerns to the Commission and to work with the Commission staff toward the creating of better projects when additional units are approved for Dartmouth. At the suggestion of the Mayor, Ald. Hawley agreed to have further discussions with Planning Dept. staff, along the lines of his proposed motion, and to bring the item back to Council at a later time if he wishes to do so.

Ald. Hawley did not proceed with the introduction of a motion at this meeting.

The following notice of motion was given by Ald. Crawford for the next regular Council meeting:

THEREFORE BE IT RESOLVED and I will so move that the Provincial Dept. of Transportation be requested to construct a One Hundred Series Highway to by-pass Main Street and the MicMac Rotary in the City of Dartmouth, said highway to be constructed via the shortest distance between the Number 7 Highway and the A. Murray MacKay Bridge, as outlined in previous plans of the Provincial Dept. of Transportation and commonly known as the 107 By-pass.

Ald. Withers asked about the progress with property surveys in the Orichton Ave. Ext. area. Mr. Purdy said they are well underway and most of the basic work has been completed. Ald. Withers asked to be advised of the time and place for the next meeting with residents in this connection.

His second inquiry pertained to the overhead crosswalk sign for Victoria Road in the area of Northbrook School. Mr. Bayer advised that some of this equipment has come in and Portland Electric will be proceeding with the crosswalk installations at the various locations approved.

Ald. Withers inquired about the ownership of easements over properties in the Woodland Park Subdivision. Mr. Fougere said the Solicitor looking after this work is no longer in the City and it will be necessary to find out who the new Solicitor is that will be taking over from him.

Ald. Withers asked if the program of taking over private streets has started. He referred to Banook Ave. as one of the streets in this category in need of immediate attention.

The final inquiry made by Ald. Withers had to do with the report requested on substandard housing. Mr. Moir agreed to take this matter up with Mr. McNeil again, to see if he plans to submit a further report.

ALD BREGANTE

Ald. Bregante asked when lines are to be painted on the section of Pleasant Street in front of the Dartmouth General Hospital. Mr. Moir and Mr. Bayer advised that efforts are being made to get the line-painting truck back for this section.

Ald. Crawford asked when Council will be dealing with the sick leave and benefits report presented to the former Council. Mr. Moir said it can probably be discussed before Christmas.

Ald. Crawford asked to be kept informed, along with other members of Council, on any progress that is made in acquiring the railroad team tracks and land located behind the Liquid Carbonic building.

Ald. Crawford asked when a further discussion can be expected in connection with the Park & RideStudy tabled recently with Council. Mr. Bayer said this item was tabled for presentation at the next Committee meeting.

Ald. Crawford discussed with the Solicitor, points raised in a memo from the Solicitor's office, in response to previous inquiries made at Council with respect to the Rent Review Act. Dealing with the question of tenancy hearings and the opportunity for outside representations to be heard at such hearings, the Solicitor said there is nothing to prevent an Alderman from giving support to a tenant group in his ward, but it would be doubtful whether the Rent Review Commission would hear anyone other than the parties directly involved.

D. ROMKEY

Ald. Romkey inquired about the dangerous traffic situation on the section of Portland Street from Penhorn Mall to Jersey Drive. He was advised that the T.M.G. have this matter under study already and expect a preliminary report from a traffic consultant by the next T.M.G. meeting.

Ald. Romkey asked if additional information could be made available to new members of Council on the subject of the 107 By-pass and the plans for improvements to the Rotary. The Mayor said that a series of information meetings and briefings are planned, at which time new members will be broughtup-to-date on all major issues such as the 107

This meeting of Council constituted an information session for presentation of the Sea Base study report, prepared by O'Halloran Campbell Consultants Ltd. Copies of the report have been circulated with th

of the report have been circulated with the agenda. Mr. O'Halloran made the presentation to Council, in conjunction with preliminary remarks made by Mr. Bayer, who pointed out that we now have the figures and specifics to complement the idea of creating wharfage facilities in the Wright's Cove area. This need for wharfage facilities to be developed as an adjunct to the Burnside Industrial

Park development, has been recognized for some time.

The Sea Base study was authorized by City Council in January of 1982. An accompanying report from Mr. Bayer recommends that Council and the Industrial Commission endorse the report, thereby permitting the initiation of a series of actions to be taken, as detailed in the report. The Mayor pointed out that Council is not expected to take any official action on the study at this meeting, which was intended as an information session.

Following the presentation by Mr. O'Halloran, the members had an opportunity to voice concerns about the Sea Base proposal and to ask questions of both Mr. O'Halloran and Mr. Bayer. Ald. Hawley raised a number of questions, dealing with: (a) ownership of the land under the water in the Cove area; (b) the location of DND shells in relation to the Sea Base development; (c) the availability of fill material that will be required; and (d) the viability of the wharfage facilities after the sea base requirements of oil and gas development no longer exist. Ald. Stubbs and Crawford had particular concerns about one of the points raised by Ald. Hawley, that is, the question of the unexploded ammunition remaining on the bottom of Bedford Basin and whether, in fact, permission will be given by National Harbours Board and/or DND to allow a development such as the Sea Base to proceed in such close proximity to this ammunition. Ald. Crawford said he was aware of a recent instance where permission to develop in the area has been denied to a private interest, and Ald. Stubbs commented on the negative response given to the City when the container pier was under consideration for Navy Island and then subsequently on a later occasion when development in the same area was being proposed.

Ald. Levandier questioned the cost of the proposal

and considered it excessive for the City to undertake.

He also had concerns about increased traffic by ships

under the two bridges without adequate pier protection.

It was pointed out by Mr. Bayer and Mr. Moir that the

City would not expect to bear the cost of the Sea Base

development, but would seek participation by other government levels and the private sector. The kind of financial contribution the City would make is represented by the 'seed money' that is required to bring the proposal to a point where private interests can submit proposals and nothave to go through the various government processes that are required to clear the way for the development.

Ald. Peters also had reservations about the kind of costs the City could get into and whether these are justified in terms of the need that exists of such a facility.

Ald. Greenough and Greenwood commented on the potential that the Sea Base has for the City, especially in a location so close to our Industrial Park, and felt that it is at least worthwhile to take the necessary initial steps in approaching other government levels and in attracting the interest of the private sector. Ald. Crawford said he was basically in favour of the proposal, but he would not want to see it proceed any further without first contacting the office of the Minister of Defence and/or DND officials to determine whether or not development will be permitted in the Wright's Cove area. He wanted to see this step taken immediately before Council proceeds with any endorsation of the study. Ald. Crawford quoted from the Whitman-Benn study of 1972 and the Fenco report of 1976 to substantiate his points about the danger zones that have been designated by DND and other questions associated with the presence of ammunition on the harbour bottom around the magazine area. The Mayor noted that development has been allowed to proceed in the Burnside Park where such zones are designated.

At the conclusion of the question period, Ald. Crawford moved that an immediate contact be made with
