your Committee recommend deferring the purchase of a stone crushing plant; the existing crusher is being repaired and will soon be in operation and it is proposed to arrive at the exact cost of operating and crushing rock before deciding on the purchase of another plant.

Petition of Concrete Sidewalk, Portland Street .

On motion of Crs. Otto and Hyde, Resolved, in view of the inability to secure suitable quarters and the passing of regulations for the guidance of the Vendor, that the appointment of Vendor take effect in and from the 31st. day of May A. D., 1921, instead of May 1st., 1921, as set forth in resolution passed on March 29th., and that the said resolution be amended accordingly.

On motion of Crs. Verter and Hyde, Resolved, That the offer of \$70.00 received from Mr. John Kilroy for land required from his property for Street widening purposes be accepted and the Town Solicitor be instructed to prepare deed for same and pay over said sum when deed is completed.

The Town Engineer reported, recommending that the following street lights be installed and asking for authority to instal same.

Halifax Board of School Commissioner, asking that the grant to the Halifax Evening Technical School be increased from \$150.00 to \$600.00 per annum. Referred to the School Board.

Letter read from Eunice C. Allen, See'y., Shannon Chapter, I. O. D. E., asking for permission to sell red roses on the streets in celebration of the Patron Saint of England, on ST. George's Day, April 23rd., for the purpose of enriching their Treasury for war memorials. Request granted.

Letter from Town Engineer, suggesting the placing or erecting of signs near schools in the Town such as "School- Drive Slowly" or something similar. Referred to Street Committee.

By-laws were read and ordered The Electric Wiring to lie on the table and the Town Solicitor was instructed to prepare legislation necessary for the passing of these by-laws.

Councillor Lynch's Notice of Motion to rescind resolution passed by the last Council re. application to the Provincial Government for a further loan of \$200,000 for the Housing Commission was dealt with and on motion of Councillors Lynch and Smith, Resolved that the resolution passed on Oct. 28th., 1920, applying to the Director of Housing for a loan of \$200,000 to be applied under the Nova Scotia Housing Act, 1919, be rescinded. Motion passed. Councillors Lynch, Smith, Carter & Otto for and Councillors Hyde and McLean against.

On motion of Crs. McLean and Carter, Resolved that the Town shall make application to the province of Nova Schotia for borrowing a sum of \$100.000 to be used in the Town of Dartmouth by the Housing Commission under the provisions of the Nova Scotia Housing Act. Passed.

On motion, a Committee comprising of Councillors Smith, McLean and Otto were appointed to meet the Housing Commission in reference to regulations re. loaning of money to applicants and also to show good cause why this additional money should be borrowed.

Letter read from Imperial Oil Co., Ltd., D. M. Allen, Jr., Supt., stating that at a meeting of the delegates of the Industrial Welfare Council of Imperoyal, the question of Time Saving was brought up and a motion was unanimously carried that the Daylight Saving Plan be asked for and that this Council take steps to reconsider the adoption of the Daylight Saving Plan. Received and the Clerk was instructed to reply, stat ing that the matter would have the Council's earnest consideration.

W. H. Hattie, Prov. Health Officer, asking that representatives from the Council be appointed to meet the delegates from the County in reference to health matters to be brought before the Governor-in-Council on Tuesday evening. We would also recommend that an amount not exceeding \$750.00 be authorized to be spent on remodelling to suit requirements of the Vendor."

Petition from ratepayers on Edward Street, asking for a Permanent Sidewalk on the west side between Ochterloney and Queen Streets. On motion, request was granted, subject to to there being sufficient funds to carry on the work.

Letter read from the Acadia Sugar Refining Co., Ltd., stating that they had a proposition to put before the Council and as the same was not ready yet, they asked that the date of expiration of the agreement between the Town and themselves be extended until such time as the Committee from the Town Council had definitely passed upon their proposition. Ordered to lie on the table. proposition.

Letter read from Geo. S. Richards, Church St., complaining (1) of the noise caused by the repairs being made to cars outside of the garage, just opposite to his house; (2) that the Town workmen had been dumping refuse and rubbish at the head of the street. Clause 1, referred to Police Committee; Clause 2, Town Engineer.

Jas. F. Lahey, stating that he had recently purchased a property on Maitland Street., and asked that repairs be made to the street in order to facilitate teaming and stated that there was a large amount of loose rock and material on the property which might be suitable for grading streets which the Town could have for the Mauling. - 1. A man must own his own lot and give a deed thereof to the Housing Commission before there is any advance of money.
- 2. Commission to advance 75% only on contract price of building and price of lot.
- 3. The applicant to be required to give security of 25% of the loan.
- 4. All payments must be made direct to the contractor.

The following notice and regulations in regard to Clean-Up were approved and the Clerk was instructed to impert copies of same in the Halifax Evening Papers and Dartmouth Patriot.

Present :- Mayor Vidito, Crs. McLean, Smith, Lynch & Carter; also R. H. Murray, Deputy Town Solicitor.

Deputy Town Solicitor Murray submitted a draft set of regulations in regard to the Legal Vendor for the Town of Dartmouth as follows:-

LEGAL VENDORS, REGULATIONS, TOWN OF DARTMOUTH.

1. Each vendor, before entering upon the duties of his office, shall file a bond executed by himself and a Guarantee Company as his surety in the sum of One Thousand Dollars, conditioned on the faithful performance of his duties as vendor. Said bond must be approved by the Police and License Committee of the Council.

2. The vendor shall comply in all respects with the provisions of the Nova Scotia Temperance Act, and amendments thereto, in the selling of intoxicating liquor in the Town of Dartmouth.

The vendor shall weekly on a day to be appointed by the Town Clerk, make a complete return to the Town Clerk of all sales made by him, and shall on such days, deposit with the said Clerk all moneys which he may have received as such vendor.

4. The office hours of the vendor shall be from 10 A. M. to 1 P. M. and from 3 P. M. to 6 P. M. on all days, excepting Sundays and legal holidays, and he shall at no other time or times sell or dispose of any liquor, excepting in cases of emergency.

5. No vendor shall permit a customer to remain on his premises a longer period that is necessary to transact his or her lawful business there.

6. The said premises of the vendor shall be approved by the Police and License Committee and shall comply with the following:-

- (a) There shall be only one entrance to said premises and such entrance shall be facing a public street.
- (b) Said premises shall have at least one window facing a public street, which window shall be clear transparent glass. No blind screen or other obstruction of any kind shall be allowed in connection with such window, so as to conceal any part of the interior of the shop from the view of persons on the street without.
- (c) The premises generally shall comform to such requirements as may be deemed advisable by the Police and License Committee and the Inspector under the Nova Scotia Temperance Act.
- 7. All liquor shall be purchased and paid for by and upon the order of a Committee, consisting of the Town Clerk and two members of the Town Council appointed by the said Council.
- 8. All packages, parcels, cases or other receptacles containing importations or purchases of liquor made from time to time shall be opened in the presence of the said Inspector and one or more members of the Committee referred to in Paragraph six (6) and the Town Clerk, or his Assistant, who shall keep an accurate record thereof and who shall have the power at any time to compare said record with the stock on hand and the sales by prescription or certificate.
- 9. If any vendor violates any of the foregoing provisions his appointment as vendor may be forthwith cancelled by the Council and his powers under said appointment shall thereupon absolutely cease.
- 10. The foregoing provisions are not intended to take the place of provisions or penalties against vendors imposed by the existing law for neglect or violation of such law. Said penalties shall also be enforceable in addition to the penalty of dismissal from the office of vendor, and the Council may supplement the foregoing provisions from time to time.
- ll. In the event of there being doubt as to the genuiness of a prescription or certificate presented to the vendor, or that the person presenting the said prescription or certificate, is not the person for whom it was issued, the vendor, before filling the said prescription or certificate, in order to satisfy himself in these respects, shall have a reasonable time to communicate with the physician or inspector whose name appears on the said prescription or certificate.

The regulations were dealt with clause by clause. Clause two was struck out and section "B" of Clause Six was struck out.

On motion, Resolved, that the Legal Vendors regulations as amended be adopted and that the Clerk be instructed to forward a copy to J. A. Knight, Inspector-inChief for his approval, and on motion, Crs. Hyde & Otto, & the Town Clerk were appointed a Committee as required under the Legal Vendors Regulations for the purpose of purchasing liquor, etc.

Re. Housing. Letter read from J. J. O'Toole, Chairman of the Dart. Housing Commission, submitting a list of applicants in for loans to be made under the additional \$100,000 asked for. (27 applications amounting to \$97,839). After some discussion, on motion, the matter was referred to the Town Solicitor and Mr. O'Toole.

On motion, Resolved, that "An Ordinance Fort the Regulation of Traffic" On Streets in the Town of Dartmouth as submitted by the Deputy Town Solicitor be approved and that the Clerk be instructed to forward copies to the Governor-in-Council for his approval.

The question of Mm. Phillips street line was up for discussion and on motion, the Town Solicitor and Town Engineer were appointed a Committee to wait on the Governor-in-Council and present the Town's claim.

Daylight Saving. On motion, recolved, that this Council adopt the Daylight Saving Scheme from May 9th. to Sept. 5th. inclusive and that the citizens be respectfully requested to set their clocks one hour ahead on Monday, May 9th., 1921.

Petition read from Rev. J. A. McGlashen, Mrs. John Moir, Sr. and A. C. Pettipas, et al, asking that permission be granted to George Evans to operate a ferry on schedule time to suit the travelling public (North end); the docks to be at the foot of Jamieson Street, Dartmouth and at the foot of Russell Street, Halifax. On motion, request was granted.

Letters read from :-

Dartmouth Coal & Supply Co., Ltd., calling attention to the deplorable condition of the road leading from Pleasant Street to the Marine and Fisheries known as the Old Ferry Road it being unsafe for the travelling public and injurious to foot pedestrians; also there were no lights on that road, Referred to the Street Committee.

Dartmouth School Board asking that the captured German gun donated to the Town of Dartmouth by the Militia be set up on the Park School grounds. On motion, request granted until such time as the Council may require the gun.

Ronald McDonnell, asking for an increase in salary. Referred to the Police Committee.

The Town Engineer reported that a building owned by Mrs. Isabella Smith on Wentworth Street, was in a very dangerous condition. On motion resolved, that Mrs. Isabella Smith be and she is hereby directed to demolish and remove the building belonging to the said Mrs. Isabella Smith, situate on Wentworth Street, which has fallen into decay and has become a menage to public safety and that a copy of the resolution be served on the said Mrs. Isabella Smiht.

On motion, resolved, that the sum of \$200.00 be granted to the Engineer for gas and repairs to his er to date from May 1st., 1921, as he used his car in the services of the Town.

Application for water connection was received from John Hartlen, Preston Road. On motion, resolved that Mr. Hartlen's request be granted and that he be supplied with water from the Town mains at a minimum charge of \$15.00 per annum, he to pay all costs of connection, including cost of meter and the installation of same and that the meter be installed to the satisfaction of the Town Engineer also that the Town Engineer have access to the meter at all times and that no change be made excepting under his supervision. Further that he be allowed the maximum amount of 3,000 gallons per month and be charged 20% for very 1,000 gallons used in excess of the 3,000.

Letter read from The Acadia Sugar Refining Co., Ltd., stating that they desired to be supplied with the Town of Dartmouth water for domestic purposes to supply about 35 or 40 houses in addition to water required for fire protection.

On motion, Resolved, that the Clerk be instructed to write the Acadia Sugar Refining Co., Ltd., notifying them that the terms in their letter of the 4th. inst., are not acceptable to this Council and altho their agreement expires on the 15th. inst., that this Council will supply them with water at the old rate for one month from above date, pending the execution of a satisfactory agreement between the Town of Dartmouth and the Acadia Sugar Refining Co., Ltd.

Letter read from Jas. L. Harrison, complaining of a light being out on Prince Street, stating that he had reported it to the Police authorities and Supt. of Streets. Referred to Supt. Nichols to replace the light.

The Street Committee reported as follows on the several matters referred to them ;-

Letter from Frank Lahey, complaining of surface water finding its way into the cellar of his house. Referred to Town Engineer to report on and submit proposal, with estimate to remedy same.

Letter from Jas. F. Lahey asking that the lower end of Maitland Street be graded to make passable for teaming work. The Engineer ordered to carry out this work which is now well in hand.

Letter from J. G. Rainnie and The Dartmouth Development Co., asking for some street work to be done on the Old Ferry Road and also that some lights be placed between Pleasant Street and the Marine & Fisheries on the Old Ferry Road. The Engineer has been instructed to repair the bad places on that street. Provisions of Street lights will be included in a report being prepared by the Engineer covering all localities where additional lights are required.

Street Lighting System. Alterations to; the attached estimate from the Dartmouth Electric Light Co. of making the suggested alteration is submitted for the Council'l discussion,

Councillor A. Carter, Chairman of the Street Committee :-

"In reference to Street lighting the estimated cost of "moving your transformers and switchboard and making the "necessary changes so as to operate the street lights from "our plant is \$500.00 with the monthly charge of \$10.00 to "cover rent and labor. It will not be necessary to sign a contract for the street lighting."

The report was then adopted as a whole.

The Water and Sewer Committee reported recommending the extension of the water and sewer mains on McKay Street to supply two houses now waiting to have the Plumbing connected up which have been up to the present, sewering on the street on the adjoining properties. Referred back to the Committee for a more complete report.

The Water and Sewer Committee also recommended the purchasing of 350 feet of 28" Cotton Jacket Fire hose from the Dominion Rubber System (Maritime) Ltd., at \$1.85 per foot, price includes coupling complete in 50 foot lengths. Adopted.

The Fire Committee reported that they had taken over the new Axe and Ladder Truck purchased from the American La-France Fire Engine Company.

The Police & License Committee reported, recommending that the salaries of all Police Officers be fixed for the balance of the year as follows :- (Same to include such other duties as may be assigned to them from time to time by the Council):

The minutes of the last meeting were read and approved.

The Water Committee reported on the following reccomendations:-

McKay. Street. The Council at its last meeting authorized making new connections to the existing sewer and water pipes provided permission was first obtained; after this was obtained excavation was made over the pipes in line with one of the proposed connections the sewer was found to be very shallow, so much so that it is of no use to those requiring drainage; the shut off valve on the water pipe was found to be so corroded as to need renewal, this was done and a portion of the old pipe removed for inspection as to condition, the small piece of pipe removed with the valve is wrought iron and is about half full of corrosion, the main pipe line of cast iron is almost completely corroded up.

The Town Engineer does not recommend connecting any more services to this old pipe line and the sewer

as stated, is of no use.

In view of the foregoing facts procured since the last meeting of the Council your Committee strongly urge that a new 6" water main be laid in McKay Street together with a 12" sewer at a total estimated cost of \$3600.00.

The sewer is estimated to oost \$1718.00
The sewer frontage is estimated to bring in \$1748.
The water is estimated to cost \$1882.00

expected to be completed shortly covering grading and 6% of the cost of laying the water services in these streets, which will enable this work to be proceeded with, the total estimated cost of which is \$10175.00; the amount of revenue to be obtained from sewer frontage is estimated to be more than the cost of laying sewers.

Lyle Street. In compliance with a resolution passed at the last meeting of the Council the Town Clerk wrote to Messrs. Benjamin Bros. outlining the conditions under which sewer and water would be provided in this street-i.e., if they would agree to pay 6% annually for twenty years of the cost of laying water main, this amount to be proportionately reduced as more development takes place or until the water rates are equivalent to the special charge.

Mr. Benjamin has replied that they cannot agree to this proposal but have submitted an alternative proposal which is to make agreement with the owners of building lots abutting on the proposed pipe line to pay equal proportions annually for twenty years of an amount equal to 6% of the cost of laying the water main, these amounts would in turn reduce as or un-

til the total regular water rates equalled such 6%.
Your Committee recommend that this extension be made subject to the above agreements being completed - the estimated cost of

the work if \$4070.00

Out-fall Sewer. Your Committee have again had under consideration the question of providing a main sewer outlet for the Eastern section of the Town and are now recommending this work be put in hand by constructing the trunk sewer from Pleasant Street to the Harbor through the property of J. P. Mott & Co. at an estimated cost of \$20,000.

As the Town develops this sewer is becoming more and more of a necessity and the attached report of the Town Engineer on this subject dated May 13th., 1921 points out the desirability of constructing this out-fall sewer.

Your Committee feel that owing to the large number of unemployed ratepayers in the Town, some construction work could well be undertaken now, it is hard to estimate what conditions will be during the winter when conditions are as bad as they are at the present date.

This work might well be undertaken as a relief to those unemployed, by employing only unemployed married men resident in Dartmouth for twelve months or longer; such mem will now willingly work for smaller rates than heretofore and in this way lessen the cost of the proposal and eliminate the expenditure of a large sum later in charity.

It might here be pointed out that time is getting short, the season is well advanced, and some construction work, if only to relieve unemployment, should be put in hand as soon as possible.

On motion the report was received and dealt with clause by olause.

On motion of Crs. McLean and Smith, Resolved that the Town Engineer be authorized to extend the Town's water and sewer mains on McKay Street to replace the present inadequate mains owned by Mr. Allison.

Cameron & Harvey Streets.

On motion of Crs. Hyde and Otto, Resolved that the water and sewer mains be extended on these streets subject to deeds of dedication being given to the Town and also that agreements be executed whereby the property owners will pay 6% annually on the cost of the construction.

Lyle Street.

A motion was adopted that the Water and Sewer be extended on Lyle Street to supply Messrs. Benjamin Bros. on condition that property owners along that street, execute a satisfactory agreement with the Town, whereby they pay six per-cent annually on the cost of construction ..

- 2...Re. flooding of Cellars on Wyse Road, your Committee recommend that the sewer on Jamieson Street be extended to the junction of Boland Wyse Roads to take care of surface water and two catch-pits constructed. The estimated cost of this work is \$300.00. Passed.
- 3...Re. Oiling of Streets, your Committee recommend that Crichton Ave., from Ochterloney Street o Oak Street, and water street from Ochterloney Street, Windmill Road, thence to Dawson St., be oiled. The estimated cost of this work is \$375.00. Passed.
- 4...Re. repairing and covering Water Street from Portland Street to Ochterloney Street., your Committee recommend that the purchase of 1000 gals. of Tarvia B. km be applied to this section of the street. The cost of the Tarvia is 23¢ per gallon and the cost per square yard for the work will be 11¢. The total cost of the work including sweeping, putting in of material and covering with gravel will be approximately \$300.00 Passed.

The following letters were read from :-

Sec'y., Union N. S. Municipalities, stating that the 16th. annual convention would be held in Halifax, August 23rd., 25th., and asking that the Council appoint delegates to attend the convention. Councillor Carter moved that the whole Council be delegates. In the matter of helping to entertain the convention, it was agreed that this be left in the hands of Councillor Carter.

Mrs. H. Lethbridge, stating that it was her intention to build two bungalows on the corner of Jamieson Street and Windmill Road and asked for something definite from the Council in regard to widening Windmill Road.

Banook Canoe Club, stating that the Club intended holding a regatta on August 4th., the Town's Natal Day, and asked that the Council proclaim that day a public holiday, and asking that the Council grant them \$200.00 towards defraying expenses:

Whereupon it was resolved, that the Mayor be asked to proclaim that day, the Town's Natal Day, a public holiday and that the usual grant of \$200.00 be paid the Club.

Mayor of Halifax, requesting the co-operation of Dart-mouth with the Warden and Council of the Municipality of Halifax and the Mayor and Council of the City of Halifax, and extending a hearty invitation to the 1921 convention of the Union of Canadian Municipalities.

On motion, letter was received, and the Clerk was instructed to write the Mayor of Halifax, stating that the Dartmouth Town Council would attend the Convention and co-operate with the preparation of the programme for their entertainment.

Sec'y., G. A. Holmes, of the Trustees of School District 88, asking that the Town convey to them a deed of the original school property purchased by the Town of Dartmouth from the late Dominick Farrell, providing that no previous conveyance of said property has been made either to the County of Halifax or to the Trustees of the lately consolidated sections of Tufts Cove and Woodside. Referred to Town Solicitor for report.

Chronicle Publishing Co., stating that they intended to issue a special edition on Dartmouth's Natal Day and asked that the Council take a full page advertisement, price of which would be \$215.00.

On motion of Crs. McLean and Lynch, it was resolved that the Council take a half page and that the preparation of the matter be left in the hands of Councillor Hyde.

Douglass-Fullerton Co., Ltd., stating that they understood a number of castings had been imported from a firm in Galt. Ont. They felt that they might have been given an opportunity to quote on these castings as they considered they were capable of quoting on any design that might be required. After some discussion it was resolved on motion of Councillor Otto, that in future the Town Engineer be instructed to inform Dartmouth manufacturers when materials were needed by the Town and get their prices.

American LaFrance Fire Engine Co., stating that a settlement was due them on the Motor Ladder Truck and that they will expect same this month.

A. S. Wolfe, urging that people unable to obtain employment be employed in the improvement of Windmill Road which had been decided upon and money borrowed some years ago for the purpose. Referred to the Street Committee.

Mrs. H. L. Gates, complaining that her property fronting on Portland Street was in a very bad condition caused by the construction of a new storm water sewer through her property. She asked that the matter be promptly attended to, Referred to the Engineer and Water Committee to take immediate action.

John D. Corkery, applying for the extension of the water and sewer mains on Mott Street to his property. Referred to the Water Committee to report on.

L. McLachlan, asking for a Chimney Sweep License to protect him against competition from Halifax Chimney Sweeps. He asked that a by-law be adopted to provide for better management in the business. The Clerk was instructed to notify him that by-laws were now being prepared.

- J. Urquhart, complaining of the condition of Bolton Terrace, it being impassable for motor vehicles. Referred to the Street Committee to report on.
- E. H. Armstrong, Minister of Public Works and Mines, calling attention to the recent legislation respecting inatitutions for the treatment of insane persons and for the custody and treatment of mentally defective persons and inspection of Prison Farms. Read and ordered filed.

Petition from H. B. Gentles and others, property owners on Dundas Street, requesting that a concrete sidewalk be laid down on the East side of that street, between Queen and Portland Streets. Referred to the Street Committee to report on.

The Town Engineer reported that an accumulation of boat knees are piled on the south side of Chruch Street below Water Street on the property of the late E. F. Williams. He asked that the necessary steps be taken to have the obstruction removed.

After some discussion, it was resolved that the Engineer be instructed to submit a list of all encroachments on streets and public docks.

Hackney Licenses duly approved by Inspector Liddell were granted to George Myers and H. B. Conrod.

Plumbers Licenses approved by Inspector Forbes, were granted to Mrs. Lily Sawler, Ralph Innes and George Richards.

The following bills were submitted ;-

After some discussion the bills were referred to the Finance Committee for report.

The appointment of Town Assessors for the ensuing year was discussed and on motion of Councillors Lynch and Smith, it was resolved, that the Clerk advertise for applications for the position of Assessors required by the Town of Dartmouth and asking the applicants to state their experience and salary desired. In view of the fact that it was necessary to make the appointment soon, to comply with the legislation thereon, the Mayor and Finance Committee were authorized to make the appointment.

Registration of Unemphloyed.

After some discussion on this subject, it was decided to advertise in the press that a Register would be opened at the Town Hall and those desiring employment be invited to register their names. On motion of Councillor Lynch, seconded by Councillor Otto, it was resolved, that a Committee be appointed on publicity and the establishment of a bureau on employment at the Town Hall, Councillor Lynch and Councillor Otto were appointed as such Committee.

A number of accounts signed by two councillors were passed for payment.

HOUSING COMMISSION BY LAW:

On motion of Councillors McLean and Otto the following By Law was adopted:

WHEREAS the Town Council of the Town of Dartmouth on the fifteenth day of October, A. D., 1919 passed under the Nova Scotia Housing Act 1919 a By-Law declaring under Section 12 of the said Act that part Two of said Act shall apply to the said Town and appointing under Section 18 of the said Act a Commission to be known as the Housing Commission of the Town of Dartmouth for the purpose of carrying out the provisions of Part Two of the said Act, and limiting under Section 19 of the said Act the powers of the said commission to the purposes set out in Sections 20 and 21 of the said Act;

AND WHEREAS the said Town for the purposes of Part Two of the said Act is desirous of borrowing from the Province of Nova Scotia the sum of One Hundred Thousand Dollars (\$100,000.00), the said Town having found that the sum of One Hundred Thousand Dollars (\$1000,000.00) previously borrowed from the Province of Nova Scotia under By-law dated August second, A. D., 1920 is insufficient and inadequate to meet the present demands for housing as contemplated by the said Act, in said Town of Dartmouth;

AND WHEREAS the Director of Housing has approved of such borrowing;

BE IT, THEREFORE, ENACTED AND ORDAINED by the Town Council of the Town of Dartmouth as follows:-

THAT forthe purpose of Part Two of the said Act, and under the said Act, the Town of Dartmouth do borrow from the Province of Nova Scotia the sum of One Hundred Thousand Dollars (\$1000,000.00) to be repaid as provided by said Act; and within a period of twenty years from the date of the loan, and to bear interest at the rate of five per centum per annum, payable half yearly;

THAT as collateral security for the payment of the said loan, the said Town do issue under and in accordance with the said Act and the Municipal Debentures Act 1914 as amended, one hundred Debentures of the said Town for One Thousand Dollars (\$1000.00) each; that the said Debentures be numbered 1 to 100 inclusive; be dated from the first day of September, A. D., 1921; be payable in 20 years from the date thereof at the Office of the Town Clerk in the Town of Dartmouth and bear interest at the rate of five per centum per annum, payable half yearly at the said office. That the Mayor of the said Town do sign and the Clerk thereof do countersign the said Debentures; that they do seal the same with the corporate seal of the said Town and that the said Clerk do sign the interest coupons or, if the same are lithographed, either sign the same or have them impressed with a facsimile signature of his and that the Town Clerk be and he is hereby authorized and directed to deposit the said Debentures with the Provincial Tressurer of Nova Scotia under the said Nova Scotia Housing Act, 1919.

The Committee of Finance report as follows:

Your Committee of Finance having had under consideration the matter of the condition of the office accommodation of the Town Clerk and Treasurer and the volume of business now being transacted therein beg to recommend that

the following changes be made therein; namely,

lst: That a Teller's Cage be placed in the South portion of the office, nearest the vault and that people paying taxes be admitted by using a door now disused and that a counter be placed in said office to give access to wicket of the Teller's Cage and an additional window be placed in the west wall of the office to give more light in the said office.

2nd: That the Housing Committee and its Secretary be given accommodation in a portion of the Council Room and that the room so vacated be used as the Mayor's Office.

3rd: That suitable signs be placed over the doors of each of the offices and that the office hours be

stated on the signs;

4th: Your committee are of the firm conviction that the offices now provided for the various officials are entirely too small in view of the great increase of public business within the last few years and would strongly urge that steps be taken to borrow sufficient money to erect a suitable new Town Hall.

5th: In the matter of Clerical help, it is the opinion of this committee that efficient working of the office cannot be maintained with the limited staff engages at present, and we would recommend that a male

clerk be engaged at once.

Clauses 1, 2 & 3 adopted. Action on 4 & 5 deferred.

The Committee on Water and Sewerage reported as follows:

lst. That Chas. G. Cleveland, who is manufacturing syrups under the name of "Crosskill & Co." in the lower flat of his three appartment house, corner of Maple and Myrtle Streets, be provided with a new connection to the main, that a meter be installed, and a charge of 20 cents per 1000 gallons be charged, with a minimum rate of \$25. per annum for meter and installing same.

2nd. That an Out-fall Sewer be constructed from Pleasant Street to the Harbour along the Cld Ferry Road at an estimated cost of \$22,700.00 and that a 6" water main be laid at the same time from Pleasant Street along the Old Ferry Road as far as the Eastern Passage Road at an additional estimated cost of \$1850.00, the property owners concerned will agree to pay annually an amount equal to 6% of the cost of laying water main for twenty years or less should the revenue from water rates equal such 6%; the amount collectable from sewer frontage is about \$4141.25.

The location of this out-fall sewer has been changed because of the fact that satisfactory arrangements could not be made with the property owners concerned by constructing this sewer through the Factory grounds of J. P. Mott & Co.

The new location is less costly, brings in more revenue, and better suited for future extension of sewers to drain the S. E. portion of the Town.

3rd. The small sewer on Portland Street is inadequate to take care of the amount of water on this Street, and conditions warrant the construction of this out-fall at once, with an extension along the Old Ferry Road to Portland Street next year.

4th. That in conjunction with the above, sewer and water be laid on the Eastern Passage Road from the Old Ferry Road for a distance of 120 ft. at an estimated cost of \$1175.00, the property owners agreeing to pay 6% on the cost of laying water for twenty years or less should the revenue from water rates equal such 6%; \$550.00 will be received for sewer frontage - water is estimated to cost \$611.00 and the sewer \$564.00.

Clauses 1, 2 & 3 were adopted on the casting vote of the Mayor, Councillors Smith, Hyde, and McLean voting for and Lynch, Otto, and Carter against.

Clause 4 was adopted, Councillor Lynch dissented. The report as a whole was adopted.

SALE OF HOSE REEL:

A Delegation being present from the Dartmouth Engine Company were given a hearing. They stated that a Hose Reel, which had not been in use had been recently sold to a resident of Woodside. Councillor McLean said that he thought possible that a mistake had been made and the wrong Hose Reel had been delivered to the Woodside people. After some discussion the matter was referred to the Fire Apparatus Committee.

ASSESSORS:

Applications were read from Geo. A. Orman of Dartmouth and A. S. Arthur and G. H. Saunders of Halifax for the position of Town Assessor.

The Mayor stated that he had been informed by Mr. R. H. Murray that the law had been changed at the last meeting of the Legislature, so that the law now respecting Assessors provides that a board consisting of a Chief Assessor and three other Assessors.

On motion of Councillor Lynch, seconded by Councillor Otto, resolved that Geo. A. Sterns, Charles Bell and Geo. Orman be appointed Assessors for the ensuing year at a salary of \$200.00 each, to perform all duties laid down by statue, and that Harris S. Congdon be appointed Chief Assessor for the ensuing year at a salary of \$800.00, to perform all duties as laid down by statue.

NATAL DAY:

On Motion resolved that the Chief of Police be authorized to engage nine Special Police for the Natal Day Celebration.

AGREEMENT ELECTRIC LIGHT:

Draft of Agreement between Dartmouth Electric Co. Ltd. and the Town of Dartmouth read and on motion the same was referred to the Town Solicitor and if found O. K. by him, then to be signed by the Mayor and the Town Clerk on behalf of the Town.

ALEX. HUTT.

Read letter from Alex. Hutt stating that he desired to purchase a piece of land from the Town at the rear of his property. On motion his letter was referred to the Public Property's Committee for report.

WATER RATES:

The following resolution moved by Councillor McLean and seconded by Councillor Otto was read and unanimously adopted: The Water Committee submit draft estimate for the Water Year ending December 1st, 1921. They recommended in view of the increased amount required for the present year to increase the Domestic from 35 cents to 50 cents and the pipe rate from twenty cents to thirty cents. Rate for W. C's from two dollars to three dollars. After considerable discussion and in view of the various proposals made to increase other special rates, this report was referred back to the Committee for further consideration.

TEMDERS:

Resolved on motion of Councillor Carter that the Street Committee be authorized to ask for tenders for all supplies required for permanent side-walks.

A number of accounts signed by two councillors were passed for payment.

Tenders:

The Committee have asked for tenders for material necessary for the construction of concrete sidewalks and beg to recommend the following: The lowest tender in every case being accepted.

15¢ for returned bag.
Sand, 7¢ per bushel, bare.
Stone, \$2.60 per ton F.O.B.Dartmouth. Dart.Coal & Supply Co.
Lumber, \$117.75. Dartmouth Coal & Supply Co.

All the Tenders received are respectfully submitted to Council.

Light on Johnstone Avenue:

The Committee recommend that a light be installed on Johnstone Avenue. The location of a light in this locality is very necessary, as there is considerable traffic and the roadway is very dangerous. There are at present no lights installed on this road.

Alteration to Street line at Junction of Portland Street & Prince Albert Road:

Your committee recommend that certain alterations be made to the Street lines at the junction of Portland Street and Prince Albert Road. The Trustees of St. James Presbyterian Church have offered to deed to the Town about thirty-five feet of land, the town to do all the necessary work and pay for any addition-

al concrete sidewalk that may be necessary to complete this work. As this is a very dangerous corner for traffic and as the alteration will greatly lesson any chance of accident, as well as, improve the locality your committee recommend that the work be done. The total cost of this work will be approximately \$275.00.

Your Committee ask of Council authority to purchase 5200 gallons oil to finish street program. The cost of this oil will be approximately \$600.00.

Re. Letter of Alex. Hutt:

Mr. Hutt wrote the Council expressing the desire to purchase a piece of vacant land in the rear of his premises on Portland Street. The committee are of the opinion that this land is not needed for Civic purposes and might well be disposed of, except that portion through which the sewer passes. The question of establishing the value of this land is difficult, and we feel that the proper method of disposing of it is by public auction. The recommendation of the Committee is that the land be sold at public auction, either in block or in separate lots, at a date to be decided by Council, and that the engineer be instructed to prepare a plan of said property.

Re. Letter of Mrs. Lethbridge:

Mrs. Lethbridge is the owner of a house and land situate on Windmill Road; a large portion of this property is included within the area necessary for the widening of this road.

Mrs. Lethbridge wishes to construct two houses on the vacant land and asks the Town to define its proposed street lines.

The new street lines as laid down on the plan for the widening of Wi ndmill Road take in the major portion of all land owned by Lethbridge as well as the house now on the property, and the balance of land remaining after new line is established will not be sufficient for the erection of these two houses. There are two solutions to this question.

1st. To survey the property, define new street lines and expropriate that portion of the land necessary, and thereby prevent the erection of any new structures,

leaving the question of purchase and disposal of balance of property until some future date.

2nd. To expropriate all of the property, move the house to a new location and sell it. Your committee request an extension of time in this matter in order that they may get fruther data before submitting final report.

The minutes of meetings held Aug. 1st and 16th were read and confirmed.

Petition read from a number of rate payers residing on or near the Esson Road, that the Council order that the said road be laid off as a street. If this were done it would be a great convenience for general traffic, as well as the petitioners, and profitable to the town through property developments which would follow. Ordered to be acknowledged and Street Committee were requested to take the matter up with the County authorities, the road referred to being a portion of the southern boundary of the town.

The Water Committee reported,

Making the following recommendations;

- 1... That the acceptance of quotation from Dartmouth Coal & Supply Co., Ltd. for 570 feet of 48 in. dia. Amco Segmental Sewer, at 5.27 per lin. ft. Service connections @ 1.46 each, being the lowest tender. Tenders attached.
- 2... That the water and sewer to be extended up Lyle St. to connect the houses owned by the Benjamin's. The owner to pay the sum of Twenty Five Dollars each, per annum until such time as other users of water on this street reduce the cost to 6% interest on construction, or at the expiration of twenty years.
- 3...That the extension of water up Crichton Avenue, to Oakdale Crescent, along Oakdale Crescent, north to Columbus Avenue, along Columbus Avenue to Oakdale Crescent south, along Oakdale Crescent south. All property owners being willing to pay 6% on cost of construction, in the same manner as agreed for Cameron & Harvey Sts.
- 4...That on and after Oct. 1st, 1921, consumers requiring water at the Slip, apply for quantity required on Town to be supplied and pay in advance for same, any additional cost, such as labour, etc., to be collected afterwards.

 Your Committee recommend the request be granted, subject

 the Council.

Letters were read from the following:-

Rosedale Nurseries, Dartmouth, objecting to the charge made them for installing a water meter, and requesting that a more moderate charge be made for that work. Referred to Water Committee to report upon.

Mrs. Effic Silver, requesting that she be paid \$25.00 for damage to her clothing, caused by falling into a partly filled excavation on Mott St. Referred to Water Committee to report upon.

- P. A. & Stairs Benjamin, objecting to pay 6% interest on the cost of proposed Water and Sewer extension on Lyle St, and asking that the charge be reconsidered. They also complained that the roadway on Lyle St. was really unfit for travel, owing to numerous rocks, holes etc. Referred to Street Committee as to repairs required and the Water Committee as to charge for interest on cost of extension.
- W. N. Forbes, Plumbing Inspector, reporting that D. J. Hodgson on Hester St., had installed plumbing in his house. He did the work himself but he is not a plumber. This is contrary to the Bye Law relating to plumbing. Referred to the Water Committee to report upon.

Police and License Committee recommend that Bye Law No. 184 of the Town of Dartmouth, as approved by the Governor in Council on 22nd January 1907, should be repealed and the following be substituted for --

Bye-Law 184.

(a) Commutation tickets may be issued in books containing, at the option of the purchaser, fifty-two or one hundred and four tickets, and each ticket will be good for one passage between the hours of 6 a.m. and 11.15 p.m. on any day during the month printed on such ticket for the person purchasing the same from the Commission if detached and deposited or surrendered as hereinafter provided.

(b) Holders of commutation tickets are required to detach their tickets in the presence of the ticket taker and deposit in a receptacle provided therefor, or surrender to the ticket taker whichever may be required of them.

(c) No commutation ticket holder shall transfer to or permit the use by any other person, whether a commutation ticket holder or otherwise, of any of his or her tickets.

(d) No person other than a purchaser from the Ferry

Commission of a book of commutation tickets shall use any com-

(e) Every purchaser of a book of commutation tickets shall at the time of the purchase thereof sign his or her name on the cover of such book, and shall if requested by the ticket taker sign his or her name on any commutation ticket tendered,

for a passage on the ferry at the time of the tender thereof.

(f) Tickets or books of tickets presented to a ticket taker by any person other than one who purchased the same from the Commission may be confiscated by the Commission.

3..... Commutation tickets shall not be good for passage on the ferry between the hours of 11.20 p.m. and 6 a.m. and all persons shall between said hours pay the rate prescribed by the schedule of fares for the time being in force.

4.... Holders of commutation tickets for teams or vehicles shall not use or permit the use of such tickets for any business other than their own.

23....Drivers of teams for which commutation tickets are held in addition to depositing or surrendering a commutation ticket when entering the ferry shall deliver a script ticket issued at the rate prescribed by the schedule of fares in force for the time being.

The Water and Sewerage Committee reported:

Re Letter from Plumbing Inspector re. contravention of plumbing bye-laws by D. J. Hodgson, Hester Street.

We have had Mr. Hodgson before us and he explained to us that the work in question was done by himself in entire ignorance of the Law and he satisfied your Committee that he did not intentionally violate the regulations; we instructed him that he must either engage a plumber to take out a permit and have the work done according to law or else remove all work done by him; he has since engaged a plumber, who has completed the work satisfactorily.

Claim of Mrs. Silver, Fairbanks Street, for damage to clothing by falling in trench.

We recommend that Mrs. Silver be paid \$5.00 for damage to boots and that she also be paid the cost of having her dress cleaned.

Letter from Rosedale Nurseries re. cost of installing meter.

We recommend that the charge of above, i.e., \$50.00, be withdrawn and that the Rosedale Nurseries be charged 10% on the cost of the meter annually.

Tenders for 1 lead service pipe.

We recommend the purchase of two tons of 2 x 8 lb.

lead pipe from Messrs. Stairs Son & Morrow Ltd., Halifax;

tenders for the pipe are attached hereto and the acceptance of the lowest tender is the one recommended.

Application for sewer and water extension along Erskine Street, Eastward from McKay Street.

We recommend the above request be granted; the estimated cost is \$350.00, four properties will be served with water which will more than pay 6% on the cost of extending the main and the amount collectable for sewer frontage will pay the cost of laying the sewer.

Application from Alexander Smith, Windmill Road, to take water through meter lately used by the Halifax Water Boat Co.

We recommend this request be granted subject to a

We recommend this request be granted subject to a minimum annual charge of \$300.00 together with an amount equal to 10% on the cost of the meter; the water is to be used for watering boats and will be charged for at the rate of 20 cents per 1000 imperial gallons.

Supply of water at Marine Slip.

A change in the method of supplying water at the Marine Slip is recommended and we suggest the following form be authorized by Council together with the amended charges as shown:-

The above change will be the means of eliminating any bad debts as no water will be supplied until the charges have been paid.

Cost of service pipe to outside consumers and installation of meters.

Your Committee ask that the Council will make a definite rule in connection with the above as some doubt and misunderstanding now exists in connection therewith.

We recommend that the cost of laying and providing the service pipe from the main to the street line should be

borne by the Applicant.

With regard to meters we recommend that in all cases the cost of installing the meter should be borne by the Water Dept. and the consumer be charged an amount equal to 10% on the cost of the meter annually.

The report was read and upon discussion of Clause 6, Cr. Lynch moved, seconded by Cr. Otto, an amendment that the minimum annual charge for water supply to Water Boats be \$300.00 per year, with the rate of 20¢ per 1000 Imp. Gals. The report as amended was adopted.

The Street Committee to whom several matters were recently referred, report progress.

Letters were read from the following:-

Consumers Cordage Co., Ltd., stating that the installation of a water meter at their works was unnecessary as they had an ample supply of water of their own and did not require the Town water and asked that their building be disconnected from the Town Service.

On motion of Cr. Lynch, seconded by Cr. Otto, resolved that the water be turned off, and the key be returned to them.

Dartmouth School Board, asking that the Town Council take action, by calling a public meeting of the rate-payers and holding a plebiscite to vote an additional sum of \$15,000.00, to build an equip the proposed addition to Hawthorne School.

Thereupon motion it was resolved that a meeting of the ratepayers be held on October 21, 1921, and a plebiscite be held on October 22, 1921, with the object of obtaining the consent of the rate-payers for the issue of Town Debentures to the extent of an additional \$15,000.00 to build and equip a new school; this to be done provided a satisfactory assurance can be obtained from the Local Government that the necessary legislation would be passed.

Thomas Lahey, offering Five to Ten Thousand tons Blue Stone at 75¢ per ton, delivered at Breaker. Referred to Street Committee for more information.

Harris H. Dares, Elderbank, stating that he had several houses on Elmwood Avenue, Dartmouth, built several years ago, which were occupied by tenants who were greatly in arrears with their rents, all were now out of work. He asked what action the Council would take towards paying the rents of these people.

The Clerk was instructed to inform Mr. Dares, the Council

regret they were unable to undertake the collection of rents for him.

Bye-Law relative to Chimney Sweeps.

BE IT THEREFORE ENACTED AND ORDAINED by the Town Council

of the Town of Dartmouth, as follows:-

The fee payable for a license to do business as a Chimney Sweep shall be:-

(a) For a resident of Dartmouth,(b) " " non-resident " " \$3.00

\$5.00

- The rates for chimney sweeping shall be those stated in the schedule of this ordinance.
- Every licensed chimney sweep shall sweep any chimney when requested to do so.
- 4. No person shall employ any person, except a servant in the house or building, other than a licensed chimney sweep to sweep any chimney.
- If any chimney, flue or stovepipe takes fire, the occupant of the building in which such fire occurs, shall be liable to a penalty, unless it appears that the chimney or flue has been properly swept within Twelve Months before the fire, or in the case of a stovepipe that proper care has been taken to prevent fire and that it was an unavoidable accident. In the case of the occupant being a weekly or monthly tenant, the owner of the building shall be liable to the penalty. If any such fire occurs within Twelve Months after the chimney or flue was swept by a licensed sweep, such sweep shall be liable to a penalty unless it appears that the fire was not occasioned by insufficient sweeping.
- Every licensed sweep shall keep a book and enter the names of the persons whose chimneys he sweeps, the street and number of the building, and the date of sweeping.
- No boy shall be employed to enter any chimney for the purpose of sweeping the same. Every chimney shall be swept only by machines constructed for that purpose.
- 8. Proper precautions shall in every case be taken to prevent injury to the premises from soot, and the sweep shall remove all soot from any premises in which he has been employed.
- Every licensed sweep shall have an office or place of business with a sign indicative of the business.
- 10. Every apprentice or boy employed by a licensed sweep, shall when at work, wear in some conspicuous place a badge inscribed

with the name of the person employing him.

Every person who contravenes or fails to comply with any provisions of this ordinance, or does, or suffers anything in respect to which a penalty is imposed, shall for each such offence be liable to a penalty not exceeding five dollars, and in default of payment to imprisonment for a period not exceeding one week.

SCHEDULE.

We respectfully ask Council to authorize your Committee to expend between now and the end of the year a sum not exceeding \$7000.00.

In connection with this we would like to point out that an expenditure of approx. \$4000.00 has already been made on the widening of Windmill Road, by cutting down the rock on Synott's Hill, without any provision in the estimates; also an extensive programme of oiling has been carried out, although there was no provision in the estimates.

We propose, with the Council's approval, to continue the removal of rock on Synott's Hill in order that very necessary and long delayed repairs may be made on this portion of Windmill Road; temporary repairs are strongly condemned as a waste of money on account of the impracticability of doing anything permanent and efficient.

The proposal is to widen the roadway to 75 ft., and in lieu of a sidewalk on the Eastern side, the rock will be cut to a slope from new street line to the new gutter, which it is proposed to make amply large enough to drain the hill in such a way as to prevent flooding of properties on the Western side of street.

Tenders have been called for the removal of this rock in question and we recommend for acceptance that submitted by the McNab Construction Co. @ \$2.65 per c. yd., being the lowest figure the tenders are attached hereto.

Authority is also requested to expend a sum of \$250.00 for a further treatment of Tarvia on Water Street.

Cemetery. Your Committee have commenced the laying out of the new portion of the cemetery at the corner of Victoria Road and Stairs Street; the Engineer has prepared a suggested lay-out which we recommend for approval.

We suggest a charge of \$20.00 for each lot, \$5.00 for single graves and the usual charge of 50 cents for burial permit.

Referred to the Water Committee for report.

Alexander Smith, stating that he would be willing to pay for the Water, to be supplied him through meter, at the rate of \$300 per year, payable quarterly.

On motion, it was further resolved that this decision, re payment for Water quarterly, would apply to all proprietors of Water Boats, obtaining Water from the Town.

Chief of Police, A. Liddell, thanking the Council, on behalf of himself and Mrs. Liddell, for the present made them by the Council and Officers, on the occasion of their wedding.

B. L. Turple, asking permission to instal a Gasoline Pump on Ochterloney Street, on Wm. V. Whebby's property, opposite Greenvale School

On motion, permission was granted him, the work to be done under supervision of the Town Engineer. The pump to be removed whenever so notified by the Council.

The Town Council met this date at 8.00 P.M.

Present: - Mayor Vidito, Crs. McLean, Smith, Lynch, Otto and Hyde.

The minutes of the last meeting were read and confirmed.

The Street and Public Property Committee reported as follows: Recommend the acceptance of Tender submitted by Wm. P. Beazley for sundry material for installation of new and repairs to existing Street Lights.

That the Engineer be authorized to install additional Street

lights where required in various localities.

Re letter from N. S. Board of Fire Underwriters, re inspection of electric installations, we beg to report that we are taking this matter up with the Board to obtain more information and hope to report to the next meeting of the Council.

Adopted.

The Water and Sewerage Committee reported as follows:

1. In order to remedy the flooding of cellars by sewer backing up, as complained of in a letter from ratepayers, resident on Stairs Street, we recommend that the existing 12" Sewer from Wentworth St. to Edward Street be taken up and an 18" sewer be laid at an estimated cost of \$3250.00. This length of sewer is of a muchflatter grade than the portion from Victoria Road to Wentworth St; the latter being 18" in dia; connecting into the 12" flatter grade causes the flooding. The new sewer would be a little deeper and would carry off all that comes through from Victoria Road.

2. Re. request from Mrs. Fraser to extend Sewer on Upper Water Street, we have been unable to interview Mrs. Fraser but will report at the

next meeting.
3. Re. Water supply, Consumers Cordage Co. as the cutting off of the above will materially affect insurance we would now recommend that the valve controlling the supply be kept shut and sealed, and that a penalty of \$500.00 be imposed for using water for any other purpose than Fire Fighting and that the Town Solicitor be instructed to prepare the necessary agreement.

4. Re claim of John Myers for damage to car, we beg to report that we

will interview claimant before making any recommendation.

5. Tender for sewer pipe-we have to report that through a clerical error the tender of Messrs. Brookfield Co.for sewer pipe was reported and accepted as the lowest; when that of Eagar Coombs Ltd. was the lowest, we therefore recommend the acceptance of the latter and the previous acceptance be rescinded.

Adopted.

The Police Committee reported, recommending consideration of the following report from Chief of Police Liddell.

He called attention to the importance of taking urgent steps to prevent traffic accidents at the following places:

Corner of Pleasant Street and Prince Albert Road.

Corner of Ochterloney St. and Victoria Road. Corner of Portland Street and Victoria Road.

Several accidents had taken place at these corners and he considered them a danger in their present condition. He suggested that the N. E. corner of Pleasant Street and Prince Albert Road be taken over by the Town and Pleasant Street, widened, or that Pleasant Street be made a one-way Street for vehicular traffic, from Prince Albert Road to Erskine Street, and notice be put up to that effect, or as a temporary preventive measure, that notices be put up on Prince Albert Road, 50 yards North and South of its junction at Pleasant Street, warning traffic to go slow on account of this dangerous corner.

That Victoria Road, from Portland to Ochterloney Street be made a one-way street for vehicular traffic.

That the following streets be made parking streets for

vehicles:

Prince Street......East side. between Ochterloney and Queen Street.

That notice boards be stuck up at all entrances to the Town, showing rate of speed allowed in the Town.

On motion his suggestions: That signs and parking limits for autos was agreed to. Also that the signs respecting speed limits be put up. Action on the other clauses in his report was deferred.

Letters were read from the following: -

Dertmouth School Board; requesting the Council to issue and call Tenders for Town of Dartmouth Debentures to the amount of \$30,000.00 as voted by the ratepayers, for the purpose of erecting and equipping a new school in the Town of Dartmouth.

W. G. DeBay; stating that his property had been badly damaged by overflow of Street Water, during rains and Winter snow-storms; he said further that he would hold the Town responsible for any further damage from same cause.
Referred to Street Committee to report upon.

Managers, Branch Banks in Dartmouth. Read letters from the Royal Bank, Bank of Nova Scotia and Canadian Bank of Commerce; in reference to the business taxes due by them. After some discussion the same were referred to the Town Solicitor for report.

Town Clerk; reporting the results of the Plebiscite held on July 23rd; this was ordered filed.

Frederick Fisher and Quinton P. Lantz, residents Cunard St., Dartmouth, stating they were returned men and unable to pay Taxes, owing to ill health; that while receiving pensions it was barely enough to pay their living expenses.

Referred to W. H. Darnell, Sec'y. Employment Bureau for inquiry

and report.

Mrs. Edith B. Baker, Sec'y. V. C. Nurses, stating that the amount of the Grant paid by the Town, with other receipts, was quite insufficient to pay their expenses; that the work had increased during the past year and that it was very necessary to appoint a third Nurse, to cope with the work. They therefore asked that the Council increase the Grant during the coming year.
Referred to the Incoming Council for consideration.

W. E. Sievert; stating that on Sept. 22, 1909, he had purchased at Public Auction, a lot of land on Green Street, owned by the Town and that he had not been able, for various reasons, to secure a Deed

of the property, and that he had applied for the same.
Referred to Town Solicitor and Engineer for report and that Joseph Findlay, owner of the property adjoining the Town land on Green Street be asked to send in a description of his land, fronting on that Street, or to bring in his Deed for inspection.

Bye Laws, re Electric Lighting and use of Electric Energy in the Town of Dartmouth, were submitted on motion received and ordered to lie on the table for Fourteen Days.

John Johnston and Barle Woodworth, owners of Town lots fronting on Windmill Road, complaining of excessive charges for Water service connections made to their dwelling.

Referred to Water Committee for report.

Resolved that all bills signed by Two Councillors at this meeting be paid. In future all Bills to be paid on the 15th of each month, and that lists of same be placed before the Council.

The Council then adjourned and met immediately after as the,

BOARD OF HEALTH.

Letter read from Miss Mary D. Patterson, Supt. Health Center No. 2, calling attention to the condition of dwellings 8, 10, 12 and 14 Geary Street, which were entirely without Water and Sewer connections. Two of the dwellings, in her opinion were very unsanitary. (George VanBuskirk owner).

We recommend the payment of bill submitted by John Myers for damage to his auto due to the accident on Pleasant Street.

On motion the report was adopted and the amount of his claim \$54.00 directed to be paid, upon a receipt in full drafted by the Town Solicitor, being signed by him.

Re Issue of Town Debentures \$46,000. The following resolution was unanimously adopted.

Resolution of the Town Council of the Town of Dartmouth to borrow under chapter 93 of the Acts of 1921, Sixteen Thousand Dollars (\$16,000), for permanent sidewalks, curbs and gutters and Thirty Thousand Dollars (\$30,000) for a school site and erecting and equipping a school building on said site.

Whereas by Section 1 of Chapter 93 of the Acts of 1921

it is enacted as follows:

- 1. The Town of Dartmouth is hereby authorized and enpowered to borrow, on the credit of the Town, by the issue of debentures the following sums of money or any or either of them:-
 - (a) A sum of money not exceeding Sixteen Thousand dollars for the purpose of constructing permanent sidewalks, curbs and gutters, or any of them.
 - (b) A sum of money not exceeding Thirty Thousand Dollars for the purpose of purchasing in said Town a school site and of erecting and equipping a school building on said site.
 - (c) A sum of money not exceeding Fifty Thousand dollars to be used for water and sewer extension within the Town.
 - (d) Asum of money not exceeding Twenty-five Thousand dollars for the purpose of laying down permanent pavements on the streets of the Town.
 - (e) A sum of money not exceeding Fourteen Thousand dollars for the purpose of installing a fire alarm system in the Town.

And Whereas by Section 5 of said Chapter 93 it is enacted as follows:

5. Before any money is borrowed under the authority of Section 1 of this Act the Town Council shall submit the question of the proposed borrowing to a Town meeting of ratepayers to be called by advertisement for ten days previous thereto, to be discussed at such meeting and to

be voted upon by the ratepayers assessed on real estate and shall obtain the approval of a majority of such ratepayers voting thereon, and the provisions of Sections 191, 192 and 194 of Chapter 56 of the Acts of 1902 shall mutatis mutandis apply.

And Whereas on the 30th day of June A. D., 1921, the Town Council of the Town of Dartmouth passed the following resolution:

Resolved that notice be given that a Public meeting of the ratepayers of the Town of Dartmouth will be held on Friday July 22nd, 1921, at the Assembly Hall, Greenvale School, Dartmouth, for the purpose of considering the issuing of debentures of the Town for the following purposes:-

Further resolved that a plebiscite of the ratepayers assessed on Real Estate be held at the Town Hall in Dartmouth on Saturday, July 23rd, in reference to the above borrowings.

And Whereas notice was duly given in accordance with section 5 of said Chapter 93 and section 193 of Chapter 56 of the Acts of 1902, of the said time and place of said meeting and of said voting.

And Whereas said meeting was duly held and said vote duly taken at the time and place so fixed and under and in accordance with the provisions of said Section 5 of the said Chapter 93 and of Sections 191, 192 and 194 of Chapter 56 of the Acts of 1902,

And Whereas the said notice set out the questions to be voted upon that is to say:

- 1. Are you in favor of the issue of Town of Dartmouth Debentures to the amount of \$16,000 for the purpose of constructing permanent sidewalks, curbs and gutters?
- 2. Are you in favor of the issue of Town of Dartmouth Debentures to the amount of \$30,000 for the purpose of purchasing in said Town a school site of erecting and equipping a school building on said site?
- 3. Are you in favor of the issue of Town of Dartmouth Debentures to the amount of \$25,000 for the purpose of laying down permanent pavements on the streets of the Town?
- 4. Are you in favor of the issue of Town of Dartmouth Debentures to the amount of \$14,000 for the purpose of installing a fire alarm system in the Town?

And Whereas immediately upon such vote having been taken the Town Clerk transmitted to the Mayor, a statement of the number of voters who voted on the questions the number who voted in favor of borrowing such moneys, the number of those opposed to borrowing such moneys and the number of spoiled or rejected ballots, if any, which statement is as follows:-

I beg to report that a vote of the ratepayers of the Town of Dartmouth, on July 23rd, 1921, a Poll was taken on the following questions:-

No. 1. Are you in favor of the issue of Town of Dartmouth Debentures to the amount of \$16,000 for the purpose of constructing PERMANENT SIDE-WALKS, CURBS and GUTTERS?

No. 3. Are you in favor of the issue of Town of Dartmouth Debentures to the amount of \$25,000 for the purpose of laying down PERMANENT PAVEMENTS on the streets of the Town?

Number who voted in favor....114.

Number of spoiled ballots.... 20.

And Whereas the said statement truly sets forth the results of the said vote,

BE IT THEREFORE RESOLVED that the Town of Dartmouth do accordingly borrow on the credit of the Town by the issue of Debentures the sum of Sixteen Thousand Dollars for the purpose of constructing permanent sidewalks curbs and gutters and the sum of Thirty Thousand Dollars for the purpose of purchasing in said Town a school site and of erecting and equipping a school building on said site;

That for the purpose of borrowing or raising the said sum of Sixteen Thousand Dollars, Sixteen Debentures of the said Town for One Thousand Dollars each be made issued and sold under and in accordance with said Chapter 93 of the Acts of 1921 and The Municipal Debentures Act 1914 as amended, Debentures to that amount being deemed necessary to raise said sum; that Six of said Debentures be payable in five years from the date thereof and be numbered 1 to 6 both inclusive; that Ten of said Debentures be payable in twenty years from the date thereof, and be numbered 7 to 16 both inclusive;

That for the purpose of borrowing or raising the said sum of Thirty Thousand Dollars, Thirty Debentures of the said Town for One Thousand Dollars each be made, issued and sold under and in accordance with said Chapter 93 of the Acts of 1921 and The Municipal Debentures Act 1914 as amended, Debentures to that amount being deemed necessary to raise said sum, and that the said Debentures be numbered 17 to 46 both inclusive;

That all the Debentures aforesaid be dated the 1st day of November A. D. 1921, be payable at the office of the Town Treasurer in Dartmouth and bear interest at the rate of six per centum per annum payable half-yearly at the said office; that the Mayor of the said Town do sign and the Clerk thereof do countersign the said Debentures, that they do seal the same with the corporate seal of the said Town, and that the said Clerk do sign the interest coupons or if the same are lithographed either sign the same or have them impressed with a facsimile signature of his.

Letter read from F. F. Mathers, Commr. Municipal Sinking Funds, enclosing copy of a Model Form of borrowing Act; he re-commended to be used in future where practicable.

On motion same was received and the Clerk was instructed to acknowledge receipt thereof.

On motion the Clerk was instructed to advertise that tenders would be received, by three insertions in the Halifax Herald and Morning Chronicle and circularize bond dealers and banks in Halifax, including some bond dealers in Montreal and Toronto.

The matter of improving the Electric Lighting system in the business district of the Town for several weeks proceeding Christmas, was brought up by Cr. Carter and after some discussion, it was agreed that if the merchants would pay the expense of instaling same, the Town would pay for the current consumed.

After some discussion the proposal was referred to the Street Committee with Town Engineer, with power to deal with the matter.

List of accounts as submitted by the Town Clerk being read were ordered to be paid, provided that same were signed by two Councillors.

Meeting adjourned and met immediately after as:

BOARD OF HEALTH

Reports were read from Sanitary Inspector Liddell, re complaints made by Officials of Mass-Halifax Health Commission, re dwellings No. 8, 10, 12 and 14 Geary Street; Cellar in the Findlay house, 275 Ochterloney Street, and Merlebank, Water St.

Case 1-Dwellings, Geary Street: he reported the sanitary conveniences very primitive. Yards and outhouses were well kept. There was no water or sewer connections to these dwellings, but water was supplied from an ordinary out-door tap on the premises.

Case 2-Cellar, Findlay House: It appeared that water had been leaking into the cellar caused by rain water collecting on the surface and filtering through the earth into the cellar. It did not appear to be caused by unsanitary conditions.

Case 3-Merlebank, Water St: He found paper and tin cans scattered about cellar in this house, but nothing unsanitary.

Minutes of meetings held, February 10th, 15th and 24th, read and approved.

Mrs. Roome and Robert Stanford of the Community Welfare Bureau, were present and given a hearing. They asked that a decision be made at this meeting to give work to the unemployed, promptly, as the need was great. The Mayor promised this delegation, that this matter would be taken up at this meeting.

Another Delegation, consisting of Jas. Burchill and H.O'C. Baker, representing the V.O.N. was also given a hearing. They suggested that the Council increase the present grant of \$500 to \$1,000 from the Town and School Board. On motion of Councillor Pettipas, this matter was referred to the Finance Committee for report.

Re qualifications of Ferry Commissioners: - after general discussion of this subject, on motion of Councillor Smith, the Town Solicitor was instructed to look into the qualifications of Mr. A.C. Johnston, as a Ferry Commissioner and report thereon.

Town Solicitor reported re Motor Sales Co's., letters recommending that Mr. Gillis or some other member of the firm take out license, thereby becoming responsible for the vehicle. His opinion was accepted and Mr. Gillis to be informed thereon.

Letters were received from the following:-

Dartmouth Welfare Association: - Stating that the following resolution had been unanimously passed by them at a meeting held on the 2nd inst..

on the 2nd inst.,

RESOLVED: - That in view of the distress and want prevailing in many families due to lack of employment, the General Board of the Community Welfare Association respectfully request the Town Council to take immediate steps toward resuming work on the Old Ferry Road sewer and begin any other work contemplated during the spring and summer months.

J.Mcl Daley: - (Solicitor for Henry Lethbridge) asking whether it was the intention of the Town to purchase the property of Mr. Lethbridge for the purpose of Widening Windmill Road. Mr. Lethbridge was about to make extensive alterations to his house, and desired to know not later than March 10th, 1922. Referred to Town Solicitor for report.

Canadian Bank of Commerce: Enclosing sworn statement of business done at their bank, stating they would pay Town taxes for 1921, viz., \$133.50.

Bank of Nova Scotia: - Enclosing their check for Bank taxes and by them for \$175.70.

W.F.Charlton, Pleasant Street, complaining of the poor drainage of his dwelling owing to the defect in the sewer from his house to the main sewer on Pleasant Street. Referred to the Town Engineer and Water Committee to report on at next meeting.

Sanitary Inspector Liddell: - calling attention to the unsanitary condition of the houses owned by Geo. E. VanBuskirk, on Geary Street and Mrs. Hattie Renner, Ochterloney Street., caused by overflowing of privies and cess-pools on

their property.

On motion of the Board, it was resolved that they be notified to connect with the main sewer before the first of May next otherwise they would be prosecuted and further, that the Inspector be notified to "Follow Up" these cases.

Railroad Association of Canada, C.P.Riadell, General Secretary:-Asking whether the Town of Dartmouth was likely to adopt "Daylight Saving" for this summer and suggesting that the most convenient time would be from the Sunday nearest the First of May to the Sunday near est the first of October. On motion it was decided to adopt same from May 1st to Labor Day. This period was accepted by the City of Halifax.

Peoples Coal Company: - Asking for the appointment of Jack Bateman and Chas. A. Collins as weighers, also one from:

Dartmouth Coal and Supply Co:- asking the appointment of W.J. Meredith, John Short, and C.S. Edwards as weighers. On motion their request was agreed to and the appointments made.

F.G.Crimp: - re damage to his cellar caused by the overflow of st storm water on March 5th. Referred to the Water Committee for report.

A.A.Smith: Offering to supply any new Motor Trucks wanted by the Town this year. Referred to Water Committee.

Walter Creighton: - Asking for the issue of a Town Bond of \$1000 to enable the Housing Commission to put in a claim for an additional loan, Timothy Graham's house for \$983. On motion it was resolved that his request be granted and that the Mayor be authorized to issue the additional bond for \$1000 for deposit with the Local Government as securety for the loan.

Walter Creighton: - Stating that Mr. Geo. Mitchell had not attended any meetings of the Housing Commission for about a year and asking the Co uncil to appoint a new member to the Commission to fill his place. The Clerk was instructed to write Mr. Mitchell and ask if he wanted to remain on the Board.

Parker Archibald: - Municipal Clerk: Stating that a joint meeting of the Arbitration Committee for the City of Halifax,
Town of Dartmouth and County of Halifax, would be held on Tuesday
March 7th, at 4 p.m. at the County Court House, and requesting that
representatives from Dartmouth be present, On motion the Mayor,
Town Solicitor and members of the Finance Committee were appointed as such Committee.

Dertmouth Board of Trade: - Enclosing copy of Resolution passed by that Board on the 23 ult., as under: - RESOLVED: - That the Board of Trade feel that, in the interests of the public safety of our Citizens, in passing on and off the Ferry Boats in Dartmouth, over the Railway Track, passing in front of the Ferry Cates, that the Government, be asked to take such steps as may be necessary to insure the safety of our people at this dangerous crossing.

The Town Council then passed a resolution similar to the above and the Clerk was instructed to send copies of the same to, Hon. A. McLean, Dr. Blackaddar, M.P. and Hon. Wm. C. Kennedy, Minister of Railroads and Canals.

W.E.Sievert: - Stating he preferred to have a Warranty Deed from the Town of Dartmouth for the two lots recently purchased by him.

Referred to the Mayor and Town Solicitor.

W.K. Gray: Secretary of the Unemployment Association, requesting that the Town Council recognize them and that their representatives would call daily at Impercyal and other large employers to learn their requirements as to laborers, required, from day to day. On motion their request was granted.

Petition: From Chas. L. George, and some ten other owners of property on Joffre Street, Eastmount, requesting that that Street be opened up, as shown on the plan drawn up by Mr. Peckings, C.E. of Halifax, filed with the Registrar of Deeds, in Halifax. Referred to the Street Committee for report in four weeks.

DeWitt vs. Town of Dartmouth: The Mayor and Town Solicitor, special committee appointed to investigate account rendered by Mr. W.H.Covert for services rendered in connection with this suit reported as follows:-

The action was brought against the Town for alleged negligence of the Town in the construction of its Streets. The action was in the Supreme Court for large damages and was brought by McInness, Jenks, & Co., on behalf of the plaintiff.

Mr. Foster, the town solicitor transferred the papers to Mr.

Covert as was done in several other instances with the implied ratification from the Town, but nothing to this effect was entered in the Town minutes.

The case and litigation were such that we believe the Town would have authorized Mr. Foster to employ Mr. Covert on behalf of the Town and as Mr. Covert has agreed to reduce his account to \$80.00 we would recommend that the Town ratify the action of Mr. Foster and pay this sum to Mr. Covert.

Letter read from Town Engineer Barnes: - stating that his annual report is unnecessarily delayed owing to the fact that he has been unable to keep his books up to date. An extract from this letter is as follows:-

I must point out that there is a vast amount of clerical work in a Town Engineer's Office where efficiency and records are to be maintained, and I would respectfully ask that the question of supplying clerical help be not long delayed. As soon as practicable a full report will be complied and available for public distribution, in the meantime I can only offer apologies for its non inclusion in the Town's Annual Report.

Letter received and action deferred.

Town Engineer reported: -Re out-fall sewer, Old Ferry Road, Estimated cost 30" Dia.
"Anco" Seg. sewer) from Portland Street to Pleasant Street on Old Ferry Road, estimated present day cost \$ 11,000.00 estimated cost in summer \$8,000 estimated sewer frontage to be received, 1440 ft., © \$2.50 ...\$3,6000.00. Report received.

Town Engineer :- Re Windmill Road Improvement and Widening report as follows:-Shortness of notice and condition of the site generally have not allowed of carefully going into the cost of widening a nd grading that portion of Windmill Road necessary before sewerage can be given to Brookside Avenue.

It will be quite a problem to obtain the necessary amount of fill within the immediate vicinity of the work, so that it may be more desirable to consider the erection of a bridge in lieu of filling.

At this early stage all I can suggest is that Logislation be sought for the borrowning of say \$10,000.00 to be spent in such amounts, localities and times as the Council shall hereafter determine under the express heading of Windmill Road Improvement.

At the earliest opportunity I will submit alternative proposals

with estimates.

On motion of Councillor Pettipas seconded by Councillor Young it was resolved that this Council approve of the extension of water and sewer in Brookside Avenue and that the amount required to raise Windmill Road at a point where the sewer will pass, be borrowed and the cost be taken out of a loan of \$10000.00 to be borrowed on a vote of the rate-payers in connection with the widening of Windmill Road.

In view of the great quantity of snow on the streets of the Town the Mayor asked that the Town By-Laws re snow shovelling be carried out. Referred to the Street Committee to deal with.

Re Ferry Commission :- The Mayor stated he was strongly in favor of abolishing the present Commission form of conducting the Ferry It was very unfair, and that Legislation should be obtained to change it and provide that the Mayor and three Councillors shall form Ferry Commission. Councillor Pettipas supported the Mayor. Consideration deferred until next meeting.

Councillor Smith moved and seconded by Councillor Pettipas that the Water and Sewer Committee be authorized to call for tenders through Engineer Barnes for Water and Sewer Pipe and all stock in connection with the work on Brookside Avenue. Passed.

Accounts submitted signed by two councillors were ordered to be paid.

Present: - Mayor Mosher, Councillors, Smith, MoLean, Lynch, Young, Otto, and Pettipas. Also the Town Solicitor.

Draft Legislation read providing for the borrowing, of \$15,000 for completing the Hawthorne School. Also legislation to include in the estimates for 1922, and assess and collect, the sum of \$750.00 to be paid to the committee in charge of the One Hundredth Anniversary of the Dartmouth Engine Company, \$500.00 to be paid the V.O.N. in addition to sums now payable, to authorize the Ferry Commission to pay the sum of \$200.00 to committee in charge of the One Hundredth Anniversary of the Dartmouth Engine Company, providing that no discriminating rates shall be adopted against persons not being inhabitants of the Town of Dartmouth, also further providing that School Children residents of the Town of Dartmouth actually attending a higher grade in any school in the City of Halifax or in the County Academy than provided in the public Schools of Dartmouth.

Police Committee reported: - That under Section 9 of the Hackney By-Laws the following rules shall govern the operation of Motor Busses for carrying passengers in the Town of Dartmouth:-

- 1. The starting place shall be on Water Street, at Stern's Corner, and in front of the Bank of Nova Scotia.
- 2. The maximum time allowed at the starting place shall be ten minutes.
- 3. The route shall be from the starting place to Portland Street south along Water Street and returning by Portland Street, north along Water Street to starting point.
- 4. The service shall be as nearly as possible, every half hour.

The report was adopted. The Committee further recommended that a clause be adopted to specify routes on which the omnibuses should travel and rates of fares. The decision in this matter was deferred.

Read letter from the G.W. V.A. requesting that the Council pay the expenses of the erection of a Tablet, presented by the I.O.D.E. as a memorial to those who fell and those who served in the Great War, from the Town. It was proposed that the Tablet be erected and placed on a granite slab with a concrete base in the grounds in front of the Post Office building in Dartmouth. After some discussion the sum of \$200.00 was granted to meet the expense of ereoting the tablet referred to. This matter was referred to the Streets Committee to have the work done at once.

A discussion took place in reference to the change in the constitution of the Ferry Commission. Councillor Pettipas moved and Bouncillor Smith seconded, the following resolution, which was adopted.

RESOLVED: - that legislation be obtained at the present session of the Legislature amending all legislation covering appointments to Dartmouth Ferry Commission so that in future the commission be composed of four members of the Town Council besides the Mayor, in addition to two citizens appointed annually from the Town by the Town Council, said appointees to be rates on the Towns assessment roll to an amount of not less than, \$1,000, this legislation to become effective August 1st., 1922.

Carried four to two.

Letters read from the following.

Town Solicitor: - reporting that Mr. Sievert was not entitled to a warranty deed as the Town did not undertake to give warranty deeds.

Some discussion took place in reference to this and the Council then finally decided to suthorise the Town Solicitor to prepare a warrenty deed for Mr. Sievert.

W.H.Dean :- Asking to be appointed as Employment Agent for the Town, and another letter from: -

The Unemployed Workmen's Association: - recommending Mr. Dean for the position. These letters were filed.

J. W. Willis: - objecting to pay for the 60 ft. beyond the end of the new sewer fronting his property on Erskine Street, Referred to the Water Committee for report.

On motion it was resolved that the sum of \$50000 be borrowed for the extension of Water and Sewer main and that a public meeting of the Rate Payers be held at Greenvale School on the 15th April next, and that the Town Clerk be authorized to give due notice in the usual way.

There is legislation for the issue of Town Debentures for the sum of \$5,000 referred to as per Nova Scotia Acts for 1921. Chap. 93. Sec. 1 Sub-sec. (c).

It was moved by Councillor Lynch and seconded by Councillor Otto, that Mr. Henry Lethbridge be notified that the council did not wish to buy his property at the present time. Adopted.

It was further resolved that the resolution passed at the meeting of March 6th, proposing the borrowing of \$5,000.00, additional, for the Widening Windmill Road, be and is hereby cancelled.

A.C. Johnston, Ferry Commissioner :- Town Solicitor reported re Mr. A.C. Johnston's qualification as a Ferry Commissioner:-"I investigated the qualification of Mr. A.C. Johnston to entitle him to act as a Commissioner on the Dartmouth Ferry Commission, I am unable to do so as the information lies within the knowledge of Mr. Johnston and I have no power to summon him, or make an intelintelligent report unless he volunteers information regarding

his qualifications."

"As I already pointed out the only effective method of procedure to question such qualification is by Quo Warranto proceedings in the Supreme Court., and this is the position assumed by Mr. Johnston who states he is qualified to hold the office."

Meeting adjourned.

The Police and License Committee recommend that no decrease be made in the present License fees for Taxis for the present year, and the Clerk write the Taxi Drivers to that effect. This was passed 4 - 1. Councillor Pettipas voting against.

Synott's Hill trough has to be moved back on the new

street line and the trough on Pl asent Street was knocked over last fall and has not been since in commission.

- 2. D.A.A. It is recommended that sewer and water services be supplied to the new Bleacher being erected on the D.A.A.A.grounds and that a charge of \$15.00 per annum, be fixed for the use of water.
- 3. General: The several matters referred to us at the last meeting of the Council are being dealt with and will be reported on at the meeting of the Council to be held June 5th.
- 4. S. & W. Extensions. We are going carefully into the programme of sewer and water extensions so as to defer as late as possible such that might be well to undertake in the late fall and winter for the purpose of un-employment relief. The above report was taken up clause by clause and passed.

RESOLUTION re the borrowing of \$25,000 on debebtures. was deferred.

It was moved and seconded that the Town of Dartmouth by its Town Council apply to the Governor in Council, for its consent to borrow on the credit of the town the sum of Five Thousand Dollars, (\$5,000) for the purpose of Widening Windmill Road, pursuant to the provisions of Sections 2 and 5 of the Act relating to the Town of Dartmouth passed at the last session of the Legislature of the Province of Nova Scotia.

Passed.

Town Solicitor Murray, reported on several matters referred to him as under:-

1. RE THEFT R.K. ELLICT'S Goods: - "Assuming there was negligence in the storing and care of the goods of Mr. R.K. Elliott which were recovered by the police in the search of premises in Dartmouth. I am, nevertheless, of opinion that the Town is in no way legally liable to Mr. Elliott for such loss.

After reviewing a great many authorities on the subject of the liability of a Town I think that the law may be briefly stated as follows:- "If the duties to be performed by the officers are of a public nature and have no peculiar local characteristics, then they are really a branch of public administration for the nurposes of general utility and security which affect the whole kindom and.....it does not seem unreasonable that the corporation who appointed the officer should not be responsible for acts of negligence of mis-fessance on his part".

Under the circumstances of the case I have to advise

against the paymentoof the claim.

RE POLL TAX: The Mayor requested an opinion regarding Chapter 50 of the Acts of 1918, Section 13, which refers to an amendment to "The Public Highways Act." Section 12 (1) reads:-

"In every municipality within the Province there is hereby imposed and there shall be levied and collected in each calendar year hereafter, beginning the year 1918 -- upon each male person within the municipality of morethan twenty-one and not less than sixty years, who is not assessed, a poil tax of \$3.00 etc."

A "Municipality" is defined in "The Public Highways Act" as "The county of district under the jurisdiction of a Municipal Council." Section 3 of the same Act provides that the Act shall apply "to all highways within the Province not included within the boundaries of a city of incorporated town." Clearly, therefore, Chapter 50 of the Acts of 1918, Section 13, does not apply to the Town of Dartmouth.

RE APPCINTMENT OF ASSESSORS. After looking into the different statutes relating to the appointment of assessors for the Town I think that on the present state of the legislation, which is somewhat mixed, the best course to pursue is as heretofore, viz., the appointment of a Chief Assessor and three other Assessors, making in all four.

4. RE CANADIAN INVESTORS CHEQUE: - This was accepted.

Mr. Murray, Town Solicitor, explained that his absence from last meeting was caused through not receiving the customery notice of the meeting.
