Minutes of last meeting read and approved.

WATER COMMITTEE REPORTED: - ( See report pages 471 and 472) After considerable discussion it was moved by Councillors Otto and McLean, that the whole matter be investigated by the Council in Committee and reported back at the regular meeting of the Council. The report of the Water Committee, ( clause 1) as previously placed before the Council at last regular meeting was unanimously adopted, on motion of Councillors Smith and McLean, and the increase in rates confirmed.

FINANCE COMMITTEE ; Report read clause by clause . Clause one was adopted, clauses two, three, and four read and received. Clause five was referred back to the Finance Committee to take whatever action they saw fit for the collection of the outstanding amount of \$25.00. (See report page 474)

RE BUS LICENSES applied for by

L.M.Bell, John A. Gillis, Jr., Burton Turple.

were granted on motion of Councillors Otto and Young, subject to the signing of an agreement between the Town and the applicants.

The following resolution was also unanimously passed on motion of Councillors McLean and Walker. "RESOLVED that the Town Council cooperate with the Dartmouth Board of Trade in protesting against the charges made by the Public Utilities Board and Local Government for Buses running from Dartmouth to Imperoval.

Councillors Otto and Young moved that the Mayor and Town Clerk be autorized to sign the agreement between the Town of Dartmouth and Tax Collector Russell Brooks, for the current year. Re Police Vacations, it was decided to leave this matter in the hands of the Police Committee as in previous years.

Councillor Young asked that steps be taken to put Queen Street in proper condition. Repairs to this street was badly needed. The Engineer was instructed to attend to this matter along with other streets that had been previously complained of.

1. Re Water Supply, he recommended that authority be given him to give the water mains a thorough inspection and cleaning. On motion this clause was adopted and the Chairman of Streets and Water Committeds authorized to buy a suitable pump required by the Town Engineer.

2. Re Victoria Park: - The cost of proposed fountain for the centre of this park will be in **be** in the vicinity of \$250.00, but as that part of the Park is low some grading or fill will have to be provided which will run the cost up higher than otherwise.

On motion this report was adopted.

TOWN ENGINEER'S REPORT, read,

Letter received from J.L. Allen applying for the position of SECRETARY TO THE HOUSING COMMISSION, made vacant by the sudden death of Walter Creighton. On motion this appointment was deferred, until applications had been called, such applications to be received up to the 28th June. The Clerk was instructed to insert an add in the Dartmouth "Patriot", calling for applications.

The Finance Committee was authorized to obtain a suitable die with Town Coat of Arms for office stationery.

Clerk was instructed to notify plumbing Inspector Forbes to make a systematic Plumbing Inspection and report on the different water fixtures and condition thereof of all houses barns, etc., in the Town.

Gentlemen: -

Your committee on finance beg to report that at a recent meeting, consideration was given to a number of matters.

1. Tenders were received for the printing of forms used in the office, as follows:-

Independent print, \$16.00; Dartmouth Patriot, \$16.25.

The tender of the Independent print, being the lowest, is recommended.

2. A conference was held with the manager of the bank which with the Town does its business with regard to a lower rate of interest on overdrafts or a higher rate of interest on credit balances. The conference was a very satisfactory one. Your committee is not prepared at this time to make a recommendation but hopes to be in a position to do so at the next meeting.

3. The claim of the Workmen's Compensation Board vovering amount due on assessment for 1922 nad 1923 has been dealt with as directed by Council at the last meeting. Since then a cheque for \$1,108.79 has been forwarded to the Compensation Board, leaving a balance of \$240.00 due on September 1st, this year. The amount of assessment for 1923 has been reduced \$24,000 on two items, representing a tax of \$150.00.

Your Committee would receammend that the engineer write the Compensation Board giving the duties of the electrician, it being felt that the rate of \$3.50 now charged is not a fair one inasmuch as the town is not now operating its own plant and that the council authorize the engineer to request an adjustment of the rate.

Your Committee is pleased to state that every courtsey was extended to the Town by the official in connection with a revision of the original estimate covering expenditures during the year.

4. In view of the importance of increasing the revenue at this time from unpaid taxes due on 1923 assessment, your committee recommends that a discount of one per cent be allowed on all taxes paid from the 19th day of June up to and including the 1st day of August. Information in possession of the committee emphasizes the importance of this step being taken.

x 5. Consideration was given to an outstanding account amounting to \$30,00 - 5.00 ..\$25.00 arising out of a loan authorized by a previous member of a council for 1921, but never approved, so far as can be determined, bu the council at that time. The circumstances of this loan is such as to see that it is refunded into the eivie traasury even should it be found necessary to ask that the ex-councillor make it good. There appear to be no authority enabling any councillor to loan money out of the civie traasury and the question arises as to whether it does not come in the class of "misdirected administration". If the matter were a lowed to go unnoticed it is just possible that in later years the officials might be held responsible as is so frequently done. One member of the finance formittee who was a member of the council at that time has no recollection of the loan ever having b en authorized. The fact that the amount involved is comparatively small does not alger the principle, for that rason your committee recommends that the solicitor be authorized to take whatever action is necessary to fecover the amount infavor of the requests. Minutes of last meeting read and approved.

Annual report read from the V.O.N., re visiting schools This was received and placed on file.

Report read from Chairman of FINANCE COMMITTEE § see pages inserted). After considerable discussion this report was adopted. Councillors Pettipas Walker, and Young voting "for" and Councillor McLean "against". Town Solicitor was instructed to draft letter to be sent to other Municipalities.

Report read from Water Committee, as follows:-"With reference to the supply of water to the Canadian National Railways the following report is submitted and recommendations made in that connection and all metered consumers. The agreement between the Town and the C.N.R. with regard to the supply of water expired in April and they asked for a renewal of the Agreement; the Council expressed willingness to have the agreement renewed conditional on the rate per 1,000 gallons being increased from log to 20g, it being felt that the Railway Department should not pay any less rate than other consumers. Since the last meeting of Council Messrs Appleton and Simpson (representing the C.N.R.) have had an interview with your chairman, the Deputy Town Clerk and myself when they pointed out that in no case in the Dominion are they pay ng more than log per 1,000 gallong. When water is sold by the meter some consideration should be given to the amount sold, or in other words a consumer taking 10,000,000 gallons should be rated less per 1,000 than one taking only 10,000 gallons. I am therefore submitting a new schedule of meter rates which I would recommend for adoption and to date from January lst, this year. These rates could be inclusded in the matter to be placed Before the Public Utilities Commission at the forthcoming hearing. The schedule of meter rates referred to above is as follows:-

MRS. SARAH CREIGHTON, expressing thanks for sympathy extended to her in the sudden death of her husband, Walter Creighton, late secretary-treasurer to the Housing Commission. Moved this be received and placed on file.

MR. CAUGHLAN, Edward Street claiming damages for oil that splased on his sister-in-laws clothing from the Town Oil sprinkler. Referred to Street Committee for report.

Re Issue of Water Debentures (\$6,000). (See resolution attached). Councillors Pettipas and Smith moved these Deb. run twenty years and rate of interest to be 5%. Councillors Smith and Walker, moved the Clerk be instructed to call for tenders for these bonds in the usual way. Carried.

Letter received from Marks-Cross Arena Co. Ltd. asking that water connections be made at once as they were all ready to start. It was moved this be left to Water Committee to deal with at once. Carried.

Present: - Mayor Mosher, Councillors, Smith, Young, Otto, Pettipas also Town Solicitor Murray.

Town Solicitor Murray submitted opinion of T.R.Robertson, Barrister of Halifax, as under:-

"I have carefully considered the questions regarding certain appointments by the Town Council of Dartmouth, which y u have submitted to me. The Superintendent of Water Works has been appointed by virtue of Chapter 56, Acts 1902, Section 51, which enacts that the Superintendent of Streets for the Town of Dartmouth shall as at present be Superintendent of Water Works, and the present and all future incumbents of such office shall hold office during good behaviour. The Town's Incorporation fact provides that in the event of the Council reducing the salary of an official holding office during good behaviour, such official shall have the right of appeal to a Judge of the Supreme Court. I am of the opinion that the Town Council has power to reduce the salary of the Superintendent of Water Works, but such reduction is subject to reconsideration before a Judge, if the officer appeals. I am of opinion that the Town Engineer, in view of the wording of Acts 1920, Chapter 106, Section 24, holds office for the year, but I am of opinion that his salary may be reduced by the Town's Incorporation Act, Section 127. I am further of opinion that the resolution rescinding the appointment of certain Town officials is not valid insofar as both these officials are concerned, and that the proper procedure is to reduce their salaries to such an amount as the Council deems fit, leaving the Superintendent of Water Works to his remedy of appeal, and the Town Engineer to his remedy of resignation, if he so desires. "Signed T.R.Robertson.

On motion this was received and adopted.

After some discussion the following motion moved by Councillor Otto and seconded by Councillors Smith and Young was adopted:-

"Whereas in the opinion of this Council it is vital to the interests of the Town to economize in its expenditures and amongst other methods of accomplishing this object it is imperatively necessary that the pay of officials of the Town should be reduced. THEREFORE RESOLVED that commending the 1st day of August 1923, the present rate of pay of the hereinafter named officials be reduced and that they be paid after the said 1st day of August at the rate per year without recognizing any term of office, at the rate per year set opposite their respective names.

H.E.R.Barnes, Town Engineer......\$2200.00 E. Nichols, Supt. of Water Works.. 1500.00 Further Resolved that the resolution of the Council passed on the 21st day of May 1923, be rescinded as far as it affects the above mentioned officials in the reduction of their pay. "

On motion of Councillors Smith and Young the following resolution was adopted:- RESOLVED that the water be extended to the Dartmouth Skating Rink and be connected to the Park School if agreeable to the School Board, the mimimum charge to be \$25.00 per year including meter rental.

The rate for booths at Lake Banook for Natal Day was fixed at \$5.00 for a single lot and \$10.00 for a double one. N.

On motion of Councillors Pettipas and Young the following resolution was passed:-

WHEREAS the upkeep of roads and streets in the different towns throughtout the Province of Nova Scotia is very burdensome and a heavy drain upon the resources of the respective town; and Whereas the Provincial Government not only levies upon the towns a tax in respect of highways, which has to be paid by the said towns, but also prevents the said towns from levying any license or fee upon the motorists who reside in the said towns, and who are greatly responsible for the deterioration of the streets and roads in the said towns, the fees for operating the motors being paid exclusively into the Treasury of the Provincial Government; Be it resolved that it is the opinion of the Town Council of Dartmouth that the exclusive method of levy adopted by the Provincial Government, whereby the fees in respect to motors are payable to the Provincial Treasury, without return being made to the towns, is unfair, inequitable and unjust, and that it is further of the opinion that tat least half of the fees so collected by the **Provincial** Government should be remitted to the cities and towns for the upkeep of their streets and roads, each town to be paid one half of the fees paid into the Provincial Government by motor owners residing in the said towns wherein their motors are operated.

FURTHER RESOLVED that a copy of this resolution be forwarded to the Union of Municipalities for the Province of Nova Scotia and to the cities and towns throughout the Province with a view to securing united action of the part of the Towns of the Province of Nova Scotia to request the Provincial Government to amend the present legislation so that at least half of the fees collected as aforesaid shall be remitted to said cities and towns, "

Moved that Town Engineer be instructed to put down a bridge at or near the corner of Maple and Thistle Streets, much needed at that place.

Councillors McLean and Young moved that the Dartmouth citizens band be engaged for Natal Day. Some discussion took place and the general opinion was that if the Citizens band is engaged for that day then the proposed grant be with-held.

Number of accounts duly signed by two councillors passed for payment.

Meeting then adjourned.

With your permission I beg to report on the position of the Town financially, particularly with respect to current expenditures and the ability **to phovide** for same.

This report is prompted by the action taken by me, on information received from the Bank, directing that no cheques be issued other than for salaries. The action taken was immediately communicated by letter to the mayor as follows:

Dartmouth, July 5th/23

His Worship the Mayor Town of Partmouth

Dear Sir:-

As chairman of the finance committee I feel it is my duty to acquaint you with the position of the town financially and also of the action taken in an endeavor to improve the situation.

In conversation with the manager of the Royal Bank, I find that the town is overdrawn to a larger extent than the Act allows, or will be if further cheques are authorized for payment, unless more taxes are received. In view of this fact, and after a long conference last evening with the town clerk, I instructed him not to issue cheques payable to the order of the town other than for salaries. I would respectfully request that you confirm my action until meeting of council on Tuesday evening. If you feel, however, in your judgment that this is not the proper course to pursue, the order given by me, of course, is automatically remained, but in that event I would ask to be relieved of further responsibility as chairman of the finance department. Trusting for your dovi co-operation and advice in this matter,

This letter was delivered to the mayor on the morning of the 6th. Letters were also sent to the town clerk and the bank manager notifying them of the action taken. The letter to the Town clerk reads as follows:

Dear Sir:-

(1) (1)

Accept this as your authority for refusing to sign any cheques payable to the order of the town, except those covering salaries, unless otherwise authorized by His Worship the Mayor. This order becomes effective from this date and under no circumstances is it to be disregarded without permission as stabed, or by the undersigned.

In conversation with the mayor the following evening (July 6th) he stated that the action taken was quite satisfactory to him and that he would confirm it. This is how matters stand at the present time and I feel should be left that way until there is an improvement.

In case it may be enquired why the necessity for adopting such a rather severe course, I might explain that it was imperative to do under solto prevent a more embarassing situation developing. Under our power to borrow one and one half per cent of our total valuation on real and personal property, bank statement shows that the maximum amount has been loaned. Were payment of accounts chargeable out of general revenue continued, the statuatory authority would be exceeded. This would impose upon the Bank the unpleasant duty of refusing to honor cheques payable to the order of the town. This is what has happened in other places. It is not desirable that it should occur in Dartmouth. The town council is the proper body, it appears to me, which should decide a matter of policy of this nature, not the Bank, but failing to do so, the Bank would be compelled to do so in their cwn interest and as a guarantee of protection. The situation is not as serious as the difficulty is as hard to meet in finding ways and means to finance for general purposes. The town's position financially is absolutely dound by reason of its assets. The seat of the whole trouble is non-payment of taxes. It cannot be overlooked, however, that the tax rate in the past was not high enough to provide for obligations. Had the tax rate been fixed on the basis of providing for even known expenditures, the situation today would not be such a difficult one to handle. The taxpayers were deluded in this respect. The rate of \$2.95 per \$100 assessment for 1923 is without question much lower than legitimate obligations require and cannot continue much longer without developing serious financial complications. It is surprising the large increase represented in what is known as fixed charges, these including tax impositions  $f \neq p$  by the government and the regular municipal charges such as maintenance of paupere, feeble minded and treatment of the sick.

The estimated cost of administering the affairs of Dartmouth for 1923 was fixed at \$229,863, less \$24,057x revenue totalling \$84,957, leaving a balance of \$145,806 to be assessed for on the basis of a valuation of \$4,926,100. It was on this basis that a tax rate of \$2.95 was reached and it was estimated that \$145,806 would be realized.

In The item of "revenue" included \$63,000 outstanding taxes (for 1922, while the overdraft at the end of that year amounted to

have

\$79,737; in other words the current year might be said to/commenced with an adverse balance of \$142,737 as that was the amount required to be collected. The difference, of course is that the item of \$63,000 is known as an asset and the item of \$79,737 as a liability. The item of \$63,000 **XEXANXENSEXXEXTRACTOR** unfortunately is only available in part for use during the current year as it is never possible to collect all of it until the Lien Lew becomes effective two years thence. By including it in as revenue and applying it to reduce The estimated expenditure for the current year is, in my opinion, a mistake and this raises the important question, and a controversial one, as to whether the entire system should not be changed under which estimated expenditures for the year are made. Each year, I believe, should be made to take care of its obligations by fixing a tax rate which would produce the revenue required. It is very doubtful if the Town's Incorporation Act gives the Council the right to prepare estimates in the way in which they have been prepared for the past number of years. The matter is one which should be carefully and thoroughly gone into by future councils, with the solicitor, to determine whether statuatory authority is not now being violated.

Fayment of taxes this year has been much better than expected and had it not been for the large overdraft at the end of 1922, the shortage of ready funds for general purposes, would not now be felt. From the lat day of January this year up to and including the 30th day of June, *H97.616* Has been received in taxes, this including) \$62,049 on 1923 assessment; \$118.13 on this year's poll taxes; \$14,427 on 1922 assessment; \$156 on 1922 poll taxes; \$8,623 on 1921 assessment; \$4745 on 1920 assessment and a few other smaller amounts.

Cut of the total amount received in, however, provision had to be M account made for the large overdraft, an appropriation of \$20,000) had to be made for maintenance of the public schools and the cost of running the Ľ, general service of the town had to be provided for. From these figures it can readily be seen that sufficient revenue, satisfactory though it appears unnsidering present circumstances, has not been received to enable the town to adequately finance for all purposes. There still start # 000 sphroninsately remains to be collected) \$5,000 on the 1923 assessment and the on the 1922 assessment, a total of 122,000, but unfortunately the larger portion of this will not be available for another year; in the meantime the town is compelled to make arrangements for an overdraft at the Bank to manage its affairs. And this amount does not represent all as there one are several thousands of dollars represented in uncollected poll taxes for the past three years and also an arount on the 1921 assessment which will not be paid until the Lien Law becomes effective.

Under such conditions it is quite unreasonable to expect that the council can continue to carry out without meeting with certain temporary financial difficulties. The present tie-up, if it will emphasize then taxepayers the importance of meeting their obligation to the civic treasury will have accomplished a great deal. The situation might be expected to improve by the payment of taxes by the larger to the penalty of seven per cent interest charges on and after September 30th.

In order that the situation may be kept well in hand and that unnecessary embarassments may be avoided I would recommend that accounts for general puposes be withheld for payment until there are funds out of general revenue to meet them. This would mean that the present order in force not to **jague** cheques other than for sallaries stand and that no such accounts be paid, even when funds are available, without the consent of the mayor and the chairman of the finance committee.

With a view of effecting an improvement in future years I would make the following recommendations:

That this Council pase a resolution petitioning the provincial Government to contribute to each city and incorporated Town in Nova Scotia one half of the revenue received from automobile fees registered from #hat each particular city or town, and that a copy of this resolution be in brwarded to each city or incorporated town and also to the convention of the Nova Scotia Municipalities at Amherst in August, asking for endorsation of same.

That the fees now charged by the Workmen's Compensation Board be materially reduced, and that this recommendation be treated in a similar way to the one mentioned above.

That a material reduction be made in the provincial high way which is now one tenth of one per cent of the total assessment.

The merit of the first recommendation can hardly be questioned. The cost of maintaining streets, due to the increased automobile traffic, without any direct or indirect returns to compensate of the town for the damage inflicted, is greater than the taxepayers are in a position to bear under existing conditions.

That water rates be fixed concurrently with the general tax rate instead, as is now the case, six months after the year has advanced. If this is done it will help materially to improve the town's position financially. A.C.Pettipas, C. Ville

"Your Street Committee having met on the 24th ultimo, beg to submit the following report:-

t. Letter from Mr. N.W.Noonan: - Mr. Noonan appeared before us and explained in person the complaints contained in his letter -that is that he thought he should not be charged for half cost of curb and gutter, the law being changed after the Petition had been accepted by the Council; also that he thought price too high and further that the side-walk is now too low; We h ve considered this case and are of the opinion that the cost is excessive and in view of the fact that the law was changed after the property owners had petitioned for the side-walk we would recommend that the cost of the curb and gutter be borne wholly by the Town.

of the curb and gutter be borne whodly by the Town. 2. Letter from Mr. W.J.Coughlan: - As we felt this matter was somewhat out of our jurisdiction the question of the claim for damaged clothing has been referred to Mr. R.H.Murray, Town Solicitor, for an opinion as to the Town's liability.

3. Esson Road Widening: - We have had before us a plan prepared by the Town Engineer showing proposed division into building lots of the surplus land purchased last year for the widening of Esson Road -we recommend that this plan be approved by the Council and that the lots be sold at a mimimum price of Four Hundred Dollars per lot. The cost of land puchased amounts to \$1485.00, a small piece is being obtain at no cost other than some grading-- if the four lots can be sold for \$1600.00 the improvement will work our very light in cost, especially when considering the large area taken in by the new widened street.

4. Str et Lighting: - In order to complète putting the Street Lighting scheme on a systematic basis the Town Engineer is asking for authority to purchase alumimum numerals for the purpose of numbering each street light on the pole and so keep a card index of each fixture -- this is recommended for approval, 576 numerals will be required at a cost of \$36.00.

Tenders for coal: we would recommend that tenders be aksed for the supply of coal for the Public Buildings-- Bitimunous coal for the Town Hall, Police and Fire Stations and Anthracite for the Police and Fire Stations.

## REGULATIONS AND LIMITATIONS

#### RELATIVE TO THE MARKS CROSS ARENA,

## LIMITED.

WHEREAS it is enacted by Section 7 of Chapter 73 of the Acts of the Legislature of the Province of Nova Scotia for the year 1923 as follows:-

"On and after the passing of this Act the title to all that portion of the Dartmouth Park bounded and described as follows; Beginning at the Junction of the Western side line of School Street with the North Eastern side line of Myse Road; thence North Westerly along the North Easterly side line of Wyse Road for a distance of five hundred feet; thence North Easterly and at right angles, to the North Easterly side line of Wyse Road for a distance of three hundred feet; thence South Easterly and parallel with the North Easterly side line of Wyse Road until it strikes the Western side line of School Street; thence southerly along such Western side line of School Street to the place of beginning shall be wested in the Town of Dertmouth place of beginning, shall be vested in the Town of Dartmouth, and may be granted and conveyed to the person or persons, organization or corporation, for the purpose of the grantee erecting thereon a skating rink, and which land and buildings shall be exempt from taxation for the period of ten years while the said rink is continuously in operation. The said conveyance shall also be subject to such regulations and limitations in the use of the said land and buildings as may be approved and pa passed by the Town Council and wich shall be contained in a resolution of the Town Council, and which regulations and limitations shall be embodied in a conveyance from the Town to the said gra tee. Without limiting the regulations and limit-ations as aforesaid one of the regulations shall be that the water supplied to the said building shall be paid for by the said grantee at a fixed rate or otherwise as may be mutually agreed between the said Town and the said grantee and failing such agreement the said rates shall be fixed and collected in the usual manner by the Town".

THEREFORE, RESOLVED, that by virtue of said section the said land hereinbefore described shall be granted and conveyed by the Town of Dartmouth, hereinafter referred to as "the Town", to the Marks, Cross, Arena Limited, a body corporate, hereinafter referred to as " the grantee ", for the purpose of erecting thereon a skating rink, hereinafter referred to as "the buildings", in accordance with the provisions of said Section 7.

BE IT FURTHER RESOLVED that by virtue of said Section 7 the following shall be the regulations and limitations, and shall be embodied in the conveyance from the Town to the grantee;- 1. The Water supply to the buildings shall be paid for by the grantee at a fixed rate or otherwise as may be musually agreed to between the town and the grantee, and failing such agreement the said rates shall be fixed and collected in the usual manner by the Town.

-2-

2. The buildings shall be used continuously from year to year during the skating season for the purpose of a skating rink.
3. The land and the buildings may be used at other seasons for such other purposes as the grantee may desire, subject, however, to the Fown having the right and privilege of preventing the use of the said land and any buildings thereon for any purposes which it considers not to be in the interests of the citizens of Dartmouth.

4. The buildings shall always be kept in a good state of repair, and in a sanitary and clean condition, and if the grantee fails in the fulfillment of these regulations, the town may repair and keep the siad buildings in a sanitary and clean condition, and the costs thereof shall be borne by the said grantee and form a lien thereon, the amount of which lien may be collected in the same manner by the town as in the case of default in the payment of taxes.

5. No other buildings than a rink shall be erected on the said land without the grantee first securing the approval of the Town Council.

6. Proper and sufficient exits and fire protection shall be maintained in the buildings.

7. The said lands or any buildings erected thereon shall not at any time be used for the purpose of any trade, or manufacture, or business of any description other than for entertainment purposes nor shall anything be done which may become an ampyance or a nuisance to the town or the neighborhood.

8. The town shall have the right and privilege of nominating and appointing an official of the Town who shall have the right and privilege of visiting and inspecting the said land and buildings at all reasonable times.

485

9. In the event of the grantee failing to use the land and operate the buildings for the purpose contemplated by said Section 7, the Town shall have the privilege of purchasing the said land and buildings thereon at a price to be determined by arbitration one arbitrator to be appointed by the town, a second by the grantee, and a third by the two arbitrators already appointed. Should the grantee fail to appoint an arbitrator, application shall be made to a Judge of the Supreme Court, who shall appoint such arbitrator. In view of the land having been granted by the town to the grantee without money consideration, the arbitrators in determining the value therof, shall confine their findings on the value of the said land to the extend only of the improvements made thereon by the grantee and the said findings shall be considered as the whole value of said land. The findings of said arbitrators as to the value of said land and buildings, less all encumbrances, shall be final, and the Town may purchase the said land and buildings at the value awarded if approved by the ratepayers after the question has been submitted to them under the provisions of Sections 190-194 inclusive, of Chapter 156, of the Acts of Nova Scotia 1902. The Deed of Conveyance may be executed by the grantee of by the said arbitrators, which shall thereupon vest the title to the said land and buildings in fee simple in the town.

10. The conveyance and the regulations and limitations shall be binding on the parties hereto, their successors and assignes. 11. The conveyance to the Marks-Cross Arena Limited shall be executed on behalf of the Town by the Mayor of the Town and the Town Clerk, and by the Marks Cross Arena Limited by the properly authorized officers thereof.

"At a recent meeting of the Finance Committee consideration was given to a number of matters.

A letter was read from Mr. Roy Power asking for a REFUND OF THE INTEREST paid on capital charges in connection with sewer rates on the grounds that he had not received a bill for sewer service until two years after the work was completed. Careful consideration was given to this matter and view of its importance and the possible loss to the Town of much money were the request granted, it was decided that no refund be made. The Committee was unanimous that no person be relieved of interest under any such circumstances where bills are not received. To do so would eventually have to be supported by direct taxation, This would mean that many would be required to contribute twice for the same expenditure.

for the same expenditure. REGARDING PROPERTIES TO BE SOLD under Lien Law it was decided not to interefere, but to leave the matter entirely in the hands of the Town Clerk whose duties are specified by law. As a matter of fact the committee has no right to interfere.

It is recommended that in future the Town Clerk sign all plans received from the engineer's department giving streets on which sewer are laid and in use showing the frontage each property owner is responsible for. This plan will serve as a check in determining who is responsible in future for delays in sending out accounts covering sewer frontage charges.

It was decided that October 10th be the last date for the payment of poll lax and that after the expiration of it the police be requisitioned to see that the tax is paid. T his means that a Town Clerk's warrant will be issued and payment can be demanded upon presentation by the police of the warrant, failing which arrest will follow.

On motion this report was adopted.

Deed of Marks-Cross Arena Company was submitted by the Town Solicitor and reported as correct by the committee. The Mayor and Town Engineer were appointed to inspect the building and obtain necessary information regarding the construction of the building.

1. SEWER THROUGH PROPERTY OF W.H.COVERT: Having interviewed Mr. Covert an arrangement is recommended for approval of the Council whereby Mr. Covert agrees to deed to the Town a strip of land some 500 feet long by 50 feet wide to be laid out as a street as shown on a plan prepared by the Town Engineer, compensation for such land to be made in the nature of an exchange for the sewer frontage account for the Old Ferry Road Sewer.

Sewer. \_ 2. LETTER FROM MR. N. D. DAUPHINEE RE WATER SUPPLY: - The question of intermittent water supply on Cameron Street was thoroughly discussed and your Committee recommend that the only way to remedy conditions during the coming winter will be to instruct the Town Engineer to prosecute all persons who deliberately leave water running to prevent freezing or for other causes and that the attached notice be published in the local Press.

3.SEWER - HARE LANE TO WATER STREET: - In 1920 a sewer was leid in Hare Lane and through private promerties to Upper Water Street without any written agreements; / we now recommend that agreements be drawn up with those owners through whose property the sewer is laid, to give the Town authority for such sewer.

The properties referred to are those of the Dartmouth Dev. Co., J. Forsyth and J.H.McElmon. In view of the pecular conditions we would recommend that the frontage charges of W.R.Jennett be fixed at sixfy feet and that H.H.McElmon's account be fixed at One Dollar in lieu of certain concessions granted to the town.

4. PLUMBING INSPECTOR FORBES' REPORT: - We have deferred any action in connection with the inspection recently completed by the Plumbing Inspector; the Town Clerk's Department are now comparing the water accounts with the latest list of fixtures in order to bill those water consumers who may have been omitted. A further report will be submitted in due course.

Councillors Otto and McLean moved the adoption of this report. Carried.

REPORT OF TOWN ENGINEER:- Re Esson Road Lots, as follows:-" I have interviewed Mr. H. Henry, who recently made an offer to purchase Lots 1 and 2, Esson Road Improvement, and he has offered the following proposed method of paying therefor. Purchase price, as before offered, to be \$500.00 an initial payment of \$50.00 will be made forthwith; thereafter at least \$10.00 per month will be paid in quarterly payments, it being understood that interest will be added to the unpeid principal.

Esson Rd. Lots continued:-When half the purchase price (250) has been made Mr. Henry is to be given a warranty deed of Lot. No. 1., and the deed of Lot. No. 2, to be given when the total of \$500.00 -- with interest added-- has been paid. This, it is believed, is similar to the way that the Town has disposed of Lots on Windmill Road. "

After some discussion the council decided the amount of interest to be charged would have to be at the rate of 7%. This was adopted and the Town Solicitor instructed to draw up an agreement with Mr. Henry to this effect.

LETTERS were received from the following:-" MISS SCOTT Secy. Orphans Home, Halifex, re board of ALBERT GRISWOLD. On motion of Councillors Walker and Smith it was moved this bill be paid. Carried.

"Authority is requested to make certain changes to the system on the Lake Road by removing the line from the right hand side of road to the new pole line on the left hand side of the road. This will give better lighting and will save the rental now being paid by using the Telephone Company's poles. The cost of this work is extimated at \$110.00 and the saving will be approximately \$20.00 per annum. Authority is also requested to connect the two traffic signs on Water Street with the Street Lighting System - this is extimated to cost \$175. and will save approximately \$3.50 per week trimming and

filling oil lamps. Referred to the Street Committee and Town Engineer for report.

Town Engineer further reported on the water used at the Sugar Refinery and the Towns agteement with the Company; etc., as follows:-

"I wish to draw attention to a resolution of the Council passed in June 1923 dealing with the supplying of water to the Acadia Sugar Refinery -I would suggest that, if the Town has no power under the existing agreement at least some good might result from a conference with the management of the Company.

My reason for bringing this matter to your notice is prompted by the fact that a serious shortage of water has again occured on Cameron Street, which I have traced to be brought about by the Acadia Company using Town Water.

Energetic measures are being, and will continue to be taken to stop waste and running of water relentlessly - but ap arently nothing can be done so far as the Acadia Company is concerned under the present agreement.

Referred to Town Solicitor Murray for report thereon.

LETTERS were received from the following: -

THOMAS NOTTING. stating that Town Engineer H.E.R.Barnes, had handed him a bill for collection amounting to \$100.00 for wages due. This was referred to the Town Solicitor for report. His Worship Mayor Mosher and Members of the Town Council, Dartmouth. N. S.

#### Unpaid Water Rates.

501.

The date set this year for the shutting off of water where the rates were unpaid was October 16th.; about that date there were 250 water accounts for the year 1923 unpaid.

This number included a large number of properties liable for pipe rate only, and in a few cases properties not connected with the water service; in such cases it is of course, impossible to hasten payment by shutting off the supply.

After revising the list to include only those properties that could be shut off the number of accounts was reduced to 149; as is usual a man was then sent round to warn the occupants that the water would be shut off without further notice, this naturally resulted in quite a number of accounts being settled and also in many cases owners paid sums on account, promising to pay the balance "soon", in such cases the water has been left on.

In some cases the properties were found vacant - the water was shut off but this does not bring payment.

Previous to getting after this year's accounts it was found that there was a substantial amount outstanding for 1922 the majority of which has now been paid, excepting such places where the water cannot be shut off or premises are vacant.

I am unable to say how much is now outstanding for 1922 and 1923, but it is quite a substantial sum, and should if possible, be collected before the end of the year.

It is claimed that if only those actually using water from the Town's System were liable for water rates the delinquents would be considerably reduced - and in all cases the turn-key could be used.

The foregoing is to acquaint Council of conditions as they exist and to ask that early consideration be given to any proposed whange in the Waterworks Department, particularly with regard to Finances.



(1) The Dartmouth Development Company offering a piece of land owned by them fronting on Portland Street and Gaston Road containing 20% acres for the price of \$8500.00, also an additional piece of land fronting on Gaston Road containing 3 acres. Both properties were offered for the price of \$9000.00.

(2) V. F. Farrell offering a piece of land fronting on Windmill Road at a price of \$4000.00.

(3) Robertson & Meagher, Attornies for A. T. O'Leary offering
20 acres of land fronting on the Bast side of Windmill Road, known as the "Cunard Property" for the price of \$3500.00.

Present: - Mayor Mosher, Councillors MacLean, Walker, Otto, Smith and Pettipas. Also Town Solicitor Murray. Minutes of last meeting read and approved. On motion the Order of Business was suspended and Mr. V. F. Farrell being present was given a hearing respecting the sewer rates accruing on the Farrell property fronting on Fairbanks and Water Streets. His letter was read objecting to the interest charge made him on sewer rates. On motion of Councillor Pettipas, seconded by Councillor Walker the following resolution was unanimously adopted:-

"RESOLVED that the disputed account of the Misses L. and E. Farrell covering sewer rates on property owned by them on Fairbanks, Best, Water and Mott Streets, Dartmouth, totalling \$712.31, be adjusted by a reduction of Fifty Dollars(\$50.00) without prejudice to the claim, providing the **account** is settled within ten (10) days from March 5th. 1924, and that Mr. V. F. Farrell, Agent, be notified accordingly."

Police Committee reported re a letter signed by Policemen, O'Connell, Clarke and Lawlor, was considered. They asked that they be given the same privilege that the Town pays for rent of telephones in the dwellings of the Chief and Deputy Chief. The Committee recommended that their request be not granted. The Finance Committee reported against the application of an increase in salary of Miss T. R. Mitchell. Consideration was given to the application of Mr. Clarence Hatton, Janitor, for an increase in pay from \$18.00 per week to \$21.00 per week. In view of daily special work performed by this official outside of that required of him as Janitor, the Committee recommended that he be paid a bonus of \$50.00 on December 22nd. 1924 and that said amount be placed in the estimates for the current year. It is to be distinctly understood that this bonus is not to be considered in the light of an increase in pay as the Committee is opposed to increasing salaries at this time, neither are they in sympathy with reducing the salary now paid to any official.

SALVATION ARMY - With regard to the request of the Salvation Army through their Commandant, Mr. P. Woolfrey, for the annual grant of \$100.00, the Committee regretfully find it necessary to recommend against. The Committee is desirous of keeping down expenses as far as possible and for that reason find it necessary to refuse all such requests for financial support.

CONMITTEE on WATER and SEWER reported that at a meeting held on February 22nd. inst., consideration was given to an application for the extension of the sewer on Portland Street. The Committee would recommend that, in view of present conditions and the undesirability of increasing the Town's capital debt, the request of the petitioners be not complied with.

The Committee would recommend that legislation be sought authorizing the borrowing of \$5,000 with the consent of the ratepayers to cover cost of house connections. It is understood, however, that if no applications for house connections are received no amount be borrowed.

The work of extending the old Ferry Road sewer as far as Rodney Road is practically completed; the connections are made, but some filling in still remains to be done.

LETTER read from Robert C. Pettipas, as follows:-

"As I am a ratepayer of the Town, I wish to draw your attention to the curb and gutter that was layed on Portland Street in 1922. I understand there was a protest sent in by one of the ratepayers of the Town, stating that the curb and gutter, he considered an over-charge. I also understand it was put before the Council and the Committee and that the Town wholly and solely agreed to bear the expenses of same. I am informed that the ratepayer I refer to, has been granted a new statement for the sidewalk only, as I am one that signed the same petition, also claim that the curb and gutter was an over-charge and all work done in front of my property was of a very poor nature, the work is entirely unsatisfactory."

After some discussion on motion it was resolved that the exemption for the curb and gutter on the north side of Portland Street from Prince Albert Road granted to M. Noonan, apply to all owners of properties between St. James Church and Pleasant Street, on the north side of Portland Street.

Councillor Pettipas called attention to t he large bills rendered property owners on Windmill Road (Synott's Hill) for the new curb and gutter laid down on that street in 1922. After some discussion

Referred to the Fire Committee for report. Letter read from the Nova Scotia Accident Prevention Association of Halifax enclosing a copy of the bulletin issued by the National Safety Council, on Resuscitation.

They claim that a knowledge of this method of reviving persons who are injured by coming in contact with electricity, has been the means of saving many lives. They sent a copy of the bulletin with the request that same be displayed in some **prominent** place where it can be read by employees. It was ordered that their request be complied with.

<u>RE - PETITION FROM THE SALVATION ARMY</u> - Commandant Woolfrey on motion was given a hearing. He spoke eloquently of their work in helping the poor in the Town and asked the Council to grant them \$100.00 this year as they had last year. The Einance Committee recommended that the grant of \$100.00 for this year be not made. On motion of Councillor Otto the action of the Finance Committee was sustained.

Town Council met this date at 7:30 P.M.

Present: - Mayor Mosher, Councillors MacLean, Otto, Walker, Smith, Young and Pettipas. Also Town Solicitor Murray.

Minutes of last meeting read and approved.

LETTER read from Colonel Montgomerie, President of the Nova Scotia Publicity Burean. After some discussion the matter was left in the hands of the Finance Committee to consider and report thereon. Engine Captain James DeVan of the Dartmouth Are and Badder Company and other members of the Company were present. Captain DeVan called attention to the case of Lester Corkum who is now seriously ill in Boston, Mass., U.S.A. They desired some assistance in the way of paying his passage back to Halifax. Councillors MacLean and Otto Were appointed a Committee to solicit contributions, for that object. Captain DeVan said that the Company desired that someone be sent to escort Mr. Corkum from Boston to his home here. This matter was left in the hands of Councillors Otto and Young

COUNCILLOR PETTIPAS as Chairman of the Finance Committee submitted his report on the finances of the Town together with the receipts and expenditures for the financial year 1923, and Estimates for year 1924. This report with some amendments was adopted.

REPORTS from Dr. Payzant called attention to Mr. L. B. Clark, a resident of Dartmouth, who was ill with tuberculosis. He recomended that Mr. Clark be sent to the Sanatorium at Kentville for treatment. Left in the hands of Councillor Pettipas to arrange details so that the man could be placed in said Hospital. Dominion Coal Company, employer of man referred to, agreed to contribute \$125.00 towards his expenses.

RE - LYNCH HOUSE, 63 WATER STREET; - Letter read from The Hastern Trust Company relative to this place and its unsanitary condition. The matter was left in the hands of Town Solicitor Murray to deal with, to see that the devision of the Council was carried out. On motion of Councillors Pettipas and Young the following resolution was passed.

"RESOLVED that the Town Solicitor, R.H. Murray, K.C., be authorized to take whatever action he deems necessary to see that a wholesome supply of fresh water is provided to the tenants occupying premises, 83 Water Street, Dartmouth." His Worship the Mayor and Members Town Council

Gentlemen:-

Your Committee on Finance, as directed by resolution of Council, has carefully considered the estimates presented by the Chairmen and members of the several departments covering services for the year 1924.

As Chairman of the Committee I wish to present my second annual report, with recommendations, on the work done.

The estimates for the year submitted called for an expenditure of \$251,520, less estimated revenue totalling \$81,523, leaving a net balance of \$ 169,997 to be raised by direct taxation. To do this would require a tax rate of \$3.47 on every \$100 assessment, an increase of fifty-two cents compared with the corresponding year. The assessable property in Dartmouth for the year, according to the returns of the assessors and finally approved of by the Court of Appeal, is valued at \$ 4,903,580, made up of \$3,909,750 on real estate and \$993,800 on personal property. There is a serious decrease in the value of assessable property compared with last year, the returns for which showed a valuation of \$ 4,926,100 made up of \$3,903,100 on real estate and \$ 1,023,000 on personal. From A comparison of these figures with those for 1924 shows a serious shrinkage in valuation of \$22,520. The valuation of real estate for 1924 shows an increase of \$6,680 compared with the previous year, but this is wiped out by a decrease in the valuation of personal property for 1924, compared with last year, amounting to \$ 29,200, making a net decrease, as stated above of \$22,520.

decrease in the value of assessable property creates an This undesirable situation for the council. It simply means that if the ordinary services are to be provided for and a similarx program xofx public improvement, similar to that of last year, which was limited, is to be carried out, the tax rate must be fixed at 3.47. The decrease in assessable property represents forty-five points in the rate and it is the first time since 1895, where the record is available, that the assessment has shown a decrease. In each year since the date mentioned, up to this year, there has been a steady increase in the assessment up until the present year. The loss, fortunately, is due entirely to personal property, indicating that there has been no change on the adverse side with respect to wholesome development as might be experienced where buildings, if destroyed by fire, had not been replaced. The assessmenr returns for the year, as stated, show a reasonable increase in real estate values.

The Finance Committee carefully considered the estimates as submitted, with a view of effecting substantial reductions wherenet ever possible, but found it was only reasonable to effect a/saving of \$1,800. It was found that an item of \$2,100 had to be included to cover the cost of improving the street lighting system as a safeguard against loss of life and damage to property. By a co-operative plan, suggested by the mayor, the improvements will only cost about one-half what was at first thought and the additional amount of \$2,100 added by the committee to the estimates will, with an item of \$400 originally included, cover the purchase price of new fixtures besides, as stated above, put the entire street lighting system beyond the scope of danger to our citizens.

Apart from the item of \$2,100 the estimates were only increased beyond those submitted by \$690.00 and of this amount \$500.00 is to take care of the expenses in connection with the holding of the convention of the Union of Nova Scotia Municipalities. This is an important gathering and it is the first time that Dartmouth has been extended the honor of having the convention within its confines. Municipal rulers from all parts of the Province will assemble here in August.

Decreases in the estimates totalled \$ 4,700.00, while the gross increases totalled \$2,900, leaving a net decrease of \$1,800.

AS the estimates are submitted covering each department in detail, under separate cover, only the totals and the largest items in each service, are reviewed in this report. The **555XX** estimated expenditure as revised by the Finance Committee, totals \$228,520 as against \$251,520.00 originally submitted, less estimated revenue \$\$1,523, leaving a net balance to be raised by direct taxation of \$ 146,997. This amount, of course, is subject to an item of \$30,000 clipped off the overdraft of \$91,009 as at December **3**lst, 1923. The financing of this \$30,000 item **is** explained in detailed further of in this report.

The estimated expenditure of the finance committee totalling \$39,197 comprises, among other items, **#2;87**% county court rates, (joint expenditures) \$2,076; interest overdraft bank, \$4,400; interest on bonds, \$5,962; portion of officials' salaries, \$9,356; Municipalities convention, \$500; sinking funds, \$2,125; provincial highway tax, Ac**5** 1917, 1/10 of 1 per cent of the assessment, \$4,903; health department, \$300.

The ordinary items make up the fire estimates totalling \$7,659, two the three largest are/drivers of motor engines, [2] \$2,800; fuel, \$1,000 and hose \$1,400 of which \$700 is already spent.

The estimates of the police and licenses provide for nothing additional compared with those of last year.

The streets and public property are already pruned too close to properly maintain the necessary service, the total for street work, separate from the wages for drivers, upkeep of horses, electric light service and improvements to the street lighting system, only total \$12,538 and include part salary of two officials at \$1,000. The balance of this estimates includes \$4,004 for wages of four drivers; \$1,350 feed for horses and two other items of \$250 each, the balance being made up of lighting service totalling \$ 7,367, and includes \$3,050 for lighting and \$2,500 for improvements to the system and purchase of xitures, in addition to several smaller items.

The original estimate of the charities committee totalled \$13,133. This has been reduced by \$500 on the item of maintenance of patients at the hospital, it being felt that a portion of the charges will be received as revenue.

In dealing with the tax rate it must be taken into consideration that what are rightly termed "fixed charges" or uncontrollable expenditures, total approximately \$100,000. This requires a tax rate of \$2.00 on every \$100 of the assessment. The amount is xawakix approximately made up as follows:

The above figures will enable the ratepayers to form some idea how the council spends the revenue received from them and further shows that with a tax rate of \$2.95 only 95 cents on every \$100 of the assessment is available for caring for the ordinary public services such as streets, fire, police, public health.

Practically all the revenue received from the ratepayers, including that received from various other sources, is spent before it is received. The fact is that for years the tax rate has been insufficient to provide for the needs of the town and this false economy is now being felt and will be for some years to come. A mistake was made some years when the total amount of outstanding taxes was included in as "revenue", instead, as had been the practice up to about four years ago of only including a percentage of it in as "revenue". Unfortunately the practice has to be continued as a protection against an exorbitant tax rate. Had this not been done the tax rate at that time would have had to be boosted to \$3.25 and have had to remain at that during the past few years, but would have had a wholesome effect today in a lower rate of taxation.

5

Another fact which has to be considered, and it mill no doubt surprise all the taxpayers-is the amount of exempted property. It now stands at #1/446/100 \$1,683,300, made up of \$1,496,100 on real estate and \$187,200 on personal property. This large amount includes, however, property owned by the town, such as schools, town buildings, fire buildings and Fark property and ferry, # (\$32,000 on personal) \$621,600 the assessed value of which is fixed at #010/000000 made up of \$509,400 on real estate and \$ 112,200 on personal, leaving a balance of \$1,061, 700 privately owned property. From the above figures it will be seen that **EXERPTIONEXER** ratepayers enjoy certain privileges which are not reflected in the tax rate and considering this should have little reason to complain of a higher tax rate than they have called upon to bear.

The Finance Committee is not disposed to recommend a tax rate of \$3.47 or slightly higher, in order to meet obligations for the current year. For that reason they recommend a new plan to relieve the taxpayers of such a burden. It is therefore recommended that instead of including the full amount of the overdraft, \$91,009 in the estimates, that with the consent of the bank and legislative authority, \$30,000 be classed as a temporary laan spread over a period of **\$ive** years, the first instalment of which, with interest, amounting to \$ 7,800 be included in this year's estimates. At the end of five years the full amount would be wiped out without any extra burden to the taxpayers. The instalments would work out as follows:

These amounts includes  $\sharp \not h \not e$  interestcharges at six per cent. If view of the fact that council previously passed a resolution agreeing to include the full amount of the overdraft in this year's estimates the consent of the bank must first be obtained in addition to legislative authority. If the bank disapproves the only other course te pursue is to make a five year bond issue, subject to approval of the ratepayers at a plebiscite and authorized by legislation. The committee recommends that either one of the alternatives.

Should the ratepayers disapprove of this method of financing, the only other alternative is to impose a tax rate of \$3.47. The present council is in no way responsible for the existing condition. As pointed out in this report earlier the decrease in the assessment is the cause, coupled with the fact that there is no possible way whereby the several sources of revenue can be increased. All such channels are tapped by either the provincial or federal governments.

In order to encourage the prompt payment of taxes your committee is recommending that 8 per cent interest be charged on all overdue taxes for 1924; taxes overdue for previous years not being affected by this charge. Those overdue for 1923 are affected by a seven per cent charge and those for other years to a six per cent charge.

The finance committee make the following recommendations: /. That legislation be scught to enable the council to take care of \$30,000 of its overdraft either by a temporary loan at the bank or a bond issue.

That the mayor sign all orders for supplies, the chairmen of each committee having the right to have an order recorded in the office of the town clerk but not validated until counter-signed by the mayor and that public notice be given that goods purchased on behalf of the town without an official order shall not be paid for.

3. That the salary list of each official appear in the estimates in total so that ratepayers may know exactly what each one is receiving.

4. That the deputy clerk be held responsible for **the** checking, protesting and collection, with the assistance of the chief of police, all charges preferred by the V.G.Hospital for treatment of patients, and that council be notified of the inability of any to pay, and further that those found able to pay be prosecuted for the charges under the Act.

That the tax collection be re-appointed on the same terms and conditions as last year and that he report daily to the town clerk.

/ That the tax rate for 1924, if the recommendation respecting the item of \$30,000 is approved, be \$3.00.

Report of Finance Committee.

Dartmouth, April 11th, 1924

His Worship The Mayor And Members Town Council

Gentlemen:-

With your permission I wish to report with further reference in the previous recommendation made by the Finance Committee, and approved by council, that a \$30,000 portion of the 1923 overdraft, totalling \$91,009, be taken care of in a special way/ oy arranging for a temporary lean at the Bank, payable in five annual instalments. The alternative plan was to finance the amount by a bond issue covering five years.

Realmiller

Since that plan was submitted and approved new developments occurred with the result that it is now found necessary, in order to have the original recommendation of the committee and council ratified, to make a slight modification. I have pleasure in recommending that this be done. My recommendation, thereofore, is that the resolution fixing the tax rate at \$3.00 on every \$100 of the assessment be rescinded and substituted for one which will fix a rate of \$3.10 on every \$100 of the assessment for the year 1924.

The legislation sought to approve of the original plan of financing the \$30,000 item provided for negotiating a temporary lean at the Bank. This plan is not satisfactory to the Bank from a banking point of view, but is not regarded by our Bankers as a poor business proposition as many have contended. After a conference with the Bank officials at headquarters at Halifax I am pleased to recommend the financing of the \$30,000 by a bond issue of five years. Until this can be arranged for the Bank is quite pleased to take care of the full amount of the overdraft.

I wish also to report that legislation along the lines referred to has not only been submitted but is well advanced in the House of Assembly, having been unanimously approved of by the Committee on Private and Local Bills. Assurance was given to me during the week by **Cheirman** Graham **mfxtkmxComm** and members of the committee that the legislation would be approved if the council would confirm my recommendation to increase the rate to \$3.10.

The slight increase in the rate, coupled with the policy of rigid economy in the matter of expenditures decided upon by cuncil, to take care of the yearly pon instalments maturing on the bond issue. The adjustment I regard as highly satisfactory and a complete vindication of the position and stand taken by the finance committee and the council in this matter. By this means the taxpayers who naturally find it difficult to meet their civic obligations will reap the benefit and will not be burdened with such a burden as a \$3.50 rate would impose. The plan is a complete protection to this class and it should commend itself to everyone affected.

I have no hesitation in saying that is the first real effort made to enable the town to adjust its financial situation until such time as conditions become more prospermous. I still maintain, despite statements to the contrary, that the present council is not responsible for the position it finds itself in today. It is not my purpose here, however, to offer any criticism of the unfair and apparently prganized attempt made to discredit the present administration and to insinuate that dishonest was rampant in the conducting of town affairs. My sole aim is to direct the public affairs with a minimum of inconvenience and hardships and a maximum of advantageous results.

The proposal of the finance committee to adjust the town's financial affairs was made with every honest intention and with no intention of misleading the council or the public and I feel that the the transmission of the Provincial the treatment it received at the hands of the Provincial Legislators may be regarded as gratifying, indicating as they did that they had a keen appreciation of the task the council had to deal with and at the same time not forgetting the unfortunate position in which many of the ratepayers find themselves.

The success which has favored the council's position will permit of the original street estimates remaining intact, thus providing a fairly generous // program of work this summer.

The slight increase in the rate of ten cents simply means that a person assessed \$2,000, which is the average on homes, #/#will only have to pay \$2 extra. In view of this small amount I take this opportunity to make an earnest appeal to the ratepayers to accept the reasonable increase in the way that it is intended.

In conclusion I wish to thank the provincial legislators for the sympathetic hearing they permitted on the controversial legislation and the consideration they gave to it, also the council in standing firm and supporting me in what I regard as an unfair attack, specially organized for the purpose, from a select clique.

Another matter I wish to call council attention to is the importance of having the water bills sent out so that revenue from this source may be obtained in order to keep our credit in this department up to standard.

I would also recommend that no orders be issued for supplies provided for in this year's estimates which can be delayed, until after the 30th day of June when revenue from this year's assessment will be available to meet debts contracted. If this is done the financial situation will greatly improve.

<u>DR. J.W. ALLISON</u> was present and given a hearing relative to his Assessment. He claimed that his property rated was an excessive amount. He asked for a reduction. A decision of the matter was deferred.

WILLIAM SWAFFER of the North Brook Hockey Club being present with other members of that Club. He was presented by the Mayor with a Cup donated by the Starr Manufacturing Company.

EARLE McEIMON appeared as a representative on behalf of his father E.H. McElmon. He claimed that they were charged water rates for their mill for the period from April to December 1923. As the water pipes in the Mill were frozen that winter he thought they were entitled to a deduction in the water rates charged. <u>TOWN SOLICITOR MURRAY</u> read a draft of the Legislation submitted by him to be presented to the Legislature at the next session. Councillor Young moved, seconded by Councillor Smith that the Town Solicitor be authorized to draft Legislation to pay for an in-

dependent audit of the Town Books. Passed.

<u>COUNCILLOR</u> called attention to the amount paid John C. Webber for the rent of his house at \$8.00 per month. This arrangement had been made by the then Charities Committee some years ago towards the maintenance of his daughter who was left by the death of her husband, a widow with several children to support. On motion of Councillor Pettipas seconded

by Councillor Otto the following Resolution was passed.

"RESOLVED that the Agreement, if any, existing between Mr. John C.Webber and Town of Dartmouth, requiring the Town to pay to Mr. Webber Eight Dollars (\$8.00) per month rental for occupancy of house in Stairs Lane occupied by Mrs. Webber, who has eince married, be and is hereby cancelled on and after the 30th. day of April, 1924, and that Mr. Webber be notified accordingly."

In the case of MRS. D. O'HEARN and two children whose husband had been recently committed to the Penitentiary for the period of two years for a Criminal Offence was left in the hands of Councillors

Minutes of last meeting read and approved.

<u>REPORT</u> of Water Committee was read with a statement showing the estimat ed receipts and expenditures for the year 1924, a copy of which is annexed to these minutes. On motion of Councillor Walker, seconded by Councillor Smith the following Resolution was adopted.

"That the Water Rates be fixed for the year 1924 at the same rate as the previous year 1923, namely pipe rate 20 cents and domestic rate 60 cents per \$100, these charges netting a revenue \$16,875." After discussion, on motion of Councillor Walker, seconded by Councillor Smith, the following Resolution was adopted.

"RESOLVED that the report of the Water Committee covering "Wate Maintenance Account" containing in detail receipts and expenditures for the current year, do hereby be approved, estimated receipts totalling \$14,619 and expenditures totalling \$38,297 leaving a balance of \$23,678 to be raised by direct taxation.

FURTHER RESOLVED that this Council approve of the Committee's recommendation respecting water rates for the year, namely 60 cents for Domestic Rate to be assessed on value of property amounting to \$2,215,000 and 20 cents pipe rate to be assessed on property valued at \$1,802,800, netting a total of \$16,895."

On motion of Councillor MacLean seconded by Councillor Walker, the Street Committee's report was adopted as follows:-

"The Committee on Streets and Public Property beg to recommend the purchase of one tank car load of Liquid Asphalt. Same to be used on Portland Street - from Water Street to the intersection of Prince Albert Road, and on Ochterloney Street - from Water Street to the Canal Bridge. The quantity left over to be used on Water Street from Portland Street to Synott's Hill. The balance of the appropriation for this work to be spent on oiling streets. Would also recommend buying 100 tons broken up stone from M. Mitchell @ 95¢ per ton."

On motion of Councillor MacLean, seconded by Councillor Smith, the

Finance Committee's report was adopted as follows:-

"As taxes in arrears are not coming in as promptly as desired in order to meet current expenditures, I find it necessary, in the hope of improving this condition, to recommend that the Town Clerk be authorized to issue what is known, under the Town's Act, "The Town Treasurer's Tax Warrant." Under this process taxes are payable on demand, it being understood, of course, that these Warrants will be handled by the Police. Under present conditions, as much as I hesttate to make this recommendation, I find that it is absolutely in the interest of the administration to do so. Unfortunately many do not seem to realize that the Town must have money and that the only means of obtaining it is collecting it from the ratepayers. Taxes are due the Town and they should be paid and unless there is a **hore** prompt payment of same it will be impossible for the Street Committee, or any other Committee, to commence, with any degree of satisfaction upon its program of work planned earlier in the year. It must be remembered that the Town has to depend upon the payment of taxes due for 1922 and 1923 until near the end of June when the taxes for 1924 become due.

Tax collection for April, from all sources, totalled \$2,126.18 made up as follows:-

It will be noticed from the above figures that the amount collected for April, covering taxes in arrears of Assessments from 1921 to 1923 falls from short of what it should be, if those liable would meet their obligations.

I would urge that a more determined effort be made to collect water rates in arrears and in this connection would recommend that the Clerk be instructed to sue for rates due, or have the supply cut off, the Clerk being allowed to use his own discretion in this matter. I would further recommend that the Clerk sue for **a**mounts due on house connections."

LETTERS were read from the following:-

(1)

J. WALTER ALLISON protesting against the Assessment made upon him the current year. He called attention to applications already made to the Town Council last year for their approval to his proposed plan of his property fronting on Pleasant Street, Old Ferry Road and Portland Street and for a sewer in front of his property and sidewalks. After considerable discussion, the Clerk was instructed to acknowledge his letter and inform him that the Town Council regret that they are not able to carry out his request for the extension of the main sewer and permanent sidewalks in front of his property on Pleasant Street; but that the other street work he referred to, would be carried out. After some discussion on motion of Councillor Walker seconded by Councillor MacLean the following Resolution was adopted.

"RESOLVED that Dr. Allison be informed that the Council regrets that it is not in a position, due to the fact that no special capital borrowing is arranged for, to lay a sewer on Pleasant Street from where it at present terminates about opposite Miss Seely's Cottage to connect with the new sewer at the junction of Pleasant Street and Old Ferry Road, so as to afford sewerage to his property on both sides of Pleasant Street;

AND FURTHER RESOLVED that **Pr.** Allison be notified that no money is available this year to construct concrete sidewalks as requested by him, on the west side of Pleasant Street as far as the Old Ferry Road;

AND FURTHER RESOLVED that Dr. Allison be notified that due to a misunderstanding; approval of plan of sub-division of property owadd by him bounded by Pleasant Street, Old Ferry Road, Pleasant Street and Mott's Lane was not given, that a meeting of the Town Planning Board will be held at an early date when it is hoped that the plan will be approved." H. R. SILVER objecting to pay the pipe rate on his property fronting on Hawthorne Street and Prince Albert Road. He said he was willing to pay a nominal amount for fire protection and suggested that the sum of \$30.00 be fixed as the fee. He mentioned also that the Town owed him for a quantity of stone delivered to the Town in 1922. He had received a small portion of the amount and requested a settlement of the amount due him. Referred to the Water Committee for report. <u>THE MINISTERIAL ASSOCIATION OF DARIMOUTH calling attention to the great</u> need of a new cemetery in the Town and asked that immediate steps be be taken to secure a property suitable for a cemetery and sending the following Resolution adopted by that body.

"WHEREAS the need of a new cemetery has become imperative in the Town of Dartmout, present conditions of burial in many cases being nothing short of disgraceful, arousing the indignation of citizens who feel that decent provision is not being made for this public necessity.

AND WHEREAS succeeding Town Councils have recognized the increasing gravity of the problem, and have from time to time invited this Association to confer with them regarding it, -- the latest occasion being a few months ago when a decision was again postponed, probably owing to the approaching elections,

THEREFORE RESOLVED that this Association urge upon the Town Council the duty of dealing with this crying need at the earliest possible moment to avoid further intensification of public feeling on the matter."

The Clerk was instructed to inform them that no land for a cometery will be purchased until December next. The Council have a property in view which will be available for the purpose. <u>NOVA SCOTIA MUNICIPALITY</u> calling attention to the proposed Legislation to take away the town's right to dismiss the Chief of Police under the "Nova Scotia Temperance Act" with consent of the Government. Their Executive were of the opinion that the proposed Legislation was an unwarranted interference with the rights of our Town and they strongly protested against it. Received and approved.

AMPUTATIONS ASSOCIATION OF THE GREAT WAR thanking the Council for their unanimous action in supporting their request to the Government by endorsing their stand in regard to the permanency of pensions. Ordered to be filed.

RE: JOHN LENNERTON - A resolution was adopted that the matter of sending Allen Lennerton, son of John Lennerton, to the Sanitorium at Kentville, be left in the hands of Councillor Pettipas to deal with. Read application from L.M.Bell for a motor bus (3 buses) to run from
