In reference to the question submitted to me by the foregoing resolution, I beg to state that, as the Auction Licence duty is paid into the City Treasurer and becomes part of the General Funds of the City, which are under the management and control of the City Council, I am of opinion that they have power to deal with the memorial of Mr Chamberlain in such a way as they may deem just and equitable.
