Gentlemen

We beg to submit to your notice the enclosed copy of an affidavit made by Mr. Boggs before John Egan Esq. and to call your attention to the following facts relative to it. On the morning of Monday the 13th June last Mr. Boggs called at the Office of Mr. William McKay one of the City Assessors to make an appeal from the sum of \$30000 at which the Real and Personal property of Stumard & Co. was valued, when he was informed that the day of appeal had passed that the notice was dated on the 28th of May and the 21st day had expired on the Saturday previous being the 11th June. Upon reference Mr. Boggs found that of his notices which had been left at our Office by the City Assessors, two were dated on the 28th May and the one in question on the 21st May, this difference had escaped his notice until pointed out to him by Mr. McKay. Considering that it was not the intention of the law, nor the desire of the City Council to take advantage of an error into which he had been led inadvertently supposing that the notices were all dated on the 28th May Mr. Boggs made the necessary affidavit and sent it to Mr. McKay.

Quarterly report
of Supt of Streets

The Superintendent of Streets respectfully reports to the City Council that the regular street service commenced on the 4th May last, During the first week which was chiefly occupied in cleaning the City 14 day labourers were employed 10 of which were formerly employed in the northern wards and 4 in the South district. After cleaning the City the whole labour was directed to preparing Gravel to meet the Statute labour of Wards 10 & 5 the Statute labour of these Wards has gone forward by 2 Mannings in each Week according to former practice. South and North on alternate days. The Statute labour now reduced to the strict letter of the law, excluding substitute labour and limiting the time to 10 days produces comparatively few actual labourers, this might not be so much a subject of regret if the Statute labour fund could be made available early, so as to hire the labour of a sufficient trained force. As this cannot be done without anticipating the said funds the work at commencement must when compared with the substitute system be small. Although the payments made to the City Treasurer contrasted with the collections effected during the same period on former years affords sufficient proof that the Change will ultimately realize the anticipations of the City Council. By the time the Mannings of each Ward are brought up, it will at once be ascertained to what extent the hired labour can be augmented, such is now the case in Wards 1 & 5

Respecting the System of appropriating the labour, it is only necessary to say that previous to operation the Committee appointed by the Council inspected the State of the roads with the Superintendent, the most needful repairs are the first objects of Consideration, and these to be thoroughly done instead of going over a large surface

surface with temporary repairs, this too superficial observation militates against the System, though the City must soon evidence in its favour. In parts of the City remote from any source of good material the improvement of the Streets is necessarily expensive and comparatively slow. Such is the case with the Northern wards of the City, nor is this the only disadvantage of this locality. Many of the surface improvements have to be attempted previous to the making of the main drains, which is the primary source of all improvements. Consequently, much of the necessary repairs must fall deficient of their desired effect. The extent of this requisite drainage together with the expense of cutting through rock, retards the due progression of improvement, under any system.

The Improvements on hand are in No 1 Ward a continuation of those taken in by the former Com^r. viz the curbing and paving of the East side of Lower Water St. (finished) The curbing and paving of Spring Garden Road and Chesden Row nearly completed.

In Ward No 5 the Grading of Maitland Street matting side walks and paving gutters has hitherto occupied the limited amount of Statute labour. The repairs of the other streets in the upper part of the Ward which are numerous and indispensable must be effected by hired labour. A public drain leading the Water from Gittingan St through the premises of Mess^{rs} Muckle and Kemson, which was a wooden trunk drain having given away through decay, has been removed from Water St upwards half the width of the Block.

In Ward 2 and 3 Curbing and Paving is in progress in consequence of the arrival of a large quantity of Lumber specially ordered by the Commissioners, and which must be put down to prevent the incumbrance of the Streets. The repairs of drains in various parts of the City engage daily attention. The cut road work of Ward 5 & 6 is also on hand of Warming. Sea Gravel is also contracted for at 11 per Cart load of 12 Bushels each, for top dressing side walks and repairing Streets. The surplus material from the public drains in Brunswick St is also nearly leveled off upon the Street and side walks.

The Cleaning of the Streets is an object of much importance and although engaging a large portion of

of the street labour both of men, Horses and Carts, a uniform state of Cleanliness cannot be realized so long as the Streets are made the Common receptacle of every species of dirt daily accumulated in Shops and Dwelling Houses, this with the continual grinding of street material are sources of dust which would require the larger portions of the Ward Funds to subdue. 4 Carts engaged by Contract are continually employed Carting off Cleanings, Sweeping Lumber, Paving Stones and Gravel. The books in the Superintendent's Office show how the daily labour of men, Horses and Carts are employed, The amount of Statute labour performed and unperformed, and a register of encroachments with copies of notices for their removal, Plans, Estimates and tenders for Special Improvements are open to inspection, and applications for Street lines and levels are attended to when presented.

The whole fixed labour at present is 21 day labourers, 4 Men with Horses and Carts (Contract) 1 Man paving at 6 per yard finding his own labourer, A Carpenter is occasionally employed to fit circular Curbing at 5/- per Corner, The paving in the Northern wards is at present performed as formerly by day labourers

My attention has been called officially as Mayor of this City to a proceeding going on at the Queens Wharf of putting down a row of piles close to the South side of the Fish Market Slip, where I understand a fence is intended to be put up. As the piles and fence in question will render the Slip almost useless to the City by depriving the Fishermen of the Chief landing place for their boats to be fastened, the result will be a most serious grievance to that Class of men and consequently to the City, which they daily supply with an essential part of its food,

I have therefore called upon the Recorder as the legal adviser ^{of the City} and caused inquiry to be made by him at once into the title and possession held by Citizens in this Slip property, and he states that it was reserved by the Crown by notes and bounds as far back as the 1st May 1787 and then distinctly set apart as a public market for the town of Malpas in a certain Crown grant under the Provincial Great Seal, signed by Governor Parr, countersigned by Thomas Crahan Esquire, the adjoining property, now known by the name of the Market Wharf, and further that the title of the Citizens therein was further extended and established by two Grants under the great seal, signed by Governor Sir John Wentworth, one in favour of A. Brymer and others dated 23 Sept 1794, and the other to S. S. Blowers and others dated 9 January 1797.

I find also that the Fishermen who supply this market have used the Waters in question to the same extent and for the same purposes as they now do, for a period extending to the earliest date above named viz. 1787 if not earlier. There has thus been a possession of 66 years at least of the use of the Waters in question for the access of boats, of which the work of piles and fence now in progress would deprive the Fishermen and the public of this City.

The Landings and Slips in the City are vested by the Charter act of 1851 c. 1. 107. especially in the City

City Corporation and by the Act of the Province Passed Statute
C133. 5. 14 the principal of English legislature is adopted
which gives 60 years as the period to extinguish any adverse
Claim the Crown may have in property and confirms the
possession of the subject after so long a period,

Viewing the use of the Waters adjacent
to this M^o on the South as clearly vested in the City by
the Establishment of the title equally by the long use
held for boats of fishermen, it becomes my distinct duty
as Chief magistrate of Halifax to protect this possession,
and I have therefore to give you notice that the Works referred
to and which I must assume are going on under your
authority and sanction are clearly unlawful and destructive
of the City rights, and request you to cause the removal of the
piles already put down and to leave the Water free as before

The Committee have agreed to several alterations and improvements in the Fish Market, and have declined letting the stalls for the present in the usual way by drawing for them, but would recommend the Council to let them at Auction the same as all the other City Property, making former rates the upset price if the Council thought proper,

As the Committee contemplate making several improvements viz making the Council Chamber, Committee Room, and other Offices, in the Second Storey of the County Court House, they have requested Mr. Finckley to furnish them with a plan and estimate agreeable to their suggestions likewise an estimate of the expense of putting metal spouts and conductors round the East and West sides and north end of the Court House, and putting the roof and railing in thorough repair, and painting the whole building with cement, the butters end of the roof seems to be in very bad repair, and there has been numerous complaints from tenants in consequence of the badness of the Eastern Spout. The Committee would therefore recommend the Council to have the aforesaid improvements done without delay as indeed the most of them are indispensable,

The Committee have agreed to take tenders for the building a Stone and lime Wall in front of a City Water lot to the Southward of Fresh Water Bridge its being now open and exposed and dangerous to the Public they would therefore recommend the Council to have said improvement carried out,

The application of the North British Society for a grant of certain lots in the Cemetery having been by resolution of the City Council of 25 April last referred to me for an opinion. I beg leave to report

That by the By law No XXVII Section 2 "Whatever portions of the remaining part of said Cemetery are now or may be divided into lots of nine feet square, shall be sold under the direction of the Committee for the sum of Forty shillings for each lot, except such as have been already used for the purpose of interment &c and that the 1st Clause of same By law appropriates a strip of 9 feet wide the whole length of the Cemetery on the Eastern side thereof for strangers &c directing each lot to be sold for twenty shillings, Further that on reference to the plan of the Cemetery, signed and hanging up in the Mayors Office, it appears that the eastern portions of the ground have all been divided into lots for sale under Section 2nd above quoted,
