And as in duty bound will ever pray, adding that he has confident Hope that the annexed Certificate of expenditure verified upon oath, will be found correct and have its due weight in determining your judgment.

The Memorial of William C. Moir
Shumbly Sheweth

That your Memorialist is the proprietor of a dwelling House and Bakery situate in Barrack St in this City which is now undergoing an alteration that he willing and desirous that the Street should be cut down, as he believed it might be done in such a way as material to improve that part of the City without injury to the proprietors of Houses on the Street, but when it was ascertained that a plan and survey had been made in the first instance for the alteration the effect of which would have been if acted on, to have ruined the property of your memorialist and to have materially injured that of others in the neighbourhood, a remonstrance was made to your Honorable Board and after a lengthened investigation the City Council acquiesced in the justice of the objection taken by to the proposed plan which was rejected and a new one made and Confirmed, upon which last mentioned plan a Contract was entered into for the proposed work and by it the Street in front of memorialist's property was to be cut down seven feet and a quarter instead of four feet nine inches as specified by the first plan

plan, that the work has progressed considerably, but from the level now struck it is apparent that it is not the intention of the Contractor to cut the Street to the extent specified in the plan and the Contract and hardly more than was specified in the plan which the City Council rejected and the effect of this will be to render the Bakery useless to him and his dwelling house and shop inaccessible from the Street, this he would have remedied if the Street were lowered to the extent required by the Contract as he could have built a story under his present buildings but he has no remedy if the Contractor carries out his present intentions as no space will be affected for the building of a new story and your Memorialist estimates that the actual damage this will occasion him will be at least three Hundred pounds.

Your Memorialist therefore prays Your Worship and Honorable Board not to sanction any alteration in the Contract but to require its fulfilment according to the plan which was approved of after a careful investigation and thus protect him from the loss and damage which will otherwise be entailed upon him, And as in duty bound so

I have been requested by Mr McVie to call your attention to the course which Mr Jones is pursuing in cutting down Barrack Street, disregarding the agreement entered into with the Contractor and accepting a level entirely different from the plan Mr McVie was led to believe by the City Council would be acted upon, and one differing very little if at all, from that which he was informed had been rejected by the Council on his remonstrance.

Mr Jones has pursued towards Mr McVie the extraordinary course of preventing surveyors from taking the actual level of the work in order that he might show to you and the City Council the extent of Mr Jones deviation from the plan before the work is taken off the Contractors hands, and I am on behalf of Mr McVie call your attention to the subject in the hope that you will bring it under the notice of the City Council or cause

an investigation to be made in order that if Mr Jones is deviating from the plan approved by the Council he may be set right and cautioned against accepting the Work from the Contractor till the terms of the Contract are complied,

Mr Wain has embodied his grounds of Complaint in a petition to the City Council which if not now before them will I presume be shortly presented and he therein shows that the damages he will sustain by the alteration of the plan will not be less than Three hundred pounds,

In the hope that the present application will be successful and render any subsequent recourse upon the City unnecessary

The Superintendent of Streets agreeable to a report resolution of the Street Committee has made a joint Survey of Barrack Street with Mr William McKay and submit the following report

They find in various places the present level is higher than the depths specified in the Contract as the subjoined plan will show at the same time the Street would be nothing improved by adhering to the strict letter of the specified depths and the adjoining Street below would suffer an injury inasmuch as the cutting down of George Street to suit the upper level would involve the cutting across Albernair Street,

From the head of George Street to within respect of Depons corner the level may be reduced to the difference marked in the Plan without injury to the other Street levels. These difficulties have arisen from the original maximum cut having been fixed at 12 feet a depth too low for the plan of George and Albernair Street

The Superintendent being bound on the one hand to see the Contract strictly adhered to whether right or wrong and on the other hand to see that the work was completed in a workmanlike manner, conceived that this duty would be most fully effected by making all the levels of the Streets to correspond which they will not do if the original depths are adhered to

The Superintendent of Streets begs to report to
the City Council that in accordance with his instructions he has
maturely considered the subject of opening the new line of Road
from the head of the North West Arm to the Queen Pool road, and finds
that the project is one of much importance to the Public and perfectly
practicable at comparatively small cost. The subjoined rough
Sketch shows that the distance from the head of the Arm to the
point of the Queen Pool road now open is 176 Perches, the grades
and curves are easy, and materials for making a good road
are abundant on the Spot, to avoid the embankment of Creeks
it would be advisable to adopt a line altogether clear of high
water mark (a course to which Thomas Astorinan Esq through
whose property the road would chiefly pass) has no objections
nor would he require the erection of fences on the sides of the road.
The principle obstacle which occurs in the line is at the South
West Corner of Mr Laurence Roach's field where the water of
the Arm comes so close to the field wall that it would be necessary
to bring the road partly through the enclosure, if Mr Roach
accords to this the difficulty will be obviated. The reserve
space for the width of the road would require to be 60 feet though
the first portion of the grading would sufficiently accommodate
the travelers at 32 feet wide at this width a good road might
be constructed at a probable cost of 30/- per Rod or £264
for the line projected, on good data it is supposed that $\frac{2}{3}$
of this sum may be realized by subscription and labor.

adhered to in all its bearings, substitute work in every form rejected, all money payments for forfeitures has been made to the City Treasurer whose returns will shew a decided improvement in the system of collecting these monies.

The ward books will shew that the expenditure both in statute labor and money have been strictly appropriated within their own limits as far as gone, and the prospective statement of work to be accomplished will demonstrate that the claims of the Poorer wards upon the General fund will not be neglected, all hired labor with Horses and carts has been confined first to the five persons who tendered and contracted for the same at reduced rates viz 4. 43. 3/4 per day & 1/2 per day all extra hire being confined to such persons as had duly performed their Statute Labor and proved themselves worthy of such encouragement, dividing the time as proportionably among them as possible,

The repairs and improvements have been made in such parts of the City as the Superintendent and the Committee deemed them most necessary and indispensable, The Annexed statement of these separate improvements and repairs will shew how they have been apportioned

In Ward No 1 The repairs have been chiefly made in Dresden Row, Spring Garden Road, Lower Water Street Lower end of Morris Street, Nellis St, Wallace St, Phasant and Victoria Streets, with the out roads belonging to this ward, Pyper's Bridge has also been finished by Contract.

The Paving in this Ward amounts to 357 yards, a portion of Spring garden road formerly curbed with planks is now finished, also a part of lower water Street, The repairs yet required in this Ward are chiefly in Morris Street, the street leading from Pyper's Bridge to the Roman Catholic Cemetery and Spring Garden Road west of Pyper's Bridge,

In Ward No 2. the repairs are chiefly in have extended over a portion of Water Street, Nellis Street, Salters St, Barrington Street, by Government House, Grafton Street and a part of Dresden Row. The amount of paving performed in the Ward is 653 yards and the out Roads of the Ward completed, the repairs still anticipated in the Ward is the repairing and paving a portion of side walk and gutter at the lower Country Market, The Sidewalk South of Lovelands Corner Nellis Street part of Granville Street Barrington Street the Road beyond Pyper's bridge and side walk around the Horticultural Gardens,

In Ward No 3 The curbing and paving has

Has been completed around Mars Building from Hamiltons Corner to Yumans and Frasers Office around the entire block within Hollis Street Prince Street Suffolk row and Tacterville Street also around the block from Mannys Corner to opposite St Andrews Church reducing the Crown of Granville Street upper side of Prince Building also from the Corner of the Block opposite Epurs to Bolton from Cross Corner to the front of the Golden Fleece, and a part of Prince Street below Mannys Corner below the Statute tower. A new public Chain has been made in Barrington Street 15th Rods in length by day work for the sum of \$29.1.8 or \$29.8.11 below the lowest tender, in this Ward there has been 655 yards of paving, The Repairs anticipated is the forming of Side Walks in Barrack Street and Croft Street connected with it, Side Walks near the Market Slip, side walks upper side of Hollis Street south of St. Matthews Church Repairs of part of Duke Street and Water Street.

In Ward 104. The repairs have been made in Almerston Street, paving and side walks completed from North to Bopems Corner, also on lower side and the Crown of the Street cut down and made up at Cropping of Buckingham Street, the paving of Grafton Street is in progress on both sides with the side walks, also Argyle Street on one side with side walk, the excavation of this Street has been finished by contract the amount of paving in this Ward is 311 yards, The Repairs anticipated are side walks in Barrack Street, repairs of Water Street, Duke and Buckingham Streets, 11 Rods of Public Chain in the Ward fronting Abbeys Merbles has been contracted for.

The Repairs in Ward 105 consist of grading Hamilton Street throughout making side walks and paving gutters on both sides, which required the carting in of a great amount of material, The side walks in Brunswich St have also been new graveled, Gottingen Street and all side walks West of the African Church, A new Public Chain has been made by contract 15 Rods in length West of the Bull Court, also one in Maynard Street opposite 16th Smiths property 3 Rods in length the Streets have in various parts been repaired, the amount of paving in the Ward is 725 yards, the out roads of this Ward have also been repaired. The anticipated repairs in this Ward are the Repairing of Lockman Albo and City Streets, Young Street and the road on North side of Common with sundry repairs on Water Street and Cornwallis Street.

The Repairs in progress in Ward 106 consist of Grading and paving Brunswich Street and making

Side Walks throughout. Repairs of Cottingen to Fort Needham the Fort Needham and Haupt Roads are in course of thorough repair together with Cross Roads leading into them, this Ward being comparatively poor and encumbered with a great extent of Cut Roads, requires an extra appropriation of the Contingent funds, its own funds apart from the Statute Labour does not exceed \$50 while \$100 would hardly meet its annual wants, good materials for constructing and repairing Roads cannot be obtained in the vicinity without much labour, even the upper streets especially Cottingen Street requires Man Sewers - without which all attempts at improvement are quite abortive, to specify the most necessary repairs and improvements would be futile, they can only be remedied by an extra participation in the General fund, or Special Grants, wherever the foregoing specified repairs have gone the Side walks have been top dressed with Sea gravel 473 loads of which have been used together with a large quantity of Course gravel for the streets, this has been supplied at 11 per Cart-load of 12 Bus. the proportions used in the various wards are as follows 1st. 58 loads, 2. 79 loads, 3. 75 loads, 4. 24 loads 5. 194 loads 6. 43 loads, of the large quantity of paving Stones used some were purchased the surplus stones of the old double gutters have been used in the new work, The greatest number of men employed was 311, these are now reduced to 23. The largest number of Carts employed was 12 these are now reduced to 2 Contract Carts one of which is constantly employed Carting off Clearings from two Scavengers daily employed the Clearing has occupied a considerable portion of the weekly time of other men besides the 2 regular Cleaners lifting, repairing and cleaning chains also daily contingencies not enumerated,

The Superintendent and Committee having disapproved of the plan of binding the Contractor agreed to discontinue the supply and part of the Stock on hand was sold to the Fire ward Department for covering Tanks, Mess Luard agreeing to take the balance at Contract price, The paving costs 6 per yard including all labor except excavation,

The Statute labor book for the year is not yet completed the gross amount will be about \$1400. the labour performed from \$325 to \$350 being about \$150 less labor performed than in 1832, The Forfeiture paid amounts to \$43.8.4 being \$27.15.0 more than was collected at the same date last year, the probable balance after deducting labor performed \$350 from which \$60 to \$80 may be deducted for exemptions and \$20 to \$30 for bad debt say in all \$400.0.0 which would leave about \$250 due and to become due all of which
