Whereas the piece of ground in the City of Halifax known as the Grand Parade appears by the Books of Registry of Grants of the Province to have been granted in the year 1783 by John Parr then Governor of this Province to certain parties in said grant named being Provincial Officers and to their successors in office in trust for Public use.

And whereas by the said Books of Registry the said piece of ground appears to have been again granted in 1818 by the Earl of Dalhousie at that time Governor of this Province to certain other parties in said last mentioned named for the purpose of erecting a college thereon to be conducted on the principal of the University of Edinburgh and a building was erected thereon for the purpose of a college.

And whereas it does not appear that the said Earl of Dalhousie had any authority to grant the said piece of land after the same had been granted by a former Governor in the Province with all the formalities required by law in such cases.

And whereas the said piece of ground with the exception of that small portion of it covered by the Building known as Dalhousie College has ever since the passing

of the said first mentioned Grant has used by the people of Halifax as a Public square in accordance with the terms upon which said land was originally granted.

And whereas supposing the said piece of ground to have been rightfully and legally granted a second time by the said Earl of Dalhousie, the terms and stipulations according to which the said land was granted for the purpose of erecting and maintaining a College thereon have not been complied with by the grantees under such grant and their Successors, being known as the Governors of Dalhousie College.

And whereas the said Governors of Dalhousie College have obstructed and continue to obstruct a Public Street or thoroughfare known as George Street running across said Grand Parade, so that carriages are prevented from passing along the same, and have recently commenced to enclose a portion of said Grand Parade with a fence so that the Citizens of Halifax will be debarred from the enjoyment thereof as a Public square, and maintain that they have a right to the exclusive use of said Grand Parade and may further hinder the Citizens of Halifax in the enjoyment of the same or entirely exclude them therefrom.

It is therefore resolved that this Council as guardians of the rights and interest of the Citizens of Halifax will employ competent legal Council to make diligent search and enquire into the right by which the piece of ground known as the Grand Parade was in the first instance granted to certain parties for the erection and maintenance of a College thereon, and also the right of the Individuals known as the Governors of Dalhousie College to continue in possession of the same or any part thereof and to embrace any part of the same or exclude the Public Highway known as George Street which passes over said Grand Parade Moved by Alderman Evans seconded by Alderman Longard to which following amendment is introduced

Gentlemen

I beg leave to Report for the
information of His Worship the Mayor and the City
Council that since the 1st of May I have been engaged
every day (Saturdays excepted in a sewing) the Citizens
for poll Tax for Road and Street purposes and that
I will not finish before the 15th inst and as the Law
allows holidays for returns to be made the Registry -
required under the 12th Section of the Act cannot be
completed before the end of the month

As the Superintendent of Streets has applied for
a further extension of credit on account of Streets I
may state for the information of the Council that
the amount of Street Funds raised will be £3000
but allowance must be made for deaths and removals
say £500 which would leave at least £2500 to be
dependd upon, and under law all persons must
be notified after the Registry is returned to pay within
30 days - so that no monies can be expected from
this source before the 1st of September

I may take the liberty of stating to the Council that
at present my situation is both unpleasant and
inconvenient no salary having been fixed at the time
of my appointment and consequently I am deprived
of the privilege of the other Officers of the Establishment
in drawing my Salary on the Quarter day I may
further add that the duties of the Office have increased
nearly three fold respectfully requesting the considera-
tion of the Council to this (to me) very important
matter.
