The Superintendent of Streets, begs leave to report his annual Report on Street Expenditure for the year 1854 for the information of His Worship the Mayor and the City Council.

The work performed since the report of October last consists principally in the repairing Water Street, from Prince Street to the City Market. Embanking the Street at the West side of the Convent repairing Side Walk in Hollis, Granville and Duke Street in Ward 2 & 3 repairing the Campbell Road City Street, Gerrish Street and other places in Ward 5 & 6

of this amount the Clerk of Streets considers that at least £300 must be allowed as bad debt or deductions for Engine Men and Ice Men - Deaths - Departures and other Causes.

The amount collected by the Treasurer is £1710.11.9 and with the suits now in hand for the next term will amount to £1950. and there will remain about £450 to be collected most of which must be sued for. 140 persons have been handed in for suit - and the whole of the names cannot be put through before the month of August this circumstance alone will show to your Honships and the Council, the necessity there exists for a change in the law, in order that the mode of collection may be more summary and less expensive than at present if the same process that is used in the Collection of Rates could be made applicable to the Road Tax the whole matter could be wound up between January & March, and while on this subject, I may be permitted to remark, that the law operates very well with but few exceptions.

In the 15th Section of the Act "Horses" are omitted - which is very important

With reference to your letter dated 5th August 1856, enclosing an extract from Minutes of the City Council and Copy of a Petition from certain rate payers and Citizens of the City of Halifax relative to the Continuation of Hollis Street from South Street to Fresh Water river, I beg to inform you that the prolongation of Hollis Street as proposed, will materially curtail and encroach upon the Government Lands now held by the Royal Engineer Department and that I cannot recommend any such encroachment.

In reference to South Street to meet the views of the Applicants, the Committee recommend that the Council appropriate pound for pound of the amount paid into the Treasury by subscription for the said Street by the 10th of May next or earlier.

On reading W. Hoosterman's letter your Committee recommend that when sixty pounds is paid into the Treasury the Council will furnish the sum of One Hundred in addition to open and construct as far as practicable the Quinpool Road in accordance with the plan submitted by the Superintendent of Streets and the work to be under his control and management or if £75 is paid into the Treasury they would recommend the Council to contribute the sum of £125 toward the construction of said road. Your Committee would further recommend that such steps as they deem necessary to prevent Mr. Neville or any other person taking hold of lands belonging to the City as they have but little for their own purposes.

On reading His Worship's note upon the Street fund the Committee would recommend that the old Debt due under the Old Statute Labour Law of £352.11.5 be assumed by the City & that the Amount be included in the Estimate to be assessed for this current year.

And your Committee further recommend that as under the Law no part of the road Tax can be made available before the month of September that the City Treasurer be authorised to open an account with one of the City Banks on account of the road Street fund to the amount of £750-

The Committee beg further to report that they accompanied by the Superintendent of Streets visited the different localities named in his report or estimate of Work to be done during the current year and they recommend that the same be adopted by the Council.
