That they have carefully examined the Report and Estimate and recommend that the same be confirmed with the exception that they think the sum of £500 requisite for constructing of the drain in Presden Row should if practicable be derived from some other source than the Street Fund and that the sum of Two thousand or Two thousand and one hundred pounds which will then be available for general purposes should be divided among the several wards in the following proportions viz To Wards 5 and 6 each £450 and to each of the remaining Wards £300 these sums to be expended by the Superintendant with the advice of the Aldermen of the respective Wards.

Council to the practice of throwing all kinds rubbish on the streets and grates making them a receptacle for all kinds of Nuisance - a practice which he observes is very much on the increase causing extra labour in cleaning the streets and producing seriously injurious effects upon the Sewers would recommend that the citizens be entirely prohibited from sweeping into the streets from their premises or placing thereon any kind of refuse material except in boxes or barrels which should be deposited twice in the week on days to be named by the Council, upon the side or gutter of the streets between the hours of 5 and 6 o'clock in the forenoon in summer and between the hours of 7 and 8 o'clock in the forenoon in the winter, the contents to be removed under the direction of the Superintendent of Streets.

With reference to the Sewer from the South end of Dresden Row the Committee recommend the adoption of the first proposition named in the Superintendants report which is to have it pass through the Cemetery, the advantages in this place being obvious both from the increased fall obtained and the sewer when completed being permanently self cleansing.

Your Committee highly approve the suggestion of the Superintendent that a survey of the present sewers, with plans showing their position both vertically and horizontally their size condition and grades, should be made, and they recommend that steps be taken to carry it into effect.
