— Read Report of Committee on Temperance. —

The Committee to whom was referred the Petition on Temperance &c, beg leave to report that after having carefully considered the same they have come to the conclusion that it is in the power of this Council with the already existing laws to do much

In the first place the evasions of the laws by Liquor sellers on Sundays, they think may be partially prevented by a little more exertion of the Mayor and aldermen in conjunction with the Marshall and his force and from observations of many such of the evil commences as early as 5 or 6 o'clock Sunday morning and all events before 9 o'clock so that by church hour parties are seen intoxicated rolling through the streets this the committee think may in part be avoided by the Mayor and aldermen occasionally making it their duty or business to rise early on Sunday morning and ascertain that the Marshall and his staff are upon the lookout in certain localities and where they see parties constantly going in and coming out of Liquor shops, find out what they are doing, & take with a supervision of this kind, the committee think that the disorders of the Sabbath caused by liquor traffic will be much abated.

As to that portion of the petition relative to selling without License the committee are of the opinion that when parties have many of the signs and appertinances generally found in such places and persons are seen going and coming from them intoxicated, that such should be desired sufficient evidence that those parties are evading the law and would suggest if the Law already does not give them the power to punish such, they should apply for such powers at the first opportunity. Further the committee are of opinion that it is the true interest of all concerned the Petitioners as well as the Liquor dealers that the law of closing places where liquor is sold was not permitted beyond 10 o'clock especially on Saturday as much of the evil arises in many cases from the late hours permitted to keep open such places, thus holding out inducements to youth after business hours instead of walking about for an hour after closing their shops, to a gain enclose themselves in a close unhealthy room drinking, smoking and carousing even in many cases beyond hours of 11 o'clock.

The committee would fair hope that for the purpose of doing away the excuse of many that it is necessary for the poor that shops should be open on Saturday evening later than other nights, because on Saturday generally wages are paid that Citizens in general who now pay wages on Monday, as by this Saturday would adopt the system of paying either Friday or Monday, as by this system they think much of the evil attending Sunday practices would be avoided, more especially if paid on Monday as in that case there would be but little left on the Saturday following to spend for Liquor.

As to that part of the petition asking for separations of sale of Liquor and Groceries in the same store or dwelling it is difficult to know or to state where to draw a line and at present this Council have no power to act in such away, they would

Recommend the petitioners themselves to prepare such an application to the whole Province, as they deem most suitable for such purpose and present to the next assembly, and this Committee do not think such an act prepared for the whole Province would have any opposition from our Civic body, that part of Petition relating to the Servants in places where liquor is sold would be an interference with private rights and the Committee cannot therefore touch it.

The Committee would in conclusion say that much of what is complained of by the Petitioners is too true but the law in many cases does not permit the Council to interfere at the same time they are ready at all times to act in conjunction with all well disposed fellow citizens in seeking to uphold and carry out the present laws and would only ask petitioners so far as they can themselves join with this body to aid and assist them upon all occasions in upholding the law. much evil is complained of by Hotels and Boarding Houses, being permitted to keep their Bars open on Sunday. The Committee would suggest that a more strict supervision be kept upon those places and if found evading the law the highest penalty be inflicted and further that the present law be most strictly enforced regarding the Hour of closing

and embanked, thus obtaining a large lot of Good manure for the fields  
a new dam made and also a drain crossing the road leading to cemetery  
to prevent the overflow of Water, this Road has also been recently repaired  
at a small expense, part of the material required for filling up having  
been supplied by the Committee (Streets) and when covered with a Coat  
of ground will be a good Road, many improvements contemplated by the  
Committee, such as the planting of additional Trees, making walks &c  
had to be abandoned this year for want of Funds, but as the debt due  
by the Common will be all paid off next May one instalment only being  
due, a larger amount of Funds will be at the disposal of the new  
Committee of Common, for carrying out those suggestions
