Whereas in 1858 a Statute was passed by the Provincial Legislature authorizing the Council to borrow the sum of \$38,000 for the erection of a building on the South Common to be used as an Hospital for the sick poor of Halifax acting on this authority a loan was effected and Debentures were issued payable in 20 years at 5 and 6 per cent per annum in 1859 the building was completed and being furnished with all the necessary appliances was opened for the admission of patients The Institution was placed under the control of a Committee of this Council who jointly with a Medical Board managed its affairs until 1866 with the exception of an intervening year or two that the building was vested to the Imperial Government in 1866 a scheme was devised upon which legislation was subsequently based whereby a New Poor Asylum was erected the City Hospital transformed into the Provincial and City Hospital

March 2nd

Hospital and the institution brought under the combined management of a Board of Commissioners at the same time it was enacted that in the matter of the future maintenance of the Asylum and Hospital the Province of Nova Scotia should meet two thirds of the expenditure and the City of Halifax one third accordingly this Council contributed \$30,000 and upwards towards the construction of the Poor Asylum and has regularly fulfilled its assumed obligations respecting the support of its inmates in like manner has the cost of maintenance of the Hospital been borne by this Council and since 1866 there has been drawn yearly from the Civic Treasury for this Service an average sum of not less than \$3,000. And whereas it appears that in the usual claims made on the City for its one third proportion of the expenditure in connection with the Hospital particularly the Board of Commissioners and now the Board of Public Charities had ignored an important feature of the financial arrangement which formed the grand work of the project by which the institutions referred to were placed under one Government The Records show that the management instead of taking into the account of annual expenditure the interest on the Hospital Debentures and thereby putting the burden of the construction of the building on the Province and City in proportions already set forth as in the case of Poor Asylum make up the annual maintenance account regardless of this item and consequently this Council being obliged to protect its own bonds has ever since 1866 assessed for the full amount of the interest for which no credit has been allowed thus practically making the rate payers of Halifax pay nearly one half instead of one third of the annual cost of the Hospital or in other words provide an Hospital accommodation rent free for the benefit of the whole Province In view of these facts it is expedient that an early effort be made to have the accounts of the Hospital as between the Province and the City of Halifax adjusted on a more satisfactory basis and in accordance with the evident intent of the Statute relating to this institution
