The Resolution of City Council appointing the Committee was read as also Mr Dault's letter as above and afterwards the following Resolution, which was moved by Alderman Mac Coy, and seconded by Alderman Hesslerin was discussed and adopted

Whereas a dispute has arisen between the Corporation of the City of Halifax and the Governors of Dalhousie College as to the title to the property known as the "Grand Parade" and it is desirous of having said right settled and compromised

Therefore Resolved that the Committee recommend the City Council to compromise and settle said right upon the following terms:

First: That the Governors of Dalhousie College convey all their rights to said Parade from a point fifteen feet from the southern end of the flags in front of Dalhousie College to St. Pauls Street and between Angyle Street and Barrington Street

I have examined the items of the estimate referred to me by resolution of the City Council and consider that the same, with the exceptions hereinafter mentioned, can be legally assessed on the property within the City

There is no authority for grants to these Companies in this form, but if the payment of these sums is necessary to keep up the efficiency of the Fire Department, it is fully authorized, as the expense of the Fire Department is one of the special objects of assessment

Streets (Labor & Material) \$13,000.00

Internal Health \$10,000.00

Section 8 of Chapter thirty six of the Acts of 1877 requires that the City Council shall out of the funds and revenues at their disposal set aside for the services of streets a sum not less than \$25,000.00 which shall be a first charge on such funds &c.

The estimate for streets is only \$13,000.00 to this however might be added a portion of the sum estimated for Internal Health as a large portion of that expenditure is incurred in watering and cleaning streets but even then it falls short of the required amount

These sums should I think be increased and the sum of \$25,000.00 be set apart for the street service (including watering and cleaning) as required by the Act

Infants Home \$300.00

Citizens Free Library \$550.00

This sum is in excess of the amount allowed by law for this service and is unauthorized

Halifax Visiting Dispensary \$750.00

I can find no authority for these appropriations and although these institutions may be considered worthy of support the City Council cannot in my opinion give them grants out of the general assessment without the authority of the Legislature

Comada the Stipendiary Magistrate for the City of Halifax is enabled to sentence a boy, liable to imprisonment to be detained in the Industrial School for any period not exceeding five years or less than two year, but it is provided that no such sentence shall be pronounced unless or until provision has been made by the City of Halifax out of its funds for the support of the boy so sentenced.

The City Council has for several years without any further authority, paid for the support of boys at that institution, and a number have been sent there by the Stipendiary Magistrate under the Act above mentioned.

Under this circumstance I am of opinion that the City would be liable to provide for the support of these boys now in the School and that the assessment for such a purpose would be sustained, more particularly, as section 151 of the Charter has been entirely ignored and no provision made at the City Prison for juvenile offenders.

I think, however, that no further appropriation should be made (except for the boys now in the School until the sanction of the Legislature is obtained and the Stipendiary Magistrate should be notified that the City cannot at present provide for the support of any more boys at that Institution.

Inspector of Buildings \$100.00

The Law on the subject of Inspection of Buildings is in such an anomalous position that it is doubtful if there is legally such an officer in the City.

Section 658 of the Charter provides that the City Council shall annually appoint a city architect or inspector of Buildings and fix his remuneration from time to time and it defines the duties of such officer.

By Chapter 34 of the Acts of 1872 the powers, authorities, functions and duties of certain officers including the City Architect were abolished, while Chapter 29 of the Acts of 1876 recognize the office of Inspector of buildings for the City and defines his duty with reference to dangerous buildings.

Under the circumstances, if such an officer has been appointed by the City, and has performed his duty in good faith, I think the assessment for his salary would be sustained.

Extra Assessment, Maintenance of Public Park
\$1000.00

The Act authorizing this assessment having passed before the Act of 1874 limiting the general assessment to one hundred thousand dollars a question might be raised as to the right to assess this amount in addition to that sum, but after a careful consideration of the Acts I am of opinion that this amount is in addition to the General Assessment and is properly placed in the estimate as an extra assessment. it is not in any way included among the objects for which the General Assessment is to provide and is expended by another Corporation.
