Light was discussed, and the whole previous arrangements with the  
City in re Gas Lamps and Posts talked over. finally the President of  
the Gas Co on behalf of the Directors submitted certain propositions to  
be considered by the Board and it is understood that Mr. R. Boak, Presi-  
ent, and the Chairman met on the morning of the above date and if  
practicable settle the question. Mr Boak accordingly met the Chair-  
man as arranged and the matter is again fully discussed and the  
following is finally agreed upon by Mr Boak, on behalf of the Gas  
Co. and the Chairman on behalf of the Board viz:

1<sup>st</sup> That the Gas Co. light the lamps  
keep the same clean and in good order and supply the Gas in the districts  
required to the said lamps at the same price as last year.

2<sup>nd</sup> That the compensation for the  
unused lamp-posts be at the rate of \$1<sup>75</sup>/<sub>100</sub> per post per annum.

3<sup>rd</sup> That the Gas Co will waive  
any claim they may deem themselves entitled to for a longer notice  
than they had.

4<sup>th</sup> That the Bills be paid quarterly.  
It is also agreed that the said arrangement commence on the 1<sup>st</sup> day of  
November next, and remain in force for two years from that date, with  
the exception of the compensation for the unused lamp-posts which only  
lasts for one year

The Agreement made this Twenty Fourth day of November A. D. 1885 between the City of Halifax, hereinafter called the City, of the one part, and the Nova Scotia Cotton Manufacturing Company, hereinafter called the Company of the other part.

Whereas the Company is indebted to the City for work done in extending the City Water System to the Company's Factory on Kempt Road, and other claims have been made against the Company by the City in connection with the matters hereinafter referred to which the Company disputed but all of which have for the sake of peace been settled and comprised by the Company agreeing to pay to the City the sum of One Thousand Dollars.

Now therefore it is witnessed that the City hereby in consideration of the premises and of the said sum of One Thousand Dollars the receipt whereof is hereby acknowledged doth hereby release and forever discharge the Company of and from all and all manner of claims and demands which the said City now has ever had or can or may have against the Company for any reason of any act, matter or thing whatsoever done suffered or caused or permitted to be

done or omitted to be done in upon or to in respect of the Streets, Roads & Highways which that certain branch of the Intercolonial Railway within said City and known as the Cotton siding crosses including therein so far as the Company is concerned any and all claims of any which the City has against the Company for City lands taken or used for said siding and for damages if any to lands of the City through which said siding passes.

And for the like consideration the City further agrees and undertakes not to make any claim whatsoever upon the Company nor seek to make it liable in any manner for any work or repairs now or at any time hereafter requiring to be made to or upon any streets roads or highways lying to the Eastward of Kempt Road and upon or over which said siding crosses or is placed.

Nothing herein contained shall be deemed or construed to be an admission by the Company of liability to pay for said lands or to repair said streets, roads or highways or any of them.

Nothing in this Agreement contained shall operate to release the Company from payment of any taxes or rates heretofore assessed upon it, and nothing herein contained shall be construed into an admission of liability on the part of the Company to pay such rates or taxes.

And the City hereby reserves to itself the right at any time hereafter to construct crossings over the said siding for all streets which now are or may hereafter be laid out upon the lands through which the said siding passes. The Company so far as it has or may have power agreeing that such crossings may be erected without further or any compensation to the Company. And the City further reserves to itself the right to call upon or demand from the Government of Canada or the Department of Railways and Canals compensation for any extra expense that the City may hereinafter be put to by reason of the erection of the said siding the opening up of and the erection and repairs of streets, crossings, drains sewers and other City Works and to call upon said Government or Department to perform all such additional work in connection with the same as may be caused by the existence, erection or operation of the said Cotton siding.
