Your Committee beg leave to report that at a meeting held at the Prison on the above date present Ald. Spelman and the Chairman and Ald. Cad. visitor. the following accounts were submitted by the Governor and on being examined were found correct and ordered to be recommended to the City Council for payment viz:

Your Committee would also respectfully inform you that while the expenditure of the \$900.00 borrowed under an Act of the last Session of the Legislature has made considerable improvements. yet a much larger amount will be required before the Prison and out buildings can be put in a thorough state of repair. The roof of the Prison which is shingled is in a bad condition and when renewed should be covered with slates. All the window sashes and frames in the west wing and most of those in the main building are rotten and require to be renewed. The eave gutters are a thing of the past: and as a consequence the water which falls on the roof and which should be caught and stored for use runs down the walls and finds its way in considerable quantities (through the cracks and crevices of the stone work) to the inside. much to the discomfort of the inmates and to the injury of the building. Your Committee would also call your attention to Sections 10 and 21 of the Ordinance relating to the City Prison and would say that in this respect it would be very difficult if not almost impossible to comply with the law if they were called upon to do so. Your Committee would also remind you that they are likely to be called upon to erect a system of Fire Escapes at the Prison and would suggest that a sum be placed in the Estimate or otherwise provided for this purpose.

In the matter of James A. Chipman's qualification to sit as Alderman of the City of Halifax

On the 26th day of October last the Mayor gave notice of an Aldermanic Election to be held in Ward One on the 11th day of November.

On that day an Election was held, the two candidates being James A. Chipman and John H. Barnstead. Mr. Chipman was returned as elected, and Mr. Barnstead has protested against such return and has petitioned the Council to declare his opponent's election void.

Both candidates were duly qualified to the Office of Alderman so far as statute is concerned: but neither of them had prior to the 21st of October, paid the rates and taxes due by them to the City. Mr. Chipman paid his indebtedness on the 5th of November and Mr. Barnstead on the following day.

The Statute law relating to the is as follows:- Sections 22, 67 and 69 of the City Charter passed in 1864 are as follows:- 22 In order to qualify a citizen to be eligible as Mayor or Alderman, he must be a natural born or naturalized male subject of her Majesty, of the full age of twenty one years, not attainted of treason or felony, and must in addition to every qualification necessary for a voter, be the owner in his own right of property, within the City of Halifax, real or personal, of the value of two thousand dollars beyond the amount he must justly owe.

67 Every person duly qualified who shall be appointed or elected to the office of mayor, alderman or inspector of elections, auditor or ward assessor shall accept the office, or forfeit and pay to the Treasurer of the City, to and for the use of the City a fine as follows, that is to say: for the non-acceptance of the office of Mayor, a fine of one hundred dollars; for the non-acceptance of the office of Alderman one hundred dollars; and for the non-acceptance of the office of ward assessor, a fine of forty dollars, and for the non-acceptance of the office of Auditor, a fine of twenty dollars, and for the non-acceptance of the office of inspector of elections, a fine of twenty dollars.

69 The non-payment of rates or taxes is not hereafter to be considered as an excuse or a disqualification for the office of Mayor, Alderman, or Ward Assessor.

By Section 23 of the Acts of 1871 the qualification of a voter at Civic Elections was fixed. It was necessary among other things, that he should have been assessed for rates for the year ending on the 31st of December next preceding the election and paid the same and it was provided that no payment of rates or poll tax after the 30th day of April next preceding an election, should qualify any person to vote.

By the Assessment Act of 1883 (Chapter 115) that section was repealed; and a substituted section enacted it verbatim with the exception of the proviso requiring the payment of taxes before the 30th of April.

By Chapter 42 of the Acts of 1885 the qualification of a voter was finally settled by providing in every case a voter must have paid his taxes at least thirty days before an election.

There has been no legislation since 1864 expressly affecting the qualifications of Aldermen, with the exception of Section 113 of the Assessment Act 1883 which is as follows:— Hereafter upon the nomination of any person for the office of Mayor or Alderman, before such nomination is received or considered by the City Clerk, the nomination paper shall contain an endorsement, signed by the City Collector of Taxes, to the effect that said candidate for Mayor or Alderman is not in arrears up to that date for any sum of money for City Rates or Taxes of any description.

The question then is this: Has Section 69 of the City Charter above cited been repealed. If that section is still in force it must be read in conjunction with Section 22. Effect must be given to both sections and that is done by inserting after the word "voter" in Section 22 the following words, words that the Courts consider are there, and which the Legislature has placed only a few lines further on: "except that non-payment of taxes shall not be considered a disqualification for the office of Alderman."

The effect therefore is that in order to qualify a citizen to be an Alderman it was not under the Act of 1864 necessary that he should have paid his taxes in time to have his name placed on the voter's list.

Section 113 of the Act of 1883 the only enactment that can by any process of reasoning be held to touch or affect Section 69 of the City Charter modifies it to only a limited extent and must be construed as a proviso to it.

The present Statute Law in relation to this question may then be summarized as follows:— In order to qualify a citizen to be eligible as Alderman he must in addition to every qualification for a voter (except as hereinafter provided) be the owner of \$2000.00. The non-payment of ... taxes is not hereafter to be considered as a disqualification for the office of Alderman provided however that upon the nomination of any person as Alderman seven days before election day the City Collector must certify that at that time (date) he owes the City nothing.

It must be borne in mind that Section 69 of the City Charter, above written is still in force. Any citizen may be compelled against his will to serve as Alderman. Any one citizen who has paid his taxes seven days prior to an election may pay his neighbors, nominate him as Alderman, succeed in having him elected and then if he refuses to act have him fined \$100 for such refusal.

It is questionable whether or not, even under Section 113 of the Act of 1883, payment of the candidate's taxes before or at the time of nomination is necessary. Only a certificate to that effect (true or false) is necessary; and it could with great force be argued that the Section in question is only directory and

December 15th and does not effect the question of the candidates qualification

Upon the whole I am clearly of opinion that the objection taken by Mr. Barnstead to Mr. Chipman's qualifications are wholly untenable and that he has been duly elected as an Alderman of the City. I think it proper to state that were the law such as is stated in Mr. Barnstead's protest my opinion would have been otherwise. The sections copied by him have been copied, not from the existing, but the proposed charter, and may indicate what the law ought to be, and not what it is.
