A Meeting of the License Committee held this day Present Aldermen Keefe, O'Mullin, Pearson and Taylor. the Chairman. His Honor the Recorder was also present.

1<sup>st</sup> The request of A. B. Sheraton for the unexpired term of the license granted to the premises he now occupies was carefully considered. The finding of the Committee is that the Council are not authorized to transfer a license by the previous license law, and therefore they cannot recommend any proceeding to the Council which will be in keeping with Mr. Sheraton's petition.

2<sup>nd</sup> The Committee further report as follows: Previous to the passing of the Liquor License Act of last Session a number of persons whose names appear in the Schedule annexed duly applied for licenses producing duly authenticated petitions, paying the required fee and doing everything necessary to entitle them to licenses under the then existing law. Their applications came before a meeting of the License Committee held on the third day of May last and such applications were unanimously approved by that Committee. a report recommending the adoption of such report was submitted to the City Council at a meeting held on the

4<sup>th</sup> day of May but was not then considered. In the meantime on the 11<sup>th</sup> day of May the New Act came in force. It is contended by the applicants that notwithstanding the Act, licenses should be granted to them on the ground that everything necessary to be done by them was done, and that it was solely through the City Council's delay that they are in their present position.

The Committee without committing itself to the adoption of this view are of opinion that in order to give the applicants an opportunity of asserting and establishing their alleged rights - licenses under the old law of the kind specified in the annexed Schedule should be granted to them. Such licenses however to be delivered upon the express understanding that in granting them the City incurs no liability and gives no guarantee as to their validity, a memorandum to that effect being endorsed on the licenses when delivered, and the Committee recommend the same accordingly.

Report on Application of the "Halifax Street Railway Co. Limited" for permission to lay a tramway in certain Streets of the City.

I have had several interviews with Mr G. F. De Camp, Agent for the Company and he states that he has not included in his application any of the Streets mentioned in the Charter as that document passed through the City Council and he does not consider that any further application is needed in reference to those Streets.

The charter gives the company the right to construct a single track with the necessary "turnouts" &c from Richmond through Campbell Road, Lockman, Barrington and Pleasant Streets to the foot of Inglis Street and through such other Streets in the City of Halifax as the City Council may hereafter approve on application to them for that purpose.

As Mr. De Camps application is indefinite I submit herewith a plan showing the Streets through which he proposes to lay the tramway.

It will be seen that he does not propose to adhere to the line specified in the charter but to diverge from it at Buckingham Street running down that Street to Granville Street thence along Granville to George, through George to Hollis, along Hollis to Morris, up Morris to Pleasant, through Pleasant to Inglis, up Inglis to South Park, thence northerly along South Park to Spring Garden Road down Spring Garden Road to Barrington along Barrington to George and down George to Granville where the rails will connect with the line already described.

He also wants permission to construct the following Branch lines, viz:

- 1 Along Spring Garden Road from South Park St. to Robie St.
- 2 Along Water St. from Buckingham to Campbell Road.
- 3 On Buckingham St. from Barrington to Argyle thence northerly along Argyle to Jacob, up Jacob to Brunswick, along Brunswick to Bogwell up Bogwell to Gottingen along Gottingen to Leonard and up Leonard westwardly to Robie St.

The total length of these lines is approximately 7 miles, as follows:

1 Main line from Richmond to South end and returning by way of South Park St. Spring Garden Road and Barrington St. to the point of connection at the intersection of George and Granville St. about  $4\frac{4}{10}$  miles.

freight only)  $1\frac{15}{100}$  miles.

2 Water St. Branch (intended for freight only)  $1\frac{1}{10}$  miles.

3 Leonard St. Branch  $1\frac{1}{10}$  miles.

Before any action can be taken on this application it would seem advisable that the pattern of rail to be used and the gauge of the track should be settled.

I submit herewith drawings of three different rails proposed by the company. of these No 1 seems the most objectionable for ordinary vehicles although it is the best in the interests of the company.

No 2 is the pattern which, from all I can learn, is that most in use in American Cities it should however be at least five inches in width and 45 lbs in weight per yard, and the company are willing to adhere to these dimensions if this style is adopted. I think it the least objectionable of any for use in this Country but it or any other practicable rail that has yet been devised cannot fail to be an obstruction.

obstruction and serious inconvenience to light and ordinary vehicles in our narrow and unpaved streets. Along the narrow portion of Dockman Street especially, the tramway, no matter how well it may be maintained will in all probability prove unsatisfactory to persons who own or use carriages and light wagons of any description.

No 3. rail is that proposed for curves and its adoption is almost compulsory as scarcely any other style will answer the purpose.

With regard to the route sketched out for the main line I would think it preferable and in the interests both of the City and the Company if it were laid along Barrington and Pleasant Streets as provided for under the Act instead of diverging into Granville and Hollis Sts.

As to the gauge of the track, if it is intended that ordinary vehicles are to run upon the rails the gauge of 4'- 8 1/2" will not answer. From a number of measurements taken I find that the average gauge of country wagons, ordinary carriages and box carts is from 4'- 10" to 4'- 11" from outside to outside of the wheels. The gauge of the road should therefore, in order to accommodate these vehicles be fixed at say 5 feet.

Omnibusses and flat wagons measure over the wheels from 6 feet to 6 feet 3 inches so that it will not be practicable to adopt a gauge for their accommodation.

Mr. De Camp also asks permission to erect on the sidewalks suitable light structures for waiting rooms, but as no designs have been submitted and he has not mentioned the exact localities where it is proposed to place them it does not appear advisable at present to commit either the Council or the Board to granting the request. If the structures are practically nothing more than awnings extending over the sidewalks with perhaps seats arranged along the street line no reasonable objection can be raised against them, but designs should first be submitted and the localities approved of.
