Power, B. W. Chipman, W. J. Veith, and Herbert Harris, being present, it was decided not to read the minutes of last meeting until those gentlemen had addressed the Council on the subject of the proposed exhibition.

The letter from Professor George Lawson, Secretary of the Halifax County Agricultural Society was read and also an extract from Minutes of meeting of said Society, held on the 23rd December, 1890.

Motion passed.

His Worship the Mayor read and handed in a note from Alderman Mackintosh in reference to his illness, and asking that another alderman be placed on the committee appointed to alter and amend the Building Act instead of himself, as he would not be able for some time to attend.

The Mayor then nominated Alderman Hamilton, which nomination was confirmed.

Council take up the Order of the Day.

Alderman Lyons' notice of re-consideration of last meeting on cause 5 of the report of the Committee on Laws and Privileges.

Read minutes as entered at last meeting.

Moved by Alderman Lyons, seconded by Alderman Mosher, that the same be re-considered. Motion put and pa-sed.

Resolved, That if the Provincial Government decide to give the Annual Grant of \$4,000 to the City of Halifax in aid of the Provincial Exhibition to be held in 1891, That this Council grant the sum of \$3,000 to aid the same, said sum to be assessed for under the Act of 1879.

Further resolved, That this Council appoint a Committee of three to co-operate with the Committee of the Agricultural Society, in any way they may deem advisable. Moved by Alderman Foster, seconded by Alderman Lyons, to which the following amendment is introduced.

Resolved, That the sum of \$3000 which the Council is authorised to give toward the holding a Provincial Exhibition at Halifax, be given towards the Provincial Exhibition of 1891, provided it is held at Halifax, and further that the sum of \$2000 more be tendered the Halifax County Agricultural Society, to be used in meeting repairs to buildings and any deficit that may arise, and a committee to be appointed by the Council, and an Act be procured to legalize the same. Moved by Alderman Hamilton, seconded by Alderman Sweet, which amendment on being put was passed, and the names being called for appeared thus:

Gentlemen,—We wish to call your attention to a nuisance caused by a drain running from the Distillery at Freshwater, and running through the south end of the Esplanade, the smell from which is not only dangerous to the health of the persons passing along Pleasant Street, but which we have found impossible to keep out of our houses, although the drains are properly tapped and ventilated; as during the time the Distillery is shut down in summer there is never the least unpleasant smell. It is quite evident it must be caused by the Distillery.

Should matters remain as at present we feel confident that it will be cause of sickness in the neighbourhood.

PROPOSED PAVEMENT BARRINGTON STREET.

CITY ENGINEER'S OFFICE,

19th Dec., 1890.

To His Worship the Mayor and City Council:

GENTLEMEN,—In compliance with your resolution of the 16th Dec., requesting a report as to the best material, in my opinion, with which to pave Barrington Street, I beg to say that I consider a stone block pavement the most suitable for such a thoroughfare. As you have decided to order 16,000 square yards of stone blocks,—one-half of Shelburne granite, and half of Belgian porphyry,—I would suggest that to whatever extent you may think fit to pave Barrington Street next year, the granite blocks be used on one portion, and the porphyry blocks on another, so that their comparative merits may be noted. If, however, Water Street is to be paved, it would be preferable to distribute the blocks about equally on that thoroughfare as the amount of traffic is much greater than on Barrington Street.

PAVING MATERIAL.

CITY ENGINEER'S OFFICE, 18th Dec., 1890.

His Worship the Mayor and City Council:

Gentlemen,—As required by your resolution of the 16th calling for a report from me on the quality of material submitted, with tenders for Street Paving, with my opinion as to which is the cheapest and most desirable and advisable in the interests of the public to purchase. I have the honor to state that with the exception of some of the samples submitted by Mr. Ellis, all different specimens of the granite blocks appear to be of excellent quality and suitable for the work. Mr. Redmond's samples are however, too roughly cut and would consequently form a very uneven pavement.

The blocks of manfactured Scorice submitted are exceedingly hard and appear to be good cut. I have not seen them in use and I am not sufficiently acquainted with their wearing qualities to express an opinion regarding them.

The testimonials submitted are however of a high class, and the material is recommended by the authorities in English towns where it has been in use for some years.

The sample blocks of Belgium Porphyry sent in appear to be admirably adapted for Street Paving, and the fact that this material is very largely used in many European cities is probably the best evidence that could be got that it is a good and suitable stone to use. The only objection to its adoption appears to be that the material is quarried and manufacturad into blocks abroad. As the assertion was made that the stone would after a time wear very slippery. I wrote to several cities in America for information on the subject, with the following results, viz:

In Boston no such a pavement is in use. The Commissioner of Public Works in New York, also states that there are none in use in that city, and further states that so far as known to him or his engineers, none are in use in other cities in the United States. I believe however that this is a mistake, as I am informed it has been used in New Orleans for many years.

The City Surveyor of Montreal writes that it has been in use in that city for the past two or three years between the tracks of the street railway, and referring to its wearing smooth, he says: "I see no appearance of the blocks having worn at all. I have seen porphyry used very extensively in Belgium and I consider it to be the finest stone of any for paving blocks, even more so than granite, the granite as you know wears smooth."

Regarding the question of cost, Redmond's tender is the lowest, but his blocks are unsuitable for the reason already given, and his tender is not in conformity with the terms of the specification. Henry Sorette's tender stands second, and would amount to \$28,000 on the whole order. The Scorice Paving Block Co. stands third, but the tender, like Redmond's, does not conform with the requirements of the specification. Mr. DeSola's tender for Belgian Porphyry Blocks comes fourth, being \$33,280 or \$5,280 in excess of Sorette.

This difference would, however, be largely, if not wholly, eliminated in the saving effected in laying the Belgian blocks on account of their greater uniformity.

As to which offer would be most advisable to be accepted in the interests of the public, I have no doubt that under the circumstances the decision already reached by your council, viz: to purchase half from Mr. Sorette and half from the Belgium Syndicate, is probably as wise and judicious a conclusion as could have been arrived at. It is not possible to make any decided statement as to the comparative merits of granite and porphyry until each has been actually tried in practical use, under somewhat similar conditions, for a period of years, or without personally inspecting and carefully examining pavements of the same kind in cities where they are in general use.

I should, perhaps, have added that Mr. DeSola makes it conditional that his offer is subject to an advance of 5 per cent. if delivery is delayed after April next, which would amount to the sum of \$822 on the order proposed to be given him.

LIQUOR LICENSE ACT, 1886.

Gentlemen,—I herewith forward you three applications for liquor license for Ward No. 1. These applicants are fit and proper persons to have a license, and are of good character and reputation, and the licenses are required in the ward for the public convenience.

His Honor the Recorder reads his opinion.

In γe signers of certificates under the Liquor License Act of 1886, and its amendments.

The question as to who are entitled to sign liquor certificates under the liquor license Act of 1886, and its amendments, having been raised, I desire for the information of the Council to report thereon. In order to clearly understand that question, I ask the careful attention of the Council to the Liquor License Act of 1886, before any amendments were made. The various polling sections of the city in each ward as established by law for the election of members to serve in the House of Assembly were to be taken as the licensing district, and a ratepayer was described by that act as a person rated for the time being in respect of any real or personal property, or qualified to vote for a candidate to serve in the provincial assembly. For these polling districts an electoral list containing the names of those who were entitled to vote in that section of the ward was made up under the law, and there was also a list of those rated on real and personal property. From these two lists the petitioner under section 10 had to obtain three-fifths of the ratepayers of the polling or licensing district in which the premises sought to be licensed are situated. It will be observed this last section, if there is no other qualifying it, would refer to ALL ratepayers whether resident or non-resident in the polling district. In the original act of 1886, there is no clause stating in EXPRESS TERMS that the ratepayer shall be a resident within the polling district. But by section 12 of that Act, the genuineness of the signature to such certificate, together with the qualification of the ratepayer and their residence WITHIN the polling district, shall be established on oath to the satisfaction of the chief inspector, and if the petitioner fails to prove either of these things, then under Sec. 20, Subsec 7, and Sec. 25, Sub-sec. 2, he cannot obtain a license. So that if he fail to prove to the satisfaction of the Inspector that he RESIDED in the licensing district, but proved he did not so reside, then his name must be struck off the petition as he had not complied with the Act; clearly shewing that the petitioner must get three-fifths of the ratepavers RESIDENT in the polling district. This has been the practice pursued by the Inspector for some years past. It is gratifying to know that another legal gentleman, of responsible position, held this view in a letter to the press of this city when he thought the Inspector was acting on a different principle.

But it is contended, Sec. 12 of the acts of 1886 is repealed by Sec. 2, Chap. 4. of the acts of 1888. There is no act or clause of any act in express terms repealing Sec. 12 of the acts of 1886, and if it is repealed it is because the two sections are diametrically opposed and cannot stand together.

As I have already pointed out Sec. 12 of 1886 act, required the party signing to reside within the polling district, and Sec. 2 of Chap. 4 of the acts of 1888 says: No ratepayer who resides in any licensed district in the province shall sign any certificate to accompany an application for a license for any premises not within the polling dis-

trict in which he *resides* if resident in the City of Halifax, and provided that "any ratepayer NOT resident in any licensing district may sign a certificate to accompany an application for license for any premises within any license district in which he is rated on real or personal property." The City of Halifax is a license district, and this last portion of the section gave the right to any person residing OUT of the city or in any part of the world to sign a license certificate in any district in the city, provided he is assessed in that section.

This section provides in express terms that persons in the city must reside in the polling district for which the certificate is given, and confers a new right on persons residing outside of the city to sign certificates. But how does the former portion of this section repeal Sec. 12 of the act of 1886, which requires the petitioner to prove to the satisfaction of the inspector that he DOES reside in the district? It is contended that it is repealed by implication only. I have already pointed out there is no clause in any act repealing in express terms this Sec. 12, and such repeals are not favored, and the principle of implied repeals ought to be applied with extreme caution. Every affirmative statute is a repeal of a precedent affirmative statute, where its matter necessarily implies a negative, but only so far as it is clearly and indisputably contradictory and contrary to the former act in the very matter, and the repugnancy such that all parts of it cannot be reconciled. Under any circumstances it cannot be said that that portion of Sec. 12 of the act of 1886, which requires the signatures to be proved to the satisfaction of the inspector is repealed. Both sections have one and the same object, and the section in the 1888 act only states in express terms that the ratepayer shall reside in the polling district, and Sec. 12 of the acts of 1886 says that he must prove to the satisfaction of the inspector that he does reside in the district, and if he fails to do this he cannot obtain his license—one was only the affirmative of the other and both relate to the same subject matter, i. e., that the person residing must reside in the polling district when he is a citizen. They are not inconsistent and both can be read together. But it may be said that the latter part of the 1888 act, which gives new rights to those who reside OUTSIDE of the city to sign a certificate for a license district IN the city where rated affects section 12. But it will be seen that section 12 of 1886 and section 2 of the acts of 1888, refer to citizens only; and the latter part of the same section refers to and confers a new right on those outside the city, but this does not destroy the right in the class mentioned in sec-I am of the opinion that these two sections stand tion 12. together, and I am the more persuaded in this view from the additional fact that there is not to be found in the act of 1888 a clause repealing all acts and clauses of acts inconsistent with that act. This fact ought to be taken as a strong indication that it was not intended to repeal section 12 of the acts of 1886. Then came chapter 18, section 6, of the acts of 1890, repealing in express terms

section 2, chapter 4, of the acts of 1888, and it is contended this last section being repealed it also repealed section 12 of the acts of 1886, as the 1888 act was inconsistent with the acts of 1886. I am aware of the clause in the statute which says no act nor any portion of an act that shall have been repealed shall be revived except by express enactment. Suppose that the act of 1888 repealed section 12 of the acts of 1886. Even then it might be fairly questioned whether our statute would apply, as it has been decided that a similar clause in the English statute only referred to express repeal, but did not affect a statute repealed by implication, and that the old common law doctrine was in force as regards implied repeals, viz., where a subsequent clause implied repeals a clause in an earlier act, and by it in turn is repealed, the original clause revives in full force. If section 2 of the 1888 act did not repeal section 12 of the act of 1886 by implication, the repeal of the former section by the act of 1889 could not operate as a repeal of it, and is consistent with, and can be worked under the act of 1890.

But there is another question behind this of some importance, as I have already pointed out; by the act of 1886 the various polling districts in each ward were made licensed districts, and an electoral list was provided for that district and while the act so remained there was no difficulty in requiring the petitioner to get the three-fifths of the ratepayers of that district on that list. Section 2, chapter 18, of the acts of 1890, repealed the old definition of rate-Now it means in the City of Halifax, "all persons and paver. such persons only whose names appear on some or one of the corrected lists of voters prepared by the city collector for the use of presiding officers at the last previous regular civic election," and it is those persons only who can sign. There is no longer an authorised list for each of the polling districts, but one for the whole ward, and unless section 12 of the act of 1886 is still in force every man on the list in Ward 5 has the right to sign a certificate for each of the nine polling districts in that ward, no matter if he resides in or out of the ward. If the polling district list is destroyed how can you get the three-fifths of the ratepayers of the polling district when there is no list for that district to get from? It could never be the intention that the petitioner should get three-fifths of the ratepayers of the ward, nor in my judgment three-fifths of the residents or non-residents of the polling district, for that is the only other way of compelling him to get three-fifths of the whole ward. In each case it would amount to prohibition.

There are other very grave and serious phases of the last amendment which I might discuss, but it is unnecessary, as in my view taking either construction the course pursued by the inspector is correct.
In conclusion, permit me to draw the attention of the Council to the amendment of the certificate made by the act of 1890. The original certificate said "we have hereunto appended our names and the distance approximately at which we respectively reside," and that clause has not been touched or altered in any way, and I consider this another reason for construing the act, that the party must reside in the polling district, and non-residents are not entitled to sign liquor license petitions.

Whereas, Diphtheria and other infectious and contagious diseases exist within the city to a great extent, and it has been deemed expedient to strengthen the hands of the City Medical Officer by the appointment of an Assistant, to whom has been assigned the cases of Diphtheria in City Hospital, (in connection with other sanitary matters) in which institution there are a number of patients at the present time requiring constant medical attention; and

Whereas, The time for which the Assistant Medical Officer was appointed expires in a few days;

Therefore Resolved, That the Assistant City Medical Officer's services be retained, and that he be continued in office as Assistant Medical Officer from the expiration of his present appointment until the first of May next. Moved by Alderman Pickering.

Read opinion from His Honor the Recorder on Rule 24 of Rules of Council:

HALIFAX, N. S., January 21st, 1890.

In Re construction Rule 24.

I have been requested to place in writing the proper construction of and the practice that should be followed under Rule 24.

Previous to the new rules, when a notice of reconsideration was given, the practice of the Council was for the Alderman giving the notice to move the reconsideration when the original resolution was

reached on the minutes. This practice was found very inconvenient, as the reading of the minutes could not be proceeded with until the motion for reconsideration was disposed of either by a motion or by the Alderman not moving in the matter, in which case the motion for reconsideration dropped and the reading of the minutes proceeded with.

When the new rules were drawn up it was considered that the best plan was to finish the reading of the minutes and place the motion first on the order of the day, and thereby have the matter considered immediately after the reading of the minutes, unless the usual motion to suspend the order to read the papers handed in was made, and after they were read it would be first reached on the order paper. It will be thus seen that the old practice still prevails, except as to the time when it is to be taken up, and when the question is reached on the order paper at next meeting the Alderman giving the notice must move it, and if he fails to do so the notice drops and cannot be put on the order paper. The practice under the rules of the Council as to notice to reconsider and a notice of motion of a resolution to rescind a previous motion is entirely different.

The ruling of His Worship the Mayor in this matter was, in my judgment, correct, and in accordance with the rules and practice of the Council.
