PROPOSED SEWER, KEMPT ROAD.

The petition does not clearly define the locality where the Sewer is wanted, but it may be presumed that it is intended to embrace the whole distance from North Street to Macara Street, about 1950 feet.

The southern portion (450 feet) would discharge into the proposed Sewer on Robie Street, which has already been ordered. The remainder would have to be provided with a proper outlet, and the best position for the outlet would apparently be through Bilby Street from Kempt Road to Agricola Street, where there is at present an old stone sewer, which is too shallow to be utilized. The old sewer in this locality will therefore have to be abandoned and a new one substituted at a greater depth for a length of about 450 feet. The sizes of the sewers required, are marked; on the general plan of sewerage. The total estimated cost of the new sewers referred to above is \$10,000, and the sewerage rates will amount to about \$5170.00.
