And further agree to indemnify and save harmless the City of Halifax, the Board of Commissioners of City Works and any and all of the officials of said City from all suits and actions of every name or description brought against the said City of Halifax or the said Board of Commissioners of City Works or any officer of said City for or on account of any injuries, loss or damages received or sustained by any person in consequence of any deficiency in any of its sewers, either in grade, size, workmanship or any other particulars, or for any back flowage of water or sewerage.

CONDITIONS.

1. In opening any street or public way, all material for paving or ballasting must be removed with the least possible injury or loss of

the same, and, together with the excavated materials from the trenches, must be placed where they will cause the least practicable inconvenience to the public. As little as possible of the trench must be dug until the junction piece into the sewer is found. Where a junction has been provided by the city for any lot, building, or premises, the drain must be connected at such junction, and such information as the City Engineer has, with regard to the position of junctions, will be furnished to drain layers, but at their risk as to the accuracy of the same.

2. In case it shall be necessary to connect a drain pipe with a public sewer, where no junction is left in such sewer, the new connection with such sewer can only be made either by one of the employees of the Board of City Works, or when the City Engineer or his authorized inspector is present to see the work done.

3. Immediately before any opening is made into any sewer, notice must be given at the City Engineer's Office, so that the work may be superintended and approved by the proper officer, and *under no pretext* shall any portion of the drain be covered until examined and approved by such officer.

4. The whole of the work is subject to the inspection and approval of the proper officer appointed for that purpose, and any work not approved by him must be taken up at once, and done to his entire satisfaction.

5. The street must not be broken up for more than half its width at a time.

6. The drain-pipe will not be permitted to be laid nearer than eighteen inches from any water pipe.

7. The pipes must be good, sound socket drain-pipes, of the best material and workmanship, salt glazed, well burnt, truly circular, and of full diameter throughout. The pipes to be not less than two feet in length, and of such thickness and diameter as the City Engineer may direct; all joints to be securely and completely bedded and covered in good hydraulic cement mortar, so as to prevent the escape of water, sewage, or gas. Mortar to consist of one part hydraulic cement and two parts clean sharp sand. Sand and cement to be mixed dry, and to be wetted up only in small quantities as used. No tempered up cement to be used.

8. The trench is to be excavated in each case at least one foot wider than the diamenter of the pipe. The whole lenght of the trench is to be excavated to the proper depth before any pipes will be premitted to be laid. The bottom of the trench is to be hollowed out to the correct form and size of the pipe, and is to be indented at the sockets so as to admit of the surface of the pipes having an even bearing throughout their whole length. The material excavated shall be piled compactly at the side of the trench, and where the ground is newly made on very wet soil, the drain will be laid on a prepared foundation of plank or concrete. Drain to be laid with perfect align-

o

ment and deviations from straight run to be made with special curves. Back filling to be first hand packed with care, and then well rammed to prevent the slightest settling of the drain.

9. When called for by the City Engineer the applicant will stop up all openings in the drain and fill up to the highest point with water, allowing it to stand full, and any defects which may be discovered, shall be made satisfactory within two days from notice being given of the same.

urhe 10. Where the house drain has less than eighteen inches of covering, it must be made of cast iron, and must be calked with oakum and lead.

11. When any change of direction is made in the pipe, either in horizontal or vertical direction, curves and ys must be used. No pipe can be clipped in any case.

12. All persons are required to place an effectual hand hole cleaning trap of same material and size as drain in the line of drain just before it leaves the premises.

13. Whenever, in the opinion of the City Engineer, the sides of the trenches will cave, sheeting and braces must be used to prevent caving.

14. The City Engineer is to have at all times facilities for inspecting the work and materials while under the charge of the drain layer, and, if required, no pipes or other materials for the drains can be used till they have been examined and approved.

15. The least inclination that can be allowed for water closet kitchen, and all other drains of not over six inches diameter, liable to receive solid substances, is one-half an inch in two feet, and for cellar or other drains, to receive water only, one quarter of an inch in two feet. The depth of the crown of a drain at the curb line shall be determined by a rise of a quarter of an inch per foot from the crown of the sewer directly opposite.

16. The ends of all pipes, not to be immediately connected with, are to be securely stopped by brick and cement, or other water-tight and imperishable materials.

17. All pipes that must be left open to drain cellars, areas, yards or gardens, must be connected with suitable catch basins, the bottoms of which must not be less than two and one-half feet below the bottom of the outlet pipe, the size, form and construction of which are to be prescribed by the officers named in the second rule. When meat-packing houses, slaughter-houses, lard-rendering establishments, hotels or eating-houses, are connected with the sewers, the dimensions of the catch basins will be required to be of a size according to the circumstances of the case. When the end of the drain pipe is connected with a temporary wooden catch-basin, for draining foundations during the erection of buildings, the drain-layer will be held responsible for dirt sand getting into the drain or sewer from such temporary catch-basin. 18. No private catch basin can be built in the public street, but must be placed inside of the line of the lot to be drained, except when the sidewalks are excavated and used as cellars.

19. The inside of every drain, after it is laid, must be left smooth and perfectly clean throughout its entire length; and to insure the same a scraper of suitable material, of the shape of the pipe, and slightly less in diameter, shall be drawn through each length of pipe after the same has been laid.

- 20. After the pipes have been laid truly in line on an even grade throughout the whole length, the excavated earth is to be filled in in layers. The first layer shall be six inches in depth and the subsequent layers twelve inches in depth, rammed and tramped to the satisfaction of the Engineer; if required, water shall be used at the expense of the owner, but only in such quantities as may be approved by the City Engineer.

21. The back-filling over drains, after they are laid, together with the replacing of ballast and paving, must be done within forty-eight hours after the completion of that part of the drain lying within the public way, and done so as to make them at least as good as they were defore they were disturbed, and to the satisfaction of the City Engineer, and the owners will be held responsible for any settlement of the ground which occurs within three months on account of laying said drain. All water and gas pipes must be protected from injury or settling, to the satisfaction of the engineer.

22. In removing sidewalk paving and gutters, the stone, brick, sand, gravel, or whatever other material may have to be passed or penetrated, must be removed and replaced in precisely the same condition in which it was found, leaving the street and sidewalk in perfect repair; the same to be so maintained for a period of three months, to the satisfaction of the City Engineer.

23. Every drain-layer must enclose any opening which he may make in the public streets or ways, with sufficient barriers, and must maintain lights at the same at night, and must take all other necessary precautions to guard the public effectually against all accidents from the beginning to the end of the work; and can only lay drains on condition that he shall use every precaution against accidents to persons, horses, vehicles, or property of any kind.

24. Should any of the pipes belonging to the City water works or the Halifax Gas Company be disturbed so as to cause the slightest danger, or any of the earth or stones beneath said pipes be removed, notice of the same must be given at their respective offices, and they shall have the power to make up the soil immediately beneath their own pipes, and of making good any damage to their property at your expense, which expense must be paid immediately after such work is performed.

25. Whenever it is necessary to disturb a drain in actual use it must in no case be obstructed without the special direction of the City Engineer.

26. In case a water or gas pipe should come in the way of a drain, the question of raising or lowering it, must be determined by the City Engineer.

27. All exhausts from Steam Engines, and all blow-offs from steam boilers, must be first connected with a catch basin of such dimensions as the City Engineer may prescribe, and in no case will they be allowed to connect directly with the private or public sewers without special permission from the City Engineer.

28. The drain layer shall faithfully observe all the rules for laying drains, as adopted by the City Health Board and shall not cover any of his work until it has been examined and accepted by the proper officer of the City.

29. All work shall be done in such a manner and at such times as to interfere as little as possible with the public travel and convenience; and the drain layer shall conduct his work for this object, as the Engineer may from time to time direct.

30. Should any of the terms or above conditions be neglected, this permit shall become null and void, and the applicant shall be fined as the law directs, and also the work may be executed by order nnder the direction of the Board of Works, the expense of which shall be paid by the applicant immediately upon completion.

No person shall be given or granted a permit to open, dig, build 9. or make any drain from any house or premises through, in or upon any of the streets of the City of Halifax, until the owner of said house or premises, shall first deposit the sum of five dollars with the City Engineer, who shall retain the same as a guarantee that the owner of said house and premises will properly fill up said drain, and keep the surface of said drain in proper condition and on a level with the street. In case at any time after said drain is filled up the City Engineer thinks the surface of said drain is unsafe or uneven with the street, he shall without notice to the said owner repair and keep in repair for the space of three months the surface of said drain in case the owner neglects to so do, and the decision of the engineer as to the necessity for such repairs shall be final, and conclusive and any repairs so made by said engineer, shall be deducted by him from the amount so deposited, and the balance if any shall be returned to said owner at the end of said three months. Any person who opens, digs or builds, or attempts to open, dig or build any such drain without first depositing said sum, and complying with any other law ordinance or resolution of the City Council, shall forfeit a sum not exceeding one hundred dollars, and in default of immediate payment he shall be imprisoned in the City Prison, for a period not exceeding thirty days.

Sir,—Agreeably to a resolution of your Honorable Board, I beg to submit herewith a plan, showing the proposed extension of North Starr Street.

J. Kaye and L. Kaye, who own the frontage on Young Street, 60 feet, the frontage on Kaye Street, 60 feet (north side,) and 40 feet (south side,) will give a deed for \$800. John Ryan, who ownes 20 feet frontage on Kaye Street, askes \$400, on the ground that it spoils a building lot. I think his price is high. The estate of P. Power, owning the frontage on Russell Street, asks \$480.

These prices will not stand for any length of time, and if the land is not secured at once, buildings may be erected, and in any case the expense will be much greater. It is an absolute necessity, in order to complete our distribution with any new service. It is not only necessary in connection with the new drain, but if a supply was brought in from Birch Cove Lakes, or any new service, a line of pipe on this part of the hill would be necessary to give the best distribution north of North Street. If not taken over now it must be at some time in the future, at far greater expense, or ten times the amount may perhaps have to be spent for extra distribution. We can supply North Starr Street, and the district below it, from the low service, when the new main is put in, and thus relieve the high service.

I would strongly recommend that the proposed extension be made at once, and steps be taken to buy or expropriate the land required.

Sir,—The accompanying petition of property owners on Belle Aire Terrace, having been referred to me for report, I beg to submit the following:

Belle Aire Terrace is only about 30 feet wide. If it were not a new street I would not recommend water extension. There is, however, 360 feet of main pipe laid already, and 254 feet of brick sewer. There are 5 houses to be supplied, which would require an extension of 300 feet Jas. Brown, one of the petitioners, has no houses on his property, and the 300 feet would not supply his premises. The

pipe already laid is 4", but it would be advisable to put down 6" in extending the main with the intention of connecting eventually at Ontario Street, and placing a hydrant half-way between North Street and Ontario Street.

The distance from the end of the present pipe to the main on Ontario Street is about 500 feet. The whole extension would cost about \$800, not including hydrant.

I would recommend an extension of 300 ft. provided the petitioners give a bond for the interest on the outlay.

main to the west side of petitioner's property is 200 feet. There is only one house yet erected. The extension is on the low service and the excavation will be in clay. Size of pipe, 6 inches.

The revenue from the three houses, to be built, cannot be estimated until the cost is known.

I would recommend that no extension be made until the other houses are erected unless a bond be given for the interest on the outlay.
