SIR,-In accordance with the accompanying extract from Minutes of Council, I beg to report on the letter from the N. S. Telephone Co., Ltd., asking permission to erect a pole on the east side of Pleasant Street, opposite the south corner of the Academy of Music, in the concrete sidewalk.

2nd. That the accoutrements and uniforms be furnished to the Halifax Academy Company needing the same. 3rd. That a small amount be set aside for the purchase of medals and other

suitable prizes for boys who show the greatest improvements in military gymnas-

tics, and also in military drill in order to arouse and keep up an interest in these studies. 4th. That a special committee of the School Board be appointed to carry out

4th. That a special committee of the School Board be appointed to carry out these details.

The yearly expenditure not to exceed the income from the fund.

MILL OWNERS' CLAIMS.

Read report of City Engineer re Mill Owners' Claims :

October 19th, 1892.

#### To His Worship the Mayor :

SIR,—The Claims of the Mill Owners' along the stream running from the lower Chain Lake to the Arm has never been settled, and this matter is a very important one at present. When the New Main is laid to the north-end the consumption will be greatly increased. While the supply is more than equal to the demand in ordinary years, we must provide for every possibility. In the years of minimum rain fall the supply of water is about equal to the consumption notwithstanding the statements of some citizens that an enormous amount of water ran to waste over the Long Lake dam. This statement was made through ignorance, not through to any knowledge of the facts. It is a fact that cannot be disputed that with the two mains, the time will come in the near future when all the water available from the watershed of the Long Lake will be required for the supply low service system. Such being the case, the amount of water run off to satisfy the mill owners' claims becomes a very serious matter, and it should be settled now, once, and forever.

We must admit that the mill owners have a claim to the natural flow of the Chain Lake, and having that claim, the City cannot entirely shut off the water without some compensation to the persons interested.

There may be some dispute about the rights of the mill owners and property owners along the stream, but that they have some rights cannot be disputed. The City lets down a large amount of water yearly to satisfy their claims, and the time has arrived when it would be advisable to stop this waste entirely. The rights of the property owners along the stream can never be obtained more cheaply than they can to-day. If other mills or factories should be erected along the stream, the

cost to the City of acquiring the water rights would be largely increased. In my opinion expropriation is the only way to settle the difficulty, and I would respectfully recommend that all rights to the stream of water flowing from the Chain Lake, whatever they may be, should be expropriated by the City; and as it has been found impossible to effect any arrangement or agreement with the property owners, I would recommend that an arbitrator be appointed by the City and that the property owners be asked to appoint another. The third arbitrator to be appointed as the law provides, and an award to be made. The city will save money in the building of the dam by having the water shut off, and will save the amount of water run down annually to the N. W. Arm, and the possibility of tedious and expensive lawsuits will be prevented. If the difficulty is settled now, the water supply problem, so far as the present source of supply is concerned, will be finally solved, and I would respectfully urge that the rights of the property owners be acquired before any further work is done to improve the low service system.

## CURBS AND GUTTERS, SPRING GARDEN ROAD.

#### His Worship the Mayor:

Sm,-In accordance with the accompanying resolution of the Council, I beg to submit the following report :

Spring Garden Road is certainly one of the main thoroughfares of the city, and the construction of the Street Railway track has practically made it narrower for traffic. The old cobble stone gutters, never an ornament even when new, are now in a dilapidated condition from the effects of frost. This street, leading as it does to the Gardens and Exhibition Building, and followed by strangers going to or returning from the Park, should be in the condition that-would reflect credit on the city instead of as at present tending to confirm the reputation Halifax has unfortunately set up for bad streets and sidewalks. I have already expressed the opinion that the Permanent Pavement Fund was intended for the improvement of the principal streets of the city, and I think Spring Garden Road comes under this head. This street probably ranks next in importance to the principal business streets in the centre of the city, and the improvement suggested in the resolution would be much appreciated.

I would respectfully recommend that granite curbs and gutters be laid on both sides of the street where required from Pleasant Street to South Park Street.

#### AGRICOLA STREET EXTENSION.

#### Chairman Board of City Works:

SIR,—In accordance with the accompanying Extract of Minutes of Council, I beg to report on the petition of the Halifax Land Co. and the property owners in the neighbourhood of the proposed extension of Agricola Street. As stated in the petition of the residents of the district affected by the proposed improvement, a great many advantages would accrue to the city and to those having occasion to use the street. The city is directly interested in the extension of this street, and it would decrease the cost of hauling broken stone from Merkel's field. At present the stone is hauled from the crusher through a lane to Gottingen Street. The owners of Merkel's field have sold a lot including part of this lane, and the present owner is fencing in his land and shutting up the lane. It would therefore be necessary for teams hauling broken stone to go north to Duffus Street and come around to Gottingen Street, increasing the length of haul and therefore increasing the cost of broken stone delivered on the streets. If Agricola Street was extended through Merkel's field, through the Hennessey property to Young Street, a direct outlet would be afforded for teams hauling stone for the city. It is most desirable that the stone purchased from the owners of Merkel's field should be used up as far as possible, and for this purpose it will be necessary to keep the land now covered by the crusher and the stone pile for some time to come. The extension of this street must necessarily increase the value of the property affected. The owners of Merkel's field are very anxious that the improvement should be made. Should the city expropriate the land necessary to carry out the improvement, the owners of Merkel's field could fairly be asked to contribute in cash, but the city should at least have the use of the land free of charge for about three years, and no further charge should be made for stone. If the extension is continued through to Macara Street, it will open up an avenue from Point Pleasant Park to Lady Hammond koad, the advantage of which need not be stated here. In a former report made on this subject I gave the value placed on property by the owners, their demand is exorbitant, and I would respectfully recommend that before any further action is taken in this matter, appraisers be appointed to value the land that would be taken, making every allowance for the improvement of the land on each side of the extension. If the result of the appraisement is satisfactory, I would strongly recommend that the land required for a street 100 feet wide from Merkel's field to Young Strset be expropriated, and that the extension asked for by the petitioners be carried out.

#### WAR DEPARTMENT SIDEWALKS.

#### Chairman Board of City Works:

Sir,—In accordance with the resolution of Council, dated 20th July, 1892, I corresponded with Col. Hill, C. R. E., for the purpose of ascertaining if the Imperial Authorities would contribute towards the cost of constructing and maintaining sidewalks in front of their property. Col. Hill replied, saying that he could only speak for that portion of Imperial

Col. Hill replied, saying that he could only speak for that portion of Imperial Government property controlled by the War Department. Seperate communications would have to be addressed to the Naval Authorities. The resolution of Council covered roadways as well as sidewalks. I was under the impression that the resolution referred to sidewalks only and that it was not the intention of the Council to ask the War Depaatment to contribute towards the maintenance of the streets. I explained the matter to Colonel Hill and asked for an answer. Attached hereto is a copy of his reply. He declines to give an answer under the present circumstances, and intimates that when the War Department was asked to contribute towards the cost of construction and maintenance of any particular sidewalk, the matter would be laid before the War Office for consideration. As the correspondence with Col. Hill was not encouraging, I have not communicated with the Naval Authorities in reference to the land controlled by them If it is the intention of the Council to press the matter further, I will communicate at once with the Naval Authorities. In the mean time I await further instructions.

SIR,- In reply to your letter of 28th ult., to Major Maycock, I beg to state that I fail to see that the previous correspondence has been misunderstood.

The extract from Minutes of City Council, dated 27, '92, asking that the Imperial authorities should contribute a fair quota of the cost of constructing and maintaining the sidewalks and roadways in front of said Imperial property.

In your letter of the 28th ult, you admit that there are only one or two sidewalks in front of War Department land. Judging from the extraordinary delay that has taken place in laying the brick sidewalk outside the Gun Wharf, (for which the War Department provided material), it does not appear probable that more of the permanent material sidewalks are likely to be made within any near period. It seems, therefore, useless to open up the question as a whole. On receipt of intimation that the city authorities really intend to lay down within a reasonable specified time any definite length of sidewalk, with permanent materials, in front of War Department land, the General Officer Commanding is prepared to lay the question of pecuniary assistance from Imperial funds, before the War Office.

## Chairman Board of City Works:

SIR,—The accompanying petition for Sewer on Hollis Street, between George Street and Sackville Street, having been referred to me, I beg to report—

The sidewalk on both sides of the street, between George Street and Prince Street, except that at the Post Office requires renewal. There is nothing to pre-vent the work being done on the west side at once. On the lower side of the street, however, it would be advisable to have sewer connections made before a permanent sidewalk is laid. There is no drain at all in the street at present, and I would recommend that this sewer be placed on the Order Book to be constructed Twould recommend that this sewer be placed on the Order Book to be constructed early in the next season. Having proceeded to the sugar refinery and on examination of the boiler and engines, and having raised steam and started the engines, time 8 min 12 sec, with cold water, boiler,  $\frac{3}{4}$  full, average steam 80°, 90° presure started with 60 lbs. steam, having completed all the tests submitted by the Board perpendicular and horizantally during the tests, no heating, quite cool.

#### QUEEN'S WHARF, October 14, 1892.

Having taken the engine down to the Queen's Wharf, and on examination of the boiler, and steam having been got up with cold water and engines started, time 6m. 40s., and the tests submitted by the Board having been satisfactorily completed. Steam 90" 99" tests, both perpendicular and horizontally.

The design of the engine is very good, and all parts easily got at and well proportioned. In steamboat practice the safety valve is put direct on the boiler by law.

There is no doubt that the old engine has the advantage over the new one in the facility of turning, as the old one has a  $\frac{1}{2}$  circle, and the new one has only one quarter of circle, and the old driver has the controle of the engine to himself. It would be better to have the pipes of brass for the safety value from the boiler of brass.

 $S_{IR}$ —Being requested by you to make an examination of the mechanical efficiency regarding construction of the "Ronald Steam Fire Engine," we beg to report as follows:

For the purpose of inspection, we had the cylinder and slide valves covers removed, also the junk ring of piston and cap or crank shaft journal taken off, the door taken down from water cylinder.

We found the steam cylinder in very good order, and the piston good in design. Slide valves and cylinder faces in good order.

The water cylinders are good in design, and valves in good condition, but noticed that the valve casings were not fitted with guards.

The crank shaft and journal brasses were in good condition."

The boiler of this engine we found to be good in construction and workmanship, their being no leaks.

The safety valve is fitted on the main steam pipe, which, in our opinion, should be on the boiler.

The brakes are worked by two levers from the rear end, which we think is a great disadvantage, as the driver of the horses should have control of them.

The forward wheels do not swing under the framing of engine. This would be a great disadvantage in turning the corners of some of our steep hills. Those wheels, when turning, come against a roller screwed on a stud. If by any accident this stud is broken or bent, the wheel would strike against and damage the feed pipe of pumps supplying the boiler with water, and render them useless. There is an injector which should be available in case of any injury to those pumps. The boiler can also be fed from the main pumps.

There are no fittings on this boiler for keeping hot water circulating when standing in the engine house.

In conclusion, we would state that we found the workmanship of the "Ronald Steam Fire Engine" of a very high order.

Moved by Alderman Dennis, seconded by Alderman Boak, and on being put is passed.

Read report of Committee on Laws and Privileges, on petition of residents of south end of Gottingen street,  $\tau e$  nuisance caused boys on Sunday, also, by smoke from blacksmith's shop, and a petition of Truckmens' Union for repayment of fines imposed in Police Court on certain truckmen.

October 26th, 1892.

The Committee of Laws and Amendment beg to report as follows :

They submit for approbation of the Council a number of proposed Ordinances, prepared by His Honor the Recorder, regulating the position of awnings, signs, gratings, coal-holes, etc., on the public streets, and dealing with other matters.

The Committee beg to report in relation to the petition of a number of residents on the south end of Gottingen street, that the attention of the Chairman of the Police Committee has been called to the nuisance of a number of boys on Sundays in the said locality, and steps would be taken by the Police to prevent a continuance of the said nuisance,

In regard to the other complaint from said residents as to the escape of smoke from a blacksmiths shop. Your Committee consider that the proper course of any aggrieved party is to seek redress from the courts.

## OCTOBER 26th, 1892.

In relation to a petition from a committee of the Truckmens' Union for the repayment of the sum of \$50 paid by certain Truckmen to their counsel for successfully defending a prosecution under one of the City Ordinances. Your Committee beg to report that they cannot recommend such repayment out of City fands.

Moved by Alderman Boak, seconded by Alderman Eden, that the same be referred to the Board of City Works to report on. Motion passed.

Read report of Charities Committee *re* tender for supplies for Poor's Asylum for one year, from 1st November, 1892; and on letter from W. H. Wiswell, County Clerk, and Treasurer *re* charge for certain patients in the Mount Hope Asylum.

## October 20th, 1892.

The Charities Committee met this evening, Present : The Chairman, Aldermen Pickering, Lane, Foster, and Outhit.

Tenders for the supplies to the Poor's Asylum for one year, from November 1st, 1892, were opened and the following accepted.

At a meeting of the Charities Committee held on October 7th, the annexed letter from W. H. Wiswell, County Clerk, claiming that certain patients in the Hospital for Insane, who are charged to the County should be paid for by the City, and asking for an investigation into the same was read.

Alderman Pickering stated that he had an interview with Mr. John Shatford, Warden of County, in reference to the matter, who said that Mr. Wiswell had written this letter to the Council solely on his own responsibility and without any authority whatever from Municipal Council. He further informed Alderman Pickering that he was satisfied the City had paid every cent of its indebtedness to the Municipality of the County of Halifax at the last settlement by arbitration.

On motion it was referred back to the Council for their consideration; and beg to add that after a careful investigation of the accounts, we can find no ground, in fact nor has Mr. Wiswell been instructed to write the aforesaid letter.

Moved by Alderman Hamilton, seconded by Alderman Morrow, that said account be referred to the Committee on Public Accounts for report. Motion put and passed.

## ORDER OF THE DAY.

Alderman Foster's notice of reconsideration of resolution, in re purchase of Steam Fire Engine being put on the Order of the Day, is now taken up.

Moved by Alderman Foster, seconded by Alderman Eden, that said resolution be reconsidered. Motion passed.

Read resolution of Alderman Foster, seconded by Alderman Eden, re purchase of Steam Fire Engine as entered on Minutes of last meeting.

The following amendment is now introduced :

Resolved,—that Whereas the Ronald Steam Fire Engine is not up to modern requirements inasmuch as her turning gear and brakes are not equal to modern construction of fire apparatus. And whereas, the Amoskeag Fire Engine, the last purchased by the City has proved satisfactory and minus the defects above referred to in the Ronald machine, and at less cost to the City than the Ronald. Therefore resolved, that the Amoskeag Fire Engine be purchased at a cost of \$4940.00 and in keeping with the order and specification now before the Council. Moved by Alderman Pickering, seconded by Alderman Lane.
