The meeting was called to consider and deal with the various schemes re Civic Government offered for the consideration of the Council, and the transaction of other business.

Read Report of Commissioners of Point Pleasant Park, covering a financial statement re Point Pleasant Park to 31st December, 1893.

Halifax, December, 1893.

To His Worship the Mayor and City Council of Halifax,

The Commissioners of Point Pleasant Park beg leave to submit to the Council their report upon the condition of the Park and the work done during the year. With the limited means at disposal it has not been possible to enter upon any extensive scheme of improvement. The Commissioners feel that their chief duties are to carry out such work only, as is necessary to preserve the natural beauties of the Park and its scenic and scientific features of interest and to provide and keep in repair the necessary roadways, seats and other facilities so that the citizens and summer visitors to the City may fully enjoy this pleasant retreat.

The roads and carriage drives have all been kept in as fair condition as possible. The footpaths also have been attended to, but still need considerable extension and improvement.

JANUARY 12th, 1894.

Owing to the rapid growth of tangled underbrush, and the general decay of trees in some parts of the woods where overcrowding for a long period of years, has rendered them hopelessly unhealthy, A large amount of labor has to be expended every year in thinning, pruning and cutting out dead and decaying tim-ber and the encumbering undergrowth. This work is absolutely necessary to prevent cisastrous fires during the dry season, and it absorbs no inconsiderable portion of the funds available for Park management.

Where unsightly and dead or dying trees are cut out, young and healthy trees are planted in their places; such young trees grown in the nursery grounds to proper size for transplanting have been put out during the past season to the number of 300. There are still in the nurseries the following trees that were purchased when quite small and at very little expense, but are rapid.y growing into robust valuable trees that will be available for future planting :

3000 Norway Spruce, 1000 Scotch Fir or Pine, 400 young Hardwood trees of different kinds.

The condition of the piece of water known as Steele's Pond, has long been a matter of anxiety from its dangerous depth in some parts, and the precipitous character of its bank along the principal public drive. It was accordingly decided to fill the bottom of this pond with hard material, so that there shall not be a greater depth of water that four feet in any part of the pond at any season of the year. Last winter the severe frost formed very thick ice on the pond, and advantage was taken of this circumstance to cart 3000 loads of stone upon the ice, the stone was laid upon the surface of the ice over the deep parts of the pond previously marked by stakes. When the ice thawed, the stones found their way to the bottom. This work cost about \$600.00, and can be completed for about a sum of \$400 more.

Last spring about a thousand yards of new fencing was put up from waste material chopped in the process of thinning. This fencing was necessary in order to enclose the piece of ground belonging to the Imperial Government, which lies between the park land and Mrs Baulds property. A dangerous part of Steele's Pond was also fenced.

The Commissioners would further represent to the City Council that the present appropriation is insufficient to carry on the necessary work in maintaining so extensive an area of grounds, in a condition creditable to the city. An annual sum of at least \$3000 should be placed at disposal of the Commissioners.

The erection of a proper dwelling house for the Park keeper should also be

provided for, as this has become a necessity and cannot longer ie delayed. The accounts of expenditure by the Commissioners from 1st April to 31st December, 1893 are submitted herewith, showing a balance due by the city of \$224.31. A considerable expenditure will still have to be made before 1st April, 1894, which terminates the Park year.

Read suggested resolution from His Worship the Mayor re amendment to Franchise Act, as follows :---

That Sections 33 and 34 of the City Charter are hereby amended by striking out of section 33 the words, "Provided also that he shall have paid the rates at least thirty days before such election."

Moved by Alderman Stewart, seconded by Alderman Mosher, that said resolution do now pass. Motion passed.

Moved by Alderman Foster, seconded by Alderman Eden, that the Order of the Day be suspended to allow Alderman Foster to introduce a resolution. Motion passed.

The following resolution is now introduced :--

Whereas, This council has repeatedly expressed to the company holding the exclusive franchise for building, maintaining, and operating a tramway upon and along the streets of the City of Halifax, the opinion that the service rendered is inefficient both in respect of operation of its present lines, but also that the same does not and has not afforded accommodation to important sections of the city.

And Whereas, The said Company has been indicted as a nuisance by the Grand Jury of this County and the said Company has been compelled to acknowledge by its default the truth of said indictment, but has taken no steps to abate said nuisance.

And Whereas, The said tramway is, and has been in the hands of a Receiver, and it does not appear that it has resources or means to construct or operate an efficient line of railway to meet apparent needs of the City.

Therefore Resolved, That his Honor the Recorder be instructed to prepare an Act to be submitted to this session of the Legislature asking that the franchise of said Company be cancelled and that the same be granted to the City Council with power to deal with the same in the best interests of the City of Halifax.

Moved by Alderman Foster, seconded by Alderman Mosher.

Moved by Alderman Foster, seconded by Alderman Wallace, that the same be referred to His Honor the Recorder for report. Motion passed.

The Council now proceed to discuss the question of Civic Reform. Moved by Alderman McFatridge, seconded by Alderman Ryan, that the Council now consider the Bill of the Citizens Reform Association, and the suggested resolution of His Worship the Mayor on the matter of Civic Reform. Motion passed.

The following resolution is now introduced :--

Resolved, that in the opinion of this council, it is desirable to make some change in the present mode of Civic government.

Also Resolved, that this council is of opinion that the change should be in the form of having an executive apart from the legislative branch thereof. Further Resolved, that the council now proceed to the discussion of the principle of the same.

Moved by Alderman Stewart, seconded by Alderman Mosher, and being put, is passed.

Alderman Morrow gives notice of reconsideration.

Senator Power on an invitation from the Council accepts a seat within the rail.

Moved by Alderman Foster, seconded by Alderman McFatridge, that Mr. J. E. DeWolfe be requested to express his views on the matter. Motion passed.

JANUARY 12th, 1894.

Mr. DeWolfe addresses the Council on the matter before it, and is followed by Mr. E. G. Kenny and Senator Power.

His Worship the Mayor leaves the chair, which is taken by Deputy Mayor Mosher, and addresses the Council on the various schemes submitted. After doing so His Worship resumes the chair.

Aldermen Foster, Stewart, Hamilton, McFatridge, Eden, Ryan, Wallace, Morrow and Mosher respectively address the Council on the subject.

The following resolution is now introduced :---

Resolved, that the commission now known as the Board of Works, be abolished, and that legislation be obtained to that effect, thereby saving \$1000 a year. and bringing the administration of that department directly under the control of the Council. His Worship the Mayor to assume the duties now performed by said board. The change not to take effect until the 1st May next.

Moved by Alderman Hamilton, seconded by Alderman Foster, said resolution on being put is passed, 12 voting for the same and 1 against it. The names being called for appeared thus:

(Sec. 2.) When from any cause a vacancy occurs in the office of Stipendiary Magistrate for the City such vacancy shall not be filled by a new appointment, but the powers and duties of such Stipendiary Magistrate shall thereupon devolve upon the Recorder.

(Sec. 3.) From the time when the Recorder assumes the duties of Stipendiary Magistrate his salary shall be at the rate of two thousand four hundred dollars a year, and he shall give all his professional labor to the city and act for no client other t an the city. In addition to his salary he shall receive no other remuneration except the costs in suits in which the city shall prevail and which shall be collected from the adverse parties.

NEW PIPE LINE.

CITY ENGINEER'S OFFICE, Halifax, N. S., January 15th, 1894. His Worship the Mayor :-

SIR,-When submitting a report on the New Pipe Line, I estimated the cost of the Main at \$104,000, and stated that the possible cost of the whole work might be \$200,000. After the work was ordered a report was again made to the Board of Works, calling attention to the fact that a great deal of work would be necessary to complete the scheme not included in the estimate (\$104,000.) This work included :-

Right of Way and Land damages.

New Dam, Gate House and Waste Weir.

Moving old Gate Houses and Keeper's House.

Clearing and Grubbing.

New Road.

Raising Nickerson's Dam. Altering 15" High Service Main. Changes in Distribution in City.

Purchase of Mill Owners' Claims.

This additional work was estimated to bring the total up to \$200,000. It was decided to proceed with the work. The amount provided by the Borrowing Bill was \$150,000. Of this amount \$15,000 had been already expended on the High Service, leaving \$135,000 available. This amount was further reduced by \$20,000 taken for works of construction. If the original sum had been left intact, for the new main, it would have been sufficient to complete the work. A saving of \$20,000 was made by purchasing the iron at a very low rate, and a saving of about \$10,000 will be made by abandoning the plan for altering It will be necessary to borrow \$15,000 to complete the work proposed. This would not include land damages, the cost of which I cannot estimate, and I would recommend that authority be obtained, at this session, to borrow what the land damages amount to when the question is decided.

There was no money provided when passing the estimates for Water Extension in the City this year, and I would suggest that \$10,000 be included in the Borrowing Bill as usual.

Read application of Thomas Bushell for the position of keeper of Dog Pound. Moved by Alderman Stewart, seconded by Alderman McFatridge that Thomas Bushell be appointed Keeper of the Dog Pound under the Ordinance relative to dogs. Motion passed.

Read letter from N. H. Meagher, Secretary City Health Board, informing the City Council of the intention of the City Health Board to make application to the Legislature at its present session for power make rules for the regulation and licensing of plumbers, also for authority to exercise the powers mentioned and set forth in Section 507 of the City Charter. Moved by Alderman Hamilton, seconded by Alderman Morrow that the same be placed on file. Motion passed.

Read letter from His Worship the Mayor to J. B. Neily *re* negotiations for the sale of the Ronald Steam Fire Engine, with reply of Mr. Neily thereto. Ordered to be filed.

Read opinion of His Honor the Recorder *re* dedication of Mott and Seldon Streets covering a report of the City Engineer and deed of said streets.

MOTT AND SELDON STREETS.

RECORDER'S OFFICE, HALIFAX, N. S., Jan. 19th, 1894.

The Engineer reports to me these streets are in their natural state, and no houses on either side of it. He also reports that from the description in the deed he is unable to locate the street. Under these circumstances I am of opinion the Council should not accept the deed under the circumstances.

DEAR SIR,—In reference to Mott and Seldon Streets they are in their natural state. There are houses on Harvey Street. I cannot recommend the acceptance of these or any other Streets until some system is adopted and an official plan made so that they may be properly located.

The description begins at the "corner formed by the east side of said Oxford Street and the south side of lot number twenty on said plan." I cannot locate that point, because I do not know where the east line of Oxford Street is. It is folly to go on as we are going, and I have already urged that a change be made. Until it is made I cannot recommend the acceptance of any more Streets.

Read letter from John D. Ronald requesting the City to purchase his Steam Fire Engine. Moved by Alderman Hubley, seconded by Alderman McFatridge, that the City Clerk acknowledge the receipt of Mr. Ronald's letter and inform him that the City do not at present need another Engine. Motion passed.

Read letter from Annie Creed, Widow of Ex Librarian Samuel Creed, asking that the City grant her an annual allowance of \$100.00. Moved by Alderman O'Donnell, seconded by Alderman Hamilton,

that the same be referred to the Library Committee for report. Motion passed.

Read report from the City Auditor relative to City loans and informing the Council that another lot of bonds amounting to \$46,000 will fall due on 1st July next. Moved by Alderman Morrow, seconded by Alderman Mosher, that said report be forwarded to the Committee on Public Accounts for report. Motion passed.

Read Draft Act submitted by His Honor the Recorder, relative to the abolition of the Board of City Works.

Read clause 1. On motion it was resolved that said clause be amended to read as follows:

The Board of Works, on and after the first day of May next, shall be abolished and shall then cease and determine and all the rights, powers, duties, obligations and authority shall be transferred to and vested in His Worship the Mayor, subject to the control of the Council, and all moneys due, payable or collectable by said Board shall thereafter be paid to the City Collector, but all moneys payable by said Board shall thereafter be paid in the same way and subject to the same investigations as other moneys are now paid by the City. Motion passed.

Read clause 2. On motion it was resolved that this clause be amended to read as follows:

The City Engineer shall be responsible for the mode and manner of constructing the Public Works of the City and carrying on the same to a successful completion, and all other works ordered by the Council The said Engineer shall also, on or before the tenth day of December in each year, report to His Worship the Mayor who shall submit the same to the Council, the amount required for the repairs of streets, and the Council shall vote such sum as they think necessary.

Read Draft Act entitled, "An Act to Amend the City Charter of Halifax and the Acts in amendment thereof." On motion the same was considered clause by clause.

Read Clause 1, re Superannuation Allowance of Mr. Thomas Rhind, Ex-City Clerk. Passed.

Read Clauses 2 and 3 substituting the words "Deputy Chief of Police," for the words "Deputy Marshals," where they occur in Sections 202, 221 and 222 of the City Charter. Passed.

Read Clause 4, authorizing the Chief of Police to serve and execute writs issuing out of the Police and City Courts. Passed.

Moved by Alderman Hubley, seconded by Alderman O'Donnell, that the Chief of Police be appointed Deputy City Marshal, with authority to exercise all the official functions of City Marshal, during the absence or illness of said City Marshal. Motion passed.

Read Clause 5 striking out the words "Chairman of the Police Committee" in Section 229 of City Charter. Passed.

Read Clause 6 adding the words, "or the City Council" after the words "The City Health Board" in seventh line of Section 508 of City Charter. Passed.

Read Clause 7 giving the City Council authority to appoint any competent person as Chief of Police. Passed.

Read Clause 8 relative to the protection of Water Meters from frost. Moved by Alderman O'Donnell, seconded by Alderman Hubley, that

said clause be struck out. Motion passed, 8 voting for the same and 3 against it.

Read Clause 9 relative to the confirmation of City Ordinances. Passed.

Read Clause 10 relative to expropriation of land for New Pipe Line. Passed.

Read Clause 11 empowering the city to use a steam roller upon its streets. Passed.

Read Clause 12, substituting the figures "1860" for the figures "1890" in the City Charter, Section 660.

Read Clause 13, empowering the City Council to borrow a sum not exceeding two thousand dollars, in case of a deficiency of funds received from the contemplated Provincial Exhibition of 1894. Passed.

Read Clause 14, authorizing the City Council to borrow three thousand dollars for purchase of fire hose, and seventeen hundred and fifty dollars to pay overdrawn accounts. Passed.

Read Clause 15, Imposing a penalty on persons bringing poor and indigent persons into the City. Passed.

Read Clause 16, Repealing, as regards the City of Halifax, the two last lines of Section 4 of Chapter 35, Revised Statutes, 5th Series. Passed.

Read Clause 17 giving every person the right to vote for Mayor and Aldermen whether his taxes are paid or not, if otherwise qualified by law. Passed.

Read Clause 18 relative to issuing of permits to open or excavate the soil of any street. Passed.

Read Clause 19 relative to depositing a sum of money before permit is granted to open soil of street. Passed.

Read Clause 25, re salary of amalgamated office of Recorder and Stipendiary Magistrate. Moved by Alderman O'Donnell, seconded by Alderman Hubley, that said Clauses 24 and 25 be struck out. Moved in amendment by Alderman Stewart, seconded by Alderman Hamilton, that said Clauses be adopted. Said amendment being put is passed, 9 voting for the same and 2 against it.
