### HALIFAX VS. REEVES.

June 7th, 1894.

The Supreme Court here having by a bare majority decided against the City in the above cause and some of the judges holding that in this case the City would have to prove the original line of the street as laid out. If this was good law the City would lose entire control over its streets, and it was of great importance to get the opinion of the Court at Ottawa on that point as the City contended that the line of street on the ground was the line the statute mentioned.

When arguing the cause an objection was made there was no appeal which was decided in favor of the City, after which the merits were argued, and I was glad to hear His Lordship the Chief express his opinion that the street line meant the line on the ground, and Mr. Justice Sedgewick was very imphatic on the point.

I annex hereto two letters from our agents on the subject, from them it appears that the cause was lost through a mistake of the trial judge, and the Court at Ottawa considered but for the mistake the City would have-succeeded. I have written for a copy of the judgment and when received will forward it for the information of your Worship and the Council.

SPRING GARDEN ROAD.

### Chairman Board of Works:

SIR,-The resolution of your board in reference to a sidewalk on Spring Garden Road, asked for a report on the best material for laying a permanent pavement on the north side of Spring Garden Road, the estimated cost thereof, and how far west it would be advisable to lay such sidewalk this summer. There is no question in my mind that concrete is the nearest approach to permanent work that we can get, unless we use granite flags the full length of the sidewalk. Granite is too expensive however for consideration in any but the business Streets; although concrete is the next best material, I would not recommend its adoption for this sidewalk. There are several places where construction would be difficult and the cost increased. The other materials available, asphalt, brick and plank, cannot be considered as permanent, and it is questionable whether the permanent pavement fund should be used to put either of them down. Asphalt, properly put down, makes a good sidewalk, while the cost is only half that of bricks. If good material is used it will wear quite as long if not longer than brick. It is certainly not advisable to lay a very expensive sidewalk on Spring Garden Road, and I would recommend that asphalt be tried, the material to be genuine asphalt and not tar composition. Granite curbs and gutters should be laid before any sidewalk is put down. The sidewalk on the north side is used a great deal all the way out, but especially as far as South Park Street, and a good walk is needed from Pleasant to South Park Street.

Stephen's Mill.—This mill is situate on the West side of Grafton Street,

Stephen's Mill.—This mill is situate on the West side of Grafton Street. South of Buckingham Street. It is an old wooden building, with piles of lumber all around it and in an old building immediately South of it. There i protection to the boiler, and should a fire once gain headway in this build there can be no doubt but that from its surroundings the loss to property w

be a very serious one, and your Committee consider that it should not any longer be allowed to be operated in its present condition, nor where now situated. Gladwin's Mill, Barrington Street.—This mill is in one of the very worst

localities in the city for an establishment of that nature; it is completely filled with dry lumber; there is no yard to it, it being entirely surrounded by large wooden buildings, and should a fire occur there, it would be impossible, because of its situation, for the firemen to successfully cope with it, and the probabilities are that a large section of that portion of the city would be reduced to ashes.

*Dempster's Mill*—This mill is to a certain extent, isolated, and your Committee think carefully conducted; but they found a wooden shute leading from the second story of the mill to a point just in front of the boiler for the purpose of conveying the shavings and refuse from the mill to the boiler house where it is used as fuel. Should a spark from the furnace set this refuse on fire, there is nothing to prevent it, and it would without a doubt, almost in a flash, follow this refuse up the shute and enter the main building. To prevent this, your Committee recommend that an iron door be placed in the building at the upper end of this shute, which door, in the event of a fire occurring as already mentioned, could be at once closed and the fire thus prevented from gaining a hold on the main building.

Quigley's Mill, at corner of Maynard and Falkland Streets.—This is an old ooden building. There is very little stock carried, and the boiler-house wooden building. is outside of the main building. In this case, your Committee would recommend as a precaution that the Western side of the mill to the height of the boiler-house be cased with heavy sheet iron, and that an iron door be at once placed between the boiler-house and the main building. Merlin's Mill, Maynard Street.—This mill appears to be carefully conducted

but your Committee would recommend that the furnace and boiler be removed from the mill and placed in a brick building separate and apart from the main structure.

The John's Mill (so called) Gottingen Street.-This mill is in a very dangerous locality, and should a fire occur there, it is hard to say where it might end. Your Committee would recommend in this case also that the boiler be placed in a brick building outside of the mill, and as there are not any facilities for storing lumber outside, that not more than two days' supply be kept on the premises at any one time.

Gordon & Keith's, Dundonald 'treet.—Your Committee consider this, as far as fire is concerned, to be one of the safest mills in the City, as every precaution is taken to prevent a fire occurring on the premises. The danger in this case would be from the large quantity of lumber stored around it. Brookfield's Mill.—This mill is isolated, and in the event of a fire occurring the

damage would be confined to the building itself.

Your Committee would recommend that no steam saw or plaining mills be allowed to be operated in the central portions of the city, except in brick buildings with walls of not less than one and one-half bricks in thickness, so that in the event of a fire occurring therein, the flames might be confined to the building in which it originated, and also to protect it in the event of a fire occurring in its immediate vicinity.

Your Committee would also recommend that in the matter of all steam saw or plaining mills in operation in the city without the sanction of this Council there-for having been first obtained, that His Honor the Recorder be instructed to immediately take such proceedings against the owners thereof as the law directs.

SIR,—The accompanying petition and minute of Council respecting a sidewalk on Hollis Street, between George Street and Prince Street, on the east side, having been referred to me, I beg to report :—

In reference to the advisability of constructing a Concrete Sidewalk in this block, the first objection is, of course, the expense. The estimated cost of the work is \$900. The property owners would pay about \$275 or \$300.

The sidewalk is in a very delapidated condition and quite unlike some blocks which have been taken up and re-laid. The only good piece in it is the granite laid in front of Levy and Michaels' property. This would have to be taken up except where it is necessary for coal holes. The sewer has just been laid and connections are not made yet. There are five poles in the block, only three of which are necessary; one for the C. P. R. Telegraph Co., and two for the other wires. An effort should be made before proceeding further, to get the Gas Co. to remove their poles. They did so in other streets and there is no reason why they should not do so here. The usual work of altering hatches and coal holes and repairing and renewing gas and water service pipes must be done.

and repairing and renewing gas and water service pipes must be done. With the exception of the two blocks south of the one in question, no concrete sidewalks, have been laid until all encroachments were removed. There is a stone step in front of Messrs. Burns & Murray's building which encroaches on the sidewalk, and I would respectfully recommend that no new sidewalk be laid in this block until that encroachment is removed.

## HALIFAX, N. S., JULY 31st, 1894.

His Excellency the Governor General of Canada and the Countess of Aberdeen, arrived at Halifax, this evening by the 7.20 o'clock train and were met at the North Street Railway Station on behalf of the citizens by His Worship the Mayor, His Honor the Recorder and the City Clerk in their robes of office, Aldermen Stewart, Wallace, Mitchell, Hubley, Eden and Mosher, His Excellency Commanding H. M. Forces in Canada and other Military and Naval Officers, His Honor the Lieutenant Governor of the Province and Members of the Executive Council and Representatives of the Dominion and Provincial Parliaments, together with a very large concourse of other citizens were also present.

Drawn up in a line on the Railway Platform was a guard of honor from the Kings 1st Liverpool Regiment with colors and full band.

At the moment of the arrival of His Excellency a Royal Salute of twenty-one guns was fired from the Citadel.

On stepping from the train His Excellency was received by General Montgomery Moore, who introduced to him His Honor the Lieutenant Governor, who in turn presented to His Excellency, His Worship the Mayor, the Reception Committee of the City Council and others.

After the conclusion of the presentation of a large number of those in attendance their Excellencies took their carriage and proceeded to Maplewood, at the North-West Arm, accompanied by the City Council's Committee and a large number of others in carriages.

## COUNCIL CHAMBER, CITY HALL,

### 12 o'clock, noon.

### AUGUST 1st, 1894.

A meeting of the City Council was held at above hour. Present: His Worship the Mayor, Aldermen Stewart, Wallace, Mitchell, Hubley, Eden, Mosher, Morrow, Geldert, Dennis, Redden, Hamilton, Duggan, Ryan, O'Donnell, McFatridge, Foster, Creighton and Outhit.

The meeting was called for the purpose of presenting an address to His Excellency the Governor-General, on the occasion of this his first visit to Halifax.

His Excellency, accompanied by Countess of Aberdeen, arrived at the main entrance at sharp twelve, after passing a Guard of Honor from the 63rd Battalion of Rifles at the western side of the entrance. Their Excellencies were received by His Worship the Mayor and the Reception Committee and escorted to the Council Chamber. The portico, corridors, grand stairway, Council Chamber, and adjoining

room had been adorned with plants and floral decorations, besides being carpeted and specially furnished for the occasion.

The Grand Parade in front of the City Hall was thronged with citizens, and inside filling the Corridors and Council Chamber was a large number of principal personages of the city, who with their ladies had been invited to be present.

Having entered the Council Chamber His Excellency and Countess Aberdeen, were each presented with boquets of flowers by two little sons of His Worship the Mayor, after which the Vice-Regal Party was then addressed by His Worship.

### YOUR EXCELLENCY AND COUNTESS :

It affords me extreme pleasure to welcome you to our city and province. My council, acting as representatives of the citizens, have assembled here to-day, and have with them a number of friends to do honor to the occasion.

It is the first time in our history that we have been honored to the extent of having the governor-general and his lady take up their residence amongst us; and we earnestly hope that however long or short your stay may be, that it will give both satisfaction and pleasure to you and yours.

I will now request our city clerk to read the address we have prepared to greet you with, and would ask the attention of all present to its reading.

The following address engrossed upon parchment was read by the City Clerk, and by His Worship the Mayor presented to His Excellency:

To His Excellency the Right Honorable Sir John Campbell-Hamilton Gordon, Earl of Aberdeen, Viscount Formantine, Baron Haddo, Methlic, Darbis and Kellie in the Peerage of Scotland: Viscount Gordon of Aberdeen, County of Aberdeen, in the Peerage of the United Kingdom; Baronet of Nova Scotia, etc., etc.

#### May it please Your Excellency:

The Mayor and Corporation of the City of Halifax, on behalf of themselves and of the citizens, most cordially welcome Your Excellency and Lady Aberdeen to this city by the sea and assure you that in no part of this Dominion exists a warmer attachment to the person of Her Most Gracious Majesty the Queen, and to yourself as Her representative, than in the City of Halifax and Province of Nova Scotia.

We beg to offer you our sincere congratulations on your assumption of the high office of Governor-General of Canada.

We recognize that you have won a high place among the public men of the mother country by your talent, energy and statesman like qualities, and we feel justified by your successful record as representative of Her Majesty elsewhere, in anticipating that Your Excellency's tenure of office in Canada will mark an era of honor to yourself and be conducive to the best interests of the people.

We are glad to understand it is the intention of Your Excellency and Lady Aberdeen to remain some time amongst us—this being the first occasion of a governor-general's residence in our city, even for a short period, and we trust that this, your first visit to our city and province, may be of such a pleasant nature to yourself and family that we may be honored with your presence amongst us on each succeeding year of your administration as governor-general of Canada.

We beg that Your Excellency will convey to Lady Aberdeen the sentiments of high esteem in which Her Ladyship is held by the citizens of Halifax, not only on account of Her many noble and womanly qualities, but for the constant efforts put forth by Her Excellency to elevate humanity and forward all good works.

At Halifax, N. S., August, 1892.

To the Address His Excellency made reply in about the following words:

### Your Honor Mr. Mayor, Ladies and Gentlemen:

It is with feelings of deep appreciation and much pleasure that I receive this address, expressing as it does in no uncertain manner and in language both emphatic and graceful your loyalty towards the Queen and your good-will towards Her Majesty's representative. Such a manifestation would under any circumstances in its first aspect be appropriate and in its second aspect agreeable, but especially is this the case when such an utterance, such a manifestation is received from the representatives of a city and a community which occupies so prominent a position as that of Halifax, both in the past and present life of British North America and indeed of the British Empire as a whole. I can assure you, Mr. Mayor, that both Lady Aberdeen and I will always remember with grateful feelings the assurances contained in this address. You may be very sure also that if any person should be familiar with something more than the name of the historic Province of Nova Scotia I ought to be one of those, not only becaue I claim to be a native of the older Scotia, but because I think that the earliest distinction and title which was received in my family was that of the baronetcy of Nova Scotia. You can imagine therefore that this circumstance has added to the interest and appreciation with which I have looked forward to, coming to see something of this land, with which I can thu- claim somehereditary connection. Hitherto I have not been able to ascertain whether this designation carries with it any special privileges, s ill less, whether it conveys any emolument. I am in hopes, however, that some light may be thrown upon this subject, even should it be necessary to ask the premier of the Province to introduce a bill for this purpose. I suppose, gentlemen, such a bill might be designated as one for the relief of the Governor-General. Meanwhile I hope to take full advantage of such other privileges as I may enjoy here, not only in the official capacity but personally, as for the time being a resident in this city or district. I do not propose on this occasion to make any general observations on the circumstances and public topics suggested by such as expression as that which I had the honor of receiving at your hands. I am, of course, a very newcomer, and I am here as an observer and learner, I hope to profit by being a member of this community for a while, especially as regards that most effective method of instruction, namely, conversation with the leading and most influential men who are best able to give information regarding the history, the resources and the institutions of your Province. Such being the case you may be sure that Lady Aberdeen and I will have good reason to be glad that we have had this opportunity of becoming your guests and fellow residents. I cannot help alluding further to one fact, namely, that although we have heard much of the attractions and charms of this city and its surroundings, their realization has far exceeded our expectation. Indeed I cannot but quote a remark made by Mr. Emmerson after he had visited a celebrated spot in the United States. "This," he said, "is the only place that I have seen that came up to the brag." I am sure a similar observation may be applied to Halifax. I may also be allowed to remark that with special feelings of satisfaction and pleasure we observed the extremely hearty manner in which your citizens evinced their public spirit and loyalty, and also their cordial hospitality, in the manner in which they greeted us on our arrival yesterday in this city, and again this morning. Let me add that the expressions which you have made use of towards Lady Aberdeen are felt by her extremely. I am sure I cannot imagine anything more encouraging to those occupying a position of responsibility and trust, to endeavor to discharge rightly the duties of such a position, than assurances of confidence and of good feeling, such as those which you have now uttered. In conclusion, I beg to express my hearty good wishes to you Mr. Mayor and your colleagues, in your administration of municipal affairs for the welfare of the city. We have observed with very much interest, also, the pleasing and attractive manner in which this sentiment has been displayed by flag decorations on the streets, a display which has been further elaboratedin the charming floral and other adornments within these walls.

The members of the City Council were in turn presented to His Excellency, as also His Grace the Archbishop, His Lorship the Bishop, and other clergymen; the Judges of the Supreme and County Courts, members of the Executive Council, several of the ex-Mayors of the City and others.

A number of the Ladies present were presented to the Countess of Aberdeen by the Lady of His Honor the Lieutenant-Governor.

At the conclusion of the above ceremonies, and a few moments more spent in conversation their Excelliencies took their departure, being escorted to their carriage by His Worship the Mayor and General Montgomery Moore.

Your Committee have had under consideration the petition of the residents of Inglis Street asking for the extension of said street, and a large mass of correspondence, reports and plans relative to proposed extension, and your Committee. after hearing parties interested, beg to report that they have adopted the follow-

ing resolution. Alderman Hubley dissenting. Resoluted, That the proposition of the petitioners, residents of Inglis Street and elsewhere, and the plan proposed by the owners of Marlboro Wood, be recommended to the favorable consideration of the City Council, subject, however, to the following provisos and conditions :

That no financial burden or responsibility shall be assumed by the city in 1. connection with the proposed extensions from Inglis Street to the shores of the N. W. Arm, but that the grading and all other work in connection with said extensions shall be entirely borne by the said owners of Marlboro Wood. 2. That the owners of Marlboro Wood shall convey to the city a free right of

way from the proposed continuation of Inglis Street at the junction of the proposed extension of Inglis Street and Robie Street to the shores of the N. W. Arm, with landing privileges at the shore, said right of way to be laid out under the supervision of the City Engineer, but all expenses incident to the making of the said right of way to be borne by said owners of Marlboro Wood. 3. That the owners of Marlboro Wood shall give to the city a deed in fee simple of the land owned by them immediately adjoining the Collins property

and extending from Robie Street to the junction of the proposed extension of Inglis Street and Robie Street

4. That the owners of Marlboro Wood shall also bear the expense of the grading of the extension of Robie Street to the junction of the proposed extension of Inglis Street.

5. That before expropriation is undertaken the money estimated by the City Department of Works as necessary to cover all expenses must be deposited by the owners of Marlboro Wood with the City Treasurer; and that said cash deposit must be made within 90 days from date. Moved by Alderman Morrow, seconded by Alderman Mosher.

In regard to the letter from Mr. Hartlen, asking for relief from a judgment held by the City against him, your Committee consider that the City cannot legally
