The petition is signed by nearly all the property owners and business men in the block. The estimated cost of the whole work is \$1,450. If the work is to be done it should be completed as soon as possible. The street and block are among the most important in the city.

There are several large business buildings in the block, and the petitioners are entitled to the same consideration as their neighbors. The work should be finished before the exhibition opens, and I would recommend that it be done at once.

#### FORSYTH, SUTCLIFFE & Co.'s HATCHES.

#### His Worship the Mayor.

SIR.—The accompanying letter from Forsyth, Sutcliffe & Co. is in reference to four hatches in front of their premises on Hollis Street, where a new concrete sidewalk is being laid

On the 25th October, 1893, the City Council passed an Ordinance providing that no hatches should be constructed on any street of a greater width from the wall of the building than two (2) feet. The length along the building was not limited at all. At the next session of the Legislature this Ordinance was legalized, and in addition an Act was passed authorizing the City Engineer to reduce the width of all hatches wherever concrete sidewalks were laid to two (2) feet. The closing sentence of the clause as passed was, "But the party, if dissatisfied with the decision of the City Engineer, may appeal to the City Council."

With regard to the right of possession claimed by Forsyth, Sutcliffe & Co., the City cannot afford to recognize any claim of any portion of the streets, as the whole width of the street belongs to the City, no matter how long any encroachment has existed. Hatches are permitted under certain restrictions; but under no condition could they be regarded as permanent rights.

Permission is asked to increase the width of two of the four hatches, on the ground that the extra width is required. Such permission cannot be given by the Council, as the Ordinance already mentioned makes it illegal.

The cellar under the property is now  $8\frac{1}{2}$  feet, and it is proposed to deepen it  $1\frac{1}{2}$  feet more. At present, only one-half the hatch is used for light and air, the other half being closed with a wooden cover. In my opinion, two feet is ample to give all the light and air that is required for the cellar under this property. The petitioners do not propose to use the hatches for goods at all, as they have a hoist in their warehouse, and are talking of putting m another.

This is the first case coming up under the new law, and as there may be appeals from other property owners, the decision in this matter should be given very carefully, as it will establish a precedent for those following. I do not wish to appear arbitrary in the matter, or to interfere with private rights or business; but I think it is a very important matter, and should be settled once and for all by the Council We have delayed the work until the Council could decide, and I would respectfully urge that it be settled at once, otherwise we will stop the work.

There is no question that this street is entitled to more improvement than it has received, as it is an important business street. A curb and gutter is to be laid on the east side, between Prince William Street and Gerrish Street We cannot get the material to do much more this year, but I think we could get enough for the two most important blocks. I would recommend that granite curb and gutter be laid this year on the west side of Gottingen St, from Cornwallis street to Gerrish Street. The estimated cost is \$2310.00.

#### CURBS AND GUTTERS.

April 25th, 1894.

## His Worship the Mayor :

SIR,—In accordance with the accompanying extract from minutes of the City Council, I beg to submit the following report respecting Curbs and Gutters :

I have had a plan prepare 1 by the junior assistants, showing all the Curbs and Granite Gutters laid in the City. I think we should proceed systematically, beginning in the most important streets. When work is begun on a block it should be finished at once, as it can be done much more cheaply than if it is laid in patch-work. One of the principal pieces of work done last year was left in an unfinished state. I refer to the curb and gutter on Inglis Street. It is not necessary to refer at this date to the advisability of doing the work performed on this street, but it is certainly advisable to complete it. There is about 300 feet yet to be laid. There is nearly enough stone left from last year's work, and the cost would be about \$275.00. The water from the street runs into Mr. Roy's field, and a catchpit cannot be put in until the curb is laid. It would not be advisable for the City to widen the sidewalk at present, and in any case the cost cannot be taken from the Permanent Pavement Fund. I would recommend that nothing be done except the laying of the curb and gutter.

The block on North Street, a portion of which was laid last year, should be finished, as it is in the vicinity of the Station. In my opinion it is most important that the first impression made on visitors by rail should be a good one, as first impressions are lasting. We are to have a visit from His Excellency the Governor-General, and the Streets in the neighbourhood of the Depot are in a very unfinished condition. Our steep hilly streets cannot be kept in good condition with the old cobble gutters, as the water will not follow them, and the only remedy is a curb and granite gutter. I would certainly recommend the laying of the unfinished block, if no more, on North Street. The cost would be about \$250.00.

Part of the curb and gutter ordered was intended for the North side of Spring Garden Road, and it is very much needed. The street is one of the most important in the City, and there is great traffic on it. The estimated cost of laying the curb and gutter is \$2,158.00, including making up the street. I would recommend that it be done this year. The other material should be carted to the Common, and I would recommend that none of the other gutters be laid until the curb is to be reset, a new side walk laid or the street macadamized. It is a waste of money to tear up a cobble gutter where there is a curb, simply to replace it with a granite gutter. If the cobble gutter needs relaying it would then be advisable to replace it with granite, but not otherwise. I think it would be cheaper to deposit the rest of the curb and gutter on the Common until it is required.

If Lower Water Street is to be paved next year it would be advisable to change a part of the order for sixteen inch gutters, as eighteen inch gutters cost more and are not needed. If such is the intention of the Council, I think the Contractor will have no objection to make the change.

All the points referred to must be settled at once, as the stone will be delivered. shortly.

GOTTINGEN STREET SIDEWALKS, BRUNSWICK LANE TO PRINCE WILLIAM STREET, EAST SIDE. May 16th, 1894.

#### His Worship the Mayor :--

SIR,—In accordance with instructions, I beg to report on the above sidewalk. In considering it I am obliged to seperate it into two sections. First, Brunswick Lane to Cornwallis St. The estimated cost of a concrete sidewalk in this block would be \$1,860.00. The property owners would pay about \$620.00

There is a corner curb to lay at Brunswick Lane and granite gutters on the whole block. There is no covering on the sidewalk now. There are three poles in the block. The usual work of altering hatches and coal holes and repairing and renewing gas and water service pipes must be performed. I would recommend, as in the report on the Hollis Street sidewalk, that the following encroachments be removed before doing any work :--

At No. 15½, one wooden step, No. 17, porch, No. 19, porch, No. 21, stone step, No. 23, stone step, No. 25, stone step, No. 29, stone step, No. 31, two wooden steps, No. 35, a wooden step. There are also four trees in this block. I could not recommend the construction of a concrete sidewalk where there are trees. No concrete would stand the swaying of the trees in the wind, to say nothing of the growing and expanding of the trunk and roots. It would be impossible to keep the water out. I do not think, however, that there should be trees in our narrow streets in busine's blocks, and I presume the property owners would consent to the removal of the trees if they are anxious to have the sidewalk.

The most serious obstacle is the drainage of the street and houses. There is no main sewer to carry water from catchpits, and the houses on the lower side are drained in some cases to privy vaults and in others through private property to Maitland St. Under these circumstances, I cannot recommend the construction of a concrete sidewalk until the sewer is built and houses and catchpits connected Second. Cornwallis St. to Prince William St. There is a new sewer in this block, but No. 61 and 63, Mrs. Cullen, owner; 65, 67 and 69, J. A. Hancock, owner; 103, Miss M. Heffernan, owner, and 105, Wm. O'Toole, owner, are not drained into it. I have sent out the usual notices, but they have not been complied with. There are five poles in the block, one of which should be taken out. There are also five trees in this block. The estimated cost to lay the whole block with concrete is \$2,825.00 The property owners will pay about \$975 00.

There is a brick sidewalk as good as new in front of Nos. 71, 73, 75, 77, 79, 81, 83, 85, 89 and a good sidewalk of concrete flags in front of No. 87. It would be considered a hardship by property owners to be compelled to pay for a new sidewalk when they have already paid for a good one. If concrete is to be laid, it should not be put down in patch-work. However, I leave the question for the Council to decide. The Council has already laid down the principle that the whole block should be done at one time. There are steps encroaching on the street in front of Nos. 57 two, 59, two, 71, 75, 85, 89, two, 892, two, 91 and 109. I would respectively recommend as in the case of the other sidewide presented

I would respectively recommend, as in the case of the other sidewalks reported on, that no work be done in this block until all drains are laid and encroachments removed, as this block, which is one of the busiest in the City, looks now like a village street instead of one of the great thoroughfares of the City.
