WATER EXTENSION, WILLOW PARK.

March 25th, 1895.

His Worship the Mayor.

SIR,-I beg to submit the following report on the accompanying petition for water extension to Willow Park.

We have to consider four plans for extending the supply to this district. 1. From the west end of the pipe on North Street to Windsor Street, thence northerly along Windsor Street. 2. From the West end of the pipe on Almon Street to Windsor Street, thence

north and south along Windsor Street.

3. From north end of pipe on Windsor Street, northwardly along Windsor Street.

APRIL 2nd, 1895.

4. From Quinpool Road north along Windsor Street. Plan No. 1, The pipe on North Street is laid west from Kempt Road to King's Place. It is six inches in diameter, and the supply would come from the 12 inch main in Agricola Street. This six inch pipe will eventually have a large district to supply and is therefore not large enough to supply Willow Park for domestic service, while it would be no use whatever for fire service.

Plan No. 2. Extension on Almon Street to Windsor Street. The estimated cost of laying a nine inch pipe from the end of the pipe on Almon Street to Windsor Street, not including pipe to be laid on Windsor Street, is :--

This pipe would draw its supply from the 12 inch main on Agricola Street, and in order to give fire pressure the old pipe must be taken up on Almon Street from Agricola Street to the end of the present main west of Kempt Road, and nine inch pipe laid in its place. The pressure would not be as good, however, as could be obtained by adopting Plan No. 4; but, although I do not recommend the adoption of Plan No 2, I would suggest that in future extensions on Almon Street nine inch pipe be used so that eventually Willow Park will be connected by a nine inch pipe with the main on Agricola Street. The circulation will be better, and as future increase in the supply will come from the north, this district will get a more direct service.

Plan No. 3. Extension along Windsor Street :

This plan will give a more direct service than No. 1 or No. 2, but the supply must come through a six inch pipe from the 12 inch main on Robie Street, up Compton Avenue and along Windsor Road to the end of the present main. It would be folly to put in any extension which would not be permanent and give the petitioners domestic pressure only, and very little of that. Plan No. 4 is the only one that meets all the requirements This plan is to lay a nine inch pipe from the main supply pipe on Quinpool Road along Windsor Street to Willow Park, taking up the six inch pipe now laid in a portion of Windsor Road. This scheme would give direct service, and Willow Park would obtain the best available fire and domestic pressure.

The estimated cost is, from 15 inch main, Quinpool Road, to 6 inch main, Welsford Street:

The estimated revenue is \$136.72. If revenue were to be considered we should be obliged to postpone the extension to Willow Park for a good many years, for without water building lots sell very slowly in such an elevated district as this. That portion of the line from Quinpool Road to Welsford Street will never bring in any revenue because it has been reserved for a park. At first sight it might seem more advisable, shorter and cheaper to take up the pipe in Compton Avenue, but in case of fire in Willow Park the whole north end would have to be cut off, while with a district main each district would be independent.

This question should be discussed on a basis entirely different from that adopted in the average water extension. It does not affect half a block only but a large district, the residents of which get a proportionately small return for their taxes. This district has no fire protection whatever, and during last summer had no domestic supply of water and no near neighbours to buy, beg or borrow from. The extension to Coburg Road was a parallel case, and while the usual custom of requiring a return on the outlay is a good one, I think it should be departed from in this instance and consider I am justificed in recommending the extension according to Plan No. 4 from Quinpool Road to Edinburg Street on Windsor Street, and houses immediately north of Edinburg Street and 950 feet west on Edinburg Street.

WATER EXTENSION, FORSYTHE, SUTCLIFFE & CO., METROPOLE BUILDING.

March 22nd, 1895.

His Worship the Mayor :-

Sir,—I beg to report on the accompanying letter from Forsyth, Sutcliffe and Co., respecting water extension to the metropole building.

There is a main supply pipe in the street which is large enough for ordinary domestic service. Messrs. Forsyth, Sutcliffe and Co. require a six inch pipe in order to run their elevator. It has been the custom in the past to charge half the cost to the city and half to the property owner for whose benefit the pipe is laid I would recommend that a six inch pipe be laid to the Metropole building provided Messrs. Forsyth, Sutcliffe and Co. pay half the cost. The branch pipe to supply the building will of course be put in solely at their expense, but the work must be done by the City as there is a concrete sidewalk in front of the building. Messrs. Forsyth, Sutcliffe and Co. will be required to make a deposit of the estimated cost (to them) before work is commenced in accordance with the custom of this Department.

It is stated in the letter that similar work has been done for others withou^t charge. It is true that a pipe was laid to G. M. Smith's new building free o^f charge against the recommendation of the City Engineer. The Board of Works claimed that a new main was needed and the City should put it in. The same claim cannot be made in this case and they should be put on the same footing as Bauld, Gibson & Co., Burns & Murray, Hayward & Co.. Ungar's Laundry, Smith Bros, and others who have paid for their pipes.

ARGYLE STREET CURE AND GUTTER.

March 22nd, 1895.

His Worship the Mayor :

SIR,—In September last the accompanying extract from Minutes of Council was referred to me asking for a report as to the desirability and cost of a curb and gutter on Argyle Street on both sides from Jacob Street to Buckingham Street. At that time it was getting too late to do the work as there was a large quantity of work ordered. For this r ason I did not report on it at once.

There is curb laid now on both sides of this street, and as this block is an important one it would be better to keep it cleaner than we have been able to in the past. For this reason, if for no other, the work should be done, as two men can keep a granite gutter clean were eight are required on a cobble gutter. The estimated cost is, stone \$368, laving \$175. The stone is of course permanent, but the laying in this instance cannot be considered as permanent because it must be taken up when a good sidewalk is laid and graded. I would recommend that the cost of the stone be taken from permanent pavement account but that the cost of laying be charged to street account.

ELECTRIC LIGHT FINES.

March 7th, 1895.

His Worship the Mayor :

SIR,—In the accompanying letter, the Halifax Illuminating and Motor Co. complain of injustice in the exaction of fines. There are four cases put before the Council:—

1st A fine of \$38.00 for November 4th, when the Company was obliged to shut down owing to a heavy storm. I would recommend that this fine be remitted

2nd. A fine of \$108.00 is imposed for September 10th In this case the lights were turned out in the morning at a time when the police claim it was not daylight, while the Company claim that the lights were turned out in accordance with the moonlight schedule followed for years. The Council must act as judge in this matter and decide whether the case can be considered a wilful violation of the terms of the contract or an error in judgment. I am inclined to the latter and measures have been taken to provide an arbitrator for similar occasions in future.

3rd. December 3rd, a fine of \$93.00 was exacted. It was during monlight nights, and the Company took advantage of fine weather to make some repairs to machinery, it happened to be dark one night while repairs were being made and no lights were on. 4th. On the 15th and 17th October, a fine of \$432 is imposed. It was during moonlight nights and the police report the weather at some part of the night cloudy, while the Company claim it was not dark enough to turn on the lights. This cannot occur again, as in future the the Superintendent of Fire Alarm is to be sole judge in such matters. I would recommend that the Council take up the four cases separately and deal with them as they think best. The year closed three months ago and this matter should be decided at once.

Read letter from B. F. Pearson covering a report from the City Engineer, *re* proposed extention of Inglis and Robie Streets. Moved by Alderman Hubley, seconded by Alderman Ryan, that the same be referred to the Committee on Laws and Privileges for report. Motion passed.

Read letter from the Board of Trade informing the Council of the intention of said board to hold a meeting during the current week for the purpose of considering the question of the best mode of access to the railway terminus at North Street for freight and passenger traffic and requesting the Council to attend said meeting in a body or by selected representives. Moved by Alderman Hamilton, seconded by Alderman Stewart, that the City Clerk be instructed to acknowledge the receipt of said letter and inform the Board of Trade that the Department of City Works has under preparation plans for the widening of Lockman Street which will be laid before the Council at an early day, the Council will then be prepared to meet the Board of Trade for the purpose of discussing the subject and to request the said Board to postpone their proposed meeting until said plans are prepared and the council in position to fairly consider the matter. Motion passed.

Read litter from N. Meagher, Secretary City Health Board, covering a resolution passed by said Board requesting the City Council to place to their credit the sum of \$1,000.00. Moved by Alderman Hubley, seconded by Alderman Stewart, that the matter be referred to His Worship the Mayor for report and that the City Health Board be requested to furnish His Worship with a detailed statement of their expenditure during the current year. Motion passed.

Read report of City Engineer, on petition of David Thomson and others asking that the position of the Electric Light at head of Woodill Street be changed.

ELECTRIC LIGHT, AGRICOLA STREET.

March 26th, 1895.

His Worship the Mayor :

SIR,—In reference to the accompanying petition I beg to say the light was formerly about the corner of Sarah Street. It was removed to its present position at the request of residents of Woodill Street. There is a light on Sarah Street, one on Harris Street, one at the corner of Agricola Street and West Street and one at the corner of Cunard Street and Agricola Street. There is no light for Woodill Street except the one in question, and that s reet would be in darkness if the light now located at the head of the street were removed. A counter petition would be presented immediately. In my opinion the light serves the interest of more people where it is now than it could where the petitioners ask to have it placed.

Read report of Department of City Works covering plan re widening of Lockman Street.

To the Members of the City Council:

GENTLEMEN,—I herein submit for your information the plan and report together with an estimate of the probable cost for the widening of Lockman Street

The department went to considerable trouble to try and get the estimate for the proposed work as accurate as possible, and as far as labor and material are concerned for the carrying out of the work, I think a generous estimate is given.

We male an effort to get the property owners to state a sum which they would be willing to accept as compensation for disturbance and land required. While a small proportion gave a reasonable statement others were outrageously unreasonable and some would not state any price. Now, there is a difference of opinion amongst the citizens as to the actual

Now, there is a difference of opinion amongst the citizens as to the actual necessity of widening this street and some do not think it such, but would look upon it in the light of an improvement that is desirable if it can be had at a reasonabl ecost.

I would recommend that the Mayor be requested to call a joint meeting of the members of the board of trade, the Citizens and the Council to consider the plaus

and estimate and the subject generally, and if after consultation and consideration it is thought advisable to enter upon the work, that expropriation steps be taken and all the awards of arbitrators filed with the City Engineer for submission to the Council before coming to a decision, as my experience has proved that it is one thing to expropriate and pay a sum into court bef re an arbitration is held, and another thing for a city or government to get those concerned to accept those sums paid in as ample compensation,

To avoid this as much as possible I would not involve the city in the widening scheme without first having some positive figure as to its cost, and if the price shown after the arbitration awards are filed does not exceed fair and reasonable expectation, I would much rather that the widening take place than have the proposed new street opened with a dead end against the I. C. R. Station at North Street.

In some cases in the widening of Lockman Street it would be advisable to buy the whole property and sell what is not required. If this course is followed the full value of the property would be required in some cases where damages only have been estimated. This would increase the cost as the money must be borrowed, although part of it may be returned again. In estimating the cost of opening the street through the middle of the block, the item "Buildings,' which includes O'Mullin's brewery, is an estimate for the land on which buildings stand and the value of the buildings. Nothing is allowed for land passed through where no buildings are interfered with, as I consider that in this case the benefit to the property would be greater than the injury done

Read Report of Special Committee appointed to investigate charges made against the Caretaker and Matron of the Hospital for Infectious Diseases.

April 10th, 1893.

The Special Committee appointed to enquire into the matter of the dismissal of the Keeper and Matron of the Hospital for Infectious Diseases, met this day. There were present the whole Committee, viz Alderman Duggan, Chairman, and Aldermen Morrow, Redden, Foster, Creighton and McFatridge; also members of City Health Board, viz: Dr. McKay, Chairman, Aldermen Eden and Hubley, W. H. Neal, Esq, and Dr. C. D. Murray; also the City Medical Officer, and the Secretary of the City Health Board.

Your Committee beg to rep rt that the charges preferred against Mr. and Mrs. Hardesty, (as per letter of the City Medical Officer, to the Health Board, dated February 16th, 1895) were as follows:

Both the Caretaker and Matron or Nurse have openly and persistently refused to carry out my instructions in the following particulars.

1st —Mrs Hardesty was requested by me to nurse and care for a female patient who went to the Hospital on Tuesday last, she positively and very emphatically refused to have anything to do with the patient, defied my authority and again and again reiterated her refusal.

2nd.—Mr Hardesty when requested by me to arrange for the dissenfection and washing of the clothing of some of the patients to be discharged in a few days, refused to allow any member of his family to do any washing for any of the patients When asked by me who else was to do it, he did not know who was to do it or how it was to be done.

3rd.—Mr. Hardesty has also refused to do anything more towards keeping the road open from Gottingen Street to the Hospital for the Ambulance and Visiting Physician.

Your Committee enquired into the charges above mentioned :--In regard to the first charge it was shown that the patient referred to was sent from the Victoria General Hospital suffering from German Measels. Mrs. Hardesty considered that she was only obliged to look after patients suffering from Diphtheria and Scarlet Fever. This case was the first that had been sent there for treatment, while she may have refused to look after the patient yet did not neglect doing so. Another reason given by her for her actions was that she understood that Miss Shortt, a nurse that was then in the Infectious Hospital was to look after the case.

On the 2nd charge it was ascertained that the clothing in question belonged to he nurses and patients that had been sent there from the V. G. Hospital. It

was not all wearing apparel there was a lot of fancy work that had been made up in the institution. They did not consider it was their duty to wash articles belonging to these nurses more especially the fancy work. While at first refusing to do this work they however did it. They considered that it was the duty of the nurses who were looking after these patients to do their washing and more especially such articles as belonged to the V. G. Hospital.

In reference to the 3rd charge it was not positively stated that it was Mr. Hardesty's duty to shovel snow from the roadway. While he declined doing the work yet the roadway has not as yet been reglected. Your Committee came to the conclusion that the charges were not of a very

Your Committee came to the conclusion that the charges were not of a very serious nature and were the result more than from any other cause of conflicts between the matron and the nurses from the Victoria General Hospital. The Board of Health were divided on the question of their dismissal from the fact that Mr. and Mrs. Hardesty did apologize for any insubordination and promised that the same would not occur again. The Committee are of the opinion that they should not be dismissed on this the first charges against them.

Aldermen Creighton and McFatridge objected to the above recommendation.

Read letter from C. W. Rennels, complaining of damage to his property through defective main sewer on Gottingen Street, covering an account "\$12.00," from James Modaghan & Son, relative thereto. Moved by Alderman Eden, seconded by Alderman Foster that the matter be referred to the Department of City Works for report. Motion passed.

Read letter from His Worship the Mayor covering correspondence and plan relative to citizens being granted certain privileges on the slopes of the Citadel. Placed on Order of the Day.

Read report of Special Committee on extension of Brunswick Street southwardly through Imperial property.

April 26th, 1895.

The committee appointed to enquire into the extension of Brunswick Street through Imperial property to connect with Doyle Street beg to report that in their opinion this important work should be carried out without further delay. In view of the fact that the military authorities are at the present time about to erect buildings which will make the prosecution of this work more difficult if not impracticable in future the committee recommends that the military authorities be asked to delay for a short time the prosecution of the work upon which they are now engaged and that they be requested to state the terms upon which they will convey to the City sufficient land for the construction of a street 60 feet in width through said property.

The following resolution is now introduced:

Resolved, That the report of the committee on the extension of Brunswick Street be adopted and that His Honor the Mayor appoint a committee to wait upon the military authorities at once on the subject and ascertain the terms upon which they will co-operate with the City in carrying out the desired improvement.

Moved by Alderman Geldert, seconded by Alderman Dennis, and passed.

His Worship the Mayor submits an address to the Council on the various civic improvements effected during his connection with the City Council as Alderman and Mayor during the past nine years.

His Worship the Mayor retires and Deputy Mayor Stewart takes the chair. The Mayor's address is now read:

To the Members of the City Council:

GENTLEMEN,-In retiring from office I have thought that it would not be amiss to say a few words in parting and take a retrospective glance at the work that has been perfected and the progress made in the nine years that I have had the honor of a seat in the Council, six as an Alderman for Ward Two, and three as Mayor, and in that way give an account of my stewardship; and only as an assistant do I lay claim to any credit in the various progressive steps that have been taken during that period by the City Council for the general good. When I came into the City Council nine years ago it was evident to me that while the intentions of those who had gone before were to place the city in a good sanitary condition, and at considerable expense a sewerage plan of the city had been prepared (in fact, twelve hundred dollars was paid to the assistants City Engineer Keating had executing the plans), it was to me apparent that he would be unable to do anything for the city at large with the law as it then stood, which required property owners to put down a cash deposit of \$1.25 per foot frontage, as in a great many cases owners who were perfectly willing to pay their proportion were not in funds to do so, and in other cases where the owner was eager to have the work done, his adjoining neighbor had made some temporary arrangement that satisfied him, and as a consequence he would not put up the deposit, and in that way we were handicapped and could not advance the work with this state of affairs. I looked about for a remedy, and at a meeting of the Conncil held March 22nd, 1887, I moved a resolution which was favorably entertained by the Council and passed, wherein it was proposed to give property owners ten years in which to pay their proportion of frontage rates. The Recorder was instructed to draft an act for submission to the Legislature embodying this idea, which was done ; but when submitted to the Committee on bills in the house it was not reported up. This having come to our notice I called the attention of the Council to it, and by unanimous consent I was allowed to call the matter up again and get a resolution passed on April 28th, 1887, again calling upon the house to pass the bill, which in compliance with our wishes was done; but the bill was shorn of its money power to enable us to carry it out. The citizens by this time having been thoroughly aroused as to the necessity of proper sanitary provision joined with the Council at a subsequent meeting of the Levislature and pressed upon them the needs of the city in this respect, and an act was passed placing ample funds at our disposal for some time. This the citzens lost no time in taking a lyantage of, and as a consequence the works department has not been able as yet to over-take the demands made upon it. To illustrate the advantage that has been taken of this act and how much it was needed previous to its passage, say from '74 to '87, we had but 41 sewers including the mains, total length 26,166 ft., while since its passage, to comply with the wishes of the people who have kept up an incessant clamor for sewerage facilities, we have built 132 sewers, total length 62,184 ft., so that in the near future we shall have the city and suburbs placed in a good sanitary condition, which is something to be thankful for, and I have yet to hear of a taxpayer who disapproves of the money spent to forward this object.

Variovs improvements and extensions of the water service have taken place during this time, and it is gratifying to know that whilst we have been enabled to extend the water north, south, east and west, the revenue derived from this source has permitted us to make frequent reductions from the original rates and place at the disposal of the citizens a water supply equal to, if not superior to that enjoyed in any other city.

In consequence of the great advances made in electrical service, we have the city lighted by electricity, which, although costing a larger sum annually, is a boon that no citizen would now forego for a corresponding reduction in his taxes.

The New City Hall has also been completed. The corner stone was laid on the 21st June, 1887, the work was pushed forward and accomplished since, and we have now a hall that does our city credit and will compare favorably with the public buildings in cities of far more pretentions.

The present Poor's Asylum was erected and equipped at considerable cost to the city, but in that institution the poor are generously cared for and the rules governing the Asylum, which were submitted 15th Augut, 1887, have, with modifications that have occasionally been found necessary, worked satisfactorily.

Various sums have been granted for the purpose of fostering exhibitions in the city from time to time, and my opinion is that as the spirit of the age is to encourage these shows, we must to hold our own in that respect, without going beyond reasonable bounds in the expenditure, do the same as others are doing

Large sums have been and are being spent on schools, and whilst there are some who complain of this expenditure, I do not see how, if we desire to progress with the world, we can relax any of our educational expenses

On account of the increase in the number of buildings and the large area over which they were spread, it has become a necessity to make changes in the Fire Department appropriation, as the time had gone by in which you could expect to have the apparatus brought to and worked at fires by hand, so steam fire engines had to be procured and drivers and horses attached to hose carriages. This has added largely to expenditure in that department and there is every probality of its necessarily increasing by the addition of a wholly paid department in the near future.

The vexed question of providing proper Cemetery accomodation, in consequence of the Camp Hill and Holy Cross Cemeteries having reached their limit, has been overcome. and all denominations are now provided for, and it is to be hoped the new cemeteries will be satisfactorily laid out.

To meet the demand for better roads and sidewalks a large amount has been spent on this service in providing a steam roller and stone crusher, concrete sidewalks, paving, curbing and gutter stones. I would not advise the laying of much mcre of the concrete sidewalks, as in my opinion good asphalt is the best for the residential part of the city, and when the Council is prepared to go on with it I think asphalt will be the best and cheapest material that can be used.

I have been disappointed in that the railway facilities the city has been striving for such a length of time have not materialized. The Council has done its part to obtain that end, as on reference to the minntes of March 26th, 1890, it will be seen that by a resolution I moved at that meeting the Council generously supported measures to have the work, with the widening of Lockman Street, pushed on; but the Dominion Government did not co-operate with us, having decided on another course, which having long delayed, we hope will be accomplished during the coming season, and it is to be earnestly hoped no patch-work measures will be adopted, but the terminus will be such as all can be proud of. To do this it will be necessary for the government to place a good sum in the estimates for this year and clear out all the old buildings now occupied by the marine and fisheries department and others; have a clear site and not let those old buildings stand in the way when a durable, permanent work is to be accomplished. I have had some correspondence with the railway deyartment on this subject, and I handed John F. Stairs, M. P., some time ago a plan of the proposed extension. He mislaid it or handed it to Sir Wm. Van Horne when here, and I have been unable to get it back, nor has he apparently succeeded in tracing it.

have been unable to get it back, nor has he apparently succeeded in tracing it. We have made large additions to the books in the library and this has been appreciated by the public, as is shown by the very large increase in the number of books issued, and our Local Government is about to grandly supplement this boon to the city by the provision they are making in the contemplation of erecting a building for that and other purposes.

I am pleased to inform you that the measure taken by the council to place the management and control of the police in the hands of a commission has worked very satisfactorily. The chief has been constant and faithful in attending to the duties assigned to him. The sergeants and men have given every satisfaction. The detective is ever on the alert when duty calls, and I think our force compares favorably with a corresponding number of any other city. The council will have to make some other provision apart from the superannuation fund for the retiring of some of the men now on the force who have given the city long and faithful service; the amount available from the fund being of no service for some years yet, I would suggest that a certain amount be supplemented from the unexpended balances for a few years until the fund is strong enough to stand alone, as under existing circumstances it is not likely to be of any use to any man now on the force. I am sorry the men did not come forward earlier in the year with their petition in regard to salary, so that the question could have been dealt with and legislation secured if the Council had taken action in the matter. However, it may be kept in mind and something accomplished by next year.

It was my good fortupe to be the head of the works department to carry into effect the much needed improvement in the water service connected with the extension of the so-called new pipe line. There was a doubt in the minds of some as to the value of this extension, and I am pleased to inform you that it has fully realized the expectations of the promoters of the measure. and I doubt if there is any one to be found but who is satisfied that the work was well performed.

This year a large extension is to be made in Willow Park, and those living within that district will then enjoy the advantages long held in other portions of the city.

The visit of their excellencies the Governor-General and Countess of Aberdeen to our city last year was one of the most pleasing that has ever occur ed in our city. Other Governors-General and their wives have visited us in the past, but none of them was able to enter into and hold the affection of us all as his excellency the present Governor-General and the Countess of Aberdeen. They hold the minds and hearts of our people by the innate goodness of their own dispositions, and having hearts and sentiments in touch with the people that make them beyond question rulers that we shall always thank God for having had. They were pleased with the attention shown them and I feel sure that their visit was as fully appreciated by them as we were delighted with their presence amongst us and honored by their company.

The plans for the widening of Lockman Street, together with an estimate of its probable cost, are now before you, and you will observe, if our calculations prove correct (and the department has taken considerable trouble to make them so), that this work will not cost anything like the sum that it was thought by some of our citizens it would, and there is every liklihood if the work is carried out that the increased value to the property would justify an incre-sed assessment on it, that the citizens as a whole, while sharing the advantages, would not be called upon to pay anything additional in their taxes over and above what they are paying now. Knowing that the council has had the matter under consideration for some time, and will deal with it in a manner which they think will be in the best interests of the city, I will make no recommendations here other than that contained in the report from the works department.

other than that contained in the report from the works department. Reports from the various departments will be submitted, which I hope will prove satisfactory.

I am in a position to say that the citizens have secured good and faithful service from the various civic officials on our staff, whom I have found diligent and attentive to the duties assigned them.

This gives a partial summary of the work that has been performed during my time, which you in your wisdom will continue as circumstances may call for.

I will now bid you an official good-bye, assuring you that I shall ever cherish kindly remembrance of my association with you.
