Memorial of Fred Spain and other hackmen against the wearing of badges on their hats.

Moved by Alderman Outhit, seconded by Alderman Mosher, that the Order of the Day be suspended to read the papers submitted. Motion passed.

His Worship the Mayor now asks His Honor the Recorder for his opinion as to whether the Halifax Electric Tramway Company have complied with certain provisions of their charter to an extent sufficient to justify the City Council in recognizing them in any way in the consideration of electric street railway matters, it being His Worship's opinion that before the said Halifax Electric Tramway Company can commence business it is necessary that they should pay into the Supreme Court at Halifax the sum of fifty thousand dollars to settle the claims of the Street Railway Company now in operation.

His Honor the Recorder says that he is not aware that the Halifax Electric Tramway Company have paid into court the said sum of \$50,000 for the benefit of the old Street Railway Company, and that until the claims of that company are amicably settled the company now seeking privileges of the City Council have no authority under their charter to commence business.

Moved. by Alderman Dennis, seconded by Al!erman Stewart, that Mr. B. F. Pearson, the solicitor of the Halifax Electric Tramway Company, be permitted to take a seat within the Council rail in order that he might afford to the council any information required on the Motion passed. Mr. Pearson having in accordance with the subject foregoing resolution taken a seat within the Council rail is asked by His Worship the Mayor to state if the Halifax Electric Tramway Company is legally organized and if they have paid up the amount of stock specified by their charter. Mr. Pearson in reply savs that the Provisional Directors of the Halifax Electric Tramway Company have not taken steps to have the stock paid up but that the organization of the company is now going on, over \$100,000 worth of supplies have been contracted for by the Provisional Directors and the money provided to pay for them; that the Provisional Directors are authorized to go ahead and do what is necessary to have the tracks built this year, and that amicable arrangements have been made (under one section of their charter) with the old company by which the old company will hand over all their property to the new company within a few days.

His Worship the Mayor says if the new company are not organized and if they have not paid into court the \$50,000 for the old company the delay is not the fault of this Council.

In answer Mr. Pearson contends that the only clause which says the company cannot commence business is the clause requiring stock to the amount of \$200,000 to be paid up before business is commenced and that the clause relating to the settlement of the claims of the old company does not prevent the new company from doing business until said claims are satisfied.

The Halifax Electric Tramway Company are simply asking the Council now that if they do organize now that they will be permitted to lay their tracks on certain streets so that they may be in a position to do business.

The new company are not required to pay into court the \$50,000 until they go to tear up the tracks of the old company. They have now authority from the Legislature to lay tracks on the streets where the tracks of the old company are now laid and the only request they now make of this Council is to be permitted to lay tracks on streets where the old company have not got them; this will not in any way injure the old company.

Mr. Pearson withdraws the application for permission to lay tracks on North Street from Lockman Street to Upper Water Street.

The following resolution is now introduced :

Whereas, By section 3 of its charter, the Haffax Electric Tramway Company, limited, were given the right and privilege to construct, maintain and operate a line of single track electric railway upon and along certain streets in the City of Halifax, named in said charter, and also along such other streets as the City Council for the City of Halifax should determine;

And whereas, It is considered, in order to make the said tramway service more effective, leave should be given, to said company by the City Council to extend their tramway upon and along other streets in the City of Halifax, besides those named in said charter;

Be it therefor resolved and determined, That the said Halifax Electric Tramway Company, limited, may, and the right and privilege is hereby granted it, so soon as it shall have been organized under the provisions of its said charter and subject to its terms, to construct, maintain and operate a line of single track electric railway or tramway, with the necessary sidetracks, switches, turnouts, and other appliances for the passage of cars, carriages and other vehicles upon and along the portion or portions indicated of the following streets, in the City of Halifax, to wit:

1st. Along Jacob street, commencing at Brunswick street, thence running easterly to Grafton street, thence southerly along Grafton street to Buckingham street, thence easterly down Buckingham street to the eastern side of Granville street.

2nd. Commencing at Roome street and running thence to Richmond street on Campbell road.

3rd. Commencing at east side of Lower Water street, at the foot of Morris street and running thence westerl on Morris street until it joins the main line at the junction of Morris and Hollis streets.

4th. Commencing at Fawson street on Lower Water Street, and running thence northerly to the south side of Morris street.

5th. The construction of said railway shall be subject to the terms and conditions of the charter of said company.

6th. Further resolved, That the company shall do no work in or upon any of the streets mentioned in these resolutions in the City of Halifax until the company shall satisfy this Council that it has been duly organized according to the terms of its charter, and that the rights and franchises of the old street railway company have been duly transferred to this company under either section 17 or 37 of its charter, and this Council shall determine by resolution that such has been done. Moved by Alderman Redden, seconded by Alderman Dennis. On motion said resolution is considered clause by clause.

Read clause No. 1, re Jacob Street. Moved by Alderman Redden, seconded by Alderman Dennis, that this clause do pass. Said motion being put is passed, 13 voting for the same and 5 against it. The names being called for there appeared.

Be it resolved and determined, that the Halifax Electric Tramway Company, limited, may, and the right and privilege is hereby granted it, so soon as it shall have been organized under the provisions of its charter, to construct, maintain and operate a line of single track electric railway or tramway with the neressary side tracks, switches, turnouts and other appliances for the passage of cars, carriages and other vehicles upon and along the portion or portions indicated of the following streets in the City of Halifax, to wit:

1st. Commencing at a point where South Park Street crosses Spring Garden Rold, thence running northerly along South Park Street, thence North Park Street and Agricola Street to Almon Street, thence westerly along Almon Street to Windsor street or Willow Park.

2nd. Also commencing at a point on Pleasant street at the foot of Morris street, thence running along Morris street to South Park Street. That said company shall construct its line as provided in its charter as far west as Windsor street before the first of August, 1896.

3. The construction of said railway shall be subject to the terms and conditions of its charter.

TRUCKMEN'S PETITION.

JULY 24th, 1895.

His Worship the Mayor.

Sir,—The accompanying petition from city truckmen having been referred to me, I beg to submit the following report :—

The usual rate of wages paid by this department to truckmen is two dollars (2.00) a day for ten hours. During the last three years we have done all work that it was possible to carry out by contract, under that system and we have adopted the same principle in hauling stone for street purposes. When teams are employed to haul broken stone to any street they are paid by the load, and the rate per load is fixed at such a figure that truckmen will be able to make two dollars (\$2.00) a day. In the case referred to in the petition, the truckmen were told to start at twenty-five cents (.25) a load. I instructed Mr. McDonald to ascertain how many loads each truckman should be expected to haul and rate them accordingly. They would only haul six loads, and I declined to increase the allowance to them unless they would haul more stone. They claim that they have hauled all that can be hauled that distance in a day; this however, is not correct. While the teams working for the City have hauled eighty-four bushels of stone to Cornwallis street and would haul no more, the same sized carts have been hauling one hundred and twenty-five bushels to Water street. I have asked the opinion of several employers of truckmen as to the quantity of stone that should be hauled to Cornwallis Street in a day, and they have agreed with me that the quantity hauled is not enough; and as I have already said the truckmen themselves have proved that they have not been doing a fair day's work for the City as they do for a private contractor.

I have no wish to reduce the rate of wages paid to truckmen or anybody else, and when they give the City a fair day's work they have always received a fair day's pay. If they had hauled one hundred and twenty-five bushels to Cornwallis street-the same quantity that they have hauled to Water Street, one mile further down town—they would have made their full rate of wages of two dollars (\$2.00) a day. If they had made any effort to haul more stone, I should have been ready to meet them half way. The trouble in the past has been that truckmen and ordinary laborers seem to have an idea that they may take their own time on city work and demand the same pay for half the work that they would be entitled to for a full day's work. The sconer the city employees are taught to understand that they should work as faithfully for the City as for anybody else, the sooner will the City get one hundred cents value for every dollar expended.

I do not make these remarks in any spirit of antagonism toward the truckmen or their petition, but only to carry out a principle that I have been endeavoring to put in operation for the last three years; and I trust that the Council will not ask this department to pay men money that they do not fairly earn.

LETTER FROM DAVID LAURINSON.

July 16th, 1895.

His Worship the Mayor:-

SIR,—I beg to report on the accompanying letter from David Laurinson respecting a drain on Cornwallis street.

I have asked Mr. Johnston for a statement of the facts and enclose his reply-He says that he has no recollection of any conversation with Mr. Laurinson in reference to the matter. The permit was issued to Mr. Mulroney, himself and no application was made for the location of the junction of the sewer until after the work had been started. Mr. Laurinson then applied for the position of the drain and was told where it was. He discovered that he was several feet out of the way and was obliged to change the excavation so that he could connect with the proper junction.

Mr. Morrison, Foreman of the Water Department, estimates the extra cost of his work at \$2.00 instead of \$10.00 named in his bill. The claim is a very peculiar one and I cannot see how the city could recognize it either legally morally, or in any other way.

There was no mistake made in giving the location of the drain as the measurement was correct and any extra cost to Mr. Laurinson was caused by his own neglect and carelessness. Under these circumstances I cannot see why he should appeal to the city as they are in no way responsible.

SIR.—With regard to the accompanying letter from David Laurinson, I beg to report as follows :

On the 3rd June a permit to connect the Atlantic Hotel with the Cornwallis street sewer was given to John Mulroney. A day or two later, David Laurinson came to the office and saw Mr. Pickering and asked the latter if there was a connection left in the Cornwallis street sewer for J. Mulroney's property. Mr. Pickering turned up the plans and told him there was one fourteen feet from the manhole on Water street. Laurins n said he was a few feet away from this, and Mr. Pickering told him it was necessary to connect into the connection which had been left. These are the facts of the case as far as I can ascertain.

As regards my telling Laurinson that there was no connection left in the sewer, I have no recollection of any conversation whatever with him. It was not possible that I could have told him there was no connection as there is one distinctly marked on our plan of the Cornwallis street sewer. It is altogether likely he would have told Mr. Pickering when he asked if there was a connection left that I had told him there was none if I had done so.

With regard to his claim of ten dollars for extra work Mr. Morrison, the foreman of the water department saw the amount of extra work that was necessary

to be done to connect into the connection and he estimates it at two dollars, and says this is very liberal. Mr. Donovan who also saw it makes the same estimate.

HOLLIS STREET SEWER.

July 31st, 1895.

His Worship the Mayor:

Sin —I beg to report on the accompanying petition from agents and owners of property on Hollis Street between Prince Street and Sackville Street :

The sewer has been ordered in accordance with the law on the recommendation of the City Engineer. There are no properties on the eastern side of the street as far as I can ascertain which have drainage through their own premises, and to the public sewer. Some of the properties on the western side of the street have no drainage whatever.

There have been several complaints from tenants in the block respecting the old privy vaults and other nuisances which cannot be removed until there is a sewer in the street, as the law authorizing the Board of Health and the City Council to remove such nuisances is only affective when a sewer is constructed in the street. When the sidewalks were laid we were obliged to conduct the water from the down spouts across the sidewalks, in direct violation of the law, as there were no drains to which they could be connected.

Any property which already has good drainage will not be compelled to connect with the new sewer. The City however, cannot relieve any property in the block from payment of sewerage rates, as Section 504 of the City Charter specially provides that no property whatsoever liable for sewerage rates shall be relieved from payment of the same under any circumstances.

feet wide along the eastern side of said Lockman Street, and to sell to the Dominion Government such portion of said block of land as may lie east of a straight line drawn from the southeast corner of the Passenger Station at North Street, parallel with Lockman Street, until it strikes Cornwallis Street.

That said Commission shall be empowered to lay off to the westward of said line a street of sufficient width in substitution for said Water Street, which may be sold in addition to said land to said Dominion Government for railway facilities.

SIR,—The accompanying petition referred to me is signed by property owners on Agricola Street between Willow Street and North Street. LETTER FROM W. F. PARKER RE LOCATION OF TELEPHONE POLES.

His Worship the Mayor,

SIR,—The Halifax Electric Tramway Co., applied to the City Engineer for permission to erect poles on Coburg Road among other streets and asked me to locate poles to be placed there.

In order to place the poles in the proper position I was obliged to ask the Telephone Co. to alter the position of some of their poles. They have a line of poles which have been in use for some time on the south side of Coburg Road, and in compliance with my request have altered the location of several of them.

In spacing the poles the one nearest Mr. Parker's house came immediately in front of it, and to make it as unobjectionable as possible I had it removed beyond the line of his house. It could not be moved farther away without making the length of span dangerous so that the wire would sag down on the street railway wires.

I examined the bottom of the hole before the pole was placed in it and it was apparently solid rock, consequently there could be no water pipe or drain pipe under the pole, and I have written to Mr. Parker to that effect.

All property owners object to poles in front of their property, but they must be placed somewhere and we are placing them where they will be as little inconvenience as possible.

PAVING LOWER WATER STREET.

His Worship the Mayor,

SIR.—The work of paving Lower Water Street is approaching completion, when this work is finished Water Street will be paved from Cornwallis Street to Morris Street. There will still be one block at the south end unfuished, name¹y :—the block between Morris Street and Fawson Street. There is is a good deal of traffic on this portion of Water Street, principally by truckmen hauling coal from Boak's wharf, Dominion wharf, McKenzie's wharf and others. All coal carts going south go to the south end of Water Street and through Fawson Street on their way fafther south to avoid the hill on Morris Street. The Street Railway car shed is being built in this block, and besides the main line approaching the car shed there will be sewer branch lines which will cross the street and enter the build-

ing. These tracks will occupy the whole street at that point, and as the soil is wet clay, like brick clay the street will be almost impassible for truckmen unless it is properly paved. The work on Water Street is being done below the estimate and there will be sufficient material remaining to do the block as we are leaving out a portion of the Market Square, which at first it was proposed to pave. I would recommend that the material provided for the Market Square be put down on the south block of Water Street, so that the street will be in good condition for truckman working in that neighborhood. The expense will not be great as the Street Railway Company will be compelled to pay about half. I would recommend that the work be done when the street railway track is being laid.

His Worship the Mayor :--

Sept. 3rd, 1895.

Sin,—The accompanying letter from Moir Son & Co., complaining of the rates charged them for use of water having been referred to this department. I beg to report that the matter was before the Council last year. A letter was received from Moir Son & Co., early in the civic year but was not dealt with until nearly the close of the year. A reduction was made in the meter rates to take effect on the first day of May, 1895. The water rate was at that time considered excessive and as the council by passing a resolution to adopt the reduced rates, have admitted that the charge last year was excessive. I think the reduction should have dated from the lst of May, 1894, instead of 1895. If this were done I think it would satisfy those complaining of the cost of water. I would therefore recommend that a rebate be made in this years water bills to all those affected by a reduction in meter rates for last years consumption. That is that the amount by which their bills would have been reduced last year shall be credited in this years account,

SIR,—The north half of that portion of Henry Street and Edward Street lying between Morris Street and South Street was deeded to this City about twenty or thirty years ago. The southern half of these two blocks has never been taken over by the City. With a good deal of trouble I have succeeded in getting a deed from the Shields estate, who own the property in the southern half of these streets, and I beg to submit the deed, which has been approved by His Honor the Recorder, and a plan of the street showing the property deeded. As the deed of the street has now been submitted and accepted by the Council I beg to submit the - following report:

We the undersigned, Arbitrators in Milsom vs. City of Halifax agree and find the value of the within described property to be one thousand dollars; in addition thereto we allow Mr. Milsom fifty dollars, legal expenses in connection therewith.

This agreement made in duplicate the twenty-fifth day of July, in the year of our Lord one thousand eight hundred and ninety-five, between John Milsom of the City and County of Halifax, in the Province of Nova Scotia, Esquire, of the First part, and the City of Halifax, a body corporate, of the second part;

Whereas, the City of Halifax have agreed to purchase from the said John Milsom a part of his lands situate on the first Chain Lake, that is to say the portion or tract of land hereinafter described; and the said John Milsom has agreed to such purchase; that the question what sum the City of Halifax ought to pay to the said John Milsom as the fair value of the said portion or tract of land with the rights, easements and appurtenances thereunto belonging, and as hereinafter described, shall be referred to the award, order and final determination of John P. Longard of the said City of Halifax, an Arbitrator chosen by the said John Milsom; William Woodill of the same place, Victualler, an Arbitrator chosen by the said City of Halifax; and to such a third Arbitrator as the said John P. Longard and William Woodill should by writing under their hands, before they enter on the business of the reference, nominate and appoint to act with them.

And Whereas, the said John P. Longard and William Woodill as such arbitrators duly nominated and appointed by the respective parties hereto, have by writing under their hand duly chosen and appointed as such third Arbitrator as aforesaid, Brooks W. Chipman, of the said City of Halifax. Esquire.

Now therefore this Indenture witnesseth, that for the purpose of effectuating the said recited agreement, it is hereby covenanted and agreed by and between the parties hereto in manner following :-

1. That the matters and question aforesaid be and the same hereby are referred to the award, order and final determination of the said John P. Longard, William Woodill and Brooks W. Chipman, so as the said Arbitrators or any two of them make and publish their award in writing, signed by them or any two of them of and concerning the matters referred, ready to be delivered to the parties or either of them on or before the thirty-first day of August, A. D. one thousandeight hundred and ninety-five, or any subsequent day to which the said Arbitrators shall from time to time by writing under their hands extend the time for making the said award.

2. That the portion and tract of land hereinbefore mentioned the fair value of which is to be determined as aforesaid, is the portion and tract of land particularly described as follows :--

"All that lot, piece or parcel of land, situate, lying and being in lot No. 10 of the Dutch Village lots near the Chain Lakes in the County of Halifax, the said lot being more particularly described as follows:—Beginning at a granite stone marked H. W. No. 12, situated on the northern boundary line of the said lot No. 10, distant thirty-one hundred and fifty feet more or less, from the Dutch Village Road; thence S. 12 E at right angles to the north boundary line, to the southern boundary line of said lot No. 10; thence S. 78 W. along said southern boundary line of said lot No. 10 to the south-west corner of the lands belonging to the said John Milsom; thence following the courses of the western boundary of the said lands to the north-west corner of them; thence N. 78 E. along the northern boundary line of said lot No. 10 to the place of beginning."

3. That the Arbitrators shall be at liberty to proceed ex party in case the other party after reasonable notice shall at any time neglect or refuse to attend on the reference without having previously shown to the said Arbitrators what the latter shall consider good and sufficient cause for failure to attend.

4. That the witnesses on the reference and the parties if examined shall be examined on oath or affirmation.

5. That the parties respectively shall do all acts necessary to enable the Arbitrators to make a just award and that neither of them shall wilfully do or cause to be done any act to delay or prevent the Arbitrators from making their award.

6. That the parties shall on their respective parts in all things obey, abide by, perform, fulfil and keep the award so to be made and published as aforesaid.

7. That the reasonable charges of the said three Arbitrators shall be paid by the City, or in such other way as the Arbitrators shall direct; but the amount to be paid each Arbitrator shall in no case exceed twenty-five dollars each.

8. The award of the said Arbitrators or any two of them shall be final and conclusive. That upon the making and delivery of the said award or within a reasonable time thereafter, the said John Milsom upon payment or tendering by the said City of Halifax the amount awarded him by the said Arbitrators or any two of them as aforesaid shall make, execute and deliver to the said City of Halifax, a good and sufficient deed of conveyance of all his right, title and interest in and to the said tract and parcel of land hereinbefore described, free from encumbrances, lien or claim and with the usual covenants.

9. Provided nevertheless, and it is hereby agreed and understood between the parties to this agreement that nothing in this agreement contained shall in anywise prejudice or affect the right of the said John Milsom to proceed to finaljudgment in that certain action between the parties hereto, commenced and prosecuted by him as plaintiff, against the said City of Halifax as defendant, touching certain alleged trespasses by the defendant upon lands of the plaintiff being the cause or action in the Supreme Court at Halifax, number A.—No. 6652 and which is now standing for trial in the said Court.

STREET LIGHTING.

August 20th, 1895.

His Worship the Mayor :

SIR,—In accordance with a resolution of Council, I beg to report on the accompanying petitions protesting against the removal of lights at the Paint Factory and on Coburg Road.

I cannot reply to the claims of the petitioners against the removal of lights on Coburg Road, as the matter is not one for argument, as they present it. It is absolutely necessary, in order to keep within the appropriation, that a number of lights should be discontinued, and I find it impossible to make a selection which will leave out the lights on Coburg Road referred to in the petition.

In reference to the other petition, I may say that being at a crossing of a railway track, there may be danger if it is left in darkness, and it would probably be advisable to allow that light to remain and remove another instead. I would recommend that No. 176, at the corner of Liverpool and Windsor Streets, be removed instead of No. 208—the light at the Paint Factory.

As this matter has been delayed another month it will be necessary to discontinue one other light in order to keep within the appropriation, and I would recommend that No. 100, on Quinpool Road, be discontinued in addition to those already recommended.

I am unable to make any selection which would be less objectionable than that already recommended, except the light at the Paint Factory, and I would therefore again recommend that the lights named in the former report, except 208, together with 176 and 100 be discontinued until the end of the year.
