SIR,-I beg to report on the accompanying petitions for water extension to properties on J ibilee Road and Maple Street.

Manle Street is not the property of the City, and has no definite line, grade or location. In fact, South of Jubilee Road it is an open field, and North it is lit le tetter, and I cannot recommend any water extension in it while it is in its present condition.

To extend the water on Jubilee Road, far enough to supply the petitioners 745 feet of 6 inch pipe would be necessary connecting with the high service The excavation will be solid rock. The estimated cost is

## BARRINGTON AND BUCKINGHAM STREETS SEWERS.

#### February 26th, 1896.

#### His Worship the Mayor :

SIR,—The sewer system on the supposed line of the street railway is nearly all constructed or ordered where there is any immediate necessity for new sewers, with the exception of that on Barrington Street between Buckingham and George Streets and on Buckingham Street, between Granville and Grafton Streets. There will be a crossing at Buckingham Street with curves on both sides under which it would be very difficult to construct a sewer after it is laid as the ties are placed close to ether. The old sto e sewer on Buckingham Street causes the freezing of the fire hydrants every cold winter, and as the district covered by these hydrants is one of the most important in the City, this condition should not be allowed to continue. Under the circumstances, I would recommend that these sewers, namely, on Barrington Street, from Buckingham Street to George Street, and on Buckingham Street, from Granville to Grafton Street, be constructed before the street railway track is laid. The estimated cost of the Barrington Street sewer is \$2,500. Estimated rates \$1,137.50. Buckingham Street, estimated cost, \$2,600; estimated rates, \$712.50.

#### MISS NORDBECK'S LETTER, SEWERAGE ASSESSMENT, COBURG ROAD.

February 26th, 1896.

#### His Worship the Mayor :

SIR,—The accompany letter of Miss Nordbeck referred to this department, complains of an assessment for Sewerage sixty feet beyond the end of the Coburg Road Sewer at Walnut Street. She objects on the ground that the property could not be drained into the 'ewer. There are many places in the City where the cellars of properties fronting on a street through which a sewer runs could not be drained into the sewer, but for which sewerage assessment has been paid. In nearly every case the plumbing of the building can be drained into the sewer, and it is only the bottom of the cellar which cannot be so drained. While this at times is a hardship, it seems to be unfair to exempt the property from sewerage tax while a benefit can be obtained. The property opposite that owned by Miss Nordbeck, on which there are two houses, has been drained into the Coburg Road Sewer, and the only result of exempting Miss Nordbeck's property would be that she would not have to pay the sewer tax until she erected houses on the property, at which time she would be obliged to pay the same as the property on the other side.

Under these circumstances I cannot recommend the granting of her request.

And whereas, It is generally recognized that the Act now in operation is unworkable in a city situate as Halifax is, being a seaport town and army and navy station, and having a large floating population during the summer months;

And whereas, The Council is desirous that the liquor traffic in this city should be so restrained and regulated as to conduce to temperance and sobriety among the citizers, and to that end such a license law should be framed as will receive the moral sanction of the majority of our people and can be enforced with strictness and efficiency;

Therefore resolved, That His Worship the Mayor is requested and empowered to appoint a committee of six members of this Council to confer with a committee of a like number to be nominated to represent the recognized temperance bodies of the city with the object of framing a License Act adapted to the requirements of the City of Halifax, which Act shall be prepared in time for enactment at the next session of the Provincial Legislature. Moved by Alderman Hamilton, seconded by Alderman Redden, and passed.

Moved by Alderman Stewart, seconded by Alderman Redden, that No. 13 on Order Paper be now taken up. Motion passed.

Read No. 13, viz., Letter Board School Commissioners asking that the amount appropriated for school purposes be paid to the board in equal monthly instalments.

His Worship the Mayor requests the Council before entering upon the ordinary business of the meeting to consider the advisability of taking immediate steps to endeavor to secure for Halifax, commercial benefits to which the city is entitled. Nothing should be left undone that would assist in enabling Halifax to become the Winter Port of Canada. One of the principal obstacles to the attainment of this object is the freight rates on goods forwarded over the I. C. Railway between Halifax and the west. At present the tariff discriminates unjustly against our city, in favor of other ports. #### DRINKING FOUNTAINS.

## His Worship the Mayor :

SIR,-I beg to report on the accompanying letter from the Ladies' Auxilliary of the S. P. C. referred to this Department.

F. D. Corbett has requested that the Drinking Fountain for animals placed on Bedford Row, in front of his property, should be removed to some suitable place. The Ladies' Auxiliary of the S. P. C, are desirous of erecting in some convenient

The Ladies' Auxiliary of the S. P. C, are desirous of erecting in some convenient place in the City another d'rinking fountain for animals, and are of the opinion that the new fountain should be placed on the space formerly occupied by the City building.

There is no doubt that the existing fountain on Bedford Row, in its present location is a nuisance for many reasons, and the centre of the square would be a more convenient place for these using the fountain, while it would be more out of the way of public traffic.

The Department would, after consideration of the matter, recommend that permission be granted to the Ladies' Auxilliary of the Society for the Prevention of Cruelty to erect a Fountain on the Square North of George ! treet, provided the design of the fountain the exact location, the method of construction and erection, etc., are satisfactory to this Department.

The Works Department would also recommend that the old fountain on Bedford Row be removed to the corner of North Street and Campbell Road. There is nothing of this kind in the North end, and if located at this point it would be a great convenience to men and animals.

GENTLEMEN,—At the meeting of the Commissioners of Halifax Common held at the City Hall on the 4th inst., at which were present (ommissioners Mitchell, (Chairman) Lane. Redden, Creighton, Geldert, Scanlan, Morrow and Pickering, they had before them an application from the Wanderers Amateur Athletic Club asking for an extension of the present lease of the grounds occupied by them.

It was shown to the satisfaction of the commissioners that during the present lease the Wanderers have spent nearly ten thousand dollars upon the property in fencing, laying off tennis courts, bowling greens, cricket crease, building of track, grand stand, pavilion, and general improvements, etc., and as it is the intention of the Wanderer's Amateur Athletic Club to further improve and beautify the grounds at a cost of about \$2000.00, they feel they would hardly be justified in so doing with the present lease expiring at so early a date.

By Chapter 59 of the Acts of Nova Scotia, 1886, (and by virtue of which Act the city is authorized to lease this and adjoining property) the City of Halifax upon request of the Commissioners of Halifax Common may lease this property for such period at such rental and upon such other conditions as said commissioners shall determine.

The commissioners recognizing the legitimate and heathful recreation afforded every class of our citzens by the existence and the encouragement of such worthy institutions, it was unanimously *Resolved*, That a lease of fifteen years be now granted to the Wanderers Amateur Athletic Club, upon the same terms and conditions as heretofore- The same to commence and take effect at the expiration of the present lease. Also, further *Resolved*, That the Secretary communicate the same to the City Council for their information and concurrence.

Read report of Special Committee on reorganization of the Fire Department.

The committee appointed for the purpose of organizing the paid fire department present their report as follows:

1. The committee recommend the appointment of the following officers and men, who, until further provided, and subject to the provisions hereinafter mentioned, shall constitute the department: A chief of department, an assistant chief, two or more district chiefs, two pipe men for chemical engines, four engine men for steam fire engines, fifteen drivers and seventy-six call-men.

2. The committee recommend that the duties of assistant chief be performed by the present caretaker of City property, who, in addition to the duties hereinafter mentioned, shall be required, under the chief, to see that all fire engines, hooks, ladders, ladder carts, waggons, horses and all other apparatus and

appliances appertaining to or used in connection with the department are kept in good order and condition, and constantly fit for service.

As the duties just enumerated have for some time heretofore been performed in a satisfactory manner by the caretaker of City property, and as the salary of that officer for the coming civic year, has already been provided for in the estimates, the committee are of the opinion that it would not be expedient at the present time to make any change in the duties now performed by the caretaker in connection with the fire department.

3. As the duties which would otherwise devolve upon the chief of the department will, for the present, to a considerable extent, be performed by the assistant chief, and as the chief of the department will not be required, in consequence, to devote his whole time to the service of the City, the committee are of the opinion, and would recommend that the appointment to the office of Chief of the Fire Department should not now be made for a longer period than one year.

one year. 4. The committee have carefully considered the question of the cost of the department, and the amount of salaries and wages payable to officers and men and report their estimate for the following year for the approval of the council:

5. The committee recommend that the Chief of the Department, as soon as practicable, after his appointment, furnish the Board with the names of such number of men as it may be necessary to appoint in addition to those now employed, and, on such names being approved, at once proceed to organize the various companies.

In making all recommendations, whether on the organization of the department, or in filling vacancies which may occur thereafter, the chief of the department shall be governed by the following considerations: The men recommended for appointment shall be of strictly temperate habits; of good moral character; and certified by the City Medical Officer to be in good physical condition.

While it is not desired to exclude experienced men now connected with the department, the men recommended for appointment generally shall not be upwards of thirty years of age; and after the department is once organized, no appointments of men over that age shall be recommended or made.

The Board of Fire Commissioners, on recommendation of the chief, shall appoint two or more of the foremen of the department to act as district chiefs, and, in case of the absence of the chief, the senior district chief present shall during such absence have and exercise all the authority of the chief and perform the duties of his office. The officer in command of the company first arriving at a fire shall be the officer in command until the arrival of the chief or one of the district chiefs. In addition to the duties imposed upon him by the Act of the Legislature, the chief of department shall be held responsible for the discipline, good order and proper conduct of all officers and men who are or may become members of the department.

He shall be empowered from time to time, subject to the approval of the Board of Fire Commissioners, to make such rules and regulations for the government of the department as he may deem expedient. He shall be required to furnish the Board with exact rolls of the respective companies specifying the name, age, occupation, place of residence and date of admission or discharge of each member. Immediately upon the organization of the various companies, he shall recommend to the Board for their approval a foreman for each company ; whose duty it shall be at all times to preserve order a d discipline in their respective companies, to require and enforce compliance with the ordinances, rules and regulations of the department, and the orders of the chief of the department The foreman of each company shall be required to report in writing to the chief of the department the name of any member guilty of neglect of duty or disobedience of orders.

The chief of the department shall report from time to time to the Board of Fire Commissioners the names of such officers or members of the department, if any, as, in his judgment, should be removed or discharged, with the reasons therefor and the Board shall have the power at any time to remove officers or men when, in their opinion, the efficiency of the department, or the public interest requires it.

Whenever from any cause a vacancy occurs in the department, except in the office of chief of the department, the chief shall at once recommend the name of some properly qualified person to fill the same. It shall be the duty of the chief of the department to prepare the pay roll of all

It shall be the duty of the chief of the department to prepare the pay roll of all persons constantly employed by the department, and payment shall be made on his approval, and that of the chairman of the board.

The chief of the department shall cause any person intentionally raising a false alarm of fire, to be prosecuted according to law.

6. It shall be the duty of the assistant chief to see that the regulations under title 8 of the Revised City Charter are strictly enforced, and to report all violations of the ordinances relating to buildings, fire limits, etc.

He shall examine all shops and other places where shavings or other combustable materials are believed by him to be collected or deposited, and whenever, in his opinion, the same may be dangerous to the security of the city from fire, he shall direct the owner, tenant or occupant of said shops or other places to remove the same ; and, in case of nsglect or refusal so to do, he shall cause the same to be removed at the expense of such owner, tenant or occupant, who shall in addition be liable to a penalty not exceeding \$20 for such neglect or refusal.

The committee recommend the following general regulations for the approval of the Council :

(a) Every officer and member of the fire department shall sign the following agreement to be deposited with the chief of the department:

I, , having been appointed a member of the Halifax Fire Department, hereby agree to abide by the ordinances of the city, the rules, regulations and orders of the Board of Fire Commissioners and of the Chief of the Fire Department.

Any officer or member who shall neglect or refuse to sign the same shall not be entitled to any compensation whatsoever, and unless he shall so sign within ten days from his appointment, he shall be deemed to have declined the same.

(b) Any officer or member who shall neglect or refuse to perform his duty, or who shall be guilty of any disorderly conduct or of disobedience to any officer, or of the rules and regulations of the department, may be suspended from duty by the chief of the department, who shall within seven days thereafter report his action to the board staing the name of the person suspended and the cause therefor, and the board may continue such suspension for any definite period or remove him from the department. No person so suspended from any duty shall act as a member of the department or be entitled to the pay or to any of the privileges of the department during such suspension, it being provided that the chief of the department shall have power to reinstate in cases which have not been reported to the board. And in all cases of removal from office or from the department, the name of the person removed with a statement of the reasons therefor, shall be entered on the books of the board.

(c) Any officer or member of the department removing permanently from the City, shall thereupon cease to belong to the department.

(d) Every person admitted to the department shall be and remain a member of the company to which he is first assigned until he shall be transferred to another company or discharged, and no member shall be transferred to another company or discharged except by order of the chief of the department.

(e) Every member of the department shall at all fires wear such badge as the Board of Fire Commissioners shall prescribe; and no person without such badge shall, except by permission of the chief, district chief or officer in command, enter within the lines formed at any fire.

(f) If any officer or member shall, except in case of sickness, be absent from more than one third of the fires or alarms of fires occurring during the year, such absence shall be considered good cause for his discharge from the department. An intentional violation of any of the provisions of this ordinance by any officer or member shall also be good cause for his discharge. No company with its apparatus shall leave the City to attend a fire in an adjoining town except by order of the chief of the department and chairman of the Board.

(g) No gambling shall be allowed in any building occupied by any company connected with the fire department, nor shall any spirituous liquors be used therein.

(h) No unauthorized person shall open any of the signal boxes, except in case of fire, or interfere with the wires on the poles or other supports of the wires.

(i) No person shall destroy, injure or deface the fire alarm telegraph or any of its connection, wires or appurtenances or interfere with or do any act to prevent or delay its proper use and operation.

(j) Any person licensed by the Mayor and Aldermen or competent authorities to remove any building or do any act which shall require the cutting or removal of, or any interference with the wires of the fire alarm telegraph, shall first give notice to the chief of department twenty-four hours at least before the same shall be required to be done.

(k) No occupant of any building or room in which there is a hatchway or trap door shall suffer the same to be left open at night.

(1) Any member of the department or person permanently employed therein who may be disabled while on actual service at fires, so as to be unable to perform his duty in the department, shall receive the pay which he would otherwise be entitled to receive from the City during the continuance of such disability not, however, exceeding three months from the time of injury; it being provided that "call" men so injured shall receive eight dollars per week during such disability, not, however, for a longer period than that above named.

(m) The chief of the department before leaving the city to be absent one day or more, shall report his intention to the chairman of the Board of Fire Commissioners. No district chief or foreman shall leave the city to be absent one day or more without first reporting his intention to the chief of the department, or in case of the absence of the chief of department, to the district chief then in command of the department; and in no case shall the chief of department or any district chief or foreman be absent from the city more than six days without the written consent of the chairman of the board. An absence from the city for a longer time than six days except when authorized as aforesaid shall be sufficient cause for removal from office of the person so absenting himself. No member of the department other than those mentioned shall leave the city without having procured a substitute to the acceptance of the foreman of his company.

*Resolved*, That the foregoing report be received and adopted and that the Council proceed at once to the appointment of a chief of the fire department who shall assume the duties of his office on the first day of May next.

Read clause 2. re duties of Assistant Chief, etc. Moved by Alderman Geldert, seconded by Alderman McFatridge, that this clause pass.

Moved in Amendment by Alderman O'Donnell, seconded by Alderman Hubley, that the consideration of this clause be deferred until next meeting. Amendment put and lost.

The original motion is now put and passed.

Alderman O'Donnell gives notice of re-consideration.

Read Clause 3, re appointment of Chief. Moved by Alderman Geldert, seconded by Alderman Redden, and passed.

Alderman O'Donnell gives notice of reconsideration of clauses 1 and 3.

Read Clause 4, re estimates of expenditure.

The following resolution is introduced :

*Resolved*, That clause 4 pass with the provision that no part of the \$4,800 contingencies be expended by the Board of Fire Wards without the previous consent of the Council.

Moved by Alderman Hamilton, seconded by Alderman Redden. Moved in amendment by Alderman Foster, seconded by Alderman Mosher, that said clause be amended by substituting in the item "contingencies" the sum of \$4,300 instead of \$4,800, and providing that the remaining \$500 be set apart to meet a portion of the salary of an electrician to be subsequently appointed. Said amendment on being put is lost 4 voting for the same and 12 against it. Names being called for there appeared :

Read Clause 6 with its several sections, (a) to (m) inclusive, re duties of assistant chief and general regulations for the department, together with resolution re immediate appointment of a chief of the department. Moved by Alderman Mosher, seconded by Alderman McFatridge, that clause 6 be adopted. Motion passed.

Moved by Alderman Geldert, seconded by Alderman Redden, that the report as a whole as amended do now pass. Motion passed. Alderman O'Donnell gives notice of reconsideration.

Moved by Alderman Redden, seconded by Alderman Eden, that John Connolly be appointed the Chief of the Fire Department.

Moved in amendment by Alderman Hubley, seconded by Alderman O'Donnell, that applicants for the position of Chief of the Fire Department be advertised for. His Worship the Mayor refuses to accept the amendment on the ground that the Council had just decided to proceed at once to the appointment of a Chief of the Fire Department, His Worship the Mayor's opinion being concurred in by His Honor the Recorder. On the vote being taken for the appointment of John Connolly as Chief of the Fice Department, there appeared :
