Moved by Alderman Hubley, seconded by Alderman Foster that the time for meeting be extended until 3.30 o'clock. Motion passed.

3.30 Roll called. Present the above named, together with Aldermen Geldert, Creighton, Redden, Campbell, Hamilton, Lane, Mitchell, Rvan, O'Donnell, Eden, McFatridge, Outhit and Mosher

The Council was summoned to consider the estimates for the civic year 1897-8, to proceed with business standing over and the transaction of other business.

The minutes of last meeting are read and confirmed.

# STREET RAILWAY REPAIRS.

#### December 29th, 1896.

#### His Wership the Mayor :

SIR,—The provisions made in the Charter of the Halifax Electric Tramway Company for repairing the streets between the rails and two feet outside the rails have no<sup>t</sup> given satisfaction to this Department, The Ci y should be in a position to cause th<sup>e</sup> Company to make repairs promptly whenever it is deemed necessary.

The clause in reference to Snow removal provides that the Company shall deposit five hundred dollars (\$500), on the first day of November, and that the City may use the money in doing work which the Company neglect to do.

We have no fund from which we can take money for repairing their tracks; and I would recommend that the Act be ammended so that the Company shall be required to keep a sum of five hundred dollars (\$500) on deposit all the year round and that the City may use it in repairing the road at any time when the Company neglect to do so after proper notice.

I think this would be the means of keeping the streets through which the track runs in a better state of repair, and would decrease the number of complaints received by this Department; and it would be far more satisfactory to the Department,

#### SEWER ALMON STREET.

#### December 29th, 1896.

#### His Worship the Mayor:

SIR:—The construction of the new sewer on Gottingen Street made it necessary to construct a small piece of sewer on Almon Street to connect the old drain on Almon Street with the new Sewer on Gottingen Street. We did not expect that it would be necessary to go farther than the forty (40) feet for which the corner properties are exempt, but as the old drain was crooked, we were obliged to go a few feet farther; and I would recommend that the Council authorize the construction of a sewer in Almon Street for a distance of one hundred (100) feet West of Gottingen Street.

Read opinion of His Honor the Recorder as to the course the Council should pursue to obtain from the Halifax Electric Tramway Company, Ltd., certain required information.

#### IN RE ELECTRIC TRAMWAY.

#### December 24th, 1896.

In obedience with the resolution of the Council asking for my opinion as regards what course they should pursue to compel the above Company to submit to this Council. their Time Table and Fees, I beg to report that there is no difficulty in compelling them to submit the Time Table and Tariff of Fees to this Council. If they fail to do so, the Council after the expiration of thirty days after demand can apply to the Supreme Court for a Writ of Mandamus to compel them, and if they fail to comply within a certain time, the Council can then apply to the Supreme Court to forfeit the Charter of the Company. I enclose herewith a resolution, which, if the Council are disposed in the matter, I advise them to adopt.

Resolved, That the Halifax Electric Tramway Company, Limited, incorporated under Chapter 107 of the Acts of 1895 of the Legislature of Nova Scotia, be and are hereby requested to submit to this Council within thirty days from the passing of this Resolution, its Time Table as to the rate of speed for running their cars and their tariff of rates, and its transfer arrangements, for the approval of this Council under Rule 8 of its Charter.

Further Resolved, That this Council will take legal proceedings against said Company in case it fails to comply with this resolution, and that a copy of this resolution be served on the Company by the City Engineer without delay.

Moved by Alderman Hubley, seconded by Alderman Mitchell and passed.

Read letter from the City Collector of Rates and Taxes relative to the work in his department together with comparative statement of receipts for 1885 and 1895.

On motion the consideration of the same is deferred to be taken up with the estimates.

Read letter from S. M. Brookfield, covering a petition from the Halifax Graving Dock Company, Limited, asking that the property of said Company be relieved of taxation until such time as the net yearly returns are sufficient to meet the interest upon the Debenture Bonds of the Company. Also covering a document signed by Robert Boak and others endorsing the application of the petitioners. Placed on Order paper.

Read account (\$5482.22) from Monastery of Good Shepherd for maintenance of women and girls committed by the Stipendiary Magistrate of the City of Halifax to said Institution from June 30th, 1890 to date.

Moved by Alderman Hamilton, seconded by Alderman Eden, that the same be referred to the Committee on Public Accounts together with His Honor the Recorder for report. Motion passed.

Read report of the Committee on Public Accounts, covering the Estimates for the civic year 1897-8.

#### December 26th, 1896.

### To His Worship the Mayor and Members of the City Council :

Gentlemen, The Committee on Public Accounts beg to submit herewith for the consideration of the City Council the Estimates for the Civic year 1897-98. Attached hereto will be found statements from the Board of School Commissionors, the Committee on Charities, the Department of City Works, the Police Department, the County of Halifax, the Institute for Deaf and Dumb, etc., regarding the various appropriations required by them for the year, all of which were carefully considered.

Your Committee also submit herewith applications from H. S. Rhind, William F. Reilly and William R. Hamilton for increases in the several salaries received by them, and also a letter from the City Collector presenting a comparative statement of the work of his department.

Under the Acts of 1896 the City Council was authorized to do all things necessary for the establishing of electric light works for the purpose of doing its own electric lighting. Your Committee recommend that the Council take into consideration the advisability of carrying out the power conferred upon them by said Act: at the present time the City is spending annually about \$21,000 for electric lighting.

Your Committee would recommend that the City Engineer inquire into the matter and ascertain the cost of plant and report at a future meeting.

#### MINER T. FOSTER, Chairman.

Moved by Alderman Hamilton, seconded by Alderman Lane, that the Order of the Day be suspended to allow Alderman Hamilton to introduce a resolution. Motion passed, and the following resolution introduced :---

1. Whereas, it is desirable in the interest of the City tax-payers that the cost of maintenance of civic institutions should be reduced as far as possible without impairing their efficiency.

2. And Whereas, the annual cost of Rockhead to the City, is between \$5,000 and \$6,000, and the annual civic contribution to the maintenance of the County Jail is about \$2,100.

3. And Whereas, since the establishment of Rockhead and the County Jail the condition of affairs has grately changed owing to the abolition of imprisonment for debt, the Speedy Trials Act, and the establishment of Reformatories for Juvenile offenders.

4. And Whereas, The inmates of Rockhead of late years have been mainly persons sentenced for drunkenness and such institution should be conducted more on the lines of a Reformatory than a penal institution.

5. And Whereas, owing to causes above mentioned the demands for space in the County Jail have been much less than formerly, and it has been suggested that the two institutions should be combined, thereby securing greater efficiency at about one-half the present cost to the City.

And Whereas, The County Jail with slight changes could be made suitable for a police court and police head-quarters thus enabling the police department to vacate the City Hall, where the existence of a police court is open to serious objections, and the premises in the City Hall now used by the Police Department could with some changes be utilized as a public market the situation being central and convenient thereby obviating the future expenditure of a large amount of money for market site and building.

Therefore Resolved, That His Worship the Mayor be requested to appoint a Committee to confer with the warden and Councillors of the County of Halifax with a view of discussing the feasibility of consolidating the two institutions by the City taking over the County Jail.

Moved by Alderman Hamilton, seconded by Alderman Redden. Placed on order Paper.

Moved by Alderman Creighton, seconded by Alderman Eden. that the Council adjourn until 7.30 o'clock this evening. Motion passed.

# EVENING SESSION.

Council met pursuant to adjournment at 8 o'clock. There were present His Worship the Mayor, Aldermen Geldert, Outhit, Faulkner, Redden, Butler, O'Donnell, Foster, Hubley, Line, McFatridge, Ryan, Mitchell, Campbell, Creighton, Hamilton and Eden.

The Council now proceeds to consider the Estimates.

Alderman Foster, Chairman of Committee on Public Accounts, makes an explanatory financial statement respecting the same:

No doubt it will be gratifying news to the Council and taxpayers of the City to know the Committee on Public Accounts this year will not ask for new legislation to borrow more money.

The amount at credit of permanent paving account is sufficient to meet the requirements for next year.

The amount coming in from sewerage frontage account should be ample for next year u iless something unexpected turns up (like Young Avenue five houses) no less a sum than \$21,493 having been collected on this account last year, which speaks well for Collector Theakston.

There will be \$25,000 required for water extension, but as there are \$50,000 six percent old water debentures maturing in July next which can be refloated at 4 per cent, the amount of interest on the \$25,000 required will be made up in this way and the interest account not increased.

There will be money required for grading Lockman Street. The interest on this amount will be added to the new interest account, together with the interest on \$5,009 repuired for Dry Dock Subsidy.

 $p_{\tau_{en}}^{2}$  The Committee had before them applications for increases to their salaries from William F. Reilly, Chief Clerk Works Department, \$100, H. F. Rhind, Clerk in Collectors office, \$200 and William R. Hamilton clerk in City Clerk's office. The application for Mr. Reilly is recommended and the amount placed in the estimates. The Committee has also added \$200 to salary of 3rd clerk in Collectors office.

By referring to the estimates it will be seen a large sum is added this year to interest account, viz., \$16,440.54 which is a poor outlook from a financial standpoint unless the amount of assessable property is also increasing, as our last large loan was taken outside the city and province. Capitalists offering for our loans will not pay in the future what they have in the past unless we keep the interest account down in proportion to our assessable property.

#### February 8, 1897.

#### To His Worship the Mayor and Members City Council :

GENTLEMEN,—The Committee on Laws and Privileges met this day for the purpose of considering the letters referred to them by the Council in relation to alleged misconduct of the Chief of Police in connection with executions issued out of the City Civil Court. The Committee find that the charge made is not sustained, inasmuch as the execution in the case of Croucher vs. Quirk was issued by the City Clerk on Wednesday, the 13th January, 1897, and was sent to the City Marshal (the officer appointed by law to receive and execute civil writs) the same day, and was placed by him in the hands of Sergeant Collins at 10 o'clock on the following morning to be executed.

The Chief of Police does not appear to have any communication with any of these officers or to have received any information from them on the subject or to have interfered with them in any way in the discharge of their duty or to have made use of his position for the purpose of obtaining an advantage over other creditors; and, as a matter of fact, no unreasonable delay occured in connection with the levying of the execution.

The Committee, however, learned and think it their duty to bring the following facts to the knowledge of the Council :--

1. On the first of December last the Chief of Police endorsed a promissory note for Matthew Quirk and took from him by way of security therefor a bill of sale covering said Quirk's stock of goods.

2. At the time of the making of said indorsement and the taking of said security it was agreed and understood that said bill of sale should not be recorded, but should be held by the Chief of Police, and that the father of said Quirk should give the Chief of Police notice of any trouble arising in consequence of which the filing of the bill of sale might become necessary.

3. In pursuance of said agreement and understanding the Chief of Police was notified of the fact that judgments would be obtained by Messrs. Grant and Croucher on the thirteenth of January last, and on the following day, the fourteenth of January, while the execution in the case of Croucher vs. Quirk was in the hands of the sergeant of police to be executed, the Chief of Police placed his bill of sale on record, thus defeating the execution.

While this result does not appear to have been accomplished by any act on the part of the Chief of Police interfering with officers under his control or leading to delay in the execution of the process of the court the Committee are of the opinion that no official holding a position such as that of the Chief of Police should engage in outside business transactions which even if innocent in themselves may have the effect, as in this case, of throwing suspicion upon the manner in which civic officials discharge their duties.

Attached hereto will be found the evidence taken at the investigation.
