TRUSTEES ROCKINGHAM SCHOOL VS. CITY.

This was an action brought against the City to test the liability whether the assignees of Alexander Forrest were liable to pay all school rates due on the property in the City of Halifax belonging to the assignees, as Mr. Forrest resided at Rockingham. Under the School Act, all property held by the trustees or assignees at the time of the making of the County assessment roll for one year shall be liable to be assessed, and the assessment levied according to such roll in the section where the original owner of such property last resided. The Counsel on both sides differing and the amount that the City would be deprived of would be considerable, we agreed to submit the question to the court, and after argument, it decided in favor of the City; so that the school rates shall hereafter be paid by the assignees of the City.

LINDBERG VS. CITY.

At the time the Lindberg Brewery was building, Lindberg's Agent in the presence of Mr. Brookfield made an arrangement with Mr. Morrison of the Water Department to put in an extra pipe in the brewery upon the terms that the plaintiff was to pay all costs and expenses incurred in putting it in. The matter went on for a number of years, when Mr. Lindberg was called upon to pay the amount, he repudiated his liability and transferred his brewery to the Halifax Brewery Company, Limited.

As the amount was not paid, the city threatened to turn the water off, when the present owners of the brewery paid the amount due, §27.32, which Mr. Lindberg subsequently, paid them, and he brought an action in the County Court to recover the amount against the City. I appealed the matter to the Supreme Court, who allowed the appeal and reversed the judgment of the County Court and directed judgment to be entered in favor of the City.

GENTLEMEN,—The Committee on Laws and Privileges beg to report that at a meeting held this evening—present, Aldermen Geldert, Chairman; Campbell, Menger, McFatridge and Ryan, they had before them the matters below named, upon which the following recommendations were agreed to:

lst. In regard to the suggestions made by His Worship the Mayor for the enactment of certain amendments looking towards improvement in the system of Civic Government, your Committee find that the time at their disposal for the consideration of such important matters is too limited to enable them to report in time for the present session of the Legislature, and recommend that the matter be referred back to His Worship the Mayor.

To His Worship the Mayor and Members of the City Council:

Gentlemen,—The special committee of the City Council appointed to consider the application of the Dartmouth Ferry Commission for a reduction of the rental of the dock property belonging to the City used by the Dartmouth Ferry Commission, beg to report as follows:

Your committee have previously reported on this matter, recommending that under certain conditions the rental of the dock be reduced from eight hundred dollars (\$800) to three hundred dollars (\$300) per year, and at a meeting of the City Council held November 11th, 1897, these recommendations received the concurrence of the Council.

The Ferry Commission, under date January 24th, 1898, apply for a lease of the property for a term of years at a nominal rental, in order to enable them to effect improvements, estimated to cost about eighteen thousand dollars (§18,000).

To-day Alderman Lane and Geldert (Alderman Mosher having arrived subsequently) held a conference with Mr. George J. Troop and Mayor Johnston of Dartmonth, representing the Ferry Commission. These gentlemen urged the reducing of the rental from the present rate to the nominal fee of one hundred dollars (\$100) a year, and requested that the words "that no part thereof be applied to other or ordinary purposes of the Town of Dartmouth" contained in the last report of this committee be expunged from said report.

Your committee beg to recommend that the resolution passed by the Council on the 11th November last adopting the report of this committee be rescinded and that the following recommendations be concurred in by the Council.

First:—That the City give to the Dartmouth Ferry Commission a Lease of the Dock on the Halifax side owned by the City for a period of ten (10) years at an annual rental of one hundred dollars (\$100.00).

Second:—That the said Lease contain conditions stipulating that the Ferry Commission, before they shall be entitled to the reduced rental of one hundred dollars (\$100) shall make the proposed improvements on the Halifax side by the acquirement of the Stayner property and the erection of the additional passenger and steamer accommodation thereon to the satisfaction and 'approval in writing of His Worship the Mayor; that the revenue derived by the Commission from the operation of the Ferry be applied exclusively to Ferry purposes, including improvements of the service and reduction of Ferry Rates, and that in the event of the Commission failing to comply with, or committing any breach of the conditions named that the Lease shall be cancelled, and the annual rental of eight hundred dollars (\$000) hitherto paid shall be restored. Provided further, that after the said Lease has been granted, the Ferry Commission shall maintain the efficiency of the Ferry service and an improved condition of the accommodations on the Halifax side of the Harbor at all times equal to those that exist at the coming into effect of the Lease herein proposed, of which His Worship the Mayor shall be the sole judge, under a penalty of forfeiture of the Lease and restoration of the rental of eight hundred dollars (\$00.00)

Third :-- That His Honor the Recorder be instructed to prepare the said Lease and submit the terms thereof to the City Council for approval.
