The sketch submitted herewith shows a proposed slide which could be used by children or adults, although the height of any slide which could be used to advantage would be an element of danger where children are permitted to use it. The estimated cost of the structure shown is about one hundred dollars (100.00). The material would be of no use for sewer purposes. The cost of putting up and removal each year would be small and the flushing could probably be done by the Fire Department. The chairman of that department is making preparations for flooding and sweeping snow off portions of the Common for skating, and I have no doubt that he would make arrangements for flushing toboggan slides when required. The slope of the Common is not steep enough for good slides; but there are two places south of Cogswell Street on which structures might be erected. It would also be possible to erect one on Camp Hill; but the slide would have to be prepared before the frost goes into the ground, otherwise there would be danger of toboggans running out on to the street.

The revenue will be much less than the interest on the outlay. The class of houses is not a good one to guaranteee prevention of waste in cold weather. The proposed extension is a heavy one, and the district is one of the highest to be supplied by the high service main. In the present condition of the system a constant supply of water could not be given to the petitioners and the extension of the pipe to supply them would only increase the annoyance to householders using the high service supply in Willow Park and other high districts, as it would lesson the pressure and flow of water in that neighborhood.

Under the circumstances, I do not think it would be advisable to make the extension asked for; aside from the question of cost, the interest on the outlay being nearly double the revenue. I would therefore recommend that the extension shall not be made for the present.

County Court House Interest on Loans.

Sheriff's Accounts.

County Clerk and Treasurer (salaries.) Printing and Stationery.

And endeavored to have the items eliminated entirely from among the list of charges against the City; but were unable to obtain the consent of the County Council's committee.

It was finally agreed between the City's committee and Warden Wilson and Councillor Shatford, that instead of the City paying yearly nine-elevenths of the salaries of the county clerk and treasurer the City should in future contribute the sum of four hundred dollars (\$400.00) a year and no more towards the salaries of those officers, the County Council to divide the said sum of four hundred dollars (400.00) between the County Clerk and the County Treasurer as they deem expedient, and that the further consid-eration of all the other items in dispute he deformed for one year eration of all the other items in dispute be deferred for one year.

By this arrangement the City will save over nine hundred dollars (\$900)

a year. Your Committe recommend that this agreement be concurred in by the

Gentlemen,-The Committe on Laws and Privileges beg to report as follows:-

Your Committee have considered the letter of the Honorable Attorney General in regard to the Juries' Act. The Juries Act of 1899, requires that the City Council shall every year

The Juries Act of 1899, requires that the City Council shall every year appoint, to continue in office until their successors are apointed, a committee consisting of not less than two members of the Council representing different sections of the City to prepare or revise lists, of all persons within Cityliable to serve as Grand and Petit Jurors, and that the Clerk of the Council shall ex officio be a member of such committee and the secretary thereof.

Within two months after the appointment of such committee the committee is required to prepare new lists, and from time to time thereafter, as required to revise the same. All lists and supplementary lists to be published in a newspaper.

Section 75, requires that the Council shall vote such compensation to the committee preparing or revising the lists as it deems suitable for the work. Your committee is of opinion that the preparation and revision of these lists and the compliance with the many provisions of the Juries Act involves the expenditure of a large amount of time and labor.

It is recommended that a Juries Lists Revising Committee to consist of two Aldermen and the Clerk of the Council be apointed in compliance with the act.

Your committee have again enquired into the petition of Catherine E. Sulivan, for the return of taxes overpaid by her, and in view of the fact that she paid a considerable sum to the City through ignorance of the exemption she could have claimed, beg to recommend that His Honor the Recorder, be instructed to insert in any bill to be present to the next session of the Legislature to authorize the City to borrow money, a clause enabling the City to borrrow \$117.40, to repay to Mrs: Sullivan, the amount overpaid by her to the City.

COMMITTEE ROOM, CITY HALL, Dec. 26th, 1899.

To His Worship the Mayor and Members City Council :

Gentlemen,—The Committee on Public Accounts beg to report as follows: The committee have considered the resolution submitted to the Council by Aldermen Rogers, proposing to change the law regarding the payment of interest on taxes, so that interest would not be charged until after the year expires, for which the taxes are due. It was deemed by the committee that the change suggested would remove the incentive to prompt payment now held out by the City, by making it more profitable for the persons who now pay their taxes before August 1st, in order to receive the discount of 2 per cent. to refrain from doing so until May, of the succeeding year.

A measure that would not materially affect the present system to the disadvantage of the City, and would give to persons who might require it three months further time than is now allowed, is recommended, viz:—To extend the time at which interest on unpaid taxes will commence to be charged from October 1st to January 1st. It is recommended that His Honor the Recorder, be instructed to draft an Amendment to the Act passed in 1897, to the following effect:—

said rates and taxes shall bear interest at the rate of one-half per cent. permonth, including the month within which the said taxes are paid, until the whole amount is paid, and the party liable for such rates and taxes shall also be liable for the said interest."

The following recommendations are also submitted for the concurrence of the Council:--

1st. That His Honor the Recorder, be authorized to draft Legislation, authorizing the City to borrow \$50,000 for Water Construction, and \$139.15 to pay a number of Accounts chargeable to City Property Account, 1898-9, the funds of which Account were exhausted before said bills were rendered.

The said Accounts, together with a letter from the Clerk of Works, thereon are attached hereto.

2nd. That the City Treasurer be authorized to borrow, under the terms of the Provincial Exhibition Act, the sum of \$8,873.64, to meet a balance of Provincial Exhibition deficit, 1897, and the deficits of 1898 and 1899.

3rd. That His Worship the Mayor and the City Treasurer, be authorized to arrange with the Merchants' Bank, for an overdraft of \$40,000 to meet current expenses.

4th. That the City Treasurer be instructed to retire the \$8,000.00 of Water Debentures falling due 1st January, 1900, out of the Sinking Fund of 1896.

The yearly Estimates for 1900-1901 are herewith submitted for the consideration of the Council.

The total Estimate shows an increase over last year of \$2,639.50, though the amount required for the various services this year is actually \$3,360.50less than was estimated for last year. The reason for this difference of \$6,000.00 is that this year only \$2,000.00 is taken from Unexpended Balances, while last year \$8,000.00 was derived from this source with which to reduce the Assessment.

The Ordínary Assessment this year is \$850.00 more than last year, and the Extra Assessment \$4,210.54 less.

Salaries Account has been reduced \$600.00, and Police Maintenance \$500.00. Lighting Streets was increased \$500.00. The fund of \$1,200.00 provided last year for revising the City Charter, was exhausted, and \$1,000.00 is estimated this year to complete the work. A new item in the Estimates is \$1,000.00 for revising and printing the Juries Lists under the Act of 1899.

In the Extra Assessments Public Schools is \$1,920.00 less, and Poors' Asylum \$500.00 less than last year. In the Old Funded Debt interest account a saving of \$1,200.00 was effected by the retirement out of the Sinking Fund 1st July last, of \$20,000.00 Exhibition Building Debentures.

-In considering the Estimates the Committee had before them applications for increases of salary from the three City Assessors, H. S. Rhind, and L. R. Kaye, Clerks in City Collector's office; William P. Morrison, Assistant in City Engineer's office, and L. Fred Monaghan, Assistant City Clerk. None of the increases asked for were estimated for. The applications are submitted for the consideration of the Council.

Sir,—I have the honor to inform you that I had an interview this morning with some of the members of the Commission now revising the Provincial Statutes, and also with the Honorable the Attorney-General.

I pointed out to these gentlemen the utter uselessness of publishing a jury list at a great expense to the City, and that nothing was to be gained thereby. After talking the matter over it was concluded that the publication of the lists this year would not be necessary, and that legislation would be introduced to legalize the lists. I have therefore, to advise you that the Revisal Committe of the Jury Lists will not be required to publish them this year in the papers, which will be a large saving to the City.

A statement was made in the Council at the last meeting, that the City revisors would have to revise the Dartmouth lists. This is not correct. They only revise the special Jury Lists of Halfax and Dartmouth, which consists of about 200 names, very few of which will be eligible from Dartmouth.

As the Jury Act was not brought into force by proclamation at the last meeting of Council, it will take effect on the first of January next. I have to advise that it will be necessary to make a fresh appointment. It will only be necessary to pass a resolution appointing the same gentlemen now composing the Jury Revisors.

BOOK-KEEPING CITY COLLECTOR'S OFFICE.

COMMITTEE ROOM, CITY HALL, February 12th, 1900.

To His Worship the Mayor and Members City Council :

Gentlemen,—In re letter, or report, of R. A. MacIntyre, dated October 10th, 1899, regarding the City Collector's accounts, the Committee on Public Accounts beg to report that they held meetings on November 16th, 17th and 24th Mr. MacIntyre was present at the first two meetings and the City Collector was present at all the meetings. Subsequently a sub-Committee from the Committee made an examination of the system of book-keeping in the Collector's office.

In Mr MacIntyre's letter a idressed to His Worship the Mayor he states that he received instructions "to examine i to the system, etc., in the office of the Collector of Rates, to ascertain if a clange could be made to reduce the friction between that office and the ratepayers"

Assuming this statement as to his instructions to be correct, the object for which the inquiry was instituted does not seem to have been attained, if r the report while criticising the present system in some respects does not contain any specific recommendations or suggestions for its improvement, or for a new system.

The report seems to indicate that the labors of the Accountant were devoted chiefly to an examination of the entries in the Collector's books, and he presents a stries of alleged inaccuracies and irregularities which he discovered

These errors were examined in detail by your Committee. For the most part, they are cherical errors, the amounts involved are small, and there is no evidence of malfeasance or dishonesty on the part of the officials of the office. In certain cases comment is made upon what is assumed to be irregular proceedings on the part of the Collector or a failure to do his duty fully and impartially. The criticism refers to matters in which the law gives the Collector authority for the exercise of a discretion, and to some other matters or conditions for which he is not responsible.

Two errors in the Interest Account are noted—one in 1891 against the Collector and one in 1894 against the City.

The fifth paragraph of the report says. "Cash received for taxes, etc., is supposed to be paid over at once to the Treasurer. This is not the case, as sums are carried over for months and this system appears to have been so for years." Your Committee find that prior to 1897 the i terest collected from the ratepayers on their taxes was not paid over to the Treasurer every day with the tax receipts, hence the above criticism. In 1897 the system was changed, however, and since then all receipts for interest have been paid over to the Treasurer each day. No evidence was adduced to show any failure on the part of the Collector to pay over the tax receipts daily.

Your Committee endeavored to get Mr. MacIntyre to submit a draft of a new system of account keeping for the Collector's office, or of the charges which he considered it desirable to make. He replied that his investigations were confined for the most part to the year 1894, that it was stated that certain changes, which he had not seen, were made in the system in 1897, that it would be neessary before making any recommendation to examine these changes, and furthermore that some guarantee woul have to be given to any person making a change in the system that it would be fait fully carried out. This position does not seem to be consistent with the stated object of the inquiry, for if a new system were to be devised and inangurated it was surely the duty of the Accountant to examine the present system as conducted at the time of his investigations.

After making a careful inquiry into the whole matter, your Committee consider it expedient that they should besides dealing with the Accountant's report make certain recommendations as the result of their own labors, and accordingly beg to report as follows:

In their judgment the system of keeping accounts in the Collector's office is a good one, but susceptible of improvement in some minor details.

They recommend that the debit entries in the Ledger be added each year in order to give a trial balance with the totals of the Assessment books and to confirm the correctness of the posting. Also that the ruling of the Ledger for dates and credit entries be changed to conform more closely to standard ledger rulings.

They recommend that a change be made in system of making up the returns which the Collector submits to the Council so as to show the amounts collected from "Special Assessments." This change will obviate the anomaly referred to in the first section of the Accountant's report in connection with short collections.

They recommend that the difference revealed by the errors in the interest account be adjusted by the Collector.

They recommend that the Collector keep a Minute Book on file of the reductions made in water rates from time to time by the Works Department with the Mayor's signature to each item to show that it was regularly authorized, as suggested by the Accountant.

The Committee finds that it has not been the practice to pay over to the Treasurer every day the receipts in the Department of City Licenses. They are paid over daily when there are receipts of any considerable amount, but at certain times in the year the daily receipts are very small and it has been the practice at such times to allow them to accumulate for a few days. It is recommended that in all cases the receipts shall be paid to the Treasurer each day so that there shall be no exception to the rule that all the receipts of the Department shall go into the hands of the Treasurer daily.

They recommend that the Collector in making his return to the Mayor at the end of each year showing the result of sales made under the Lien Law, shall also make a return of all cases where the Lien has been lost or efforts to make it effective have proved abortive, with the reasons given therefor.

Sir,-In accordance with the accompanying resolution of Council, I beg to report on the petition attached hereto from property owners on Duncan Street.

The extension asked for is from the end of the sewer on Duncan Street to Harvard Street. The excavation would be rock. The estimated cost \$5,100 Estimated Assessment \$2,250.00. There are seven houses on the proposed extension, and I would respectfully recommend that the sewer be constructed in accordance with the prayer or the petition.

The district is High Service. Size of pipe, 6 inch. Distance, 930 feet. Estimate does not include excavation. Cost of work :--

CLIFTON AND WILLOW STREET SEWER,

CITY ENGINEER'S OFFICE, Feb. 14th, 1900.

His Worship the Mayor :

Sir,—The sewer in Willow Street and that in Charles Street have been constructed about double the capacity estimated for at the time the sewer design was made, and I have no doubt the sewers are large enough to carry off the water which will be drained into them. These two sewers empty into Robie Street at present. The latter sewer, constructed in accordance with the original design, is not large enough to carry off the rain fall in heavy storms, consequently the water backs up into Charles and Willow Streets. In the middle of January, when the ground was covered with ice and nearly all water that fell ran immediately into the sewers, cellars were flooded on both these streets, and in one row of houses where the plumbing was not completed and the covers were off the traps it went into nearly every cellar. We are examining and measuring the old sewer down through the Common and Public Gardens to ascertain what extent of sewer is too small for the work which it is called upon to perform. It will be some time before I will be in a position to report on this matter, and in the meantime I think temporary relief can be granted to the property owners on Willow Street and Charles Street. The sewer on Cunard Street between Robie and Windsor Street, is not overtaxed at present and could carry more water. By extending the Clifton Street sewer from Charles Street to Cunard Street, it is probable that the water would not back up on Willow and

Charles Streets. There are several houses on the street. The estimated cost is \$4,300. Estimated assessment \$1,950. Pending the action of the Council in reference to the main trunk sewer, I would recommend that a sewer be constructed in Clifton Street between Charles Street and Cunard Street,
