CITY ENGINEER'S OFFICE, December 31st, 1900.

His Worship the Mayor :

SIR,—In accordance with the accompanying resolution of Council, I beg to report on the petition attached hereto from property owners on Chebucto R ad asking for water and sewer extension:

WATER EXTENSION.

To supply all the petitioners it would be necessary to lay a 6 inch water pipe from Windsor Street nearly to the Connolly Road. The estimate submitted at the meeting of the Council held on November 22nd, was as follows:

If the pipe were laid in the sewer trench a reduction of about \$1:00 would be made for proportion of excavation saved, making the estimated cost \$4600.00.

SEWER EXTENSION.

The ground begins to fall West of Oxford Street and the sewer design contemplates the construction of a sewer only as far West as Oxford Street to empty towards the harbor. The estimated cost of this sewer is \$9,350.00. Estimated assessment, \$4,100.00. A: the date of the last pay day the Clerk of Works' statement shows a balance of \$904.49 to the credit of Sewerage. It will therefore be manifest that a work of this magnitude cannot be undertaken until more money is available. I therefore cannot recommend its construction at present. The water extension would involve the laying of half a mile of pipe on the high service system. Many of the houses to be supplied are not frost-proof and there is no question that water would be wasted under our present system. One of the petitioners has appealed to me personally to help him out of his troubles by recommending this work, and I should be only too glad to help any crizen of Halifax if I could do it without interfering with the public interest. In this case, however, I consider that it would be deliberately taking the water supply entirely, at some seasons of the year from those who now have a partial service, and under the circumstances, much as I should like to meet the views of the petitioners, I cannot recommend the extension.

AN ORDINANCE TO AMEND THE BYE-LAW OR ORDINANCE RELATING TO THE STREETS

OF THE CITY OF HALIFAX, WHICH SAID ORDINANCE WAS PASSED BY THE (ITY COUNCIL ON THE 25TH DAY OF OCTOBER, 1893.

Be it enacted by the Mayor and Aldermen of the City of Halifax in City Council assembled, as follows:

Said Ordinance is hereby amended by striking out Section 30 of said Ordinance and substituting therefor the following Section :--

No person shall make any permanent excavation under the surface of any street the movable covering of which extends further into the street than to a

line three feet from the street line, and then only by permission in writing from the City Engineer and on such conditions as he may name in the permit, provided, however, that coal hole tops may be located near the curb and that transparent coverings used for purpose of lighting only and permanently secured may extend five feet from the street line. The owner of the property in front of which any permanent excavation is made shall pay to the City of Halifax therefor, on the first day of May in each and every year, an annual rental of four cents per square foot of such excavation.

The Ordinance entitled "Au Ordinance to Amend the Bye-Law or Ordinance relating to the streets of the City of Halifax, which said amended Ordinance was passed by the City Council on the 30th day of April, 1896" is hereby repealed.

STEAM ROLLER.

CITY ENGINEER'S OFFICE, January 4th, 1901

His Worship the Mayor :

SIB,—The accompanying tender from Hugh Cameron, representing the Waterous Engine Company, was referred by the City Council to the Works Department for report.

At the date of the tender the street work for this year was about completed. In considering this tender there are three important points, first—the necessity for a second roller; second—the suitability of the Buffalo-Pitts roller; third—the advisability of purchasing at present.

I have no hesitation in saying that the work to be performed each year cannot be overtaken by one roller. The result is that the rolling is only partially done and in many cases is unsatisfactory. As it is not always practicable to do the street work at such a time that the roller is available as soon as each piece of work is done stones placed on the street are often knocked about for some time before the surface can be compacted. The work during the first part of the season after the frost comes out of the ground requires two rollers to perform it satisfactorily. Every street which has been affected by the frost should be re-rolled, and it is obvious that with our great mileage of streets one roller cannot overtake it. With our present Street Appropriation it is probable that we should not keep two rollers in service during the whole season and therefore the cost of operating one roller is one thousand dollars (\$1090) per annum. The cost of a second roller would probably not exceed six hundred dollars (\$600).

As to the suitability of the Butfalo-Pitts roller, I believe that it is a good roller and that it has advantages which our Aveling & Porter roller does not have. On the other hand, there are some important advantages which the Aveling & Porter roller has over the Butfalo-Pitts.

The advisability of purchasing at present is perhaps the most important point to be considered. We have a balance of twelve hundred dollars (\$1200) in the appropriation from which the first roller was purchased. If a second roller were purchased twenty-three hundred dollars (\$23:0) would be r quired in addition.

If the Council can see their way clear I should like t see a second roller in use; but before purchasing I would suggest that steps be taken to ascertain the cost of other rollers as I am under the impression that they can be obtained cheaper than the price named.

AN ORDINANCE TO AMEND THE BYE-LAW OR ORDINANCE RELATING TO THE STREETS OF THE CITY OF HALIFAX, WHICH SAID ORDINANCE WAS PASSED BY THE

CITY COUNCIL ON THE 25TH DAY OF OCTOBER, 1893.

Be it Enacted by the Mayor and Aldermen of the City of Halifax in City Council assembled, as follows:

Said Ordinance is hereby amended by striking out Section 30 of said Ordinance and substituting therefor the following section :-

No person shall make any permanent excavation under the surface of any street the movable covering of which extends further into the street than to a line three feet from the street line, and then only by permission in writing from the City Engineer and ou such conditions as he may name in the permit, provided. however, that coal hole tops may be located near the curb and that transparent coverings used for purposes of lighting only and permanently secured may extend five feet from the street line. The owner of the property in front of which any permanent excavation is made shall pay to the City of Halifax therefore on the first day of May in each and every year an annual rental of four cents per square foot of such excavation.

The Ordinance entitled "An Ordinance to Amend the Bye-law or Ordinance relating to the streets of the City of Halifax which said amended Ordinance was passed by the City Council on the 30th day of April, 1896" is hereby repealed.

Moved by Alderman Butler, seconded by Alderman Martin, that said Ordinance, having received its third reading, do now pass, and that the City Clerk forward the same to the Lieutenant-Governor-in-Council, for concurrence. Motion passed.

Power, who made the charge, and Mr Banks, the License Inspector, and witnesses called by each, and find that Mr. Banks has explained satisfactorily how he first came to be brought into this matter and to attend at the houses Nos. 100 and 117 Grafton Steet; that he did obtain a solicitor for them, but that he did not borrow \$100 for Mrs. Brockington, nor did he give her \$100 or any sum to deposit with the Deputy-Sheriff Tney find, though, that Mr. Banks called at Mr. Sanford's butcher shop on his way to his hotel, at the request of one of the inmates, and told Mr. Sanford that he was wanted at No 100 —to use Mr. Banks language—"There was some trouble up in 100 They're arrested, I believe. I told hin I though they wanted him to go bondsman, in order to put him on his guard."

The Committee feel that Mr. Banks acted injudiciously in acting as a messenger for these people, and are of opinion that it is very unde-irable that any city official should be found upon such terms with persons of the reputed character of the keepers of the houses named in Mr. Power's letter.

The evidence taken at the investigation is forwarded herewith for the information of the Council.

BETTER PROTECTION FROM FIRE.

HALIFAX, N. S., February 15, 1901.

His Worship the Mayor, Halifax, N. S.:

DEAR SIR,—Referring to the comprehensive report lately made by Mr. Robert Howe, C. E., upon the water works and fire preventative appliances of the City of Halifax (copies of which have been laid before you) we beg to bring to your notice for favorable consideration three of the recommendations contained in said report, which the Nova Scotia Board of Fire Underwriters deem of the greatest importance, and trust that the matter will be taken up by the City with as little delay as possible.

The recommendations referred to are as follows :---

1. The immediate application of a meter to every service in the City.

2. The securing of a fully equipped aerial truck, and

3. The securing of a powerful fire boat.

As the subject of proper fire protection is of the greatest importance to every property owner in the city, we feel that it is only necessary to bring the question clearly before them to gain their hearty co-operation.

clearly before them to gain their hearty co-operation. Having the dire results which are liable to follow when such protection is not provided, brought before us by the late disastrons conflagrations in Hull, Ottawa and Montreal, we should all feel that no time should be lost in making our water works and fire preventative appliances as efficient as possible.

our water works and fire preventative appliances as efficient as possible. In a City composed largely of buildings of wooden construction with shingle roots the liability to sweeping fires is naturally greater than in a City of massive construction with hard roofs.

Besides the recommendations referred to above we would like to draw your attention to the point in Mr. Howe's report regarding the high water service, which depends solely upon a single pipe line from the source of supply. In the event of a break in the pipe or the sticking of the scraper it would mean the higher portions of the City would be without the necessary water for fire protection. Mr. Howe recommends the laying of an additional Main to provide against such emergencies.

We feel the force of his arguments and trust that the City will take this matter up in the no very distant future, and lay the new main, or else build a reservoir which would, we understand, serve to overcome the difficulty.

In closing I might mention that the head offices of the various fire insurance companies doing business in this City, from their wide experience fully appreciate the situation and the need of the improvements suggested being carried out as speedily as possible.

A Committee has been appointed by this Board and the members would like to appear before the Council if you would kindly arrange a meeting.

ALDERMAN HAWKINS' QUESTIONS.

His Worship the Mayor : CITY ENGINEER'S OFFICE, February 19th, 1901.

SIR,—I beg to submit the following information in answer to questions asked by Alderman Hawkins :—

1 Why was the low service district deprived of water when a break occurred recently in one of the mains?

Ans.—The water has not been turned off the low service district since the new 27 inch main was laid, except on pipes where repairs are being made, cleaning done or similar work being carried on.

2. Where did the break occur?

Ans .- In the 27 inch main in the Misses Hennessey's field, Young Street.

3. When did the City Engineer report on the construction of sewer on Cunard Street now under construction? By whom was the said construction ordered?

Ans —The construction of the Cunard Street Sewer was not reported on separately. The reconstruction is being done as a part of the work for the relief of Charles Street and Willow Street. This work was reported to the Council at a meeting held February 13th, 1900, and a relief sewer, recommended through Clifton Street. At that time, as stated in report, we had not completed the examination of the Common sewer nor the calculations for the permanent relief of the whole district draining into it, and the Chifton Street sewer was suggested as a temporary relief only. It was expected that the sewer on Robie Street between Charles Street and Cunard Street would have to be enlarged in order to give permanent relief. We have since completed plans and calculations for the whole district draining to the intersection of Robie and Cunard Streets, and find that the common sewer at that point should be at least twice as large as it is in order to carry off the heaviest rains. We also found that as the Clifton Street sewer was to be constructed it would be much cheaper to make it a permanent relief sewer at once by continuing it to Robie Street. It will not then be necessary to alter the sewer on Robie Street north of Cunard Street, which would mean a large saving, and when the common sewer is enlarged permanent relief will be given to (harles Street and Willow Street, instead of the temporary relief at first proposed. The old sewer on Cunard Street was a disgraceful piece of work. It was constructed by Contract and varied in size from 9x14 inches to 11x16 inches. It was laid very unevenly both as regards grade and line. If the Clifton Street sewer had been built to the old grade of the Cunard Street sewer a 24x36 inch sewer would be required, but by adopting a practically even grade from Robie Street to Charles Street a steeper fall is obtained, and therefore a 20 x 30 inch sewer is sufficient. The saving made on Clifton Street by lowering

the grade is \$147.45, for although the excavation is deeper the trench is narrower. and there is a saving in the cost of material and cost of laying. Section 15, chapter 31 Acts of 1894 provides that "the City Engineer shall be responsible for the mode and manner of constructing the public works of the City.", The question reported on, and the work ordered by the Council was not the sewering of Clifton Street, but the relief of Charles and Willow Streets. Under the circumstances, I consider the plan adopted the cheapest and most efficient mode and manner in which the work contemplated could be performed and I estimated that it could be carried out for the sum named in the report (4300) I have therefore taken up 232 feet of the sewer on Cunard Street nd am laying a new sewer 20x30 inches on a practically even grade from Robie Street to Charles Street. This will make the sewer system complete as far as its injunction with the common sewer.

4. What will be cost of Cunard Street sewer now being constructed, also sewer being taken up in present construction work?

Ans.—The labor pay rols for taking up and relaying the Cunard Street sewer amount to about \$880.00 The cost of the old sewer was \$578.00. If the Clifton Street sewer had been laid to the old grade of the one on Cunard Street, the Robie Street sewer would have to be enlarged immediately after the first suit for damages at an estimated cost of over \$6000. Deducting the cost of relaying the Cunard Street sewer from this amount, over \$5000 has been saved to the City by the plan adopted. 1 Haile

AMENDMENT TO CITY CHARTER.

An Act to Amend Chapter 58 of the Acts of 1891 Known as the City Charter. as

Be it enacted, by the Governor, Council and Assembly, as follows :- Jentitie

Section 22 of Chapter 58 of the Acts of 1891 is hereby amended by striking out said section and substituting the following therefore :

The pay of the Police Force shall be as follows: Privates, four hundred dollars, (\$400) for the first year and thereafter five hundred and fifty dollars. (\$550) sergeants, six hundred dollars (\$600) for the first year and thereafter six hundred and fifty dollars (\$650); Deputy-Chief of Police, six hundred and forty dollars (\$640) for the first year and therefore eight hundred dollars. The said amounts to be respectively paid according to the proper and satisfactory discharge of their duties and at the discretion of and under the direction and authority of the Police Commission, who are hereby authorized and empowered to make Rules and Regulations for the proper government of the Police Force and the defining of their duties and the proper discharge and enforcement thereof and all such regulations as the said Commission deem necessary for the prorection of the citizens and their property. The above sums to be paid in addition to such suits of clothing as the Police Commission may deem necessary. 13 (19:150

Section 348 of said Charter is amended by adding the following sub-section (6) "An appeal shall lie and be brought in all cases from any assessment made
