## SOME POINTS OF PROPOSED PROSPECTUS

## Advantages of Halifax, Nova Scotia, as a Location for a Modern Shipbuilding Plant.

The establishment of great Iron and Steel Works in Nova Scotia has drawn attention to the special advantages we possess for the building of steel ships. The raw material which enter into the making of iron and steel can be brought together in this province so cheaply, that the finished material can be produced at less cost than in any other country in the world. That being the case there seems to be no reason why steel shipbuilding should not become an important and profitable industry in this Province. If the advantages we possess were properly known we believe the necessary capital would be forthcom ng to inaugurate the industry on a large scale. The object of this circular is to point out the special advantages possessed by the port of Halifax for the establishment of such an enterprise. These advantages may be conveniently referred to under the following heads.

HALIFAX HARBOR. The harbor of this port needs no advertising. It is known the world over as the best on the continent. Easy of approach at all seasons of the year, free from ice in winter time, with ample depth of water, and tides of not over six feet, it is capacious enough to harbor the combined shipping of the British Empire. Along its shore line suitable sites for extensive yards can be found at reasonable cost, while the great fortifications that protect it from all points would guarantee safe employment during any great war.

CLIMATE. Owing to the vicinity of the Gulf Stream the weather in winter time is rarely severe. The rain fall is moderate, so that out door work may be continued all the year round with a minimum loss of time from inclement weather. Experience shows that there are as many actual working days '(i. e., days that men can work outside) in Nova Scotia, as in any other competing country.

MATERIAL AND FUEL. Halifax is close to the great Coal and Ore produc. ing centres of the Province, and has ample and cheap transportation facilities with these centres both by rail and water. Frequent steam communication with Great Britain and the United States ensures cheap water carriage for every material that may have to be imported from these countries. An ample supply of wood is at hand, and all outfitting material is readily procurable. In short Halifax possesses the necessary facilities for receiving and handling economically and with dispatch all the raw material which would be required for the operation of such and industry on a large scale.

LABOR. Halifax has the largest population of any one place in the Maritime Provinces from which to secure workmen, and being centrally situated is of easy access from all the outlying districts to which it may be necessary to look for a full supply of hands to operate a large plant. The well known industry and intelligence of Provincialists as mechanics who readily adapt themselves to any and all kinds of work, should guarantee the successful operation of the enterprise so far as labor is concerned.

REPAIR WORK. The geographical position of Halifax makes it the natural haven for ships that become disabled in the storm area of the North Atlantic. Every year numb?rs of such ships are towed to this port either for temporary or permanent repairs. When ample facilities are provided for the heaviest class of repairs, the port would become a still greater resort for ships in distress and repairing would be a profitable department of the enterprise.

DRY DOCK . Another distinct advantage in this connection is that  $\operatorname{Halif}_{ax}$  has one of the finest Dry Docks on this side of the Atlantic, capable of accommodating the largest class of ships.

PROSPECTIVE BUSINESS. There is an immense market for tonnage in our own Dominion. The enormous traffic of the Great Lakes and St. Lawrence will require a constantly increasing fleet of carriers, and the rapid development of our coal and iron industries is creating a demand for vessels specially designed for

the economical carrage of such products. The coastwise business of the Maritime Provinces is now almost exclusively done by steamers, and it seems only a question of time when the great fishing industry of this Province will be done by steam trawlers, specially fitted for the carriage to market of fresh fish. All this points to a large andincreasing demand ior local tonnage which would furnish in itself an important market for one or more large yards in this Province. In addition to this there is an increasing tendency on the part of our Provincial capitalists to again invest in shipping, and a very considerable amount of foreign going tonnage is already owned in the Maritime Provinces. Such owners when ordering new tonnage might reasonably be expected to give a preference to the local industry.

CASH SUBSIDIES. In view of the fact that the undertaking has to be started on a large scale and is practically a new industry in this Province, a strong sentiment has been created in favor of Municipal and Government aid to promote the establishment of the first plant, to foster the industry during its initial stages. Cash subsidies amounting to Three Hundred Thousand Do, lars have therefore been voted, and would be payable to a responsible Company undertaking the enterprise, as follows:

From the Provincial Government towards the erection of the first plant

\$300,000

In addition to the subsidies enumerated above, it is hoped that the Dominion Government may give a bounty on all steel tonnage launched in the Dominion within a term of years.

The conditions governing the Provincial subsidy may be obtained by correspondence with the Provincial Government.

The disposal of the Municipal subsidies are in the hands of a Commission appointed by the City Council and the Board of Trade, subject to the approval of the City Council. His Worship the Mayor is Chairman of the Commission, and will be glad to furnish additional information to parties who may be interested in the undertaking.

#### WATER SUPPLY CAMPBELL ROAD.

CITY ENGINEER'S OFFIRE, Aug. 21st, 1902.

#### His Worship the Mayor :

Sir,-The district north of North Street along Campbell Road and cross streets as far west as Albert Street get their supply through a 9-inch pipe in the Low Service system. The capacity of the pipe is ample to supply all ordinary demands. The winter supply is fairly good, but when the street sprinkling begins at the first of April it is difficult to keep the water up to the higher levels. It is not advisable to make any r?duction in the quantity of water used for street sprinkling-in fact, it should be increased. The greater portion of the water used in the day time in this district, besides the water for street sprinkling, goes to the Sugar Refinery. Their average consumption has been considerably over one hundred thausand (100,000) gallons a day. They are not satisfied with the normal pressure on the mains, but draw the water with a pump, which reduces the pressure below what the natural flow would make it. As the efficiency of the house supply should not be impaired for the benefit of the Sugar Refinery, the time seems opportune for making some change in the present arrangement. We do not want to embarass the Sugar Refinery in any way, and we are anxious to give every facility for carrying on their work; but we cannot continue to furnish them with the quantity of water which they are now taking during the day time. Iwould therefore recommend that the Sugar Refinery Company be given notice that they must provide a storage tank on their premises of sufficient capacity to

contain a supply of water for twenty-four hours, not later than May 1st, 1902, and that after that date the water supply to the Refinery will be cut off at 8 a. m. and turned on again at 6 p. m.

# MAYOR'S ROBE AND CHAIN.

# MAYOR'S OFFICE, CITY HALL, Halifax, N. S., Aug. 26th, 1901.

#### To the City Council :

Gentlemen,-Previous to his depar-eparture on his present visit to the United States, His Worship the Mayor's attention was attracted to the subject of costume to be worn on the occasion of the approaching visit of His Royal Highness th? Duke of Cornwall and York. The Mayor's official robe now in possession of the City has been in use for about forty years and has become obsolete in design and mateeial as well as practically worn out. With the view of ascertaining the views of the Mayors of other cities in the matter His Worship wrote to various of the principal places in Canada and obtained replies which re at-tached hereto. Four out of five of the answers state that it is the intention of the Mayor to wear the official rohe and chain. His worship also obtained from England various price lists of robes and chains and from these it is ascertained that the articles most suitable for the City of Halifax would cost for the chain £60 and for the robe £40.

The committee on reception of His Royal Highness the Duke of Cornwall and York have had these matters under consideration at a number of meetings and have unanimously agreed that a robe and chain should be procured fir His Wor-ship. But while the immediate necessity for their purchase arises through the visit of His Royal Highness, your committee are of opinion that the cost would not be a proper charge against the appriation for the reception, as these articles would become always available for other purposes and the chain a permanent asset.

It is recommended that your committee be authorized to procure a Mayor's robe and chain and that His Honor the Rcorder be authorized to prepare an Act authorizing the City to borrow money for the payment thereof. DINE.

#### MEMO. OF AUDITOR'S DUTIES AND THE KEEPING OF CIVIC ACCOUNTS.

1. All bills against any City Department to be certified by the official receiving the goods or responsible for the work done and passed by the proper committee. The clerk of the committee o manager to enter into a columnar book with appropriate headings all bills passed by the committee (each bill un. der its proper heading) and send them to the City Auditor, who will compare the bills with the contracts (if any) and check extensions and additions. After the bills have passed the City Council the Auditor will attach a warrant on the Treasurer to each bill and send the same to the creditor, who will collect the amount, the Auditor to be responsible for the correctness of the bill.

2. The Auditor to be responsible that any appropriation is not overdrawn.

3. The Auditor to keep no books, except a register of warrants issued, but to be responsible that the books of every Department are in order, and that he may properly perform his duties he should have access to all books of all City Departments and power to direct such books to be kept as he shall think necessary. He should certify to all statements submitted by any Department to the City Council.

4. He should check all receipts and see that the money has been paid to the Treasurer within a reasonable time. He should examine the books of payment and satisfy himself that no accounts have been paid except those bearing his stamp.

5. At the end of each month or quarter he should compare the books kept by the various spending committees with the Treasurer's books and see that they agree.

6. In short, he should examine and pass upon every claim upon the City for money, and examine every cash entry in every department'

## His Worship the Mayor and City Council :

Gentlemen,-In accordance with a request of the Council, I now transmit my opinions as regards the validity of the Mayor's veto in the above matter.

By Section 103 the City Clerk is directed immediately after a meeting of the Council to place before the Mayor all money votes passed by the Council for the expenditure of any sum of money or the making of any contract involving the expenditure of any money from the City Treasury, and if the Mayor approves of such resolution, motion or vote he shall signify such approval in writing with his signature in the Minute, and if he d sapproves of any such resolution, motion or vote he is to signify his dissent in the same way, and shall in writing inform the Council of his disapproval, and his reasons therefor.

In this case the Mayor has not disapproved of the vote in writing with his signature in the Minute as the Statute directs, but merely informed the Council at its next meeting in writing of his disallowing the resolution, but gave no reasons therefor in his written communication to the Council.

The mode of disallowing a money resolution of the Council is clearly pointed out in the Statute and must be followed. The question came before the Council re Connolly's salary, the circumstances being somewhat similar, and was fully discussed and my opinion given in that case in February, 1900, and it is unnecessary to recapitulate the reasons which are well known to the Council.

I am of opinion that the veto of the Mayor, under the circumstances, is not a veto at all and is invalid, as he did not signify his disapproval in writing with his signature in the Minute, as required by the Act.

Therefore Resolved,—That it is the opinion of this Council that the sum of \$20 was due and payable on the first day of May last, and, not having been paid then or since, that the same is still due.

And Further Resolved,—That it is the desire of this Council that the same be paid immediately by the Mayor or his Deputy, and that the amounts be taken from the Appropriation so provided for in the Estimates for the year 1900-1901.

#### May it please Your Royal Highness:

We, the Mayor and Aldermen of the City of Halifax, on behalf of the citizens, do extend to Your Royal Highness a most cordial welcome to this city and do most heartily include in that warm welcome Her Royal Highness the Duchess of Cornwall and York.

We rejoice that our city is thus honored by the presence of Your Royal Highness, son of our most gracious Sovereign and grandson of that august Queen whose memory is, and ever will be, lovingly cherished and revered by all Canadians : and we believe that in this Imperial journey, almost compassing the worldwide confines of the British Dominions beyond the seas, Your Royal Highness is assisting to still further strengthen the ties that already so firmly bind together all parts of the Empire over which His Majesty hold sway.

"Bearing in mind the many happy days which I have spent in your city and province I am particularly pleased to find myself here again and that on this occasion the Duchess is with me.

"It is perhaps fitting that we should take leave of Canada in the province that was the first over which the British flag waved—a province so full of moving checkered historical memories—and that embarking from your capital, which stands unrivalled among the naval ports of the world, we should pass through waters that are celebrated in the annals of our glorious navy. "I am glad to gather from the address of the University of Dalhousie that

"I am glad to gather from the address of the University of Dalhousie that in the midst of that national prosperity you happily enjoy you have not neglected the interests of higher education. You recognize that nothing is so essential to the advancement of a people as adequate provision for a training which will keep the coming generation abreast of the march of intellectual progress and scientific knowledge.

"We share in your regrets as to the shortness of our stay, which will prevent us from judging for ourselves of the great mineral wealth and other resources for which your province is famed. We trust that the development of these resources already attained is but an earnest of a still greater future.

"In bidding you farewell we wish to make known how greatly we have been impressed by the affectionate sympathy with which we have been received by the people of the Dominion, and we pray that the Divine blessing may rest upon them and theirs, and upon those in whose hands is placed the guarding of its destinies."

I understood when the matter was before the council on the 12th February last that the construction of this sewer was not to be considered again until the conditions changed, consequently I have not reported upon the matter earlier. As an immediate report was insisted on at the last meeting of council, I am forced to repeat the last report. The sewer appropriation is exhausted and there will not be any balance to the credit of it for some time. It will thereby be manifest that a work of this magnitude cannot be undertaken until more money is available. I therefore cannot recommend its construction at present.

The water extension is on the high service system, which is becoming more unsatisfactory every day. The complaints this year have been more frequent and the difficulty of keeping up the supply has been greater. In deference to the opinion of the council, and in consequence of the personal appeal of property owners, I was anxious to recommend this work if it could be done without interfering with the public interest. Under the circumstances, however, I consider that it would be deliberately taking the water supply entirely at some seasons of the year from those who now have a partial service, and under the circumstances, much as I should like to meet the views of the petitioners, and of the aldermen who are urging the matter, I cannot recommend the extension.

SIR,-In accordance with the accompanying resolution of Council, I beg to report on the construction and cost of a sewer from Kempt Road through Mulgrave Park to the Harbor.

The resolution is in error in stating that the proposed sewer would relieve the present main sewer crossing the Common, as no portion of the drainings to the Common sewer could be brought to it without heavy expense for re-constructing the system already built. The unsanitary condition of the low ground between Sullivan Street and the higher part of Merklesfield is due to the want of of property drainage; but the construction of a sewer in West Young Street with proper connection from the Hennessey property will take off all the surface water for the present. The length of a sewer from Kempt Road to the Harbor would be over 4,000 feet, the greater part of which would be through private property. The estimated cost of construction is \$27,500, not including cost of right of way. I am unable at present to estimate the cost of right of way without making final surveys. The construction of this sewer seems out of the question in the present condition of the sewer appropriation. There is not a dollar to the credit of the sewer appropriation, and under the circumstances, I cannot recommend the construction of the proposed work.

Read letter from the City Medical Officer re appointment of Dr. Purcell as resident physician at Small Pox Hospital.

CITY MEDICAL OFFICER'S SUBSTITUTE-IN RE SMALL POX.

October 22nd, 1901.

To His Worship the Mayor and Members City Council:

GENTLEMEN,—With the outbreak of the present attack of small pox in our city, it became necessary to open the Small Pox Hospital for the admission of patients. The City Health Board ordered me, as your City Medical Officer, to take charge of the patients at the Small Pox Hospital and remain with them in quarantine during the time the building was occupied. I was able, however, to secure the services of Dr. Purcell to fill the position of resident physician, and his selection was accepted by the City Health Board. This has left me free to attend to all the other duties pertaining to the office, which have necessarily been greatly increased by the recent outbreak, and the measurers necessary to keep it from spreading.

I would ask your Council to confirm the engagement of Dr. Purcell from September 26th last.

#### IN RE PRESCRIBING DUTIES OF CITY OFFICERS.

RECORDER'S OFFICE, CITY HALL, September 16th, 1901.

### His Worship The Mayor :

SIR,-In accordance with a resolution of the City Council, I beg leave to state my opinion as regards the power of any person or body, other than the City Council, to change the duties of City officials.

By section 122 "The City Council shall prescribe the duties of all officers of the City by bye-laws wherever the law has not expressly appointed and prescribed their functions, and subsection 16 of section 798 of the City Charter in relation to bye-laws empowers the Council to define the duties of City officers and the manner in which they shall account for money received or expended by them.

These clauses of the Act apply only to such officials as the City Council has power to appoint under the law. It does not apply to day laborers or persons of that class appointed by the City Board of Works and who are necessary to perform the public works of the City; but, in my opinion, it does apply to officers above named, namely: those whom the City Council have the right to, and have appointed.

The Council, on the 31st October, 1872, on the recommendation of the Board of Works, defined the duties of the Clerk of Works, and *l* am not aware that these regulations have been altered in any way since they passed, and they can only be altered by the Council.

It must also be remembered that in the case of officials who are compelled by haw to give security for any moneys coming into their hands belonging to the City their sureties' and the rights of the City may be seriously affected by an alteration of their duties.
