Total number of inmates January 31st, 1903, was 378, made up of 235 men, 142 women, and 1 child.

IN RE WILLIAM AUSTIN'S LICENSE.

His Worship the Mayor and City Council:

GENTLEMEN,—The Liquor License Act directs that a deposit fee of \$10.00 to cover the expenses of inspection and advertising shall be made with the Chief Inspector of License, and if the license is granted, this amount shall be credited on the license fee, payable by him; but in no case shall such fee or any part thereof be returned to the applicant, except by order of the Council.

Mr. Austin made applications for license in the years 1900 and 1901, and in each instance I understand the license was granted by the Council; but illegally granted, as the building for which he applied for a license was within 100 yards of a school. Mr. Austin now applies for a return of his deposit. It has been always the practice of the Council where a license has not been granted, or where granted but illegally, to return the deposit after deducting the expenses of inspection and advertising; and I would recommend that this course be pursued in this particular instance.

Extract from Minutes of a Meeting of the City Health Board held on the 9th day of February, 1903:

The following resolution was introduced:

Whereas, The City Council by resolution passed the 4th day of December 1891 resolved that the City Recorder furnish the Health Board with what legal services they may require in enforcing the Health Act or Sanitary Rules without additional remuneration;

And Whereas In reply to a letter from the Recorder asking for remuneration for legal services rendered, this Board has been informed through the City Clerk that such resolution of December 4th 1891 has never been rescinded;

And Whereas the City Recorder has been asked on a number of occasions to furnish the Board with legal advice and has refused to do so unless he is paid for such services:

Resolved that these facts be reported to the City Council for their action, and that the Council be informed that unless necessary legal advice and assistance is furnished to the Board by the Recorder in compliance with the resolution of Council, this Board will be compelled to secure such advice and assistance at the cost of the City.

Read application of Robert Story for position of Coal Weigher Filed. Moved by Alderman Hubley seconded, by Alderman Lamphier, that the Order of the Day be further suspended to allow Alderman Hubley to introduce a resolution. Motion passed and the following resolution submitted:

Whereas, A vacancy having occurred in the representation of Ward Four by the resignation of Alderman Ryan, and it is desirable that said office should be filled;

Therefore Resolved that said office of Alderman be and is hereby declared vacant; and that an election to fill said vacancy for the unexpired term be held according to law.

Moved by Alderman Hubley, seconded by Alderman Lamphier and passed.

Moved by Alderman Hubley, seconded by Alderman Rogers, that His Worship the Mayor be authorized to order the Chief of Police to procure two suitable places for polling booths for the election in Ward Four, and that Alderman Hubley and Alderman Lamphier be the Presiding Officers at said election; the date of the election to be fixed by His Worship the Mayor. Motion passed.

Alderman MacIlreith submits the following notice of motion :

Resolved, that all Standing Committees and Commissions of the Council, as well as the Board of Health, and excepting the Police Commission be abolished and all the duties and powers of said Standing Committees be vested in a Board of Control and the necessary Legislation be procured to give effect to this resolution.

A draft constitution for the said Board of Control accompanied the notice of motion.

BOARD OF CONTROL IN CITY OF HALIFAX.

HOW CONSTITUTED-REMUNERATION-TERM OF OFFICE-REMOVAL.

(1)—In the City of Halifax there shall be a board of control, to consist of the Mayor and three Aldermen, three of whom shall form a quorum. Such three Aldermen shall be elected by the Council at the first meeting of the Council for the year, or in case of failure to elect at such meeting, then within one week thereafter.

(2)—Upon the election of the said three members of the Board of Control, the names of all the candidates shall be submitted to the Council and shall be balloted for at the same ballot; and each member of the Council shall for the purpose of such election be entitled to as many votes as there are candidates to be elected, but he shall not give to one candidate more than one vote.

(3)—The Mayor, when present, shall preside at the meetings of the Board, and in the absence of the Mayor the Board shall select one of their number to preside. In the event of a tie at the Board, the Mayor shall have a second and casting vote.

(4)—The Council may fix by by-law the salaries to be paid to the members of the Board of Control, but the sum shall not exceed for each member the sum of \$—per annum.

(5)—The elective members of the Board of Control shall hold office for the remainder of the municipal year in which they are elected, unless removed; but they shall, if members of the Council, be eligible for re-election. In case any member of the Board dies, resigns or becomes incapable of acting, the Council may, at a meeting called for that purpose, elect a successor to hold office for the unexpired portion of the term of such member; or in case of the temporary absence of any member for more than one month, or of his inability to act, his place may be temporarily filled by the Council. (6)—The election or appointment of any Alderman as a member of the Board of Control shall not render him ineligible for election as Chairman of the Committee.

(7) The Council at any time, after three days notice in writing to each member of the Council, may, by an affirmative vote of two-thirds of the member of the council present and voting, remove any member of the Board of Control other then the Mayor, and may after such removal proceed to fill the vacancy thus created. But such removal and the filling of the vacancy shall take place only at meeting specially called for such purpose.

2. (1)-It shall be the duty of the Board of Control:

(a) To prepare an estimate of the proposed expenditure of the year and certify the same to the Council for its consideration. The Council shall not appropriate or expend, nor shall any officer thereof expend or direct the expenditure of any sum or sums not included in or provided for by such estimates.

(b) To prepare specifications for and award all contracts, and for that purpose to call for all tenders for works, material and supplies, implements or machinery, or any other goods or property required and which may lawfully be purchased for the use of the corporation, and to report their action to the Council at its next meeting. Upon the opening of any tenders, the chairman or board shall require the presence of the head of the department or sub-department with which the subject matter of such tender is connected, and of the City Recorder when required. Such head of department may take part in any discussion at the board relating to such tenders, but shall not be entitled to vote. The Council shall not, unless upon an affirmative vote of at least two-thirds of the members of the Council present and voting, reverse or vary the action of the Board of Control in respect of such tender and decision of the work or to award the contract to a tenderer other than that one to whom the Board of Control has awarded it.

(c) To inspect and report to the Council monthly or oftner upon all municipal works being carried on or in progress within the City.

(d) To nominate to the Council all heads of departments and sub-departments in case of any vacancy, and after a favorable report by the head of the department, any other officer of the corporation required to be appointed by by-law or resolution of the Council, and any other permanent officers, clerks, or assistants, and to recommend the salaries of all officers and clerks; and no head of department or sub-department or other permanent officer, clerk or assistant as aforesaid shall be appointed or selected by the council in the absence of such nomination without an affirmative vote of at least two-thirds of the members of the Council present and voting; but the Council may, by a majority vote, refer such nomination back to the Board of Control for reconsideration.

(e) To dismiss or suspend any head of a department and forthwith to report such dismissal or suspension to the Council. Where any head of department has been dismissed by the board he shall not be reappointed or reinstated by the Council unless upon an affirmative vote of at least two-thirds of the members of the Council present and voting.

(f)-To discharge all other duties heretofore assigned to or discharged by any or all standing committees of the Council.

(2)—In the absence of any resolution of the Council prescribing the mode of appointment of all or any other subordinate officers, clerks, assistants, employees, servants and workmen not included in clauses (d) and (e) of the preceding subsection and required by any department or sub-department for the due and proper discharge and performance of the duties and work thereof, the board may by regulation or resolution direct by whom and in what manner such subordinate officers, assistants, employees, servants or workmen shall be appointed, engaged or employed.

(3)—The Board may from time to time, submit proposed by laws to the Council, and where in the opinion of the Board it is desirable, may; amalgamate departments or sub-departments.

(4) -The Board may appoint from among the officials of the City a Secretary or Clerk whose duty it shall be to keep minutes of all proceedings of the Board and prepare all reports and other proceedings of the Board ; and he shall perform such other duties and services as may be assigned to him from time to time by the Board, the Mayor or the Council.

• (5)—The Council may by by-law or resolution impose upon or assign to the Board of Control such other duties as to the Council may seem meet. And the Board shall, when so required by resolution of the Council, and upon one week's notice thereof, return to the Council copies of the minutes of its meetings, and any other information in their possession which the Council may require.

(6)—Nothing in this section contained shall prevent the Council (by a vote of a majority of the members of the Council present and voting) from referring back to the Board of Control any report, question, matter or thing for reconsideration.

(7)—In all cases where it is sought in Council to reverse, set aside, or vary the action of the Board of Control, or where a two-third vote of the members of the Council present and voting is required for any purpose, the vote by yeas and nays shall be recorded in the minutes of the Council.

(8)—The Public School Board of the City shall furnish to the said Board of Control on or before the first day of December in each year, their several and respective annual estimates.

(9)—Clause (d) of subsection 1 of this section shall not apply to any corporation to which the Council is entitled to elect a representative.

(10)--Notwithstanding anything in this Act contained, the duties herein assigned to the Board of Control shall be discharged exclusively by the said Board, except in the cases provided for in sub-section 3 of this section.

OVER-EXPENDITURE FIRE DEPARTMENT.

Committee Room, City Hall, March 2, 1903.

To His Worship the Mayor and City Council:

GENTLEMEN,—The Board of Fire Wards beg to report that they have recently made a careful examination of the financial affairs of the Department for a period covering the past and present civic years, and find that debts have been contracted for a total amount largely in excess of the appropriation. Accounts already rendered in response to efforts recently employed, together with a small amount of expenditure which it will be absolutely necessary to make before the end of the year, bring the total actual deficit, so far as the same has been ascertained, up to the sum of \$2,200.00. In addition to this the fire at Moir, Son & Co.'s establishment on Saturday night, February 28th, caused a considerable consumption of coal, damage, breakage and loss of gear and destruction of a number of lengths of hose. Being unable to give an assurance that all outstanding accounts have been rendered, and having in view the purchase of 500 feet of hose to replace hose lost and destroyed as stated, your Board find it necessary to ask for a total extra grant of \$3,000.00 to cover the deficits of the two years, and recommend that legislation be sought to enable the City to borrow that amount.

IN RE EDUCATION ACT.

GENTLEMEN, —As this Act now stands, the citizens of Halifax are very heavily taxed for the support of schools in the City and it has become a very grave and serious burden to the citizens. Under the Act, in the case of a person owning property in the City and residing elsewhere, such as Bedford, the school tax upon the property in the City owned by him has to be taken and handed over to those outlying districts and throws a burden upon the remaining portion of the property. A large quantity of property in the City is owned by residents at Bedford and elsewhere out of the City, and while these properties receive police, fire and other protection in the City, yet the citizens are not entitled to the school rates. I think the time has arrived when the City Council should deal with this matter and that all school rates levied upon property within the City should be paid to the City, not elsewhere.
