To His Worship the Mayor and Members of the City Council:

GENTLEMEN,—In accordance with the resolution of Council under date April 17th, 1903, I herewith respectfully answer the questions as ordered :—

1. Has it been the practice in the past to buy all Hardware for the Works and Water Departments from the Firm having the Contract?

No! The following are the numbers of seventy-nine orders covering goods commonly classed as hardware, from April 1898 to May 1902, which were bought from other Firms.

2. If goods commonly classed as hardware are purchased from firms other than the regular Contractors are quotations sought from different dealers?

Yes! When the order is large, such as tar, asphalt, machine oil, cement. For smal¹ shelf hardware, such as locks, bolts, hinges, door knobs, blank nuts, staples, etc. No

3. If quotations were obtained were the goods purchased from the dealer quoting lowest prices?

Yes!

4. If no quotations were obtained was price asked from dealer from whom goods were purchased ?

I presume so, as the official whose department requires the goods must certify the bill before payment.

5. If not, was price fixed in order for goods?

No price is fixed in any order, except for Cement.

6. Were any goods enumerated in contract purchased elsewhere than from Contractor!

Yes !

7. If so, why!

About the middle of last June His Worship the Mayor asked if the City wer^e obliged by the contract to purchase all hardware required from contractor. The City Engineer then stated that a clause in the contract only required the City to purchase the articles enumerated in the specification. His Worship the Mayor then issued an order that all contract goods were to be filled in on order book to the contractor and on all non-contract goods, the order book was to be left blank by the official requiring the goods. On January 8th, 1903, an order for goods amounting to \$4.37 was filled in blank by the official ordering same and I assumed from the omission that it was not contract, hence the order was sent in mistake to A. J. Grant & Co.

8. Who fills in name of person to receive order ?

I do, except in rare instances.

9. Under whose direction is it filled in ?

His Worship the Mayor's.

10. Who certifies as to the correctness of prices charged where no quotations are asked for, and is such official familiar with the market prices of such goods?

The various foremen, from their long experience, are, I presume, as familiar with the value of the goods required for their Department as can be expected, and from their well known interest and pride in keeping down the expenses of their services, the Council can rest assured that no unusual prices are paid.

For myself, I check the bills in comparison with similar ones paid, as far as possible and then the City Auditor finally checks them before payment.

In response to invitation by His Worship the Mayor, Chief Connolly addressed the Council.

A number of motions having been proposed and withdrawn, the following resolution is introduced:

Resolved, That Chief Connolly, of the Fire Department, be suspended from duty for one month from date, with loss of salary for that period.

EVIDENCE TAKEN BEFORE CITY COUNCIL.

The Clerk read Clause 6 of the Miniroty report, covering charges.

6th. That Chief Connolly, at the direction of the Chairman, has certified bills supposed to cover goods obtained by the Department, whereas as a matter of fact such goods were never ordered or never delivered to the City. That the Chief has evidently made little effort to carry out the rules of the Department, for it has been shewn that at the Annual Drill, held at the Exhibition Grounds, a considerable amount of liquor was there for the use of the men. It has also been shewn that card playing is common at the Engine Houses, and that it is not confined to games among members of the department, nor to week days; but it has been the custom to play poker, cribbage, etc., on Sundays as well as week days, and that young men from the districts round about certain of the Engine Houses have been either playing or spectators, and that the Chief too has witnessed these games on Sunday evenings without protest. We considered these very grave charges against the Chief.

In re goods charged and not delivered to the Engine Houses -the Chief asked what were the goods he certified to that were not delivered. The Clerk again read Clause 6, and cited evidence given by Chief before Investigating Committee. The Chief stated that he had told the truth before the Investigating Committee, and that anything that was done in connection with the purchase of supplies was in the City's interest, and the intention was that the goods were to be charged that way to cover charge for veterinary services of the previous year; and that he had since he took charge of the Department done everything in an honest and straight-forward way.

Alderman Hubley here asked the Chief if at the time he signed the bill for oats, he knew the City had not received them in store, or that they had not been delivered. The Chief said that he did not remember at the present time.

Read Section 2 of Clause 6, re carrying out of rules of Department,—The Chief denied any such charge, and stated that the liquor and cigars were for the use of the Committee and not for the Men. This answer was corroborated by Alderman Lithgow, who was present at the Sports, and who stated that the men had no liquor there.

Charge re Card Playing at Engine Houses, —The Chief denied the charge, and asked for a chance to call witnesses to refute the charge, and also stated that some of the members of the Old Engine Company frequented the Houses and played cards and other games.

Clause 7. "That the management of certain fires, notably the recent fire at Willow Park, Box 9, and at Mr. Anderson's barn, May 5th, 1901, was of such a nature as to lessen the confidence of the public in the ability of our Chief."

The Chief stated that if the driver of hose cart failed to bring coal he did not think the Department could be condemned for one man; also that at the Anderson fire the supply of fresh water was deficient and was hard to get at.

Clause 8. "That there is apparently very little harmony among the members of the Department and that it appears to be divided into sets, whose antagonism to seach other tends greatly to weaken the efficiency of the Department."

The Chief stated that there had been some bad feeling among some numbers he had to reprimand, but that taken as a whole the Department was all working with unanimity one with another.

Alderman Cawsey asked who consumed the barrel of ale at the sports, there being only six members on the Committee ?

Alderman Hubley asked how many men he had in training to go to Moncton ?

The Chief declined to answer these questions.
