As the remedy can be quickly and cheaply applied, I have instructed the foreman to lay another length of pipe extending the outlet clear of the sand, which will be done at once.

SIR, -I beg to report on the accompanying petitions asking for street lights.

The appropriation for street lighting is sufficient only for the number of lights that we have at present in use. When we estimate the amount that will be added in consequence of fines imposed upon the contractor in some years the sum is greater than in others and we are obliged to be governed by the small amount.

All the lights asked for are needed. It was at one time hoped that a light would be provided at the corner of Bishop and Pleasant Streets; but it has not been done, and I would recommend that \$325.00 be added to the es imates for last year and that lights be placed at the corner of Bishop and Pleasant Streets, corner of Argyle and Jacob Streets, one on Pepperell Street and one on Chebucto Road near Beech Street. The light on Longard Road at Livingstone Street, will also have to be provided for, making five lights at \$65.00-\$325.00.

### REPAIRS OLD EXHIBITION BUILDING.

GENTLEMEN.--At a meeting of the Committee on Works, held this day, the attached report of the City Engineer on letter of H. B. Clarke, lessee of Old Exhibition re its condition, was read and referred to the Council with a recommendation that its provisions be adopted.

#### His Worship the Mayor :

SIR,-I beg to report on the accompanying communication from H. B. Clarke, referred to me.

Mr. Clarke leased the Old Exhibition Building on the first of July, 1898, and has continued to lease it ever since at an annual rental of \$1140 52.

In the accompanying letter Mr. Clarke complains that the building is very much out of repair and that its condition has seriously affected his business and caused loss and damage. Under the lease, the city is to keep the outside of the building in repair, which it has not done. Mr. Clarke asked that the building should be put in good order as soon as possible, and also asks that the City make some reduction in the rent in consequence of the City's neglect to keep the building in proper. In conversation with Mr. Clarke he asked that the City should reduce the rental for this year by one quarter of the whole I visited the building during a heavy rain recently and found it in a very bad condition, although the cost of repairing it so that it would not leak would be comparatively moderate. The main roof is partially covered with shingles and partially gravel roofing. The gravel roofing has been repaired, but the shingle roof leaks in about twenty different places. There are a great many panes of glass broken in the building, caused apparently by the boys playing in the neighborhood, many of them being school children attending the Summer Street School and Mr. Waddell's (Arnold) school. The main tower over the entrance is in a very bad condition and the rain comes down all over the offices and retiring rooms. It would be necessary, in order to make a good job of it, to re-shingle the upper part of the main tower, putting in new facia boards and cornices and removing the upper windows entirely, as was done a few years ago on the main roof. This would make a good job of it and practically plece it in good order for some time. The City carpenter has made a careful estimate of the cost of repairing the tower and main roof and is of opinion that the cost will not exceed \$450 to \$500. There may be some repairs required to sills and floor joists next year, but that work is not so urgent. The towers and main roof should be repaired at the earliest possible date. There is no money in the City Property Fund to do this work at present; but it is not fair to Mr. Clarke to delay it. The amount paid for the building is a large one and there is no doubt that it will be difficult to obtain the same rent unless the City keeps it in better repair. From the beginning of Mr Clarke's lease until the first of May, 1903, he has paid rent amounting to \$5512 53. During that time the City has expended on the building tor repairs and iusurance about \$700, leaving a clear profit for the City of \$4800, which far more than pays the interest on the debt on the whole property, including all the buildings.

After consultation with His Honor the Recorder, I beg to recommend that Mr. Clarke be allowed to make the repairs under the direction of the City Works Department and deduct the cost from the rental, and that the amout of his rent for the balance of the year be reduced to one-quarter's rent.

# WATER EXTENSION CITY PRISON.

### December 2nd, 1903.

### His Worship Mayor :

SIR,—In accordance with the accompanying extract from Minutes of Council, I have investigated into the feasibility of obtaining a supply of water for the City Prison by boring or excavating and raising the water by wind power. At Leaman's slaughter house, Rockhead, such a system is already in operation They sank a well and obtain a constant supply of good water. At the Infectious Diseases Hospital a well has been sunk from which a supply is obtained the year around for the Hospital. The water is pumped by hand to a tank in the upper storey from which the building is supplied by gravitation. The estimated cost, as near as I can ascertain, would be about \$300.00 for

for sinking a well and providing a wind-mill pump. Water could be pumped to a tank elevated above the well high erough to give a fire pressure for the building; but I fear it would not be practicable in winter on account of frost It would, however, be quite feasible to pump the water to a tank inside the building on the upper storey provided the pipes could be placed in the building where they would not freeze, and the same precaution could be taken in connection with a tank If the city water service were extended to Rockhead there would be no fire pressure, but water would have to be obtained by steamers. In the winter season a fire supply could be obtained from the well suggested, if necessary, which, while it would not supply the quantity that could be obtained from the City mains, would be just as good as long as it lasted. A system such as that suggested would be far more convenient and much more satisfactory than anything else that has been proposed, except the extension of the City water main, and would not cost any more than a good watering cart, the purchase of which I understand the Committee have had under consideration. If the Committee have the money to purchase a cart such as the City Works Department could take over when they were done with it, I think the same amount of money would provide a well and wind-mill pump.

GENTLEMEN, - Your Committee on Laws and Privileges beg to report that a meeting

of the Committee was held this day, there being present Aldermen Geldert, (Chairman), Johnson, Doyle and Rogers.

Your Committee had under consideration resolutions of the City Council requesting that Ordinances be prepared to govern and regulate :---

1st. The running of automobiles in the City ;

2nd. The duties and fees of Fence Viewers;

3rd. The scaffolding of buildings under construction and repairs ;

4th. The running of shows and exhibitions

1. Your Committee have instructed His Honor the Recorder to draft Ordinances governing the running of automobiles and the running of shows and exhibitions and to report the same at next meeting.

2. Your Committee have also instructed His Honor the Recorder to prepare an Ordinance fixing the duties and fees of fence viewers.

3 Your Committee have been advised by His Honor the Recorder that the regulation of scaffolding of buildings, etc., is dealt with in the Building Act to be submitted to the Legislature during the present session.

4. Your Committee further report on claim of G. P. Henry for remuneration for alleged services, that he, having performed services for the City by the request of the then Mayor, but without any appointment or authority from the City, this Committee recommend that he receive seventy (\$70.00) dollars. provided he accepts that sum in full of all his claims against the City, said sum of seventy (\$70.00) dollars to be paid out of the Water Maintenance Account—Alderman Rogers dissenting

5. Your Committee further recommend that the Police Commission detail a special officer to enforce the Ordinance relative to pedlars and hawkers.

6. Your Committee had under consideration the report of the Board of Health re salary of His Honor the Recorder as legal adviser of Board, and recommend that as there are no funds at present available to pay said salary that the sum of one hundred and twenty-five (\$125.00) dollars be placed in the estimates for the year 1904-5 and be paid to him when the collected revenue will permit, and that his salary for 1904-5 be also placed in said estimates.

7. Your Committee had also under consideration the petition of Nathan Cornfoot for return of liquor license fee, and are advised by the Recorder that the prayer of such petition cannot be acceded to.

Your Committee had also under consideration the petition of the Sisters of the Monastery of the Good Shepherd asking to be relieved of water rates for one year. Your Committee, while sympathizing with the Sisters in their severe loss, acting under instructions of His Honor the Recorder, regret that they cannot recommend the granting of this petition.

Your Committee had also under consideration the report of the City Engineer re quality of gas supplied by the Halifax Electric Tramway Company, and beg to recommend that :

Whereas, The Halifax Electric Tramway Company, Ltd., having secured the franchises of the People's Heat and Light Co., and therefore is the only corporation which supplies the City of Halifax with gas for lighting purposes and furnishing electric light to the City and in the City;

And Whereas, It is believed that the quailty of both are inferior and below the standard required, which has led to great dissatisfaction in the City;

And Whereas, The Gas Inspector only makes a test once in thirty days and it is generally believed that the corporation can readily hear when this is to be made and might therefore be prepared for the inspector;

Therefore Resolved, That this Committee recommend that the Council memoralize the proper department at Ottawa that an inspection or test be made at least every second day throughout the year. The Ordinance prepared by the Recorder to govern the running of automobiles having been completed is submitted herewith.

# IN RE HALIFAX AND SOUTH SHORE RAILWAY CO.

RECORDER'S OFFICE, CITY HALL, HALIFAX, N. S., Nov. 19th, 1903.

### His Worship the Mayor :

SIR,—I understand it is the intention of this Company to throw a bridge across Kempt Road near the Three-mile House to some where about twenty to twenty'five feet. This is a serious matter as regards the City's rights, and a strong protest should be made by the Council against the Company narrowing the street in any way. If a bridge is to be placed there it should be across the whole present width of the road looking to its future use in the building up of that portion of the City.

According to the plans filed, this railway crosses the Dutch Village Road three times—once at Mr. Webb's property and twice near the Three-mile house—and also crosses the Bayers Road.

I underssand it is the intention of the Company to build a new road from the forks of the present Dntch Village Road and the old Windsor Road and close up the road from that point to the Three-mile House, the effect of which will be to make but one crossing at Mr. Webb's. Whether this is their intention or not, the Council should take steps by interviewing the Government at as early a date as possible to have such precautions introduced as will protect the lives and property of the citizens. If the road be diverted, as I have intimated, there is ample room to build the railway without taking the "Octagon Houses" and Mr. Tufts' house.

I would advise that the Council appoint a committee, with the City Engineer, to wait upon the Government at as early a date as possible with regard to these matters.

# EDWARD BRENNAN'S CLAIM.

### CITY WORKS OFFICE, November 25th, 1903.

### To the City Council :

GENTLEMEN,—At a meeting of the Committee on Works, held this day, the attached Minute of Council reletter of J. J. Power, Solicitor for Edward Brennan, claiming damages for loss sustained through overflow of sewer and City Engineer's report thereon were read and it was decided to recommend that City Engineer's report be concurred in.

### CITY ENGINEER'S OFFICE, November 25th, 1903.

### His Worship the Mayor :

SIR,—About two months ago the accompanying letter from Mr. John J. Power was received by the Council and referred to the Committee on Works for roport. The letter claims that the cellar of the property No. 36 Birmingham Street, owned by Mr. Edward Brennan, was flooded by an overflow from the sewer, on the 6th September ; that a large amount of coal was damaged and that the cellar was permanently dampened and rendered unfit for the storing of vegetables and milk. It also alleges that the sewer pipe is wholly inadequate for the purpose for which it was constructed. He asks for the sum of \$250.00, which he states is the minimum amount that represents the damages sustained by him.

I visited the premises as soon as possible; but found that it would be necessary to make surveys before I could report clearly upon the matter. In regard to the damages alleged to have been sustained, Mr. Brennan stated that there had been a back flow into the cellar. The water if raised on the coal would, of course, wet it, but would not necessarily damage it. The cellar has not been permanently dampened, because the water was removed from the cellar and has not since flowed in.

The sewer in this block of Birmingham Street is not too small for its purpose, but is of ample size. I could find no obstruction in the sewer and was led to conclude that the cause was a stoppage in the sewer on Rottenburg Street, which caused the water to back up into the sewer on Birmingham Street. The cellar at No. 36 is three feet above the bottom of the sewer so that the water must have risen considerably above the top of the sewer before it could get in over the top of the closet in Mr. Brennan's cellar.

As Mr. Brennan claims that his cellar has been flooded more than once from a similar cause, I would recommend that 160 feet of relief sewer be constructed from the south end of the present sewer on Birmingham Street to the Morris Street sewer, so that if sewerage backs up into this block of Birmingham Street it will flow off through the Morris Street sewer before it can rise in Mr. Brennan's cellar.

If the Council approve of this recommendation, I would further recommend that the work be done as soon as possible

The question of the City's legal liability should be referred to His Honor the Recorder.

# SYSTEM OF BOOK-KEEPING IN ASSESSORS' OFFICE.

# To His Worship the Mayor and Members of the City Council:

Your Committee appointed to investigate the system at present in vogue in the Assessors' office of the City. met for that purpose in said office on the evening of December 8th. The three Assessors, the Auditor and the City Treasurer were present and gave your Committee all the information that was possible.

Upon a thorough investigation of their present practice, your Committee concluded that the Assessment Law of the City regulated the system and that the Assessors were but carrying out the law, which they did very effectually. If, therefore, any change is made in the methods of the Assessors' Department it will, in our opinion, be necessary to have the Act changed so as to cover desired improvements.

Your Committee would recommend that the Act be so changed that it would not be necessary for three Assessors to go in a body when making their assessments. A great deal of time would be saved if the practice of other cities would be carried out, viz. :-that but one Assessor be employed in any particular part of the City at one time; and for the time that such assessment is being made a temporary clerk might be employed for each Assessor. These clerks might be secured at a small salary for the few months that they be so employed, and that they be not considered as part of the general staff of the City. It is the opinion of your Committee that the Assessors perform a very large amount of work and that a clerk should be employed in their Department so that the Assessors' office would never be closed during business hours (as is the case at present during much of the time while the Assessors are engaged in making their annual assessments) so that any citizen who might want information in this Department would be promptly served. This clerk, while not otherwise employed, could be making out bills which are sent out from the Assessors' office, but which in other cities are sent out from the Collector's office.

It is very desirable, now that the City Charter is being revised and that new tax schemes ar-being proposed, that a committee be appointed to fully consider the matter and bring in such recommendations to the Council as to changes in the law relating to the methods of the Assessors and the forms used in their office, as would bring them up to the present practice of the most progressive cities Aud in this connection your Committee would recommend that this proposed committee should make a study of the report of the Ontario Government, made by seven experts, who were appointed by that Government to report as to the best possible system of taxation for the cities of the Province of Ontario. This Committee spent several years investigating the methods of taxation and assessmens, not only in Canada but in various States of the United States and other countries, and their report is published and will come up before the next session of the Legislature of Ontario.

Until such time as the Engineer's plan of the City is completed it would be a great convenience and benefit to the Assessors if the City would furnish their office with a Goad's plan of the City or an Ordnance Chart This plan could be supplied with sheets, bound in with the leaves of said plan, and on which could be kept-according to blocks —the details of each assessment

Your Committee would recommend that the City Clerk ask the proper Imperial officer, at present located in the City of Halifax. for an Ordnance Map of the City for the use of this office, and if it is found to give sufficient information, it would not be necessary to purchase the Goad's plan. And, in the event that it cannot be secured, that a Goad's plan be purchased.

Your Committee would recommend that the Assessors be instructed to supply any citizen who wants information respecting any assessment with the necessary particulars; but that such regulations should be in force that, while giving the utmost information and liberty for any citizen to examine the books, reasonable safeguards should be taken for their saf ty

In making this recommendation we do not wish to convey the impression that the Assessors wish to conceal anything or have been discourteous; but we feel that their work would be much facilitated if a clerk be employed in the office whose chief duties would be to attend to the wants of the public in this respect, as the Assessors' time is much more valuable used in other ways.

It would seem, also, that a sufficient system of checking, as between the books of the Assessors and those of the Collector, is not in force, and it is possible for errors to occur without being detected.

Your Committee would therefore recommend that the City Auditor verify the total figures, so that the books of the A-sessors and those of the Collector would agree.

Furthermore, it occurs to us that duplicate bills of the assessment be made out the individual retaining one and the Collector the other—this would satisfy the ordinary desire of every taxpayer to retain his bill.

In conclusion, the Council will see from this report that very little can be done in the way of improving the present system without a change in the Act.

# STREET RAILWAY EXTENSION.

# His Worship the Mayor and City Council :

Your Committee appointed to confer with the Officers of the Halifax Street Railway Compony, in connection with the desirability of extending their road from the present terminus at Campbell Road to Richmond, beg leave to report as follows :-

We met the president, Senator MacKeen, at the Tramway Company's office. and laid the matter before kim. The Senator listened attentively to all the arguments offered; and, after considering the matter fully, he gave the committee to understand that he understood that the L C R, on account of the double tracking of the read to Rockingham, the building of the South Shore Railway and the general improvement of the terminus, had plans which proposed the removing of the machine shops from Richmoud to the vicinity of the present terminus of the Tramway, and in that event Campbel road would be diverted, so that, even if the Tramway were extended to Richmond and those improvements took place, their rails would have to be removed and they would be put to a large and unnecessary expense. It was concluded that the cost of extending the Tramway Company's road from the present terminus to Richmond would be about \$10,000. He therefore suggested—and the committee fully coinsided with the suggestion on account of the reasons presented, that the matter be deferred until such time as it is definitely known what are the proposed plans of the I. C. R.
