#### REPORT OF SPECIAL COMMITTEE ON WATER SUPPLY.

### COMMITTEE ROOM, CITY HALL, June 20th, 1904.

This Committee beg to report that they have been furnished with very full information by the City Engineer in reference to the water supply of this City and the working of the department, including report of the water inspectors, and comparative results of tests of City hydrants covering several years. Your Committee have also visited and inspected the works at Long Lake, Chain Lakes and Spruce Hill Lake.

We are of the opinion that the sources of the supply of both high and low water services are ample for the City's needs at present and for a long time to come. We are informed that ten million gallons passes daily though the mains, or an average of over two hundred gallons per head of population, and as twenty-five gallons per day per head is the average amount used in English cities and from seventy-five to one hundred gallons per head per day is found ample in manufacturing and other cities in the United States, our present supply should, in our opinion, be sufficient for a population of at least 80,000.

#### We recommend :

First, that the temporary stop timbers on the waste weirs of Long Lake and Spruce Hill Lake be renewed and put in good order and raised as high as they can be with safety to the dams in order to preserve as much water as possible in the lakes.

Second, that drastic measures be taken to check the waste by consumers by rigid and frequent inspection and by installing meters were necessary, also by providing penalties for parties guilty of waste.

Third, that a competent hydraulic engineer be employed to act in conjunction with our City Engineer to inspect the water systems in their entirety, both as to present pressure and supply; to report on the most economical and effective method of stopping

the underground leaks, which are suspected to exist, especially in the older parts of the present system and to report as to what our future requirements will be, both for domestic and fire purposes.

SIR, -The accompanying extract from the Minutes of Council asks for a report from the Committee on Works on the advisability of laying a concrete gutter on Green St. instead of a granite gutter, as reported upon at a meeting of Council held Oct. 16th, 1903.

I was obliged to report unfavorably at that date and have not changed my opinion.

The estimated cost of the work asked for using granite is \$1225.00. The estimated cost of laying a combined concrete curb and gutter is \$650.00. The two estimates were for laving a curb and gutter on the south side of Green Street only.

As to the advisability of substituting concrete for granite there is no doubt that the concrete can be laid so that it will stand the frost and it is also much cheaper. It will not stand wheel traffic and is therefor not suitable for level streets. If used at all it should be used on streets like Green St. which have a steep grade. We propose to experiment with a steel guard for the exposed corners which will no doubt increase the life of the concrete and if satisfactory will be used in any future work of this kind.

The question as to the advisability of performing this work at all should be determined by the Council as our street appropriation is limited and orders for permanent work are already on the book which will use about a quarter of the appropriation.

GENTLEMEN, —I have had long conversations and have gone over the accounts with the Auditor, the Treasurer and the Secretary of the Board of Health, and from the information received I find that there were special grants given for epidemic purposes for 1901-2 and 1902-3 and on an epidemic account for those years there was a balance of \$147 30 unexpended which has been appropriated to Unexpended Balances. In 1903-4 there were some Small-pox cases, amounting to \$1\*4.09. The Board not having any special grant for the purpose, in the meantime took it out of their ordinary grant of \$4000.00 which made them short that sum. I am of opinion that they are entitled to a special grant of 184.09 to replace the amount taken for Small-pox purposes from their ordinary grant; but as there is a balance of \$196.22 to the credit of the Board and \$56.33 good accounts collectable, making in all \$252.55, there would only be a balance of \$79.43 due the Board, to which I am of opinion they are entitled; and I would recommend that a resolution be passed providing that that sum should be appropriated to the Board towards paying the amount due them and paid out of their ordinary revenue and that said amount be put in the estimates for 1905-6.

#### YOUNG AVENUE SEWER.

### RECORDER'S OFFICE, CITY HALL, June 16th, 1904.

#### His Worship the Mayor and City Council:

GENTLEMEN,—In 1896 and Act was passed, when certain bouses were built on Young Avenue, directing the City Council to build a sewer in Young Avenue and authorizing it to borrow the sum of \$30,000 for that purpose. The City Treasurer sent a list of the loans required for that year, including the \$30,000 for Young Avenue sewer, to the Council; but the Council passed a resolution borrowing all the sums required excepting the \$30,000 for the Young Avenue sewer. That sewer was built out of the ordinary sewer revenue illegally and improperly. The work should not have been commenced until the amount had been borrowed according to the terms of the Act. The sewer has been built for a number of years and paid for in the way I have indicated, and in my opinion the City Council has no authority now to borrow the money to pay for the building of the sewer which has already been paid out of city funds.

In 1902 an Act was passed authorizing the passing into the Sinking Fund of moneys thereafter collected on sewer construction, less the amount of \$45,000. Said sum of \$45,000 was to be used for the purpose of paying outstanding liabilities against sewer construction account, including the cost of Young Avenue sewer and the outlet of the same and the salaries chargeable against sewer construction account. There has been already collected on general sewerage account, and placed to the credit of said account \$36,000.

### IN RE LIABILITY OF MASTERS FOR EXPENSES IN CONNECTION WITH SICKNESS OF SERVANTS.

#### RECORDER'S OFFICE, CITY HALL, June 16th, 1904.

#### His Worship the Mayor and City Council:

GENTLEMEN, —I am of opinion that a master, under ordinary circumstances, is not liable to pay the doctor's bills for attendance on a servant in his house unless he directly or impliedly by his conduct authorizes the same. If a master who has a servant with an epidemic disease removed from his house to the small-pox hospital agrees to pay the bill for removal and attendance, he is liable, or if his wife during his absence authorizes the servant's removal and agrees to pay the expenses, I think the husband is responsible unless he immediately repudiates his liability. In my judgment the Health Act should be amended so as to give the Board full power, whenever they think necessary, to remove any patient to the Small-pox Hospital and make the patient liable for any expenses connected with such removal or subsequent care.

### IN RE'R. H. EDWARDS' CLAIM.

#### To His Worship the Mayor and City Council :

GENTLEMEN, — Mr. R. H. Edwards maks a claim on the City for the loss of a horse which was killed on the Exhibition Grounds last month. The letter of his Solicitor gives no information as regards how the horse was killed. I have made enquiries and find that a wire was strung from Windsor St. to the main Exhibition Building during the time of the Exhibition, that subsequently it was cut and secured and became a dead wire having no connection at either end. It appears that this wire was either blown down or subsequently cut by some person and that the end being on the ground the keeper of the Exhibition Building coiled it around the insulator on the outside of the main Exhibition Building, bringing it in contact with a live wire which it is said caused the death of the horse.

The wire in the first instance was placed in the Exhibition Building without any authority or order from the City of Halifax and the City had nothing whatever to do with it, and though the subsequent act of the Caretaker may have caused the death of the horse, I am of opinion the City is not responsible for that act.

If it is desirable to lay down a route from the North West Arm I would recommend Chebucto Road, Oxford Street and Young Street to Kempt Road thence by the route named in the foregoing resolution.

At a meeting of the Council held on March 23rd, 1900 a resolution was passed asking the Halifax Electric Tramway Co., Ltd., to immediately take steps to make an

extension of their tram service along Quinpool Road to North West Arm bridge and along Chebucto Road from the Arm bridge to Windsor Street. If the conditions of the Charter have complied with the Company has ceased to have the exclusive right to these streets and it would only be necessary to take from them the exclusive right on Oxford St. from Chebucto Road to Young St. and on Young St. from Oxford St. to Kempt Road

SIR,—The accompanying deed having been referred to the Recorder and City Engineer, we beg to report as follows :—

The deed is from the Halifax Land Co, and conveys Livingstone St. as laid out in the Merklesfield property for acceptance by the City. It runs from Gottingen Street through to Longard Road. A large portion of it is swampy, and the ground is not graded. It would cost a good deal of money to bring it to a regular grade and to makeit safe for traffic. Under Sections 439 and 440 of the City Charter the City is bound to keep all streets accepted by it in repair, and in case of pecuniary damage to any person in consequence of neglect to keep the streets in repair the City would have to pay for it. The street appropriation is too small already to perform the work required to keep the streets owned by the City in repair, and it would be most unwise to take over a street in such a dangerous condition as Livingstone St. is. We therefore recommend that the acceptance of this street be postponed until the City can afford to grade it, or until the grading has been done in some other way.

The construction of a sewer in Pepperell Street has already been ordered by the Council and will be carried out as soon as funds are provided. The recommendation of the Board covers Preston St., between Pepperell St. and Quinpool Road, and a portion of Quinpool Road. The exact portion to be covered is not specified in the resolution. The Board recommends that this work be performed as soon as possible. It is useless to put more work on the sewer order book until funds are provided for carrying it out. "As soon as possible " would mean not until funds are provided. I agree with the Board that the construction of a sewer in Pepperell St. as already ordered by the Council is urgent, but the construction of a sewer in Preston Street between Pepperell St. and Quinpool Road is not so urgent, as the same conditions do not exist as on Pepperell Street. I would therefore recommend that the further consideration of this work be deferred until an additional appropriation for sewer construction is provided.

These estimates do not include the street railway track allowance which, under their charter, has to be paved at their expense at a cost of about \$2500.00. The request of the Association is one that should receive careful consideration, and if possible a favorable decision. This street is one of the oldest and most important business streets, and the Association are moving in the direction followed by all municipal improvement bodies, viz. : for cleaner streets and better wearing surfaces. We cannot have cleaner streets and freedom from dust without a more permanent wearing surface than the macadam. As the Council are aware, we have no special appropriation for street paving, but this work should come under the same heading as other permanent work, viz. : the construction of sidewalks and laying of granite curbs and gutters. The cost of this latter work is borne by street appropriation, and the paving of short lengths of street such as that covered in the petition could be borne quite as easily as the cost of curb, gutters and sidewalks. It is a question only of how much can be spared in one year. The proposition from the property owners, that is, to pay 75c. per foot frontage, is a valuable precedent, and if advantage can be taken of their offer it would probably be followed in future. I would strongly recommend that the work be done from street appropriation if the Council can see their way clear. If it cannot be done in whole or in part this year it might be put on the order book for the first work next season.

GENTLEMEN,—Your Committee on Laws and Privileges beg to report that at a meeting of the Committee held this day, there being present Aldermen Geldert, (Chairman), Johnson, Rogers and MacKenzie. The Committee met to consider claim of H. B. Clarke for damages sustained to costumes, etc., at the Old Exhibition Building.

Your Committee report that with reference to Mr Clarke's claim the information before the Committee led them to believe that the damage claimed for was done while the City workmen were engaged in effecting repairs to the building. The Committee have no means of estimating the damage, and refer Mr Clark's declaration and the accompanying letter to the Council with the recommendation that an Arbitrator be appointed to act on behalf of the City in estimating the damages.

### IN RE H. B. CLARKE'S CLAIM FOR DAMAGES.

### RECORDER'S OFFICE, CITY HALL, July 22nd, 1904.

#### Chairman Committee o Laws and Privileges :

SIR,-I understand the claim in this case is for damages to certain goods of Mr. Clarke caused by leakage of the roof of the Exhibition Building leased to him by the City. The liability for the damages caused by the leak depends entirely upon the terms of the There is no doubt that a tenant is liable to keep the building leased by him in lease tenantable repair unless there is a covenant in the lease relieving him of this responsibility In Mr Clarke's lease with the City there is the following clause : "and the said Harshaw B. Clarke hereby agrees to keep the internal part of the said building in repair including all "glass broken." If this clause ended here I would have no doubt that the City would have been liable to keep the place in repair as the implied covenant on the part of Mr. Clarke was rebutted by this particular covenant limiting his liability; but then the clause goes on to say "and he shall quit and deliver up possession of the same on the first day of May next in the like repair it is now in, reasonable "wear and tear excepted." That portion of the clause, in my oppinion, makes Mr. Clarke responsible for the repair of the building and he is bound to keep it in repair during the existence of the lease of and to deliver it in the like repair it was in at the time it was leased, and no further. Besides, if the City were liable to repair the building it would be the duty of Mr. Clarke to call upon the city to do so, in which case, after notice to the City, it would be responsible for any damage caused by its neglect to repair. I doubt very much if notice to the City Engineer would be notice to the City unless forwarded to the Board of Works or the Council.

Mr. Clarke claims that the agreement with the City was that it was to keep the external part of the building in repair while he was to keep the internal part and the glass in repair, and points out the fact that ever since the first time he leased it the City has kept the outside portion in repair. It would take clear and conclusive evidence to establish this against the City, but the fact of the City's keeping the outside of the building in repair since 1898 would be very strong evidence of his contention in case of a suit.

1 am of opinion on both grounds that the City is not liable to Mr. Clarke for the loss he has sustained.
