Read opinion of His Honor the Recorder re Robie St. sewer and John F. Kelly's claim.

IN RE JOHN F. KELLY'S CLAIM.

RECORDER'S OFFICE, CITY HALL, Sept. 2nd, 1904.

His Worship the Mayor and City Council:

GENTLEMEN,—Mr. Kelly claims that the City is bound by law to build, keep, control, and maintain a public sewer on Robie Street in a reasonable state of efficiency, and that the Council unlawfully neglected to build, keep, control and maintain a sewer on Robie Street in a reasonable state of repair and efficiency, and to properly construct the same, by which omission he sustained loss.

There are no facts in this notice of action which show any negligence on the part of the City and upon which I could advise. In the first place, the City is not bound to build any sewer.

The Engineer informs me that the Robie Street sewer at the time it was built wa⁹ well suited for the purpose for which it was intended, and was properly constructed, and that it is now in a good state of repair and efficiency. The Engineer informs me that at the time this Robie St. sewer was built, as also all the sewers of the City built at that time by Mr. Keating, the capacity of the sewer was measured by the then previous fifteen years rainfall. Since these sewers were built in this district there have been a larger number of houses draining into them as well as the surface water of the district. The Engineer states that the rainfall within the last seven or eight years has increased, and is very much heavier than it was during the previous fifteen years, and this fact, coupled with the number of drains from new houses draining into this sewer, has made the sewer insufficient to carry off the water during heavy rainfalls, at which time only any trouble occurs. This being the fact, I am of opinion that the City is not liable. It having built a proper sewer, and maintained it in good order and efficiency, it is not responsible for the subsequent drainage of houses into it, or for the increased rainfall.

IN RE ORDINANCE RELATING TO PUBLIC EXHIBITIONS.

HALIFAX, N. S., Aug. 25th, 1904.

To His Worship the Mayor and City Council:

GENTLEMEN,—When this matter was referred to the Committee on Laws and Privileges, who referred it to me to draw an ordinance, I stated to the Committee, and I think I subsequently informed the Council, that any ordinance drawn under the present law would be a comparative nullity, and that the law would be altered in the new Charter and ordinances made thereunder to meet the wishes of the Council, and that is the reason why this ordinance has not been submitted before.

I now enclose an ordinance, as the Council seems to be anxious to have it at once, but I may say for the information of the Council that it must of necessity remain a nullity inasmuch as after it goes into operation, every time a gentlemen wants to deliver a public lecture, or an exhibition is held, or a concert or any musical exhibition is given, the Council will have to be called together for the purpose of granting or refusing the request. In the meantime the parties applying will either have to abandon their request or hold the performance without the necessary license.

A BY-LAW OR ORDINANCE TO REGULATE PUBLIC LECTURES, THEATRICAL AND MUSI-CAL EXHIBITIONS, PUBLIC SHOWS AND ALL EXHIBITIONS TO WHICH ADMISSION IS OBTAINED BY PAYMENT OF MONEY AND FOR THE PRESERVATION OF DECORUM THEREAT.

Be it enacted and ordained as follows :

1. No owner, agent, manager or proprietor of any theatrical or musical exhibition, or public show, or of any exhibition of whatever name or nature to which admission is obtained on payment of money shall hereafter hold, or permit the same to be held, in the City of Halifax, without having first obtained a license therefor, and paying the license fee hereinafter mentioned.

2. The application for such license shall be made to the City Council, and shall state :--

(1) The name, occupation, and address of the applicant;

(2) The nature of the license applied for ;

(3) The place where the same is to be exercised, or where carried on ;

(4) The period for which the license is required;

(5) The nature and description of the theatrical or musical exhibition, or public show, and the nature of all other exhibitions of whatever kind or description for which a license is applied for.

PUBLIC LECTURES.

3. The owner, agent, or manager of any building in the City of Halifax shall not permit or allow any public lecture to be delivered in any building in the City of Halifax of which he is the owner, agent or manager, until he shall first have obtained a license therefor from the City Council, and paid the license fee therefor hereinafter mentioned.

FEES.

4. Every person applying for a license fee under this by-law or ordinance shall at the time of his application pay to the City Collector of Rates and Taxes the following license fee, viz. :--

6. For a license fee to exhibit wax works, menageries, circus-riding, rope-walking, dancing, tumbling, or other aerobatic or gymnastic performance, wild animals or hipprodrome, sparring, boxing, sleight of hand, legerdemain, jugglery, or other like tricks, pictures, painting, statuary, works of art, natural or artificial curiosties, tableaux, wonderful animals or freaks of nature, or any other exhibition kept for hire or profit when the same is exhibited elsewhere than in a theatre, music or concert hall, or other building or place duly licensed, for each day of such exhibition, a fee of \$20

11. Each license shall be signed by the Mayor, and shall specify the object and the length of time for which it has been issued.

12. No drunken or disorderly person shall be allowed to enter any building where any exhibition, public show, or public lecture, is being exhibited or delivered.

13. It shall be the duty of every person obtaining a license under this by-law or ordinance to keep good order in and about his theatre, music or concert hall, exhibition, show or public lecture, or any place of public amusement, for which a license is required by this by-law or ordinance at his own expense, and shall keep a sufficient force of servants for that purpose.

14. Any person present at any exhibition, public show, lecture, or any show or exhibition for which a license is required, who uses insulting: offensive or abusive language, or in any way disturbs the peace and quiet of the persons present thereat, may be removed from said building, and any person so offending shall be liable to a penalty not exceeding thirty dollars, and in default of immediate payment he shall be imprisoned in the city prison for a period not exceeding thirty days.

15. Any policeman shall have the right at any time during any exhibition or public lecture, to enter any building in which the same is held, and assist in keeping order or enforcing this by-law or ordinance.

16. Any person violating any of the provisions of this by-law or ordinance, shall be liable to a penalty of thirty dollars, and in default of payment to imprisonment in the city prison for a period not exceeding thirty days.

17. Nothing in the next preceding section shall be taken or construed to relieve any person from the payment of the license fee required by this bye-law or ordinance.

GENTLEMEN,--Your Committee on Laws and Privileges beg to report that at a meeting of the Committee held this day, there being present Aldermen Geldert (Chairman), Gastonguay, Doyle, Johnson and MacKenzie, they had under consideration a number of matters, as follows :--

1st. Application of George Harris for refund of money deposited by him for liquor license;

2nd. Letter Ratepayers' Association re information on assessment ;

3rd. Report Committee on Works and City Engineer on claims of Chris. Connolly and Fiederick Parsons for damages to their carriages through cave-in on Barrington Street;

4th. Report of His Fonor the Recorder covering judgment of Mr. Justice Graham in re Halifax Electric Tramway Company's assessment;

Sir,—In 1877 the late Chas. M. Black and wife conveyed to the City the street known as Lorne Terrace, running north from North Street about 351 feet, and the remaining portion of the street was opened by the executors of the late William Black, and has been opened to the public for about fourteen years. Lots have been sold to various persons on either side of this latter portion of the street, and houses built thereon, and the deeds of these lots have been bounded on this street. This street has been ever since used by the public, and the City has kept the same in repair. This, in my opinion, is a complete dedication of the street to the City, and the public h s the right to use the same. In other words, the conveyance of the lots according to the plan implied a grant or covenant to the parchasers that the streets and other public places indicated on such plan shall be forever open to the use of the public free from all claim or interference of the former owner inconsistent with such use, and the use of it by the citizens, and the repairing of it by the City is a complete dedication

Under these eircumstances. I cannot advise any amount being paid Mr. Black for this piece of street so dedicated to the public; but would recommend that the Council pass a resolution approving of the dedication and accepting the street on behalf of the public, as required by law. In this way the City would thereafter be bound to keep the street in repair.

I return herewith Mr. Black's deed.

GENTLEMEN, -- Your Committee on Laws and Privileges beg to report that at a meeting of the Committee held this day, there being present Aldermen Rogers (Acting Chairman), Gastonguay, Doyle and MacKenzie, with His Honor the Recorder and City Engineer, they had under consideration the accompanying draft of an agreement prepared by His Honor the Recorder between the Granville Street Merchants' Association and owners of real estate and the City of Halifax in re paving of the two blocks between George and Buckingham Streets

Your Committee have gone carefully over this agreement, and recommend its adoption by the Council

Your Committee also recommend that application be made to the Legislature that Section 8 of Chapter 51 of the Acts of 19.0, be amended by substituting a license fee of \$200.00 instead of \$50.00, and that a clause be inserted in the Act stipulating that any patent or other medicine offered for sale as expressed in Section 7 of said Act be first submitted to the City Medical Officer for his inspection to see that no injurious or deleterious substances are contained therein, expenses of said inspection to be borne by the City.

THIS AGREEMENT, made this day of , in the year of our Lord one thousand nine hundred and four, between the parties signing this agreement, and called the parties hereto of the first part, and the City of Halifax, a Municipal Incorporation incorporated under the laws of Nova Scotia of the other part :

Whereas, The parties hereto of the first part, doing business, or being the owners of the real property on either side of that portion of Granville Street hereinafter mentioned, have petitioned the City Council of the City of Halifax to pave with such materials as the City Council shall determine, that portion of Granville Street between George and Buckinghan Streets, in the City of Halifax, and which is two feet outside of the Halifax Electric Tramway Companys (Limited) tracks on said street, and that the parties hereto of the first part doing business, or being the owners of the real property on either side of that portion of Granville Street above described, have proposed and agreed with the said City that if it, the said City, would pave, or cause to be paved, or contract with any person, company, or corporation, to pave that portion of seventyfive cents (75c.), for each running foot of the property owned or occupied by them fronting on either side of that portion of Granville Street above described, which said City has in consequence of such offer and agreement agreed to do, or cause to be done, or contract with some person, company, or corporation to do

And whereas. The said City has by resolution of its Council agreed to enter into a contract with the Warren Bituminous Paving Company for paving that portion of Granville Street aforesaid with Bitulithic, and to require from said Company a guarantee that said pavement will be kept and maintained by said Company in good condition for the space of ten years from the completion of said pavement.

Now this Agreement witnesseth, That each of the said parties hereto of the first part, their and either of their executors, administrators or assigns, agree to pay on the completion of said work by the City the sum, and at the rate of seventy-five cents (75c) for each running foot of the property owned or occupied by him on either side of that portion of said Granville Street above described. and that the City Engineer's certificate filed in his office that that portion of Granville Street above described has been paved with the material approved of by the City Council, and that said pavement and work were properly and carefully done, shall be conclusive evidence of the facts therein contained, and binding on the parties hereto.

And it is further agreed, by the parties hereto, that the said City, or any of its officers or employees, shall in no way be liable for any loss, damages, costs or expenses sustained, or to be sustained, by either of said parties of the first part, their or either of their executors, administrators or assigns, by reason of the doing of said work, or the depositing any materials for doing said work on said street. or the closing of said street of the public, or any part thereof from time to time, or from any cause connected with or relating to said work.

And the City of Halifax, in consideration of the parties of the first part agreeing to pay the said sum of seventy-five cents (75c.) as aforesaid, hereby undertakes and agrees to, and with the said parties of the first part, to pave, or cause to be paved, or contract with some person, company. or corporation, to pave that portion of Granville Street, between George and Buckingham Streets, and which is two feet outside of the rails of the Halifax Electric Tramway Company's (Ltd.) track and sidings.

It is further agreed by and between the parties hereto that the said parties of the first part, jointly and severally promise and agree to pay the City of Halifax the whole cost of paying that portion of Granville Street aforesaid and described at the rate of seventy-five cents (75c.) per running foot on each side of said street, notwithstanding all the owners or occupiers of real property on both sides of the street have not signed these presents.

The increased cost of groceries, exclusive of flour (as per contract awarded) from now until April 30th, 1904, as compared with the corresponding month last year, will be about eighty-four (\$84.00) dollars.

PAVING STREET RAILWAY

His Worship the Mayor :

CITY ENGINEER'S OFFICE, Nov. 8th, 1904.

SIR,—In accordance with the accompanying extract from Minutes of Council I beg to report on paving material for the street railway tracks. The resolution asks for a recommendation for material for paving between all the tracks of the Halifax Electric Tramway Company. In deciding this question we must consider the whole area included in the track allowance, that is not only the space between the rails but the two feet outside the rails on each side as well.

The City requires a pavement that will be durable, smooth, noiseless and sanitary The Tramway Co. whose interests must be subordinate to those of the City, but should not be entirely ignored, require a pavement that can be taken up and relaid without destroying it.

Experience in older cities has demonstrated that no bituminous or sheet pavement in use is suitable for paving along the rails of street railway tracks. It has become the universal custom to use paving blocks along the rail no matter what material is used on the rest of the street.

The materials available are wood, brick or similar artificial blocks and stone.

Wood used in Halifax will not stand the traffic; it is insanitary, absorbing filth, and is more easily affected by frost than any other pavement.

Bricks and artificial blocks such as the "Metropolitan" block, asphalt block and scoria block are used in some cities and if we were deciding on a pavement for the whole width of the street the adoption of one of these might perhaps receive more favoreble consideration. Practice in the large cities is tending towards stone pavement for the track allowance even where the rest of the roadway is asphalt. Instead of adopting one material for one street or district and something else for another, I would recommend that granite blocks be laid on the track allowance whenever and wherever the Council decide to have the tracks paved, no matter what material may be decided upon for the rest of the roadway. The first cost of granite is very little more than the quotations for artificial blocks. They are durable and sanitary and are used in Yonge St. and King St., the principal business streets of Toronto, St. Catherine and other important business streets in Montreal and on the principal business streets of all the large cities in the Northern States. They are made in Halifax, so that the whole expenditore would be among our own workmen.

I would recommend that they be laid on broken stone and gravel as it would not be wise to alter the grades until the City is prepared to pave the rest of the roadway. When the City paves the remaining portion of any street the tracks should be brought to paving grade and the same foundation laid on the track allowance as that adopted for the rest of the roadway.

WATER SYSTEM INVESTIGATION.

BOSTON, October 28th, 1904.

To the Honorable City Council : Halifax, Nova Scotia.

GENTALMEN.—In response to a letter received from Mr. Monaghan, City Clerk, we have visited Halifax and beg to make the following statement in regard to an investigation and report upon the water system of your City.

In the first place let me briefly preface my understanding of the conditions : Halifax is supplied by a high and low service There is no question as to the capacity of the low service supply, but the distribution system is such that in case of fire the pipe system has to be manipulated by the closing of valves so that the necessary pressure can be obtained at the desired point. In the high service there is a district where the pressure is not sufficient for satisfactory domestic use; and there are other districts demanding water which cannot be supplied under the present conditions. The primary cause of the pesent intention to investigate the water system is, as we understand the matter, the dissatisfaction in the high service.

In neither the low nor the high service systems is the fire protection up to modern standards, and insurance rates are accordingly high.

From the very casual examination of the works which we were able to make, it would appear that the investigation might profitably in the first place be limited to a detailed study of the present system—examining it for capacity under present and possible development, and for pressure under the present pipe system and with such modifications as could econimically be carried out. Such an investigation would necessitate accurate studies of the quantity used, with a view to the possibility of reducing the present extravagant waste of water, gaugings of the loss of pressure in the mains and at different points of the distributing system both under conditions of normal draft and with different numbers of hose streams—these studies of pressure to be made with a view to the determination of where the greater part of the loss of pressure by friction is located, and of the best means of improving the distribution system.

From such information and from the reports which have at various times been made by your City Engineer and other engineers, it will be possible to accurately determine the conditions of the present system and to suggest any economical improvement by the laying of additional pipes, the provision of storage near the point of consumption, or the reduction of the use of water by the installation of a system of meters.

All this should, in our opinion, be preliminary to any detailed study by surveys of a new source. If it should prove impossible to properly develop the present system, then the investigation of another source might be taken up.

Along the above lines we will examine your water system, collecting all the data either personally or by an assistant, and will report the result of our findings to you, analyzing present conditions and recommending such improvements as may appear necessary, with plans and estimates of cost of these improvements, and will make a preliminary study of new sources, with approximate estimates sufficiently accurate to compare with the cost

of improving the present system, for the sum of >25.00 per day for personal services and \$10.00 per day for assistant, plus expenses—the cost to the City to be whatever the time necessary for an adequate study of the problem shall at these rates amount to; but we will agree that in no case shall the total cost of our work exceed the sum of \$2000-it being understood that all information and plans in the possession of the City shall be available for use during the investigation, and that all such work as excavating, tapping of pipes, construction of weirs, etc., shall be done by the City Department.

We believe that by a proper study of the present conditions and a clear, concise report, the water problem of Halifax can be rounded up in such a way as to make an investigation a profitable investment for your City.

Sir,—I beg to report on the accompanying unsigned letter referred by the Council for report, which purports to be a claim for damages by Mr. Edward Ward for alleged flooding from the sewer in front of his premises.

With the Foreman of Streets and Sewers I visited the house and examined the cellar and premises accompanied by Mrs. Ward. The house is situated at the corner of Charles Street and Clifton Streets, fronting on Charles Street. The bottom of the cellar is about 5 feet above the sewer. The drain goes out of the front of the house to the sewer in Charles Street. Mrs. Ward informed me that the water during heavy rains runs in at the back of the house in a stream that can be easily located It is evident. therefore, that it does not come from the house drain or along the house drain. The evidence is all against the probability of its coming from the sewer, and in my opinion it does not come from the sewer at all. There are three rain water leaders on the house—one on the north-west corner, one at the middle of the east side and one at the middle of the back of the house, all three emptying at the foundation of the The ground is low around the house, and I have no doubt that the surface house water when the ground becomes saturated runs in through the filling around the foundation into the cellar and soaks away again gradually after the storm is over. I instructed the Foreman of Streets to put some material on the side walkto raise it so that there will be no probability of the surface water from the street running in against the foundation. If it continues to run in after this is done there is not much doubt that it comes from the rain water leaders on the house which should be connected to the house drain.

SIR,-In accordance with the accompanying resolution of Council, I beg to report on the cost of a new sidewalk for the east side of Argyle Street, from Buckingham to Jacob Street.

The brick sidewalk immediately north of Buckinghan St. and the flag sidewalk immediately south of Jacob St., are in fair condition and would wear for some time longer. It will therefore not be advisable to do these portions at present. The rest of the sidewalk mentioned is in a bad state and is complained of particularly in wet weather. For an important business street like the one under consideration I would recommend a cement concrete silewalk. The estimated cost of construction is \$705.50. The work cannot be done this year, but if the Council approve it might be passed to be done next year. If it meets with the approval of the Council, I would recommend that the sidewalk be laid next year and that the renewal of the brick sidewalk at the corner of Bell Street be cancelled and temporary repairs made until the new sidewalk is laid.

REPORT BOARD OF FIRE ESCAPES.

COMMITTEE ROOM, CITY HALL, January 12th, 1904.

To His Worship the Mayor and City Council:

GENTLEMEN,—The Committee on Fire Escapes met this day. Present: Aldermen Barry (Chairman), Halliday and Lamphier, together with City Engineer Doane, Chief Broderick and Chief Engineer Condon, of Fire Department.

We proceeded on our inspestion and first visited the-

HALIFAX INFIRMARY

and were shown through the building by the Sister in charge.

Your Committee recommend that iron shutters be put on four windows on back of main building, a platform and fire escape be erected on south side of building, and a few other minor matters be attended to, which the Sister has promised to do.

We next visited the-

ACADEMY OF MUSIC

and were shown through the building by Manager Medcalfe. We pointed out a number of improvements which the Manager promised to have attended to at once. Amongst the improvements required will be an asbestos curtain and an iron railing from top gallery, a fire escape from the janitor's quarters, a door on south side of lower balcony and metal sheathing on back of stage, a fire escape on top gallery, south side, as there is only one exit from top gallery. The doors have been altered to open out.

Your Committee would recommend that the metal sheathing be taken off the centre window on top gallery on front of building.

HALIFAX HOTEL.

We were shown through this building by Proprietor Hesslein. Your Committee found everything satisfactory as regards fire escapes. The stairs and halls are wide and roomy, and there would be no danger whatever in case of fire. We recommend that notices be printed in large black letters, and put up on every landing pointing where the fire escapes are located, and that a red light be kept burning all night on every landing leading to the escapes and exits.

QUEEN HOTEL.

We were shown through this building by Proprietor Fairbanks. Your Committee found that Mr. Fairbanks has taken every precaution against fire. He has fire escapes on every landing, also life lines that can be removed to any window in a moment. He also has large printed cards on every landing pointing out where the fire escapes are located, and a fire alarm system connected with every room. Your Committee are well pleased with the precautions Mr. Fairbanks has taken as regards fire escapes,

We recommend that a red light be kept burning on every landing all night leading to fire escapes, and that a hand rail be put on fire escape on front of building.

We next visited the large tenement house directly opposite the hotel owned by the Collins estate. We are informed that when this house is fully occupied there are about three hundred people in it Your Committee pronounce this a very dangerous building. There is no fire escape for people living in the north ell of building.

Your Committee would recommend that two fire escapes be put up immediately, one on the north ell to roof of building adjoining, and one on the south side of this ell leading to yard.

JANUARY 19TH, 1904.

METROPOLE BUILDING.

There are fire escapes on four floors, but none whatever on fifth and sixth floors.

Your Committee would recommend that a fire escape be put on top landing to adjoining roof There is a length of hose on every landing, but it has not been in use for a number of years. Your Committee recommend that the hose be examined every month, and that two doors on first landing be changed to open out.

We were shown through

W. & C. SILVER'S BUILDING

by Mr. Silver.

Your Committee recommend that a fire escape be put on iront of building, No. 7 George Street, to third floor, and that a few minor matters be attended to, which Mr. Silver will have carried out. We found the main stairway wide and roomy, and no danger whatever in case of fire.

CLAYTON & SONS'

is the most perfect building we have visited. Mr. Clayton has taken every precaution against fire. The doors all open outward, and are 8 ft. wide, and there is no danger whatever in case of fire.

We recommend that a metal ceiling be placed in furnace room in basement.

HOME OF THE GUARDIAN ANGEL.

The halls and stairs in this building are wide and roomy, and it would be very easy to escape in case of fire

We recommend that the wooden fire escape now on back and north end of building be replaced by iron.

ROMAN CATHOLIC ORPHANAGE.

This building is well laid out as regards fire protection. The halls and stairs are wide and roomy.

We recommend that all external doors be changed to open outward, and that bolts be put on all such doors instead of locks, also that a fire escape be placed from top floor of main building to each ell in rear.

HOME OF THE GOOD SHEPHERD.

There is no fire escape whatever on any part of this building. There are ninety girls sleeping on the fourth story.

We recommend that two fire escapes be put on building—one on front and one on back of building immediately leading from dormitories.

ST. GEORGE'S CHURCH.

Your Committee do not think there would be any danger from fire in this building as there are plenty of exits, but we would recommend that the two top galleries be closed as it would be impossible for people to get out of them in case of fire.

We next visited the

KING EDWARD HOTEL.

Mr. Wilson took great pains to comply with the wishes of Committee, and has had fire escapes placed on north and west sides of building. The halls and stairways in this hotel are very roomy, and all appointments of hotel are up-to-date in regard to exit in case of fire and safety of guests.

We were shown through the

KEITH BUILDING

JANUARY 26th, 1904.

by Mr. Donald Keith. Your Committee recommend that an iron ladder be erected on north end of building to roof of building adjoining. The halls and stairways are wide and roomy, and, in the opinion of your Committee, there are plenty of exits in case of fire.

THE GLENDALE HOTEL

is an old wooden building. Your Committee recommend that a fire escape be placed on south side of building from top story to ground.

BANK OF MONTREAL.

Your Committee were shown through this building by Architect Johnson. The building is well protected from fire. We would recommend that a platform fire escape be put on back of building from Janitor's quarters.

ALBION HOTEL.

Your Committee recommend that red lights be kept burning at night in all halls leading to exits and fire escapes.

We were shown through

ST PAUL'S PARISH HALL

by the Janitor. The halls and stairs are roomy. Your Committee would recommend that a fire escape be put on back of building leading from Janitor's quarters to yard in rear There are plenty of exits from main hall. Your Committee also recommend that the ceiling in furnace room be sheathed with metal sheathing.

ROYAL HOTEL.

Your Committee were shown through this building by the Proprietor. We recommend that the fire escape that is now on the building be put in order, and that notices be printed and put on each landing pointing to fire escapes, and that a red light be kept burning all night on each landing, also that the electric wires be inspected by the City Electrician.

We were shown through the

DEAF AND DUMB INSTITUTION

by Mr. Fearon, and pointed out to him several improvements, amongst which were two fire escapes, one on north end and one on south end of building, with platform on top. The halls and stairs are wide and roomy.

We next visited the

CONVENT OF THE SACRED HEART

and were shown through the building by the Mother Superioress. Your Committee inspected every part of the building and found that there are about twenty-seven exits and no danger whatever from fire. We recommend that the ceiling in furnace room be covered with metal sheathing

THE SCHOOL FOR THE BLIND

is one of the most perfect buildings in Halifax as regards exits and fire escapes. Your Committee are unanimous in opinion as to the perfect condition of the building. The corridors and stairways are wide and roomy. The ceilings of furnace rooms are about to be covered with asbestos to make it more fire proof.

In the

POOR'S ASYLUM

we found everything perfect as regards fire protection. The Superintendent has several lengths of hose on every landing, in case of fire. The corridors and stairs are wide and roomy. Your Committee would recommend that two fire escapes be put on front of a building—one on men's ward and one on women's ward—leading from balcony.

We next visited

ST. PAUL'S HOME FOR GIRLS

on Tower Road. While there are plenty of exits from building, your Committee would strongly recommend that a man be appointed to take charge of furnace instead of girls, as they do not understand the furnace, and that the furnace room be sheathed with metal sheathing; also that a hand rail be placed on top of porch on front of building.

In the

· INFANTS' HOME, TOWER ROAD,

we found everything perfect as regards fire exits and escapes. The corridors and stairs are wide and roomy. Your Committee would recommend that asbestos be put on the ceiling of furnace room. Your Committee would also recommend that a man, instead of a woman, be appointed to look after the furnace.

HALIFAX INDUSTRIAL SCHOOL.

Your Committee recommend that life line hooks be placed on all windows in the main domitories, also that a hydrant be attached to four inch service pipe in rear of main building. Your Committee are pleased to report that a fire escape is being placed on back of main building.

ST. PATRICK'S HOME.

The means of escape from this building are very satisfactory, and on account of construction of building your Committee do not consider it necessary to recommend any changes except that the ceiling of furnace room be lined with metal sheathing and that two or three hand grenades be places in the dormitories.

AUG"ST 23, 1904.

Your Committee inspected

MOIR'S BUILDING

We were shown through the entire factory by Mr. Ben. Moir. They have about 60 feet of ho e connected with a four inch pipe on every landing, and concrete and asbestos on furnace room. They also have about a dozen buckets filled with water on every landing for fire purposes only.

We recommend that two iron fire escapes be put up immediately on two top flats of new building just finished. Your Committee are of opinion that there are sufficient exists on every part of these large buildings in case of fire.

We next visited

TAYLOR'S SHOE FACTORY.

We were shewn through the building by Mr. Taylor. There are exits on every landing and no danger whatever in case of fire.

We would recommend that the elevator shaft be lined with tin and that hand granades be kept on every landing.

THE HOME FOR THE AGED

is a wooden building very well constructed for the purpose, but the means of escape in case of a conflagration are very bad, and taking into consideration the age and infirmity of the inmates, unless something in immediately done it may lead to a serious calamity.

Your Committee recommend that the windows in the corridors be cut down to the floor and doors substituted for the windows and platform landings constructed of iron, that stairways leading to the ground be connected with each corridor, and that the ceiling of the furnace room be sheathed with metal sheathing.

Your Committee cannot close this report without returning their sincere thanks to City Engineer Doane, Chief Broderick, Chief Engineer Condon and Assistant City Clerk Rhind for the valuable assistance they have given your Committee all through their inspection.
