## CITY HALL, Dec. 5th, 1904.

An informal meeting of the City Council was held this afternoon at the above hour in the Committee Room, City Hall. Present: His Worship the Mayor and Aldermen Archibald, Geldert, Halliday, Campbell, Johnson, Barry, Taylor, Gastonguay, Hubley, Doyle, Lamphier, Cawsey, Martin, Hayward and MacKenzie.

The Council met persuant of the following notice served on the Aldermen.

SIR,—His Worship the Mayor desires to have an informal meeting of the City Council at his office, City Hall, on Monday afternoon at three o'clock, for the purpose of considering a very important matter.

His Worship the Mayor stated that on November 30th he had nominated Aldermen Geldert and Doyle to act with himself and the Recorder and City Clerk, as a committee to prepare an address to be presented to Earl Grey, recently appointed Governor-General of Canada, who is to be sworn into office at Halifax at an early date.

The Committee had met on several occasions, and were in session on Saturday morning when he (His Worship) received the following programme from Government House:

## INSTALLATION OF THE RIGHT HONORABLE EARL GREY AS GOVERNOR-GENERAL.

1. The Members of the Dominion Cabinet will be seated at the table, the Premier on the right, the next in seniority on the left, and so on down the table.

2. The Clerk of the Privy Council to be seated at the foot of the table.

3. Lady Grey and suite will be seated on the right of the throne.

4. The Lieutenant-Governor and Mrs. Jones, Sir C. and Lady Parsons, on the left.

## DECEMBER 5TH, 1904

5. The Judge of Supreme Court will be seated behind the Cabinet Ministers to the right of the throne.

6. At the appointed hour the Clerk of the Legislative Council announces the arrival of Earl Grey, Lady Grey and suite, to the Clerk of the Privy Council, who intimates the same to the Premier, who leaves the Chamber and conducts Lady Grey to the seat prepared for her, resuming his place at the head of the table.

7. The procession, consisting of the Lieutenant-Governor and staff, Sir C. Parsons and staff, Earl Grey and suite, enters the Chamber, Lord Grev taking his place at the right of the throne, his military secretary takes a corresponding position at the left front and proceeds to read the King's Commission. The Commission is then handed to the Clerk of the Privy Council, who then lays the Commission, oath book and other documents on the table. The Clerk of the Privy Council hands the Bible to the Judge, who hands it to Lord Grey and administers the oaths. Lord Grey will then sign the proclamation and other documents.

8. The Governor-General then takes his place on the dais.

9. An address from the Government of Nova Scotia and the City of Halifax will be presented.

10. The Clerk of the Privy Council will then bow to the Secretary of State, who advances and hands the Great Seal to the Governor-General who returns it saying: "I hand you the Great Seal of Canada for safe keeping." After this he will sign the proclamation, which the Clerk will sign with his (Lord Grey's) privy seal.

11. The Governor-General will then present the Insignia of the I. S. O. to Mr. Wallace.

His Worship said he had asked the members of the Council to come here to-day in order that he could point out to them that in this programme the Mayor and Aldermen of Halifax were wholly ignored, no provision whatever appearing therein for accommodating them.

The Committee having thought with him that some expression of resentment should be made deferred any further action in regard to the address until the present informal meeting. These facts must have come to the knowledge of those who prepared the programme, because after the Committee had adjourned he had received the following printed programme. He desired to call attention to the fact that this printed programme which had been printed in the newspapers in its original form was now amended in handwriting on the margin as appears below:

#### (Printed Programme).

### OFFICIAL PROGRAMME

FOR THE RECEPTION OF THE NEW GOVERNOR-GENERAL IN THIS CITY.

### Reception of the Right Honorable Earl Grey at Halifax, 10th December, 1904.

(Manuscript Amendment). 1. Earl Grey will be received on board "S. S. Parisian" by the acting Prime Minister and other Ministers, and conducted by them on "S. S. Alfreda" to the Gun Wharf.

Provincial 2. Upon the arrival of Earl Grey at the steps he will be received by Secretary and His Worship the Mayor. Irving, D. O. C., and Staff.

3. A Guard of Honor and Band will be furnished, and will receive His Lordship with the usual salute.

4. His Lordship and suite will then be conducted to carriages provided, and will proceed by Granville. George and Hollis Streets to the Provincial Building, in the courtyard of which a Guard of Honor will be posted, which will receive him with the usual salute

5. The installation will then take place in the Legislative Council Chamber.

6. Upon the installation of Earl Grey as Governor-General a salute of 21 guns will be fired from the Citadel. Addresses will then be presented to His Excellency from the Government of the Province of Nova Scotia and from the Corporation of the City of Halifax. His Excellency will then present the Insignia of the Imperial Service Order to Mr. J. R. Wallace.

7. Upon leaving the Provincial Building His Excellency the Governor-Genéral will be received by a Guard of Honor with a royal salute.

8. His Excellency will then proceed by George, Barrington and Pleasant Streets to Government House.

9. His Honor the Lieutenant-Governor will leave the Provincial Building before His Excellency and receive him on arrival at Government House, where a Guard of Honor will be posted.

#### SATURDAY EVENING.

1. His Honor the Lieutenant-Governor will give a state dinner in honor of their Excellencies at 7.30. Full dress will be worn.

2. Their Excellencies will hold a Drawing Room in the Legislative Council Chamber at 9.30.

3. A Guard of Honor will be posted in the Court Yard.

4. Cards for the Private Entree will be issued. Those holding these cards will assemble in the Legislative Library and enter the Chamber by the east door, and may remain in the Chamber during the presentations at a place to be indicated by the A. D. C.

5. The remainder will assemble in the Legislative Assembly Chamber and proceed through the Library and enter the Chamber by the east door, pass the throne, which will be on the south side, and pass out by the west door.

6. Ladiès are expected to be in full dress, and gentlemen in levee or evening dress, and they are requested to provide themselves with two cards on which their names should be legibly written, one to be left at the door of the Council Chamber, and the other to be given to the A. D. C. in waiting.

7. For ladies, veils and feathers are optional, but court trains are not expected.

#### SUNDAY, 11TH DECEMBER.

1. Their Excellencies will attend Devine Service at St. Luke's Cathedral at 11 a. m.

2. Major-General Sir Charles and Lady Parsons will give a dinner in their honor at Bellevue at 8 o'clock.

action of the Address Committee becoming known, he had received a further amendment to the programme in the following form.

He will be received at the Gun Wharf by Major-General Sir C. Parsons, the Lieutenant-Governor, Honorable the Provincial Secretary and the Executive Council, His Worship the Mayor and City Council and Brigadier General Lake. Cards for the Gun Wharf will be issued to yourself and friends, the Aldermen and City Officials and their friends, if they will kindly let the Deputy Adjutant General at Head Quarters, Barrington Street, know how many they would wish. Twenty minutes will be allowed from the time Earl Grey leaves the Gun Wharf until he enters the Council Chamber, when all are expected to be in their places. Tickets for the Council Chamber have been sent to Your Worship and the City Council, the addresses will be presented immediately after the swearing in. His Honor would be pleased if you would kindly bring this to the notice of the members of the City Council.

SIR,—I am directed by His Worship the Mayor to inform you that he has received certain communications from the Clerk of the Privy Council and the Hon. Minister of Finance relating to the Reception to the Right Honorable Earl Grey which he deems advisable the Members of the City Council should have an opportunity of considering.

You are therefore requested to attend at the City Hall at five o'clock this afternoon, for the purpose indicated above.

There were present His Worship the Mayor and Aldermen Archibald, Geldert, Halliday, Campbell, Johnson, Barry, Taylor, Gastonguay, Hubley, Doyle, Lamphier, Cawsey, Martin and Hayward.

His Worship the Mayor stated that he had received a lengthy telegram from the Hon. Minister of Finance and a letter from Mr. John J. McGee, the latter of which placed a new light in the subject of the preparation of the official programme for the Reception and Installation of His Excellency the Governor General and he had called the Council together for the purpose of considering the whole matter of the part to be taken by the Corporation in view of the changed conditions. He trusted that the Council would find the position of the affair so changed that they could with all due respect to themselves participate heartily in welcoming Earl and Lady Grey upon their arrival and present them with an address from the Corporation of the City of Halifax.

Read telegram from Hon. W. S. Fielding, Minister of Finance to His Worship the Mayor urging that the decision of the Council not to participate in the Reception, be reconsidered.

#### Hies Worship the Mayor of Habfax, N. S.

I regret to learn through the public press that the City Council of Halifax is disposed to withdraw from its announced intention of presenting an address to Lord Grey on his arrival at Halifax to assume the duties of the Governor-Generalship of Canada. I have no knowledge whatever of the eircumstances which have brought about such a decision, and of course do not wish to offer any opinion concerning them, but I would like to represent that no difference that may have occurred between the City Council and anybody should be regarded as a good reason for failing to extend to Lord and Lady Grey the welcome due to their personal qualities, as well as to their official position. The announcement baving been made that the City authorities would extend a welcome, the new Governer-General will reasonably expect their co-operation, and their failure to earry out their plan could hardly fail to be a source of pain and embarrasment to him. Please allow me, without any reference whatever to the difference that has occurred, to suggest that the Council reconsider their action and pay that respect to Lord and Lady Grey which they had intended from the beginning.

That immediately after I started for Halifax and arrived here last night.

I desire that the Mayor and Corporation should have a prominent part in such reception, and I would suggest to you that you and your associates should be on the wharf to formally receive His Excellency on landing; and that after the swearing in at the Legislative Council Chamber you should present an address on behalf of the City.

I hope you and your Council will cheerfully respond to this request, especially as I have had charge of such official receptions for the past twenty-five years and am desirous that nothing shall be wanting in the important one now about to occur.

## The following resolution is submitted :---

Whereas, it was the intention of the Mayor and Corporation of the City of Halifax to have presented a loyal address to the Governor-General in the Council Chamber, in the Province Building, after he had been sworn into office, and to be present to welcome him at the time of his landing at the Gun Wharf.

And whereas, an alleged official programme for the reception of the Governor-General was published in the press of this City and sent to His Worship the Mayor, signed by Lieutenant-Colonel G. C Jones, M. S., and Secretary to His Honor the Lieutenant-Governor, in which the Mayor and Corporation were entirely ignored and no place assigned them either at his reception or installation, and the Council thereapon declined under the circumstances to be present on either occasion;

And whereas, John C. McGee, Esq., Clerk of the King's Privy Council of Canada, has assured His Worship the Mayor that the programme published and sent to the Mayor

was sent and published without any anthority, and Mr. McGee has sent an official letter to his Worship, which is now before the Council, informing him that it was only on Saturday, the 3rd inst., that an Order-in-Council was passed at Ottawa, appointing him to make suitable arrangements for the proper reception of His Excellency, and that he immediately after started for Halifar, and in which he desires the Mayor and Corporation to have a prominent and proper in such reception, and also suggesting that they should be present to receive His Excellency on landing, and that after the swearing in at the Legislative Council Chamber they should present their address on behalf of the citizens.

Therefore Resolved. That the Mayor and Corporation do heartily respond to the suggestion of Mr. McGee, and will attend at the landing of His Excellency to receive him, and will be present in the Council Chamber to present him with an address on behalf of the citizens of Halifax.

Further Resolved, That a copy of this resolution be at once sent Mr McGee for his information.

Moved by Alderman Johnson, seconded by Alderman Campbell, and passed unanimously.

Moved by Alderman Hayward and sec nded by Alderman Campbell, that the Mayor wear the Official Robes of Office and the Mayor's Chain on the occasion.

His Worship stated that he would not like to be bound in the matter by a resolution of Council, but that he would be pleased to acquesce in the wishes of the Council if possible.

Read letter from Lt.-Col. G. C. Jones, Lieutenant Governor's Private Secretary, in reply to the City Clerk's letter ordered at last meeting to be sent to His Honor the Lieutenant Governor.

## GOVERNMENT HOUSE, HALIFAX, N. S.

### HALIFAX, December 7th, 1904.

## The City Clerk, Halifax :

SIR,—I am directed by His Honor the Lieut nant Governor to acknowledge your letter of the 5th inst., in which you state that the City Council in view of the official programme for the reception of His Excellency the Governer General, in which the Mayor and Corporation were wholly ignored, it would be impossible for them to carry out their intention of presenting an address I am directed to say that His Honor very sincerely regrets this decision.

Before anything was done, His Honor invited the Honorable Mr. Murray, the Premier, and His Worship the Mayor to a conference at Government House, and invited their hearty co-operation in arranging the proceedings for the occasion, and received from each of them a cheerful and ready promise or willing support. When the first programme was published, by some accident, which His Honor very much regrets, and which is not easy to explain, the names of the Members of the Government of Nova Scotia and the Mayor and Corporation were accidently omitted, and His Honor would desire His Worship and the Council to believe that this was purely accidental and not in any way intended. His Honor, however, thinks that as you had the amended copy of the programme before the Council some time previous to their decision, that it should have been considered as the official programme to date, and in evidence of his intention to pay the Government of the City all proper respect, however, be this as it may, His Honor regrets very sincerely the conclusion at which they arrived, and particularly that they should publish to the people of Canada an act of such extreme discourtesy to His Excellency the Governor General on his first arrival in Canada Had the Council been willing merely to express their disapproval of the arrangements proposed and held the authorities here responsible little harm would have resulted, but to publicly announce that no token of respect would be paid to His Majesty's representative is a conclusion at which the whole people of Canada will naturally feel deeply concerned. It is in this sense more than any other that His Honor feels so much regret at this misunder-standing

His Honor is hopeful, however, that on further consideration the Council may amend the decision which you have been good enough to convey by your letter already referred to.

To His Excellency the Right Honourable Sir Albert Henry George Earl Grey, Viscount Howick, Baron Grey of Howick, in the Vounty of Northumberland, in the Peerage of the United Kingdom and a Baronet; Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, &c., &c., Governor-General of Canada

#### MAY IT PLEASE YOUR EXCELLENCY :

The Mayor and Corporation of the City of Halifax desire to avail themselves of this opportunity of extending to Your Excellency their sincere and heartfelt congratulations upon your appointment to the high office of Governor-General of Canada.

They cannot but regard the appointment of Your Excellency as one of a particularly happy character.

A distinguished member of your family took a prominent part in the attempt to retain for the Crown the ancient Colonies to the South of us established by British valor and British love of adventure. The attempt failed and the political connection between those Colonies and the Motherland was broken, but British law, British institutions and the characteristics of the British race remained and resulted in the upbuilding there of a country of vast extent and almost inconceivable resources.

The population of the Colonies to the North, and especially the population of this Province and City, was largely augmented at that time by the influx of many thousands of people whose strong attachment to the Crown led them to sacrifice all that they possessed in the Colonies which severed their connection with the Crown in order to establish for themselves new homes in the Colonies to the North. It is only natural in a country whose people have a strong admixture of such blood in their veins that the feeling of attachment to the British Crown and British institutions should be of the most profound character, and we look forward confidently to a time when the development of our country which is now proceeding so rapidly will equal, if it does not surpass, that of the great country to the South

In this same connection it is interesting to recall the fact that it was in the time of the third Earl Grey, then filling the position of Secretary of State for the Colonies, that the important measure of responsible government was carried, and the project of providing for the construction of a railway to establish a line of communication on British territory between the Provinces of Nova Scotia, New Brunswick and Canada was approved of by the Imperial Government. Both these measures were carried largely through the efforts and influence of the then Earl Grey.

It has been our good fortune in the past to welcome to our City our present Gracious.Sovereign and other members of his family, and we desire now to renew to you, as His Majesty's representative, the expression of our devotion to his Crown and person.

To your Excellency personally we desire to extend the warmest of welcomes. The great measure of success with which you have discharged the important functions entrusted to your care in other spheres, as well as your literary ability, of which we have some knowledge, leads us to believe that we can look forward to your administration of the government of Canada with great confidence, and we trust that when the period of your administration here shall have ended you will be able to look back upon your residence in this vast, prosperous and happy country as one of the most agreeable episodes of your life.

In the welcome we extend to Your Excellency, due to your personal qualities as well as to your official positions we desire to include Lady Grey and the other members of your family.

## SAFE KEEPING OF INSANE PERSONS.

Nov. 29th, 1904.

### His Worship the Mayor :

Halifax, N. S.

SIR,—You may possibly have noticed that a great deal of publicity has been given to the circumstances associated with the recent admission to this institution of two men from the City of Halifax. Both patients had been detained for some time at the Police Station. It nearly always happens that when a patient is committed to the Police Station before being admitted here, the newspapers contain a great deal of information which cannot but add to the distress of the friends. You can readily understand that when trouble of such a nature comes into a family, publicity is a feature which the friends are very anxious to avoid.

Now if you will refer to Section 14, Chapter 46, R. S. of N. S., 1900, you will see that a patient who is in transit to the Nova Sectia Hospital may be detained in a municipal asylum for such time as will allow arrangenents to be made for his admission into the Nova Sectia Hospital I write to ask if you would not arrange that any city patient whose commital here might seem necessary could be received in one of the wards for the insane at the Poors' Asylum until the arrangements for commital here could be completed This would serve to avoid publicity, and it would also save the patient from treatment which should be only awarded to the criminal class. It is, to say the least, unfortunate that any person who has already become so unfortunate as to become insane should be treated as though he were a criminal, and sent to jail pending admission here.

### WATER SYSTEM INVESTIGATION.

ST. JOHN, N. B., Nov. 21st, 1904.

### To the Honourable City Council of the City of Hulifax :

GENTLEMEN,—In response to a letter dated November 12th, from your City Clerk, announcing our employment to investigate the water problem of Halifax, I left Boston on November 16th, with an assistant, intending to at once begin work in your City.

A telegram announcing that the Mayor had vetoed our employment, reached me at St. John. The reasons given by the Mayor, as published by the St. John papers, led me to visit Halifax with the hope that what appeared to be a misunderstanding, might be cleared up.

The first reason given by the Mayor was that I am a resident citizen of the United States. I was born in St. John and have never become a citizen of the United States. The headquarters of our business is in Boston, but my residence is governed by my work, and will during the coming year be largely in St. John.

As to the second reason given, I have nothing to ray, but the third is disposed of by my own case and that of numerous other (anadian Engineers who are working in the United States. It would seem to be rather a distorted interpretation of the home rule idea if a Canadian who has sought a larger field in which to gain experience, is to be debarred from doing work at home.

It would therefore appear that the reasons given by the Mayor do not apply to my case, and I trust that the explanation will lead your Honorable Board to reconsider the matter.

I would respectfully call your attention to the fact that the announcement of our employment in the public press, and then a week later a further announcement that the action of Council had been vetoed by the Mayor for reasons which are not pertinent, is a matter of considerable moment to me. The inference in other places will be that there must be reasons not made public, and the result will be a serious loss to us in our future work in this section of the country.

In view of the foregoing statements, I trust that your Board will bring the question of our employment up again as new business. It would afford me great pleasure to meet with you at such a time and answer any questions which you may desire to ask.

GENTLEMEN, —At a meeting of the Committee on Works held this day the attached report of the City Engineer on Minute of Council re Water Extension to proposed Immigrant Hospital at Rockhead under certain conditions was read and recommended to Council for adoption.

### His Worship the Mayor :

DEAR SIR,—I beg to report on the accompanying communication from Mr. W. W. Scott, Superintendent of Immigration.

Mr. Scott asks the City to extend the water to the proposed site of the Trachona Hospital, and offers to pay for the extension from the City Prison North, also to pay the City for the use of water and to give the City the privilege of tapping the pipe for service to the Smallpox and Infectious Disease Hospitals. He also asks the City deed a small portion of City Property. The Immigration Authorities propose to lay a 4-inch pipe from the City Prison North. This pipe will be too small to be of much use to the City in future. It should not be less than 6-inches as there is residential property along the line of extension and North of the proposed Hospital, which will be built up in time and which will require water service and fire protection A 4-inch pipe will be too small to supply fire hydrants or fire engines.

It will cost \$2050.00 to extend to 6-inch pipe from a point opposite the City Prison to the proposed Hospital site.

At a recent interview with Mr. Annand, Immigration Agent, he expressed the opinion that the Department would agree to pay 4% interest on the total cost of the Extension from Duffus Street, or say on \$6000 00, if the City would lay the pipe and deed them the small piece of land they ask for.

The estimated cost of extending the Service to the City Prison is \$3803 00.

The scneme discussed with Mr Annand, in my opinion is much more favorable to the City than the first one suggested by Mr. Scott, as the City would have the water laid in Gottingen Street from Duffus Street to the Northern boundary of the Rock Head Property, free of cost as far as interest is concerned, in 'addition' they would have a water supply at the City Prison and a revenue from the building along the route.

I would recommend, therefore, that a six inch main be laid from Duffus Street to a point opposite the piece of land asked for by the Immigration Department, and that the supply be laid to the City Prison, and the piece of land referred to deeded to the Immigration Department, provided they will agree to pay the City a minimum sum of \$240.00 per Annum for Water Tax, and further if at any time the amount of water consumed should exceed in value the sum of \$240.00 (to be determined by meter measurement) the Department will agree to pay for such excess

## TELEPHONE POLES, ETC.

### HIS WORSHIP MAYOR CROSBY,

### MONTREAL, November 24th, 1904.

#### Halilax.

DEAR SIR,—No doubt you have noticed the decision of the Privy Council re Bell Telephone Co. and Toronto, by which it is decided that the Federal Act of that Company overrides all Provincial legislation and enables the Company to place its poles, conduits and apparatus, to any extent, in and under the streets of all cities, towns and other municipalities in Canada, without any municipal consent.

As this is a matter affecting every municipality in its streets and franchises, it is the opinion of President Mayor Laporte, Mayor Urquhart, and others of the Executive, that the Union should take this matter up at once, form a strong deputation to wait on the Dominion Government, ask for a remedial general act, restoring control of our streets, and otherwise act as they see best.

If you approve of this course, please wire me, as the time is short. Also, if you can, be one of the deputation.

### W. D. LIGHTHALL, Hon. Sec.-Treas. U. C. M.

His Worship the Mayor informed the Council that immediately upon receipt of the letter he had telegraphed the Secretary of the Union concurring in the action taken by the Union in taking steps to have the rights of municipalities restored.

The action of His Worship was concurred in by the Council and . the letter ordered to be placed on the Order of the Day for further consideration.

Read report Public Accounts Committee on various matter :

### REPORT PUBLIC ACCOUNTS COMMITTEE.

### COMMITTEE ROOM, CITY HALL, Dec. 27th, 1904.

#### To His Worship the Mayor and City Council:

GENTLEMEN, —Your Committee on Public Accounts beg to report that at a meeting of the Committee held this day, there being present Aldermen Johnson (Chairman), Archibald, Gastonguay, Rogers and Doyle, they had under consideration the accounts of the Arbitrators for Services re Widening Upper Water Street recommended by this Committee in error and passed by the City Council at its last meeting. His Honor the Recorder having filed his written opinion that the Arbitrators are only entitled under the Acts 1898, Chapter 65, to a fee of \$6.00 for each lot valued, your Committee recommend that the Arbitrators be asked to amend their accounts in accordance with said Act.

Your Committee also recommend that a change be made in the Estimates 1905-6 passed at the last meeting of this Committee making the appropriation for Streets \$21,935.00 and Internal Health \$14,000.80.

The following accounts were passed as correct and are recommended for payment :

## ESTIMATES 1905-6.

The Council now proceeds to the consideration of the Estimates of receipts and expenditures for the Civic year ending April 30th, 1906. which are introduced by Alderman Johnson, Chairman of the Committee on Public Accounts, in a lengthy address in part as follows:

### Your Worship the Mayor and Members of the City Council.

As Chairman of the Public Accounts Committee, I beg leave lay before you the estimates for the year 1905-1906 and in doing so would call your attention to a few facts in connection therewith.

Your Committee, in undertaking the preparation of the estimates for 1905-06, were met by various circumstances which added considerably to the difficulty of appropriating the money of the various departments in the best possible manner. On account of the extensive fire on the water front, in which the Fire Department showed up to good advantage and by their great efforts prevented a more serious conflagration. it brought about from the citizens in general a demand on the Council that the Fire Departmentbe made even more effective than it is at the present time. This called for a greater expenditure than had been made in previous years.

When all the items of the various departments were laid before your Committee it was found that the aggregate of the items was away beyond the amount allowed by law to be expended on the City, viz: \$130.000 and also whatever income the City might have. To add to our difficulty, it was learned, upon consulting the Treasurer and the Auditor that various items which had been carried as income in previous years have not been realized, and that to calculate that these items would be as much as in previous years was calculating on a false basis, so that the following items of probable income were decreased, viz: Fines and fees in Police and City Courts from \$5000 to \$3500; current interest from \$2000, to \$1500; while the rents from City property were increased from \$2000, to \$2400; and the receipts from the Electric Tranway Company from \$5750, to \$6500. These, together with income from liquor licenses, hacks, trucks and other licences, dog taxes, etc., brought the total probable income of \$850. The City could, therefore, spend on its internal government \$162.150.

Your Committee felt that as a great many the items for the internal government of the City were fixed charges, they preferred to leave the Department of Public Works to be considered last. The salaries remain the same as the past year viz: \$31,676. In previous years part of the salaries of the Clerk of Works and the Superintendent of Streets and Sewers were charged to sewer account, but, as that account has been closed out, the committee saw fit to charge against the Water Department the whole salary of the Clerk of Works, viz: \$1100, and against the appropriation for the streets the salary of the Superintendent of the Streets, viz: \$1000

After deducting from the salaries the amounts charged to the Water Department and various other departments, it left a balance of \$22,850, to be charged against the internal government of the City.

You will observe that the estimate for the Police Department -\$30,410-is practically the same as the previous year, and that \$5900 for Rockhead Prison is the same. There is an increase in the estimate allowed the Fire Department of \$1900. This was made up by the following increases :

Last year the salaries were \$18,500, this year they are \$18,800. This does not indicate any increase, but in previous years the Department depended on securing a considerable amount from fines on the men but, on account of this item decreasing they asked for this amount, viz : \$18,800.

The Fire Wards recommended that on account of the small amount paid to the drivers, viz. : \$7 per week, in some instances, in fairness to the men it should be increased 50 cents per week. The Committee unanimously decided that these seventeen drivers were entitled to this increase. This increase amounts to \$442 The contingent account was increased from \$350 to \$500. This increase, taken together with a few decreases, for the past year, viz : Fire Alarm System \$150, purchase of horses \$125, etc., leaves the net increase of this Department \$1900 over last year.

The items for "Miscellaneous" aggregate \$4,920.36, against \$5.515.54 last year, the difference being brought about by no special claims being presented, such as the claims of Henry, Gill and Johnson of last year.

By referring to the Department of City Works you will observe that there are two new items in this Department, viz: sewerage \$500 and maintenance of road around Citadel Hill \$50. On account of considerable expenditure being made in supplying the Public Baths last year it was felt that the appropriation could be decreased \$100 this year Insurance is increased from \$800 to \$1100.

In lighting the streets there is an increase of 330, while under the heading of "Fuel" there is an increase of 275, so that the increase mentioned in this Department, after deducting the 100 saved on baths, and 24 on telephones, amounts to 1,331.

After providing for all these items, we find that they amounted to \$126,215, and as we started out to appropriate \$162,150, we had left \$35 935 to still appropriate, with but two items to provide for, viz., streets and internal health. Last year these two items amounted to \$39,000, that is, your committee had this year \$3,065 less to appropriate to these two services than they had last year. They decided to deduct \$1,500from streets, leaving \$23,500 for that purpose, and the balance—\$1,565—from internal health, leaving \$12,435. This made a total, not including the income of the city, of \$129,999.36, or within 64 cents of the legal limit.

Since the meeting of your Committee, at which the estimates were considered, there was a meeting to-day, and upon representations made by the Engineer, they would recommend to the Council that the whole of this difference, viz., \$3,065, be deducted from what was allowed last year for streets, which would leave \$21,935. In this connection your committee fully realize that the limit allowed by law is inadequate for the

requirements of the city, and that either one of two things must be done, to increase the income or to ask the Legislature to increase the limit of expenditure allowed. The only way that the income could be increased would be by increasing the fees for liquor licenses. A famous man once said that any law that is not backed up by public opinion, no matter how good it is, is like a gun without powder. It is generally conceded that public opinion is not back of the present license law, and it should receive the serious consideration of the Council.

Coming to the heading of extra assessments, there are certain items here over which the Council have practically no control. The Clerk of the Municipality of Halifax County makes an estimate that the expenses (less a Government grant \$300) would amount to \$14,580 and that under the present agreement the City is liable for 420-520of this, or \$11.776, which together with the City's share for the salary of the Treasurer, \$400, brings it up to \$12,176. The (ity is in a peculiar position in this respect. While they provide for nearly the total expenditure of running the Court House, still, their representatives appointed by the Cohncil to look after their interests, have never been notified of any of the meetings of Commissioners of the Court House I might mention, that in this estimate the expenses of the Court House are \$2,800 : Interest on Loans amounts to \$1080; the sinking Fund, \$105); the County Jail current expenses, \$2,500 The balance is made up by account for Juries, Sheriffs, criminal prosecutions, printing, criers Supreme Court, etc.

There is a demand from School Commissioners for \$116.000 which is \$5.650 more than last year. Of this \$116.000, there is \$3,300 to go towards a sinking fund. This is an item over which the Council have practically no control, except in so far as the members on the School Board representing the Council look after the City's interests.

There is an increase for the Poor Asylum of \$124). A principal item of this increase is for two new heating boilers, which are required as the old ones are condemned. These will cost \$850. It was thought that as Miss Dow does a great deal of work in connection with this institution that an amount of \$164 be allowed to pay her for her services. Many of the following items are fixed by Statute. There is a considerable increase namely, \$1285 23, for paying one half deficit for the Provincial Exhibition. Nobody will begrudge to Sergts. Joseph McNally and Thos. Condon the amount placed opposite their names, after serving the City so well for a long period of years.

Under Temporary Loans and Interest, there are but two new items namely W. L. Eaton's claim and Halifax and South Western Ry. land damages. The consolidated fund less charges of the Water Department is practically the same as last year. There is one additional sinking fund of \$5.000 under the Statute 1903-4. This makes a total proposed expenditure of \$430.180 50, to which is added 1 per cent for short collections and from which is deducted \$5,000 from unexpended balances leaving a rectified expenditure of \$429,482, or an increase of \$13015 over last year.

I learn from the City Treasurer that without taking into consideration the School Debt, which does not go through his books but is looked after by the School Commissioners, that the general debt of the City on the first of May, 1904, was \$3,088,590, since which time forty-six bonds were issued for the Halifax and South Western Railway, and \$5,000 for Dry Dock subsidy, which left a gross debt on November 30, 1904, of \$3,139, 590. Of this amount, \$1,056,600 is water debt, so that the total debt on November 30, 1904, not including water debt, is \$2,0,2,990, from which would be deducted sinking funds amounting to \$151,599.13, leaving the net debt of the City, \$1,931,390.87.

The law governing the assessment of the City is that it must not be more than 10 per cent. of the average Real Estate assessment for three years.

Some Cities consider the amounts authorized but not yet borrowed as coming under their limitation as to debt. This is the reason that this is mentioned here. In view of the fact that the City is considerably over the limit, notwithstanding that it will have to be materially increased in the future for severs. new fire apparatus, etc., it would be well for the Conneil to consider the advisability of having legislation enacted during the coming session of the Legislature to meet these contingencies.

It may be interesting to consider what part of this debt originated in recent years. Let us go back to the year 1895. The following is a statement up to date :
