AN ACT RESPECTING THE "LITTLE DUTCH CHURCH " AND CEMETERY.

Be it enacted by the Governor, Council and Assembly, as follows :-

The Cemetery and the Church thereon, situated on the North-East corner of Brunswick and Gerrish Streets, in the City of Halifax, known as the "Little Dutch Church" and Cemetery, shall not, nor shall the owners thereof, be liable for assessments, rates or taxes of any kind whatsoever levied or to be levied thereon by the City of Halifax, nor for any lien or charge created or to be created under the provisions of Chapter 58 of the Acts of 1891 or any Act in amendment thereof, or any other Act of the Legislature of Nova Scotia, so long as this property is used for no other purpose than as at present and as a Cemetery.

DEAR SIR -In answer to yours of 4th, re annual fee,

After the first two years of work the Executive found that the small fee asked for did not enable them to meet expenses, and at the Ottawa Convention the matter was discussed and left to the Executive to devise a plan. This resulted in five of the principal cities agreeing to make a special call on about ten other cities to join with them and make the fee \$4.00 p.r thousand for the purpose of placing the Union on a firm basis. A copy of that resolution and letter was sent to the City of Halifax, asking to be one of them, and presenting a bill for \$160.00. I suppose your City did not entertain the proposition; however, in September you sent us along \$40.00 and of course the Union returned thanks, because the proposition was optional: but the five cities and several others responded and the result was that the Union paid off all its debts and was greatly strengthened. The writer, helping to engineer the finances of the Union, proposed that in future the annual fee be placed at \$2.00 per 1000 of population, which would be the most equable way all round, and that proposition was put into the hands of the Executive to deal with and was adopted last fall and is working splendidly, for already the principal cities and towns have paid. This small fee, with the new Canadian Municipal Journal has met the approval of all, and the Union is stronger than ever before, and is doing good work at Ottawa.

I herewith enclose annual account supposing your population is 40,000. If this is is not correct please change to your own knowledge.

Will you kindly send your last annual report and any further information you can for our Bureau of Information.

The Halifax County Conservative Club, an organization comprising upwards of three hundred ratepayers and voters in the City, have at the present revision of the electoral lists in the City been endeavoring to secure a revision of the lists in accordance with the Statue and that persons other than the official appointed by the City for that purpose should not be allowed to interfere in reference to the registration of voters. It has however been found impossible to do this in consequence of the action of the Registrar of Voters and several complaints made to the Mayor have produced but little result, as the Registrar of Voters claims that he is not in any way under the control of the Mayor.

Under these circumstances, the Halifax County Conservative Club feel obliged to lodge with the City Council a charge of misconduct against the Registrar of Voters and the undersigned hereby charge Mr. L. Frederick Monaghan. Registrar of Voters of the City of Halifax, with misconduct in the following particulars :--

1—Permitting Mr. A. G. Cummings, who was acting on behalf of the Liberal Party on revision, to examine the cabinet containing names of persons on voters' list and give information to such persons without such Revisor making himself aware as to whether the information was correct or not.

2—Permitting said Mr. A. G. Cummings acting as aforesaid to stamp the name of the Registrar on what purported to be declarations for adding names to voters' lists and to place same on the files of the Registrar of Voters as apparently completed declarations without any declaration having in fact been made before such Registrar.

3—Directing said A. G. Cummings to prepare declarations as to persons stated to be absent or sick by some person not qualified to make such declaration in order that such persons might be added to the list although not making application personally or by any person authorized by them.

4—Permitting said A. G. Cummings to be frequently and habitually inside the counter in his office and to have free and uncontrolled access to the records of the Revisors' office.

5—Receiving declarations as to persons on whose behalf applications were made to be added to the voters lists knowing same to be false and refusing for a long time to allow persons lawfully applying to inspect declarations made for the purpose of putting voters on list and up to the present time refusing to permit such inspection of declaration made by Arthur C. Hawkins stating that Frank Burgess was absent from the City when in point of fact he was not and personally attended before said Registrar on the day when said declaration was made and endeavored to conceal the fact of said Arthur C. Hawkins having made false declarations and to shield him from prosecution for having made such false declarations.

The following Act was drafted at the instance of the City Council's Committee on Legislation, in substitution for the Act relating to the Halifax Electric Tramway Company, to be found on page 277 of the printed Minutes:

AN ACT IN RESPECT TO THE TAXATION OF THE HALIFAX ELECTRIC TRAMWAY COM-PANY, LIMITED.

Whersas, The Halifax Electric Tranway Company, Limited, has acquired by purchase, the property and franchises formerly owned and enjoyed by the People's Heat and Light Company. Limited, including the property and franchises formerly owned and enjoyed by the Halifax Gas Light Company, and is now operating and enjoying the same;

And Whereas, doubts have arisen as to the amount of taxation to be paid by the said Company to the City of Halifax in respect to the property and franchises so acquired;

Be it therefore enacted, by the Governor, Council and Assembly, as follows :--

The said The Halifax Electric Tramway Company, in addition to the taxation by law imposed upon the real property owned by it, including the real property formerly the property of the People's Heat and Light Company, Limited, or of the Halifax Gas Light Company, and the sum of four per cent on the gross tolls received from the operation of its railway and the license fee of one thousand dollars, imposed by section 33 of Chapter 107 of the Acts of 1895 and water rates, shall in lieu of all other taxes other than water rates, pay half-yearly to the City of Halifax on the first days of May and November in each year, a sum equal to four per cent. on its gross receipts during the half-year preceding from the supply of electric energy or gas for lighting or power, and such such shall constitute a lien or charge upon all the property, real and personal, and the franchises of the Company, and may be collected in the same manner and with the same remedies and at the same time as the other rates and taxes of the City; and in addition to such remedies if the said sum remains unpaid for three months after the first day of May or November in any year, the Supreme Court or a Judge thereof, may appoint a receiver of the tolls and income of the Company, who shall out of the moneys so received by him, pay to the City the amount of the said license fee then in arrear.

The said Company shall half-yearly, on or before the first days of November and May, furnish the City Treasurer with a statement of the said gross receipts, shewing the amount derived from electricity and gas respectively, verified by the oath of the Superintendent or Manager of the Company, and for the purpose of verifying such statement, the City!may if it deems fit examine the books and accounts of the Company.

The said Halifax Electric Tramway Company, Limited, shall place and maintain on all street-crossings along the line of their railway within the City of Halifax, a good electric arc light where there are none at present placed by the City, and shall also place a similar light for the safety of passengers along the line of their track at such places as the City Board of Works shall direct.

AN ACT TO AMEND CHAPTER 107 OF THE ACTS OF 1895, ENTITLED, "AN ACT TO INCORPORATE THE HALIFAX ELECTRIC TRAMWAY COMPANY, LIMITED."

Be it enacted, by the Governor, Council and Assembly, as follows :--

Chapter 107 of the Acts of 1895 entitled "An Act to incorporate the Halifax Electric Tramway Company, Limited" is hereby amended by adding thereto the following section to follow immediately after section 31 :--

31a. (1) Upon every street or part of a street on which a double track is now or hearafter laid the Company shall within forty-eight hours after any snow has fallen remove the snow and ice from the street between the tracks and the sidewalk on each side of the track to a level not exceeding nine inches above the rails.

(2) In every street or part of a street on which a single track is now or hereafter laid the Company shall within the time aforesaid remove the snow and ice from a space eight feet on each side of the track to the level aforesaid.

(3) If the Company fails to comply with the requirements of this section it shall be the duty of the Mayor to prevent the Company from running its cars and for that purpose he may use such force as is necessary.

COMMITTEE ROOM, CITY HALL, April 5th, 1905.

His Worship the Mayor and City Council:

GENTLEMEN, - The Board of Fire Wards beg to report as follows :

1. In a previous report your Board recommended the dismissal of James A. Gibbons from the Department and the Council referred the matter back to the Board for the purpose of giving Mr. Gibbons another opportunity of resigning. This courtesy has been extended to $\forall r$. Gibbons, but he has declined to avail himself of it and your Board again recommended his dismissal.

2. It is recommended that Loraine T. Heisler be appointed callman on No. 1 steamer vice James A. Gibbons, dismissed.

3. John Honey, driver of No. 3 steamer, having pleaded guilty to a charge of being under the influence of liquor, it is recommended that he be fined \$5 00, that his leave be stopped for six months and that he be required to take the pledge for one year.

4. The Chief has been authorized by the Board to shift the permanent men of the Department from house to house whenever he deems it in the interest of the Department to do so, provided he reports to the Board on each occasion.

5. The Naval Store Officer having requested the services of the Fire Department

in case of fire in H. M. Dockyard, it is recommended that the request be complied with provided the Imperial Authorities will authorize the Department to place a fire alarm box outside the Dockyard gate at the expense of the Dockyard Authorities.

6. The Board opened tenders for coal from Wm. Roche and H. D. Mackenz'e & Co. and for Veterinary services from Wm. Jakeman & Son and Howard McFatridge. It is recommended that the tenders of Wm. Roche and Wm. Jakeman & Son for these services be accepted.

7 Complying with the wishes of the Conneil, the Board has obtained a list of the members of the Union Engine Company with the length of service of each member, and append the same hereto. It is recommended that the Union Engine Company be given the use of the room in Central Engine House applied for in accordance with the conditions named in the Board's original report.

8. Mr. John White, Lessee of the old Gerrish Street Engine House, has applied for a two year's extension of his lease and the option to purchase during that time for \$2500.00. It is recommended that his lease and the option be extended to April 30th, 1906.

9. Your Board has considered the petition of Lieatenant Sunderland for pecuniary assistance, but as no provision has been made in the Estimates for the Fire Department that would permit of this expenditure, the matter is referred back to the Council for consideration by the incoming Board.

10. The immediate erection of the new Bedford Row engine house being an urgent necessity, it is recommended that this Board be empowered to advertise for tenders for the construction of the building in accordance with the plans and specification on file in the City Engineer's office.

11. On December 4th, 1904, the Department extinguished a fire in a building outside the City limits. The Company in which the building was insured declined to pay the cost of the chemicals used or to contribute anything to compensate the men for their services.

In consequence of this the Board communicated the facts to the Insurance Company in question and to all the other companies doing business in the City, asking if they would be willing to contribute in future cases. The Company which had at first declined thereupon paid the cost of the chemicals (\$10.00) and it and the other companies expressed their willingness to contribute their proportion of reasonable expenses in future cases. All the correspondence is attached hereto.

By leave of Council Alderman Martin submits the following resolution :---

Whereas, a public market in the City of Halifax is absolutely necessary to prevent encumbering the streets and rendering them at times impassable to the great inconven-

ience of the citizens, to promote the comfort of the market people and citizens and to produce a revenue for the City;

And Whereas, we have at our disposal the sum of \$60,000.00 for the erection of a market building;

And Whereas, a public landing place is also necessary and should be near the market ;

And whersas, The Military Authorities, it is believed, propose abandoning the Fuel Yard and the King's Wharf;

Therefore resolved, That a Committee consisting of His Worship the Mayor and Aldermen Johnson and Martin be appointed to interview Sir Charles Parsons with a view to making application to the Imperial Authorities for the transfer by lease or otherwise of the Fuel Yard and King's Wharf for the above purpose.

And that the City Clerk be and is hereby instructed to communicate with Charles Parsons asking him to fix a date when he can receive the Committee.

Moved by Alderman Martin, seconded by Alderman Cawsey and passed.

Moved by Alderman Hawkins, seconded by Alderman Hubley, that the Council do now adjourn. Motion passed.
