GOTTINGEN STREET PAVEMENT.

CITY ENGINEER'S OFFICE, September 7th, 1905.

His Worship the Mayor:

SIR,—I beg to submit a report on the petition from owners of property in the block on Gottingen Street between Cornwallis Street and Cunard Street asking the Council to pave that portion of the street with bitulithic pavement similar to that laid in Granville Street.

The Paving Act requires the Engineer to report to the Council first—the total length of street proposed to be paved. The length petitioned for is 454 feet.

Second—The nature of the material most suitable in his opinion to be used for the pavement. I have already reported to the Council in connection with the Granville Street pavement an opinion respecting the different materials that are available. This block of Gottingen Street requires a pavement very similar to that required on Granville Street where bitulithic has already been laid. I am in favor of a sheet pavement for such streets provided the pavement can be laid to last for such a length of time that it will be a good investment financially. I have no objection to offer or criticism to make respecting the bitulithic pavement except that already stated that I do not know the life of the pavement. It has not been tried out and the life must remain a matter of speculation. To offset this the Company offer a ten-year guarantee, which fixes its life at a period not less than ten years. The petitioners have asked the Council to lay bitulithic pavement and the Act provides that the Council shall decide the material that shall be used.

Third—The proposed cost. The estimated cost of paving the street with bitulithic' not including the track allowance, is for single track, \$3,150.00; and for double track' \$1,902.00.

Fourth—Whether in his opinion it is desirable to pave said street or portion, and any other information or remarks as he deems proper. I am strongly in favor of paving the portion of the street petitioned for, and am only sorry that the petition does not cover more of this important north end business street If the Council decide to pave the portion of the street that will be paid for by the City with bitulithic, I would recommend that the decision be made conditionally, that is, that the Warren Bituminous Paving Co., who alone can lay bitulithic pavement be awarded the contract at \$2.75 per square yard, provided they agree to the specification, terms and conditions submitted to them by the City Engineer and Recorder. It is most unsatisfactory to award a contract for work and make the specification afterwards, as once the contract is awarded the contractor has the City at his mercy and may accept or refuse conditions at his option. If the City is going to pay money for certain work it should be clearly defined what that work is to cover before the contract is made, otherwise the cost of the work is much greater than appears at the outset. In the case of Granville Street, a great deal of the work placed in the specification by the City Engineer was cut out by the contractor on the ground that he did not include it in his tender and the City had to pay for it in addit on to the amount tendered for. This occurred through no fault of your officials and a repetition should be prevented by the rider as suggested.

In respect to the paving of the street railway allowance, in my judgment bitulithic pavement is not a suitable material either in the interest of the street railway company or of the City and this opinion is concurred in by the manager of the street railway company. I am firmly of opinion that a block pavement is the only pavement for the track allowance where the rails are laid on wooden ties and where the bonding must be examined at short intervals. The block pavement can be taken up and relaid without much difficulty or loss where a sheet pavement like bitulithic must be almost a total loss. Further, I think the price asked by the Paving Co. for block pavement is higher than the Tramway Co. could do the work for themselves, and I would recommend that if the Council decide to pave this street with bitulithic the Street Railway Co. be requested to pave the track allowance with stone block pavement to the satisfaction of the City Engineer.

Moved by Alderman Martin, seconded by Alderman Cawsey, that the report be adopted, and that the street be paved with bitulithic pavement and the Tramway track allowanee with granite blocks on terms satisfactory to the Recorder and Engineer and under the supervision of the City Engineer. Motion passed unanimously.

Moved by Alderman Martin, seconded by Alderman Cawsey, that a Committee consisting of His Worship the Mayor and Aldermen Martin and Johnson be appointed to wait upon the Local Government with the object of obtaining their undertaking to pass a bill authorizing the transfer of the money left from the paving of Granville Street to account of Gottingen Street paving. Motion passed unanimously.

Moved by Alderman Cawsey, seconded by Alderman Martin, that the Tramway Co. be asked to lay double tracks on the portion of Gottingen Street to be paved. Motion passed.

Alderman Hubley gaves notice of reconsideration.

Read report City Engineer re paving Barrington Street.

PAVING BARRINGTON STREET.

CITY ENGINEER'S OFFICE, Sept. 7th, 1905.

His Worship the Mayor :

SIR,-I beg to report on the accompanying petition from owners of property on Barrington Street asking for the construction of a bitulithic pavement from Spring Garden Road to Jacob Street.

The Act requires the Eugineer to report : First—The total length of street proposed to be paved. The distance from Spring Garden Road to Jacob Street is 2,702 feet.

Second—The nature of the material most suitable in his judgment to be used for the pavement. I have already reported to the Council in connection with the Granville Street pavement an opinion respecting the different materials that are available. This street requires a pavement very similar to that required on Granville Street, where bitulithic has already been laid. I am in favor of a sheet pavement for such streets, provided the pavement can be laid to last for such a length of time that it will be a good investment financially. I have no objection to offer or criticism to make respecting the bitulithic pavement except that already stated, that I do not know the life of the pavement. It has not been tried out and its life must remain a matter of speculation. To offset this the company offer a ten-year guarantee, which fixes its life at a period not less than ten years. The petitioners have asked the Council to lay bitulithic pavement and the Act provides that the Council shall decide the material that shall be used.

Third.-Probable cost.-The estimated cost, with double track throughout, is \$12,-137.50.

Fourth .-- Whether in his opinion it is desirable to pave said street or portion, and any other information or remarks as he deems proper. I am strongly in favor of paving this street from Spring Garden Road to Duke Street, and from Bell's Lane to Jacob Street. Respecting the portion between Duke Street and Bell's Lane, however, I am quite as strongly of opinion that it should not be paved unless double track is laid. I am aware that the merchants on this street object to the laying of double track, for selfish reasons, but it is strongly in the interest of the general public that this street should be doubled tracked. The average width of this block does not vary a foot from the average width between Duke Street and Salter Street, where double track has been laid for some time. I measured the widest teams I could find in the City on a former occasion to ascertain whether there would be room for traffic on this block if double track were laid, and I could not find any cart which would not have ample clearance with double track. The service at present is an annoyance to patrons going to the trains and cannot be improved unless double track is laid. The laying of a double track on this block would be of great service to the general public. It would enable the company to make much better transfer arrangements at Buckingham Street, where now the car going up the hill is frequently missed by passengers obliged to wait opposite City Hall. Teams used in connection with the business done in the block referred to can stand against the curb with little more inconvenience than they now have in being spread across the street. They interfere with team traffic through this block by being stretched out into the street quite as much as they do with the railway track and the weight of interest of the general public should receive due consideration.

My principal reason for urging that pavement be not laid on this portion of the street until it is double tracked is that in consequence of the difference in level between the curbs, the cross-section of the street for single track must be different from that adopted for double track, and consequently if the street is paved now with the single track the whole pavement must be torn up from gutter to gutter when double track is laid and a new cross section adopted, the whole cost of paving the street now being thrown away when the change is made. While I strongly recommend the paving of the street, as already stated, from Spring Garden Road to Duke Street and from Bell's Lane to Jacob Street, I would respectfully urge upon the Council that the paving of the portion from Duke Street to Bell's Lane be postponed until double track is laid.

I would recommend the same course in awarding a contract and paving the track allowance as that recommended for Gottingen Street.

Moved by Alderman Johnson, seconded by Alderman Powell, that the Tramway Company be asked to double track Barrington St. between Duke St. and Bell's Lane. Motion passed.

GOTTINGEN STREET WATER SUPPLY.

CITY ENGINEER'S OFFICE, Sept. 6th, 1905.

His Worship the Mayor :

SIR,—At the last meeting of Council "Alderman Hawkins asked for a report from the City Engineer in writing as to why service pipes were not connected with the 27inch main in Gottingen Street instead of laying a new street main in said district."

In compliance with his request, I beg to report that service pipes connected with the large main in Gottingen Street would freeze as the pipe is not laid below the reach of frost. When this pipe was laid thirteen years ago a large saving was made by laying it in a shallow trench instead of placing it at the depth required for service pipes. The large main is prevented from freezing by the constant flow of water.

Recently the property owners on Gottingen Street have begun an agitation for permanent pavement, and as the life of the small main would expire before that of the pavement the old small main is being renewed. The course adopted was chosen because it was the most economical.

Read report City Engineer re streets leading to North West Arm.

STREETS LEADING TO NORTH WEST ARM.

His Worship the Mayor and City Council:

GENTLEMEN,—At a meeting of the Council, May 26th, 1904, the following resolution was passed :—

"Whereas, The North-West Arm is one of the great pleasure grounds of the City and is becoming more so year by year;

And Whereas, There is no apparent right-of-way for the public to approach the Arm from South Street to Point Pleasant Park;

And Whereas, An old plan of the City shows at least three streets running to the Arm between South Street and the Park ;

Therefore Resolved, That the Engineer examine the plans of the City and the deeds of the owners of properties through which these old streets run and report to the Council as to the City's rights in these streets, and if the City has no right-of-way to the Arm between South Street and the Park to make some recommendation to solve this difficulty."

Moved by Alderman Johnson, seconded by Alderman Campbell, and passed.

I have been unable to report on this matter owing to the difficulty in obtaining the necessary information until now.

Mr. H. W. Johnston, Assistant City Engineer, has gone into the matter thoroughly and prepared a plan and report setting out in detail the information he has been able to obtain. In brief, the plan filed in this office shows in red lines the streets as they were originally laid out. I have come to the conclusion, on the evidence contained in his report, and after consultation with His Houor the Recorder, that none of the streets shewn can be claimed to day by the City unless it may be the street adjoining the Park. I submit herewith, in addition to Mr. Johnston's report, copy of a letter from Mr. B. F. Pearson offering on certain conditions a right-of-way to the Arm north of "Maplewood." The only alternative proposition that I am able to suggest is the opening of a street at the line between Pine Hill College and the Library. The cost of the latter would be greater than the cost of accepting Mr. Pearson's proposition, and if the Council consider it advisable to obtain a right-of-way to the Arm in this neighborhood I would recommend the acceptance of Mr. Pearson's offer. There is a road already opened and in use down to the Arm and the cost of putting it in good order would not be heavy. The offer includes the dedicating of a piece of land at the end of the street on the Arm for a public picnic ground and boat landing. When the official plan of this part of the City is plotted we intend to lay out a proposed system of streets, but at present we are not in a position to do so.

BOUNDARIES OF STREETS AND PROPERTY FRONTING ON NORTH WEST ARM.

MR. F. W. W. DOANE, City Engineer.

SIR,—In accordance with your instructions I have compiled the accompanying plan showing existing boundaries of streets and properties fronting on the North West Armfrom Point Pleasant Park to South Street, also showing the position of the streets as laid out on the original plan of the City. This original plan is not in existence and the location of the old streets was taken from plans in the Crown Lands office, attached to various grants, and also from Plan Number 79, filed in our office, which purports to be a copy of the original plan and is signed by and dated

The lay out of the City, as shewn on this plan, agrees substantially with the plans attached to the different grants and I have no doubt is a true copy. The streets as originally laid out are shewn by red lines on the accompanying plan and as may be seen by inspection do not agree with the existing boundaries. Oxford Street is shewn as running from South Street to the Park boundary. Only two sections of this street are open-a part about 850 feet long from South Street to Oakland Road (so called) and the part now known as Franklyn Street, extending from the Bower Road to the Park. Between these points there are some stone walls, which from the evidence of plans in our office were considered of ancient date, in 1847, and which doubtless were intended to mark the limits of Oxford Street; but there must have been considerable inaccuracy in the original surveys, as they do not run in a straight line as shewn on the original plan. The original grants to the properties fronting on the Arm were bounded by this street, but by the grant of the first June, 1803, registered in the Crown Lands office, in book 20, page 109, that portion of Oxford Street from South Street to the street running westwardly to the Arm through "Maplewood" was granted to E. B Brenton. The rest of the street, as far as I can ascertain, has never been granted to private individuals. Mr. Thompson's property, according to his deed, is bounded on the east for a distance of 250 feet by a private road. This road is in prolongation of Franklyn Street, and must be intended for a part of Oxford Street. Robie Street is the next street east of Oxford Street laid down on the plan. This street is open as far south as Inglis Street, the portion between "Belmont" entrance gates and Inglis Street having been acquired from the "Marlboro Wood Company. This street was granted to Brenton and Hali-burton by the above mentioned grant of 1803, from "Belmont" gate southerly to a point half-way between Oxford Street and the next street north. The stone wall form-ing the west boundary of the Collins' property, was probably laid off as the east line of this street. The first street on the plan running east and west south of South Street is This street, as may be seen, should be north of the existing street. It Inglis Street. runs west to Oxford Street and then at right angles to Oxford Street to the Arm. It closely approximates to the existing boundary line between "Belmont" and "Oak-lands," and probably is very nearly in the location originally proposed for it. This street, from Robie Street to the Arm, was also granted to Brenton by the 1803 grant. The next street south ran to the Arm through the "Marlboro Woods" and "Maplewood" properties, and was granted to Haliburton by the same 1803 grant. The next street south is Miller Street (so called). This street was laid off across the peninsular from the Barbor and Steel's Pond to the Arm, with a bend at Oxford Street. By laying this street off by measurement from South Street it comes about 300 feet north of the War Department line at the north of Point Pleasant Park and runs to the Arm from Oxford Street (or Franklyn Street), near M. R. Morrow's south boundary. This would also be the location of it by laying off the distance as shewn on the original plan from the street

south of the Maitland property. The War Department line, as above mentioned, is about 300 feet south of the proper location of Miller Street, and as the Military authorities have been always particular in keeping up their boundary lines the probability is that this line is in the same position as located originally, thus shewing quite an inaccuracy in the original. Miller Street in its present location meets Franklyn Street at or about the boundary line between the old Penitentiary property and the property now owned by B. F. Pearson. The next street south is south of the Maitland property and north of the Park property. The easterly portion of this street may be traced on the ground, but the feace forming the north boundary of the westerly portion is in a 4 dilapidated condition, and runs in a very irregular line. However, there should be no difficulty in locating this street as originally laid out, and I can find no record of its ever having been granted to any private person. The owners of the Marlboro Woods propose dividing up their property according to the blue lines on the accompanying plan and as may be seen by the accompanying letter from Mr. Pearson, they are willing to deed to the City the extension of Inglis Street from Robie Street to Bellevue Avenue and also Be'levue Avenue from Inglis Street to the Arm, including a piece of ground on their south boundary and abutting on the Arm, about 370 feet long by 120 feet wide, for the purpose of a public park and boat landing. There are certain conditions attached to this transfer as are explained in Mr. Pearson's letter. There is a lane running down to the Arm from Franklyn Street, about 350 feet south of the north line of the Bowery Road through the property of the Presbyterian Theological College to "Pine Hill." This lane has been used as a right-of-way for a considerable number of years by people wishing to cross to the other side of the Arm but has always been fenced in and a rental charged for the use of it so that it is doubtful if the public

My dear Doane, -- On behalf of the North West Arm Land Company, the owners of Marlborough Wood, and in answer to your verbal inquiry, I will undertake to have transferred to the City, free of any charge whatsoever the right-of-way for a street say 60 or 75 feet wide, extending from the end of present extension of Inglis Street to the water, and the same will arrive at its terminus by way of a curve or street at right angles as shewn by the plan marked in red herewith enclosed.

The condition of such transfer would be the return and collection by the City of the bond given by the said Company and Messrs. Borden and Brookfield, conditioned upon the extension of Robie Street South to the present extension of Inglis Street. The necessity for this extension does not now exist, and if it required to be extended at a later period the filling in could be done by City ashes, with no expense to the City. I may say that when this bond was given the North West Arm Land Company relied upon a large deposit of gravel at the east end of Inglis Street extension for the purpose of making this filling. This gravel as you know, was appropriated by the City and was valuable for its purpose, consequently, I think the concession asked for above may be fairly asked.

In addition to the right-of-way above stated, there will be a landing on the North West Arm free to all, but subject to some conditions against building thereon. This would have to be worked out, but we would try and meet the requirements of the City in that respect. Of course, the City would have to take over and put in efficient repair the extension of Inglis Street from the Infants' Home, as after having conveyed it to the City the Company would take no further responsibility about keeping it in repair.

I would also suggest that the City should obtain from the Infants' Home people a deed of a small strip at the east end of said extension of Inglis Street so as to make a uniform width right through. If the City should decide upon this the conveyance will be made at once. It is very desirable to get the matter closed this year.

Trusting this will be satisfactory, believe me,

His Worship the Mayor :

SIR,-I beg to report on the following sewers which have been petitioned for :-

VERNON STREET.

After considerable correspondence, I have been able to get definite offers from the owners of the property through which the outlet from Vernon Street must pass. There are two routes open—one through the proposed extension of Louisburg Street in property owned by F. C. Stevens, the other through the proposed new street at the north end of LeMarchant and Vernon Streets to Henry Street, thence southerly to Bliss Street and eastwardly to the Edward Street sewer.

Mr. Stevens offers to give the City a deed of Louisburg Street through his property for \$600.00 and the cost of fencing, estimaied at \$700.00, provided they lay a water pipe as well, which will add \$1000.00 as there are no houses on the property to make any return, making a total cost of \$2300.00. The length of sewer required is about the same as for the other route.

On the other route Mr. Wm. Dennis who controls the title to part of the property required for the sewer outlet offers to have it conveyed to the City for the amount of the sewer assessment on the frontage of the property taken. This would amount to \$335.00, the frontage of the property being 268 feet.

Mr. G. C. Coster, representing the Bliss Estate, offers to deed a small lot on Henry St., also required for \$\$0.00 making the total cost of the property \$115.00.

If the Council decide to build this sewer, I would recommend that the offer of Mr. Dennis and Mr. Coster be accepted, one half of the cost to be paid from Sewer Appropriation, the other half to be paid from Street Appropriation, as the two services will receive equal benefit. This sewer is badly needed as the property on Vernon St. is rock almost to the serface and the drainage of the houses lies on the ground. It is difficult to improve the conditions in any other way than by constructing the sewer.

The estimated cost of constructing the sewer in Vernon St. eastwardly to Henry St., southwardly to Bliss St. and eastwardly to Edward St. is \$7,600.00. Estimated assessment \$2,472.50.

The petitioners ask for the construction of a sewer in the south end of Granville St. from Salter St. to Blowers St.

His Worship the Mayor retires for the purpose of receiving His Serene Highness at the entrance to the City Hall, and Deputy Mayor Johnson takes the chair.

His Serene Highness, accompanied by General Sir Charles Parsons, having arrived promptly at the appointed hour, viz., 12.30 o'clock, was escorted to the Council Chamber by His Worship the Mayor. His Worship the Mayor resumed the chair.

His Serene Highness occupied the seat to the right of His Worship the Mayor.

His Worship the Mayor said :---

Your Serene Highness :

We are met together this morning for the purpose of presenting an address of welcome to Your Serene Highness on re-visiting Halifax. We are all delighted to have you back again and we are pleased indeed to have the vessels of the British Navy with us once more. When the announcement came last year that we were to loose the fleet it was with feelings of the very deepest regret that we heard the intelligence and we are pleased again to receive the ships of His Majesty's Navy.

I will now call upon the City Clerk to read the formal address.

The address is now read.

To His Serene Highness Prince Loais Alexan ler of Battenberg, G. C. B., G. C. V. O., K. C. M. G., Rear Admiral Commanding the Second Cruiser Squadron, British Atlantic Fleet, etc., etc.:

MAY IT PLEASE YOUR SERENE HIGHNESS,-

The Mayor and Corporation of the City of Halifax, on behalf of the citizens, beg to extend to Your Serene Highness a most cordial welcome to our City, coming to us as you do both as a representative of our Most Gracious Sovereign and as the Admiral in command of a squadron of his navy.

The loyalty of the citizens of this city for their Sovereign continues unabated. It is now approaching the half century since His Majesty honored us with a visit, making this city his landing place in British North America, and from that time to the present the affection and admiration of his Canadian subjects have steadily increased.

The memory of the former visit of Your Serene Highness to this station as an officer of one of Her late Majesty's ships is recalled by us with pleasure, and we are glad to have you re-visit us after years of distinguished service.

Since the founding of our City, now more than a century and a half ago, this port has been a headquarter station for the British Navy. During all that period the officers and men of the fleet have been most closely associated with us in our social interests and pleasures, both sharing in them and largely contributing to them. It is an unavoidable cause for regret that owing to the change in naval policy, the reasons for which we fully recognize, those pleasant relations can no longer be maintained as fully and as closely as heretofore, and we gladly avail ourselves of this opportunity of renewing them for the brief period of your stay.

We beg to include in our welcome the officers and men under your command and to express the hope that your stay and their's in our midst will be most pleasant and that you will carry away most agreeable recollections of your visit to Halifax.

His Serene Highness said :-

Your Worship and Gentlemen :--

May I follow your example before proceeding to read the formal reply to your kind address telling you briefly how very pleased I am to be back in this dear old place. It is so long ago that I suppose there are very few people here who remember it. I left this harbor thirty-two years ago. I may mention as an example of how the Navy is to-day compared with that time that the ship in which I served (The "Royal Alfred") cannot compare with my present flagship. The present one is twice as long and twice as fast. I am very glad that certain circumstances have arisen which have made it possible for me to prolong my stay here, with enormous advantage to the squadron as well as pleasure to myself, and instead of spending a week here we shall remain the greater part of six weeks, which will enable us to get through with a great deal of important work besides extracting a great deal of pleasure from your City.

He then read the following reply :--

Mr. Mayor and Gentlemen :-

In the name of the officers and men of the squadron and in my own, I thank you most heartily for your kindly welcome. Halifax has been a honsehold name in the Navy for many a year, and there is not an officer or man amongst us who does not look forward to a stay in this fine harbor—be it as a new comer or like in my case to renew old associations and acquaintances.

You refer in your address to the fact that owing to a change or rather evolution in naval policy the old standing relations between your City and the Navy will in future be less close. I need hardly assure you that the regret which you are good enough to express thereat is fully reciprocated not only by the officers and men of H. M. ships, but by the Admiralty ever in close and sympathetic touch with the service afloat It may, however, be permissable to point out that this loosening of ties will be more apparent than real. This squadron of six first-class armoured ships, the most powerful your harbour has ever sheltered in time of peace, is about to establish its headquarters here for some five weeks to enable me to take advantage of the many facilities offered by this naval base in carrying out our all important gunnery exercises, whilst giving the crews the advantage of the many recreations your City and its beautiful surroundings offer. Moreover, as you are aware these visits of squadrons will be regularly repeated during the portions of the year which the former permanent squadron used to spend in the northern part of the North American and West Indies station.

Let me in conclusion thank you especially for your personal references to me. It is a long step from midshipman to admiral, but the pleasant memories of Halifax have not been dimmed in the least by this lapse of many years.

The gentlemen above named and the Aldermen present were now presented to His Serene Highness by His Worship the Mayor.

Upon the retiring of His Serene Highness and His Worship the Mayor the chair was resumed by the Deputy Mayor.
