PUMPS FOR WATER SUPPLY.

CITY WORKS OFFICE, Nov. 10th, 1905.

To the City Council :

GENTLEMEN, —In consequence of the unusual dryness of the season Long Lake and Chain Lake, the low service impounding reservoirs, fell rapidly during the months of September and October and during the last part of October had reached a much lower level than ever before. The conduit between Long Lake and Upper Chain Lake was lowered some years ago being placed at almost the lowest level at which it could flow into Chain Lake. As the level of the water dropped the quantity flowing through the conduit became insufficient to keep up the supply to the City. Your Committee waited until in their judgment and in the opinion of their officials it was absolutely necessary to increase the flow from Long Lake to Chain Lake. They then took immediate steps to instal pumps to increase the flow. All owners of pumps in the City, which pumps might be of sufficient capacity for the work, were consulted, including the Marine and Fisheries Department. Mr S. M. Brookfield, Manager of the Dry Dock, was the only owner who had a suitable plant available, and on the 1st of November your Committee began to instal his largest pump with two boilers. They were put in service as soon as possible and have been operated ever since. The recent rains have begun to raise Long Lake and Chain Lakes and it is confidently expected that it will not be necessary to operate pumps much longer.

6. Re petition of residents and ratepayers in the north end of the City for an extention of the tram car line as shown on plan prepared by the City Engineer at the request of the Committee and attached to this report.

Your Committee recommend that the Council request the Halifax Electric Tram. Company to continue their line up Duffus street to Agricola Street extension and along Agricola Street connecting with the main west end line at Almon Street, this being in the opinion of your Committee the most advantageous route to both the petitioners and the Tram Company.

7. RE DISMISSAL OF POLICE OFFICERS BRACKETT AND KEEFE.

MAYOR'S OFFICE, Nov. 10th, 1905.

To the City Council:

GENTLEMEN, —At a meeting of the Police Commission held on the 12th day of October last, the following charges against Police Officer Brackett were investigated and he was found guilty :-

Reported by Sergeant Collins "for being absent from his beat from seven till eight p. m., also for not making his standing point at seven o'clock on the 26th day of Sept. 1905."

Reported by Sergt Collins "for being drunk while on duty also for being late in reporting at the Police Station at three o'clock a. m, on the morning of the 26th August.

Reported by Deputy-Chief "for going in Mr Edwards' bar room, No. 39 Sackville St, when on day duty and loafing therein on the 26th Sept. 1905.

Having been found guilty of a similar offence by the previous Commission and fined with the understanding that if he were again convicted he was to be dismissed, your Commission dismissed him from the force. The next day a resignation was received from Mr. Brackett.

The following charge was preferred against Police Officer F. Keefe :---

HALIFAX, N. S., August 30th, 1905.

His Worship the Mayor and Members of the Police Commission.

DEAR SIRS.—I beg to bring to your notice the fact that on August the 19th, about six o'clock, as I was returning from the Regatta at the North West Arm I was assaulted by one or more parties. One of them, while defending myself from the attack of another party, without any notice and without being seen by me, struck me on the side of the face and I was in a semi-unconscious state therefrom until 11 o'clock of the same evening.

I am informed that Policeman wearing badge No. 34 was on duty at the Arm that day and was present when the assault took place. He was requested, I am told by reliable parties, to have my assailants arrested and I am further told that instead of doing so he left the scene of the assault and went elsewhere. I have made enquires and I have found that the policeman has not up to the present time effected the arrest of either of the parties who assaulted me.

I do not know the name or names of my assailants or I would have had legal proceedings taken against them before now I think this is a matter that ought to be investigated by the Police Commission and I beg to give the names of the following gentlemen who are willing to appear before your body with regard to the matter complained of. PRODUCE PEDDLERS' LICENSES.

GENTLEMEN, -- Section 678 of the City Charter of 1891 authorized the City Council to pass ordinances respecting peddlers, &c, but provided that such ordinances should not apply to persons bringing to market the products of any farm occupied by the persons offering such produce for sale in the City. NO. 3 STEAM FIRE ENGINE.

HALIFAX, N. S, Oct. 16th, 1905.

DEAR SIR,—In compliance with a resolution of Council passed at its last meeting held 5th inst., requiring me to report in writing the reasons why Engine No. 3 was delayed in working at the late Boutilier fire, I beg to submit the following for your consideration :—

When the alarm was first rang in there were two of the department engineers at least two miles from the scene of the fire, the engineer of this particular engine being one of them (one being at the Exhibition race track and one at the N. W. Arm). I may point out that there were five engines on the scene with only three engineers to operate same for the reason above stated.

The trouble with engine No. 3 was not so much with the engine itself as she was and is in perfect working order and condition, having been thoroughly overhauled and tested by myself and repaired but a short time previous to the fire, but was on account of the man acting as engineer and who undertook to start it up and get it working before the arrival of the Department Engineer, he being an outsider and in no way connected with the Department and not being very familiar with the working parts therof experienced considerable difficulty in getting her to run, not being able to get water in the boiler. Upon my arrival and investigation of the difficulty I discovered that the valve leading to the boiler through which water is fed to same was closed, and I also further discovered that the exhaust controller in the smoke stack was also closed when it should have been opened.

In the case of the former, this valve should be kept open all times and should never at any time be closed except when overhauling valves to pumps in event of same not working, in which case it should be closed so as to keep the water in the boiler to prevent same from coming back on the pumps when engine is working.

Upon my remedying this difficulty I experienced no trouble in getting the engine started and to work. By this time the Department Engineer in charge of this engine had arrived and no further trouble was experienced.

I may say in conclusion that my first impression was that the engine had been tampered with, hence my remark to this effect, but upon further thinking the matter over I am inclined to the belief that the acting engineer at the start in his excitement may have closed these valves involuntarily, hence the difficulty.

IN THE MATTER OF THE DOUBLE TRACKING OF BARRINGTON STREET.

HALIFAX, N. S., October 14th, 1905.

His Worship the Mayor :

SIR,—As I understand, the matter on which my opinion is required by Alderman Doyle's resolution, is practically whether the Council can rescind the resolutions authorizing the laying of double track on Barrington and Gottingen Streets by the Halifax Electric Tramway Company.

Those resolutions were passed at the meeting held on the 7th September. Notice of reconsideration was given but not moved at the next meeting, that namely, on the 21st September.

After the last meeting the Engineer issued a permit for the double tracking of Barrington Street.

The resolution for a stay of proceedings can have no effect if the Council has no power to rescind, and the question, as I have said, is practically whether the Council has now that power.

The general principle of the law applicable is that stated by Dillon (Municipal Corporation, 4th Ed. Sec. 290), as follows :--

"At any time before the rights of third persons have vested, a Council or other corporate body may if consistent with its Charter and rules of action rescind previous votes or orders."

The rights of the Tram. Company are those given to it by its Charter, Chap. 107, Acts of 1895. Among these, section 4 provides that the City Council shall have the power to authorize the Company to lay a double track on any of the streets or portions thereof. When that authority was given, as it was, by the resolution of the Council and after the time for reconsideration had expired it appears to me clear that the Company had a vested right to lay the double track of which the Council has not now the right to deprive it. I do not see that the issue of the permit in the one case and not in the other makes any difference. The substantial thing is the authorization by the Council, which the Engineer could neither add to or take away from.

DEAR SIR, -- At a meeting of the Council of this Board, held on the 17th inst., it . was on motion resolved that this Board record its approval of the double tracking and extension of the Halifax Tram system wherever it is practicable.

Your Committee appointed to see about the double tracking of that part of Barrington Street between Duke and Buckingham Street, beg to report that they visited the City Engineer's office where they obtained data as to measurements, etc. They also visited Messrs. Smith & Proctor and personally examined the conditions applying to this street.

In their opinion there is no insuperable difficulty in double tracking this part of the City and the benefits to be derived by the general public far outweigh the inconvenience which may be experienced by those doing business in this block.

While it is true the street is a narrow one, it is approximately the same width as the next block further south and only a few inches narrower than Granville Street. The width left on either side of the rails would be 9 feet, and the overhang of the largest cars, as given by the City Engineer, is 15 inches, and the width of the widest waggon that they have been able to get information about is 7 feet 8 inches. Taking away the width of one hub, which could overhang the sidewalk, this would leave 7 inches clear for the cars to pass, while with the ordinary light delivery waggon such as is commonly used in this street, and which is 6 feet wide over all, it would leave practically 2 feet.

If it is thought advisable because of the congested traffic in this block to leave greater width between the curb and the track, your Committee suggests that on the west side of this street from twelve to eighteen inches might be taken off the sidewalk, which is not very greatly used as a thoroughfare by pedestrians.

RE STEAM FIRE ENGINE.

GENTLEMEN,—In response to advertisement in the public press in August last, calling for tenders for supplying to the City of Halifax a first-class steam fire engine of 1,000 gallons capacity per minute, the following bids were received by the Board of Fire Wards on September 5th :—

These tenders have now been under consideration by your Board for over two months. The specifications are very lengthy and contain a mass of detail involving a great amount of work comparing the various types and devices in order to determine the most favorable offer. The Board believe it is the desire of the City Council to procure the very best and most up-to-date engine obtainable apart from the question of cost, and for this reason the lowest offer is not recommended for acceptance.

Enquiries have been made of the fire departments in various cities regarding their experience with the different types of engines in use, but we find the departments very reticent in giving information of any practical value to the City.

A delegation of prominent City business men representing the Canadian Manufacturers' Association waited upon the Board and urged that in the purchase of an engine preference be given to one of Canadian make over any engine made abroad.

The Board made every effort to procure a side-by-side test in Halifax of several of the competing engines and finally attempted to secure such a test of two of them in Montreal, but though the Canadian Fire Engine Company were willing to comply with the desire of the Board in this respect, competition was not available.

Attached hereto is a report from the Chief Engineer on the comparison made by him of the tenders of the "Merryweather," the "Waterous" and the "Canadian" engines.

The Canadian Fire Engine Company have been found very liberal in the matter of offering to add to their engine devices and improvements recommended by the Department.

In the opinion of the Board, the tender of the Canadian Fire Engine Company is the best offer made, and it is therefore recommended for acceptance. A special committee was appointed by the Board to draft a form of contract. This contract has been carefully prepared and includes a detailed specification and a list of tests which the engine will have to meet. It also embraces all improvements suggested by the Chief Engineer, and requires the depositing of a Guarantee Company bond in substantiation of the contractor's guarantee, and provides that the contract be signed and the said bond filed before the order for the construction of the engine is given.

One clause of the contract provides that the contractor will, upon demand, furnish the City, free of charge, with a second-hand engine while the contract engine is under construction and to be retained by the City for six months after the date the new engine will be due here if the new engine does not comply with the required tests.

The draft contract and all tenders are accompanied herewith.
