2nd. No. 4 steam fire engine, Bedford Row, requiring a new boiler, tenders were asked from the several boiler makers. With the possibility of having this work done cheaper by the makers; the Amoskeag local agent here was also requested to tender, but his price was \$346.00 more than that the lowest tenderer. It is recommended that the tender of T. Hogan & Co. \$549.00, be accepted upon their signing a specification to be drawn by the Chicf Engineer.

3rd. The City Electrician having communicated with a number of cities asking their experience with glass key protectors for fire alarm boxcs reported that nearly all of those using glass fronts are now discarding them in favor of keyless doors. The cost of these, about \$40.00 each, being at the present time prohibitive in Halifax, the Board has decided to install five glass fronts in the centre of the City in addition to the two now in service.

4th. Michael Supple, Call-man No. 4 steamer, having missed twelve out of fourteen alarms during the last three months, it is recommended that he be requested to send in his resignation.

5th. The Board has consipered the report of Chief Engineer Condon relating to No. 3 steamer at the recent fire at Boatilier's fish establishment. The language used in the report gave an impression that an irresponsible outsider undertook to run the engine. The fact was that the man is an employee in another department of the Cicy who had run the engine many times before but was on this occasion unable to start it for the reasons given in Mr. Condon's report. In order to obviate such an occurrence again and other difficulties necessarily incident to a force of call engineers it is recommended that the Council appropriate an amount sufficient to pay an additional call engineer and a further sum to provide for one more call man on each steamer division whereby the firing of the steam fire engines (a most important service) may be more efficiently performed. This will require about \$700 00 a year.

6th. It is also recommended that upon the signing of the contract with the Canadian Fire Engine Company that they be requested to immediately comply with the provisions of their contract to furnish the City with a second-hand engine so that the City will not be an engine short while No. 4 steamer is being fitted with a new boiler.

REPORT CITY PRISON COMMITTEE.

COMMITTEE ROOM, CITY HALL, Dec. 5th, 1905.

His Worship the Mayor and City Council:

GENTLEMEN, — Your Committee on City Prison beg to report that a meeting of the Committee was held this day, there being present Alderman Hawkins (Chairman), Archibald, Murray, Hubley and Gastonguay.

The following accounts, amounting to \$135.24, were examined, found eorrect and are recommended for payment, viz :--

Halifax Elec. Tram. Co., light, \$2.58. J. F. Kelly, rep. harness, &c., \$15.10. Jas. J. Skerry, groceries, \$30'36. J. H. Sutherland, dry goods, \$17.55. J. A. Leaman & Co. ox heads, \$9.00. Colwell Bros., uniform buttons, \$13.00. N. S. Telephone Co., half year to May 1906, \$27.00. J. J. Carnell, rep. to waggon, \$10.15. Evangelical Alliance, cab hire to Sept. 17th, \$10.50.—Total, \$135.24.

Your Committee had under consideration the matter of extending the water pipes to the prison premises and recommend that the Committee on Works place a fire hydrant in the centre of the prison grounds enclosure for fire protection purposes.

Your Committee had also under consideration a resolution of Council passed on the 8th June last in re the advisability of amalgamating the County Jail and Rockeead Prison and referred to the Committee for consideration.

Your Committee having carefully considered the question of amalgamating the City Prison and County Jail, report as follows :--

The accommodation in the City Prison is more than three times as great as that of the Jail, yet the Jail received 81 prisoners more than the prison in 1904. The maximum number at any one time in the Jail was 30, and in the Prison about 25. The Jail contains 27 cells and a debtors' room; the Prison 88 cells above the surface of the ground and 44 below

The Jail grounds are merely large enough to affiord the inmates sufficient room for exercise. The only occupation in the Jail is oakum-picking That has been discontinued because of the lack of a market.

The City Prison farm contains 94 acres and affords the prisoners employment in farm work as well as in stonebreaking. The farm yields produce valued by the Governor at \$472.00. and the stone broken was valued at \$420.35.

The total expenditure of the Jail for the past year was \$2,656.21, of which the City of Halifax paid 9/11, or \$2,187.71. The total number of prisoners was 288 criminals and 54 debtors or 342 in all. The daily average was 16.7. Each prisoner cost about forty cents a day.

On the City Prison in 1903-4, \$5,400.00 (or \$5,647.60 less \$247.60 received in cash) was expended. There were 261 in the prison in the year or a monthly average of about 23. The cost per prisoner was between \$19.00 and \$20.00 a month. The Governor reports that the cost of the food purchased for each male averaged 11 cents a day, and for each female 9 cents. The expense of the Prison is larger than that of the Jail because of the number of keepers required, the up-keep of the farm and the greater amount of fuel, etc

The City paid for its prisoners in the Jail and the Prison in the past year nearly \$7,600.00.

To transfer the prisoners from Rockhead to the Jail would mean doubling or trebling the present accommodation of the Jail. To do this a considerable quantity of land must be purchased and a new building erected. Even then it is doubtful if sufficient suitable employment for the prisoners could be provided.

The City Prison could accommodate easily the prisoners of both places and provide suitable employment. It is probable that if the entire expense (instead of the present 9/11 of this) of the maintenance of the prisoners of the Jail were borne by the City, the total outlay for one prison would be less than that now borne by the City. It would be necessary to secure the consent of the Municipality of the County of Halifax and of the Town of Dartmouth to the transference.

The most serious objection to the transference of all the prisoners to Rockhead is the inconvenience caused the Courts by the removal of those remanded for trial to such a distance.

Should it prove impossible to secure the consent of Dartmouth and the Municipality and should the inconvenience prove too great, your Committee still maintains that steps should be taken to remove from the Jail those prisoners who are serving long sentence for serious offences.

With these criminals are confined debtors, suspects, casual drunkards and prisoners detained for a few days. Something at present is done to keep them separate; but the large numbers and limited accommodation prevent thorough separation. Absence of employment and herding together tend to reduce all to the lower degrees of criminality.

Your Committee is informed that the Statutes compel the Supreme and County Court

Judges to send to the County Jail instead of the City Prison all those sentenced to imprisonment in a Jail. The Stipendiary in certain cases is also compelled to send prisoners to the Jail instead of the City Prison.

Your Committee therefore recommend that steps be taken to secure legislation permitting the judges and the stipendiaries to send prisoners either to the Prison or the Jail, as they may deem best.

Your Committee also recommend that steps be taken to confer with the representatives of Halifax County and the Town of Dartmouth for the purpose of securing their consent and support to the transference to Rockhead of all or some of the prisoners usually confined in the jail.

Your Committee further recommend that steps be taken to urge those in control of the Jail to provide employment for the prisoners.

In St. John.City prisoners, so we are told, are employed in improving the Park and the Statutes permit their employment on the roads of the city.

MAYOR'S OFFICE, Dec. 8th, 1905.

GENTLEMEN,—The Police Commission, at a meeting held on the 6th inst., had under consideration the question of the ratirement of Police Officer Blakeney, and beg to recommend to the Council that he be retired at once on account of age and unfitness for duty, under the provisions of Section 232 of the City Charter.

At the same neeting your Police Commission also had under consideration the resignation of Sergeant Baker and accepted said resignation, to take effect on the 31st December, 1905, under authority of Section 9 Chapter 73, Acts of 1903.

Your Commission further had under consideration the matter of the superannuation of Sergeant Leahan and decided that as he had been incapacitated by injury received while on regular duty he be superannuated at the full superannuation allowance, and your Commission recommend that special legislation be asked for to assess the difference between the amount he would be entitled to from the Superannuation Fund and the full superannuation allowance, the retirement to date from 31st instant.

Your Commission have also had under consideration an application from the Chief of Police for superannuation, and your Commission recommend that he be superannuated on the 31st instant, under authority of Section 9 Chapter 73, of the Acts of 1903.

The Commission desire to place on record their appreciation of the manner in which the Chief of Police has performed his duty as Police Officer, Police Sergeant and Chief, and to express regret that he feels it necessary on account of advancing years and increasing responsibility to lay down the duties of the office which he has so satisfactorily filled.

Your Commission also wish to place on record their appreciation of the valuable services rendered by Sergeants Baker and Leahan during their long connection with the police force as privates and sergeants, and to express the hope that they may long be spared to enjoy a well-earned rest.

Your Commission have also had under consideration a petition from the sergeants and men of the force asking for an increase in their salaries, and recommend that an increase of \$50.00 be granted to each sergeant and man from May 1st, 1907, on the condition that from the date on which the increase takes effect the sergeants shall pay into the Police Superannnation Fund thirty (\$30.00) dollars per year and the privates twenty-four dollars (\$24 00) per year, and that the necessary legislation to give effect to this and following recommendation be applied for during the next session of the Legislature.

Your Commission further recommend that the salary of a policeman in his first year of service should remain at four hundred (\$400.00) dollars as at present, and should thereafter be increased at the rate of fifty dollars (\$50.00) per year until the maximum salary is reached; and in the case of police sergeants that they should receive the sum of six hundred and fifty dollars (\$650.00) the first year and seven hundred dollars (\$700.00) for every year thereafter.

SIR,—In accordance with the accompanying extract from Minute of Council, I beg to report on the letters attached hereto from R. S. Rosborough and the Eastern Trust Company.

The Eastern Trust Co. threaten to cut off the drain which carries off the sewagefrom houses on the north side of North Street, west of Windsor Street. I presume they have a right to do so if they see fit, as the houses have not been draining into it long enough to acquire a right. I am under the impression that before the houses were erected the drainage did not run across North Street from these properties but flowed west toward Chebucto Road, but I may be mistaken in this matter, however, as I am speaking from memory only.

Mr. Rosborough asks that the sewer on North Street be constructed at once. This is a physical impossibility, as the material for this work has not been completed and concrete sewors built in place cannot be constructed during the cold weather. The work at the Poors' Asylum was stopped the first of November, and the Works Department were notified that if concrete work was to be done during the winter a new building would have to be erected. The Works Committee took action in the matter at once and steps are being taken to have the work of making sewer blocks pushed as rapidly as possible so that all the work on the order book may be finished next season.

Inglis St. at Ivanhoe St.—The light placed at this point would be within 250 feet of a light each way and in my judgment with our limited appropriation is unnecessary. There is only one house on Ivanhoe Street and the expenditure of \$65.00 a year to light this one property seems to be a large one. I therefor cannot recommend this light.

Chestnut Place — There was a light already at the junction of Chestnut Place and Cunard Street I have had this light placed on an arm. in the centre of the street so that it would be clear of the trees. An additional light in the middle of Chestnut Place would be only about 100 feet from the light already there. I cannot therefor recommend a new light.

North end Carleton Street.—There is a light at the corner of Spring Garden Road and Carleton St. and a light placed in the middle of the north block would only be 160 feet from Spring Garden Road. I cannot therefor recommend an additional light.

Mitchell Street.—There is a light at the corner of Inglis and Mitchell Streets and a light placed in the middle of Mitchell Street to light it would be only about 160 feet from the Inglis Street light. I cannot therefore recommend a new light.

MEDICAL EXAMINER'S ACCOUNTS.

HALIFAX, N. S., December Sth, 1905.

To His Worship the Mayor and Members of the City Council:

As Chairman of the Public Accounts Committee and supplementary to the report of that Committee presented to-night, I may state that from time to time within the past two years a number of the bills presented by the Medical Examiner of this City. Dr. Finn, have been passed on with a great deal of hesitation by the Committee, feeling certain that these bills hardly came within the Act under which he operates.

At a recent meeting of the Committee, there were three bills returned to Dr. Finn which they felt the City should not pay. They were as follows:

Robert Kennedy, a sailor, who fell from a vessel's mast, or rigging, to the deck and was fatally injured. He was taken to the hospital and died at that institution. In some way, the reason for which can hardly be explained, Dr. Finn made an autopsy on this man and sent a bill in to the City for twelve dollars.

Another case was that of William Taylor who was injured by an accident on the South Shore Railway and was brought to the hospital in this City and after a short time died. Dr. Finn gave a certificate of his death. Why the hospital authorities should call on Dr. Finn to give certificates for persons who died in that institution, is a mystery to the Committee.

Another case is that of James King, a soldier, who was found dead in Point Pleasant Park. The Committee felt that the Military Authorities should pay this and it was sent back on that account.

I called on the Premier and the Honorable Mr. Pipes respecting the habit of the authorities connected with the Victoria General Hospital calling in Dr Finn to give certificates of death, and they are of the same opinion as I am, that this should not be done. The Doctors of the Hospital who attend these people should give the certificate, and I think that hereafter that the City will not be called upon to pay such fees. A number of bills which are sent in are of well-to-do people who, no doubt, have family physicians who should be called upon to give the certificate. There are very often bills for infants a few hours old. The person who attended such mid-wifery cases should be called upon to give the certificate. The City has paid between three hundred and four hundred dollars per year to the Medical Examiner for these certificates.

The Medical Examiner returned the three bills referred to above, namely, those of Kennedy, Taylor and King. Among the bills recommended for payment to-night, are those of Taylor and King, and the Committee recommend that four dollars be paid to the Medical Examiner for Kennedy instead of twelve dollars. When these bills were returned to the Committee, they were accompanied by a letter from R. E. Finn, Barrister, which reads as follows;

"In consequence of your Committee's refusal to pass the three enclosed certificates of William D. Finn, M. D., for his fees for services performed as Medical Examiner for the City of Halifax, under the provisions of chapter thirty-nine of the R. S. of N. S. 1900.

1 beg to submit that your Committee has no alternative other than to pass said accounts; because the statute which governs is explicit, and it is for the Medical Examiner, and he alone to decide whether or not an enquiry is necessary.

As to the question of post mortem examinations the statute is equally explicit, because, to use the language of the statute "if the Medical Examiner deems one necessary, he may perform the same, and before or after make a statement on oath that in his opinion such examination was requisite and his reason for such an examination."

The statute further provides that he shall file his report with the clerk of the crown and if a post mortem is held, he shall file his statement under oath with the same officer.

Under the further provisions of the said statute, he is entitled to the fees therein provided, and the same are payable to him by the Treasurer of the City of Halifax, if the dead body the subject of such enquiry, report or inquest, was found in said City of Halifax.

I feel that your Committee will on further consideration and in the light of the provisions of the statute governing pass the said accounts; otherwise the matter will have to be submitted to the Courts to decide."

Upon receiving this letter, I submitted it to the Acting Recorder and asked him to prepare a reply for my signature in accordance with the Act under which the Medical Examiner performs his duties. The reply is as follows :---

HALIFAX, N S., Dec 7th, 1905.

R. E. FINN, Esq , Barrister, etc , City.

DEAR SIR, -I have to acknowledge receipt of yours of 6th inst., in reference to eertain accounts of the Medical Examiner.

The reason for the City's action in demurring to pass the accounts in question was because it was considered that they are not properly incurred under the statute and we are still of that opinion. Take for instance the case of the seaman Kennedy who was killed by a fall from the rigging of a vessel. He lived for some time after the accident and died at the Victoria Hospital. There was not the slightest doubt as to the cause of death. The Act provides that an enquiry is to be held only in cases where there is reasonable cause to suspect that death resulted from violence, undue means or calpable negligence in other words, a possible crime. There was nothing of the sort here : but even supposing an enquiry was necessary what possible justification could there be for an autopsy. The cause of death was manifest—the fall from the rigging. From a medical point of view it might be interesting to ascertain the exact nature of the injuries, but that was not the object of the Act, but solely to ascertain whether or not a crime had been committed.

The Act was intended solely to furnish a more efficient and less expensive substitute for the Coroner and his Jury. The way it is being operated it is certainly not less expensive. It may be as you say that the City has no alternative but to pay whatever claims the Examiner chooses to present, however unreasonable or exorbitant, but it certainly will not allow the matter to rest here. It is quite willing to pay whatever is reqisite to properly investigate any case where crime or criminal negligence can reasonably be suspected, but it is not willing to pay for a number of wholly needless and purposeless investigations, and if such claims as these continue to be presented it will be compelled to lay the matter before the Government with a view to a change either in the law or in the official.

I would recommend that copies of this letter and the one prepared by the Acting Recorder be forwarded to the Medical Examiner for his information.

P. S.—Since dictating the above, I called up Mr. Kenny, Superintendent of the Victoria General Hospital, and asked him how it happened that the Medical Examiner gave certificates for people who died in that Institution. Mr. Kenny informed me that the Medical Examiner claimed that it was one of his rights to give these certificates and that he usually kept tabs on all such cases which were at the Hospital.

Resolved, that in view of his long service and present illness that his resignation be accepted, and that when his successor is appointed he shall receive a salary of \$1,400.00 a year in full for similar services rendered by Recorder MacCoy, and that he enter into an obligation to pay Mr. MacCoy \$600.00 a year during the remainder of his life.

His Worship the Mayor and Cit Council:

GENTLEMEN, - At a meeting of the Council, May 26th, 1904, the following resolution was passed :-

"Whereas, the North-West Arm is of one the great pleasure grounds of the City and is becoming more so year by year;

"And whereas, there is no apparent right-of-way for the public to approach the Arm from South Street to Point Pleasant Park;

"And whereas, an old plan of the City shows at least three streets running to the Arm between South Street and the Park;

"Therefore resolved, that the Engineer examine the plans of the City and the deeds of the owners of properties through which these old streets run and report to the Council as to the City's rights in these streets, and if the City has no right-of-way to the Arm between South Street and the Park to make some recommendation to solve this difficulty."

Moved by Alderman Johnson, seconded by Alderman Campbell and passed.

I have been unable to report on this matter owing to the difficulty in obtaining the necessary information until now.

Mr. H. W. Johnson, Asst. City Eugineer, has gone into the matter thoroughly and prepared a plan and report setting out if detail the information he has been able to obtain. In brief, the plan filed in this office shows in red lines the streets as they were originally haid out. I have come to the conclusion on the evidence contained in his report and after consultation with His Honor the Recorder that none of the streets shewn can be claimed to-day by the City unless it may be the street adjoining the Park. I submit herewith in addition to Mr. Johnson's report copy of a letter from Mr. B. F. Pearson offering on certain conditions a right-of-way to the Arm north of "Maplewood." The only alternative proposition that I am able to suggest is the opening of a street at the lane between Pine Hill College and the Library. The cost of the latter would be greater than the cost of accepting Mr. Pearson's proposition, and if the Council consider it desirale to obtain a right-of-way to the Arm in this neighborhood I would recommend the acceptance of Mr. Pearson's offer. There is a road already opened and in use down to the Arm and the cost of putting it in good order would not be heavy. The offer includes the dedication of a piece of land at the end of the street on the Arm for a public pienic ground and boat landing. When the official plan of this part of the City is plotted we intend to lay out a proposed system of streets, but at present we are not in a position to do so.

Moved by Alderman Murray, seconded by Alderman Powell, and passed,

Moved by Alderman Cawsey, seconded by Alderman Hayward, that the Acting-Recorder report on the matter of a life interest held by Mrs. Rawley in a piece of property expropriated some years ago by the City for the West Street engine house and whom it is alleged never received any remuneration. Motion passed.

Read a petition of R. I. Hart for permission to use the name of the City in bringing an action against His Worship the Mayor and the City Engineer.

LETTER R. I. HART.

HALIFAX, N. S., December 1st, 1905.

To His Worship the Mayor and City Council:

GENTLEMEN,—On behalf of Mr R. I. Hart, a ratepayer in and a resident of the City of Halifax, I beg to ask for leave to use the name and seal of the City of Halifax as plaintiff in an action which my client is desirous of having brought against Robert T. MacIlreith and Francis W. W. Doane, claiming among other things: (1) A declaration that the payments to them respectively out of the funds of the City of Halifax for their personal expenses incurred in attending a convention of the Union of Canadian Municipalities held in the City of Winnipeg were and are unlawful, illegal and void; and (2) payment by the said MacIlreith and Doane of the respective sums received by them as aforesaid, and for such other and further relief as may be just, equitable and proper.

In the alternative on behalf of Mr. Hart I beg to ask for leave to use the name and seal and join the City of Halifax as plaintiff with Mr. Hart in an action of the same nature and for the same relief as above which my client proposes to bring against the said Robert T. MacIlreith and Francis W. W. Doane.

My client claims that the said payments were and are illegal and void and such expenses were not necessarily or properly incurred in the business of the City of Halifax and that there is no authority expressed or implied in the City Charter or any of the Acts relating to the City of Halifax authorizing the payment out of civic funds of the expenses of any official or servant of the City for the purpose of attending a convention such as the convention of the Union of Canadian Municipalities held at Winnipeg for which the said payments were made to Messrs. MacIlreith and Doane

For these reasons Mr. Hart contends that the payment of the expenses in question to Messrs MacIlreith and Doane was contrary to law and a pure gift of the money of the, ratepayers of the City of Halifax and that the rights of the City as well as his own and those of the other ratepayers of the City were and are prejudicially affected thereby; and that Messrs MacIlreith and Doane should be compelled to refund any and all sums received by them for such expenses as aforesaid.

A meeting of the City Council was held this afternoon. At the above hour there were present His Worship the Mayor, and Aldermen Hubley, Gastonguay, Martin, Taylor, Powell, Cawsey, and Hayward.

Moved by Alderman Taylor, seconded by Alderman Cawsey, that the time for meeting be extended until a quorum is present or until 3 o'clock. Motion passed.

2.50 o'clock. Roll called. Present the above named together with Aldermen Halliday, Johnson, Geldert, Murray, Doyle, Lamphier, and MacKenzie.

The Council was summoned to consider the civic estimates for 1906-7, to proceed with business standing over and the transaction of other business.

Read application of Nicholas Power for position of Chief of Police.

Moved by Alderman Doyle, seconded by Alderman Hayward, that Nicholas Power be appointed Chief of Police for the City of Halifax.

Motion put and passed unanimously.

ESTIMATES FOR 1906-7.

The Council now proceeds to consider the Estimates for 1906-7.

Alderman Johnson, Chairman of the Committee on Public Accounts, reads and submits a lengthy address explanatory of the Estimates and the finances of the City.

ALDERMAN JOHNSON'S ADDRESS.

HALIFAX, N. S., December 27th, 1905.

To His Worship the Mayor and Alderman in Council convened.

GENTLEMEN,--As Chairman of the Public Accounts Committee, I beg leave to lay before you the estimates for the year 1906-7 and in doing so I would say that your Committee took into careful consideration all the various estimates submitted to them by the Chairmen of the various Committees, and I have much pleasure in stating that they are enabled to recommend the full amounts of the various estimates presented by them.

Last year, when I submitted the estimates, it was done with apologies for cutting down the amount submitted by the various departments. It was not because the Committee knew better then the members of the Committees and Boards, such as, Public Work's, Charities, and Police Commission, etc., as to their requirements, but, because according to the then existing laws, it was impossible to comply with all their requests.

In 1905-6, the law provided that the City could only spend on its internal government one hundred and thirty thousand dollars and whatever income it may have had. The total income estimated last year was thirty two thousand one hundred and fifty dollars, which, with the one hundred and thirty thousand made an amount possible to be divided among the various departments of one hundred and sixty two thousand one hundred and fifty dollars

The Council decided that it was absolutely necessary that the City should be empowered to spend one hundred and forty thousand dollars and its income. This was granted by an Act of the Legislature last winter. The Council also laid before the Legislature various proposed Acts which they saw fit to enact and on this account I am pleased to inform you that notwithstanding the privilege of spending ten thousand dollars more on the internal government of the City on account of the income produced by the wise legislation referred to, we are enabled to provide for all the requests of the various spending departments of the City and only spend one hundred and twenty thousand dollars instead of \$140,000 in addition to the City's estimated income.

There were applications for increases of salaries from the Assistant City Clerk, Assistant Engineer, City Auditor, the first and second clerks in the Collectors office, the City Assessor, and one of his Assistants, the Clerk of Work's and the Water Inspector laid before the Committee.

The majority of the Committee recommend an increase to the Assistant Engineer of two hundred dollars; the City Auditor, three hundred dollars; First and second clerks in the Collector's office, one hundred dollars each; the Clerk of Works two hundred dollars; the Stenographer, fifty dollars, but did not see fit to recommend increases to the Assistant City Clerk, the City Assessor and one of his Assistants.

I think that when the Council takes into consideration the great increase in the cost of living and the general prosperity throughout the Country that they will approve of these increases.

On account of a number of new police officers and sergeants being appointed and going in on the minimum rate of wages, the Police Commission only ask for thirty thousand dollars, instead of thirty thousand four hundred and ten of last year.

Rockhead Prison, on account of calculating that they would receive four hundred dollars for broken stone, asks for five thousand five hundred instead of five thousand nine hundred.

The Department of City Works asks for seventy two thousand four hundred and thirty four instead of sixty seven thousand one hundred and sixty nine, making an increase of over five thousand dollars; three thousand of this is assigned to internal health and about one thousand to providing more lights on the streets of the City. You will notice that the appropriation for streets remains the same as last year.

Last winter, the Legislature, on the recommendation of the Council, passed a Paving Act and under its provisions during the coming summer, Barrington Street from Hurd's Lane to the Academy of Music; Hollis, from Buckingham to Salter; George Street from Barrington to Water, and part of Gottingen Street, will be paved. The pavement on Granville Street will also be extended to Sackville Street.

As very little, if any, work will be required on these streets which are permanently paved, a considerable saving will thus be made in the annual expenditure on streets and it is understood that Legislation will be asked during the next session of the house for an appropriation for the construction of permanent sidewalks, curbs and gutters, so it was felt that the present amount assigned to streets would be sufficient.

The paving of Granville Street has been a great object lesson, and the extension of this pavement, as proposed, will, I am sure, meet with no opposition.

There have been at various times demands from the citizens that the Fire Department should be improved. Accordingly besides expending about \$30,000 on it this year in the purchase of a new engine of the capacity of 1000 imperial gallons, and the building of a new engine house on Bedford Row, at a cost (with furnishings) of \$20,000 and other improvements that might be mentioned we are pleased to recommend that \$33,468 be assigned to this Department, instead of \$30,900 of last year; and there will be proposed legislation laid before the Council, recommending that a further sum be borrowed of about \$24,000, to purchase another chemical and another engine of 650 gallons capacity. and to build a new building to take the place of the Queen St. engine house. There are two engines now in use in the City, both of which are about forty-five years old; and, when the great advance that has taken place in machinery of all kinds during the past forty-five years is taken into consideration, every one will admit that these engines are out of date and are of little practical use and should be replaced by new ones.

The provision for miscellaneous items is increased by \$1000. This is added to the Uontingent Account. One of the reasons for this is that the Union of Canadian Municipalities will meet in this City next year, and, in order that the City may properly entertain the representatives of sister cities of Canada, it is deemed wise to increase our Contingent Account.

I referred above to much useful iggislation that was passed during the last session of the House; and, on account of the new License Act, it is calculated that the fees that will be received for licenses next year, (including all the fines in connection therewith) which does not come under the items of fines and fees of the Police Court, will amount to \$30,000 instead of \$14,500. It is expected that we will receive from hacks, trucks, and other licenses, \$3000 instead of \$2500. This is partly on account of the ordinance respecting musicians and a more careful collection of fees from transient peddlers. We calculated that we would receive \$250 more from the licensing of dogs, and \$1000 more from the Tram Co. You will observe a new item under Probable Income, viz: rents of hatch ways. It is calculated that the City has been losing about \$2500, a year from the lack of collecting these rentals. The sidewalks belong to the City, and if citizens who have a property abutting on the sidewalks make use of the space under them, they should be willing to comply with the law and pay a license. An effort will be made next year to enforce this, and it is a low calculation to estimate that we will receive \$1000, from this source.

The City's total probable income is, therefore, \$50,400, instead of \$32,150, as estimated last year, showing a gain of \$18,250 for which we should congratulate ourselves.

Under Extra Assessments you will notice that the City's contribution to the County of Halifax is \$11,000, a saving of \$1176.00; but the most striking item is that of Public Schools, \$125,300, an increase of \$9,300 over last year. On account of this extraordinary increase the Mayor and myself appeared before the government to see if it was possible to have this decreased, but, upon explanation of the various items which make up this amount, it was decided that no reductions could be made. Notwithstanding this large appropriation, and the tremendous increase in running the schools during the past few years, the Council will be surprised to learn that some of the school buildings are not in the condition that they should be. One instance might be mentioned, viz: that Morris Street school, which is one of the leading schools in the City, should be heated by eighteen stoves instead of by modern methods. The parents of the children who attend that school should demand that it be put in a proper sanitary condition. For the information of the Council, it might be well to state that in 1892-3 the appropriation for schools was \$85,000. It remained about \$100,000 until 1902-3. Only four years ago that appropriation was \$102,500, so that there is an increase of \$23,000, or almost 25%

The Committee on Charities only ask for \$24,588, instead of \$26,000 as of last year.

It was with a feeling of regret that the Committee could not allot a greater amount to the Public Gardens and Common, as that amount is fixed by statute; and they would recommend that legislation be secured whereby it would be left to the discretion of the Council.

There are no changes in Point Pleasant Park, the Public Library, Halifax Dispensary and Morgue.

Since considering the estimates, it is learned that only fourteen pupils chargeable to the City are attending the School for the Blind, so that instead of the \$1440 assigned to that object, it should be \$1260.

According to an Act of Parliament, an appropriation of \$1600 is allowed for the Industrial School and St. Patrick's Reformatory. Last year there was not a sufficient amount estimated for the Industrial School, so it was decided this year to put it up to the limit and in addition we have to provide \$246.25 for what we were short last year.

The item of \$14.69 should come under Truants. Under the Compulsary Act last year, the estimate for Truants was \$1700. The actual amount necessary was \$1714.69. The other items are fixed by Statute This would make a total of \$182,083.94, instead of \$182,263.94. Since considering the estimates we have discovered that an error was made in connection with the superannuation of Chief John O'Sullivan, sixteen months at \$297.14 per year, making \$396.19, instead of \$364.64; and the superannuation of Sergeant John Baker, sixteen months at \$148.57 should read \$198.09, instead of \$162.50. This would make a difference of \$85.14, and the corrected total would be \$199.512.63, instead of \$199.607.49.

Under the heading "Temporary Loans and Interest", the several items which occurred in last years estimates which are not found in this is owing to the fact that they are paid off, or the sinking fund is equal to the amount borrowed.

The following items viz. :- Public Baths, Loan Duke of Cornwall, Deficit Provincial Exhibition 1900 & 1901, Loan for house Public Gardens remain the same. During last winter there was a temporary loan of \$22,300 made. This amount must be paid off in five years, so that it requires an appropriation of \$4700, and, in addition to this, \$1244 to provide for the interest due and to come due on it. It was not the intention of the Council to borrow as large an amount as this as a temporary loan, and it was a mistake that it was not put on a long term; but you will remember that it was the intention to borrow \$14,300, but that afterwards \$3000 was added for the repairing of the wall in the Parade, and a general meeting of the citizens was held to impress upon the Council the necessity of borrowing \$5000 to remove the ice and snow from the streets last spring, so that it brought the total up to \$22,300, which thus entails a necessary charge of almost \$6000 to meet principal and interest.

Among the new items, is the amount to pay the interest on the widening of Upper Water Street. The item as to City Hall Debentures; Halifax and South Western Land damages; Consolidated Fund (old) less charge to Water Department, are practically the same as in 1905. I might say that an Act was passed by the Legislature authorizing the City to borrow two hundred and seven thousand dollars, one hundred and fifty thousand dollars for sewerage, and the balance for widening Agricola Street and improving the Fire Department. The interest is payable semiannually, the first of January and the first of July. The City advertised for tenders and the purchaser deposited one hundred and seven thousand to the City's credit in November. The interest for this broken period is five hundred and ninety four dollars and forty nine cents. On the first of January, the remaining one hundred thousand dollars will be deposited to the City's credit. We will therefore have to provide four per cent interest on the two hundred and seven thousand dollars, namely, eight thousand two hundred and eighty dollars, that is a total interest charge of eight thousand eight hundred and seventy four dollars and forty nine cents must be provided for. When the Committee were considering this item it was contended that as the unexpended money was earning four per cent, the citizens should not be taxed to meet interest that was already provided for, that is, the bank is paying four per cent on any balance that is left there and the money is borrowed at four per cent so that it is providing its own interest as long as it lies in the Bank.

The City Treasurer appeared before the Committee and there was a difference of opinion as to the amount that should be taken credit for in this way. Your Committee calculated that we should take credit for four thousand four hundred and fifty four dollars and seventy eight cents. During 1906-7 the money secured on account of this loan will earn that amount of interest.

Since the meeting of the Public Accounts Committee, the Treasurer has gone more carefully into the matter and he calculated that it amounted to three thousand eight hundred and twenty seven dollars and thirty-four cents, which is only a difference of five hundred and sixty-seven dollars and forty-four cents less than the amount mentioned in this estimate and I would recommend that this item be changed.

As stated before, on November 17th we receive on account of the loan one hundred and seven thousand dollars. Paid out on account of sewers, thirty seven thousand

five hundred and ninety one dollars; on account of Agricola Street, twenty four thousand one hundred and eighty one dollars, making a total of sixty two thousand seven hundred and seventy two dollars. Since that time, on account of sewers, Agricola Street and Fire Department, there was four thousand seven hundred and Fifty Dollars paid out. It is calculated that before May first, on account of sewers and the Fire Department, there will be expended twenty six thousand dollars. This will make a total of ninety three thousand five hundred and twenty two dollars, leaving a balance of thirteen thousand four hundred and seventy six, to which add the one hundred thou and dollars to be received on January first. After taking into calculation the probable amount that will be left in the Bank at the end of each month, the aggregate interest earned by this money will, as stated before, amount to, on a conservative estimate, three thousand eight hundred and thirty seven dollars and forty nine cents would leave four thousand nine hundred and eighty seven dollars and fifteen cents instead of four thousand four hundred and nineteen dollars and seventy one cents.

In addition to the three Sinking Funds for last year, as estimated, there is an additional one, that of 1905, thirteen hundred dollars. This amount is arrived at as follows : The law provides that where a sewer is built the owner of the property shall pay a part of the cost. This is a charge against the property and to be paid in instalments, the amount to provide for at the end of thirty five years is two hundred and seven thousand dollars - One hundred and fifty thousand dollars of this is to be expended upon sewers. According to the City Engineer's estimate there will be fifty thousand feet of this nonproductive, that is, the property on each side of it is either owned by the City, or Imperial Authorities, so it will leave one hundred thousand dollars of which a proportionate part will have to be paid by the citizens. The amount paid by the citizens, together with the accumulated interest for twelve years will amount to fifty eight thousand dollars which at three and one half per cent for twenty two years will amount to one hundred and twenty three thousand six hundred and twenty seven dollars. Now if thirteen hundred dollars be put away for thirty four years at three and one half per cent compound interest it will amount to eighty two thousand four hundred and eighty nine dollars, so that at the end of that period this fmnd, at the low rate of three and one half per cent, will amount to two hundred and six thousand one hundred and sixteen dollars, and as we are at present getting four per cent on our balances, it is safe to say that there will be sufficient to meet the two hundred and seven thousand when it matures thirty five years from the time it was borrowed ; this would leave the corrected total four hundred and thirty five thousand one hundred and thirty dollars and seventy eight cents instead of \$434,658.20 The one per cent. added for short collection would be four thousand three hundred and fifty one dollars and thirty cents, which would make a total of four hundred and thirty nine thousand four hundred and eighty two dollars and eight cents, from which deduct five thousand dollars from unexpended balances. This would leave a corrected total of four hundred and thirty four thousand four hundred and eighty two dollars and eight cents. This is an increase over last year of five thousand dollars and eight cents. If the assessed value of the City would be the same as last year, this would mean an increased assessment of about two cents, that is. instead of the rate being one dollar and seventy three cents it would be one dollar and seventy five cents, but it is generally understood that there will be considerable increase in the assessment values so that the rate will probably be a trifle lower than it is this year.

It may be of interest to the Council to be reminded of the rate of assessment of this City for the past ten years.

In 1895 the reason that the rate was \$1.38 was that the Council used \$35,000 of unexpended balances that had accumulated. This large amount naturally cut the rate down a great deal.

In 1896 they used \$15,000 of unexpended balances. The rate went up 20c. over the previous year.

In 1902 there was a law passed which provided that after that date the largest amount that could be used of unexpended balances was \$5000, and that any amount over this would be accumulated to the credit of the City. Each year since 1902 there has been \$5,000 used towards decreasing the assessments for the next year, and, notwithstanding that there is at precent accumulated from this source \$48,000. If the present City Council could use this \$48,000 towards running the City next year the rate would be decreased about 20c, and instead of it being about \$1.70 it would be about \$1.50, so that from this comparison it will be seen that the rate has practically remained the same for the past few years, and this in spite of the fact that "Schools" is costing us \$46,000 more than they did ten years ago ; and, notwithstanding the provision made for Sinking Funds to wipe out the paving of Water Street and other permanent work, for which \$250,000 was borrowed, and providing for \$207,000 borrowed last year, the paying of damages for the South Western Railway, the temporary loans and the large amounts which have been paid towards meeting the Provincial Exhibition deficits, and, in addition to this the appropriation for Public Works this year calls for \$72,234, while ten years ago it was \$56,000an increase of \$16,000. I repeat that when all these facts are taken into consideration, the citizens of Halifax should congratulate themselves that their rate of taxation is not higher. No good eitizen should object to the expenditure of money so long as there is something to show for it and the City is improving in appearance. Any observing citizen can see a tremendous difference in Halifax within the past few years so far as its streets, sidewalks, sewers and other improvements are concerned.

A strenuous effort should be made to improve the Assessment Law of this City. It seems absurd to think that the personal property of the citizens of Halifax should be only reckomed by the amount of furniture that their houses contain and the amount of stock in the merchant's warehouse. There are many citizens of Halifax owning large amounts in securities, who are practically paying no personal taxes. It is related that some years ago a citizen of Halifax died, worth about \$1,000,000. He was assessed about \$2000 for personal property. The City of St. John, which is not considered as wealthy as Halifax has, in round numbers, \$9,000,000, while the assessors of this City can only find about one-half that amount. The assessors are not to blame, it is the way the law is worded. The amalgamation of the Peoples' Bank with the Bank of Montreal caused a loss to this City of about \$2500 in taxes.

Another matter that the Council should be impressed with is that a large number of young men residing in the City contribute nothing to its upkeep. There is no effective law to collect poll taxes Other towns and cities in the Province have a very effective way of collecting them, and the act, so far as Halifax is concerned should be changed. Instead of the tax being \$2.00 for a man not otherwise assessed, it should be at least \$3.00 or \$4 00, with the provision that if paid by Debember 31st of each year he would be entitled to a vote.
