# To His Worship the Mayor and City Council :

GENTLEMEN,—Your Committee on Laws and Privileges beg to report that at a meeting of the Committee held this day, there being present Allermen Geldert (Chairman) Johnson and Hawkins, they had under consideration a number of matters which have been referred to them for consideration, and report as follows:

1. Petition of Edward Deal in re expropriation of land for right-of-way Halifax and South-Western Railway.

Your Committee have gone carefully into this matter and from the evidence of the arbitrators, Messrs Bishop and Carmichael who appeared before your Committee, they find that there was an error of \$75.00 made in copying the award filed in Mr. Deal's case. Mr J. A. MacKinnon, the City's Arbitrator, being unable to attend the meeting, wrote a letter to the committee corroborating the statement of the other arbitrators.

Your Committee recommend that under these circumstances the City Clerk be instructed to pay into court an additional amount of \$75.00 making the total award to Mr. Deal \$250.00 as agreed upon.

Your Committee further recommend in this connection that the City Clerk request Mr. MacKinnon to deposit at his office all the minutes, papers, notes and proof sheets in connection with the said arbitration.

#### CHIEF LICENSE INSPECTOR'S BOND.

2. Your Committee report that the City Auditor had written to the committee in reference to the bond of the Chief Inspector of License that the receipts of this department in future would be double the amount heretofore received and that under these circumstances the amount of the bond required should be increased.

Your Committee recommend that the Chief Inspector of Licenses be required to furnish the City with a Guarantee Company's bond for \$10,000.00, this being double the amount now required of him.

# LETTER M. CARNEY, ESQ., AS TO LOT OF LAND AT ESPLANADE.

Ritchie, who made a statement, and called and examined Mr F. W. Hetherington and Ex-Mayor Crosby. After carefully considering the evidence submitted (not taken under oath or subject to cross-examination by counsel on behalf of Mr. Monaghan) your committee are of the opinion that the charges made have not been sustained

# REPORT CHIEF LICENSE INSPECTOR OF CERTAIN ALLEGED VIOLATIONS OF LIQUOR LICENSE ACT.

9. Your Committee had under consideration the report of the Chief License Inspector re certain violations of Liquor License Act.

Your Committee recommend that the Inspector should promptly investigate all charges reported by the police and prosecute in all cases unless satisfied as the result of his enquiries that no offence has been committed or that no conviction could be obtained.

# AN ORDINANCE RELATING TO SNOW ON SIDEWALKS AND GUTTERS IN THE CITY OF HALIFAX.

1. It is hereby ordained and enacted that Section 1 of Ordinance No. 79, entitled "An Ordinance relating to snow on the sidewalks and gutters in the City of Halifax" is hereby amended by adding at the end of said section the following words: "and also

including the properties on both sides of Carleton Street lying to the north of Spring Garden Road "

Moved by Alderman Johnson, seconded by Alderman Murray, that seid Ordinance be now adopted and forwarded to the Lieutenant-Governor-in-Council for concurrence. Motion passed.

His Worship the Mayor here vacates the chair which is taken by Alderman Johnson, Deputy-Mayor.

Read an ordinance to regulate electric wiring and the use of electricity. Third reading.

# AN ORDINANCE TO REGULATE ELECTRIC WIRING AND THE USE OF ELECTRICITY.

Be it enacted by the Mayor and Aldermen in City Council, assembled :-

1 No electric current shall be used for illumination, decoration, power or heating except as hereinafter provided.

2. Every person, firm or company desiring to instal wires or other apparatus for the transmission or use of an electric current for any of the purposes mentioned in the next preceding section of this Ordinance, before commencing any electrical construction work of any kind whatever, either installing new electrical apparatus or repairing or altering apparatus already in use in any building on, over or under any street or any public or private property, shall file an application for a permit therefor with the City Engineer, which application shall specify in detail such material and apparatus as it is desired to use with a full description of the same, giving the location of the place where such installation is proposed, by street and number, and without a permit no such work shall be done.

3. Every such application shall be examined by the City Electrician and a permit shall not be issued thereupon until he reports in writing that the same should be issued.

4. A permit shall be valid only for the time named therein.

5. The (ity Electrician shall be notified when any work is ready for inspection and all work must be left uncovered and convenient for examination until inspected and approved. The inspection shall be made within two working days after receipt of notice and without any unnecessary delay.

6 The owner or occupier of any building shall not use any wires, fixtures or apparatus for carrying or using electric current until such wires, fixtures or apparatus have been finally certified as correct by the City Electrician.

7 No company supplying electric current shall connect its wires with the wires on or in any building until a permit is obtained from the City Engineer for such connection.

8. The City Electrician may issue a temporary permit for the use of electric current during the course of construction or alteration of buildings, which permit shall expire when cancelled by the City Electrician

9. The City Electrician shall, whenever he deems it necessary so to do, carefully inspect any installation for which a permit is issued previous to or after its completion, and if such installation has been constructed according to the rules and regulations contained in this Ordinance he shall issue a certificate to that effect.

10 A preliminary certificate may be issued by the City Electrician in the case of completed installations, but upon which no lighting or power current will be used in the immediate future. Such preliminary certificate shall show that at the date of inspection the installation was completed in accordance with the terms of this Ordinance. But before the introduction of electric current into the premises a second or final inspection

shall be made, when, if the installation is still in accordance with the terms of this Ordinance a final certificate shall be issued.

11. The said City Electrician shall inspect all overhead, underground and interior wires and apparatus conducting electric current for light, heat or power, and when any such wire or apparatus is found to be unsafe for life or property he shall notify the persons, firms or corporations owning, using or operating the same to put the same in a safe and secure condition within forty-eight hours. Any person, firm or corporation failing to comply with such notice within forty-eight hours after the receipt thereof shall be liable to a penalty not exceeding fifty dollars.

12. In case of emergency where the necessary delay in obtaining a permit would be dangerous to life or property temporary repairs may be made without a permit, but in any such case an application shall be made for a permit within twenty-four hours after the temporary repairs have been commenced and the application shall state the nature of the work done.

13. In any work performed under the provisions of this Ordinance the rules and regulations of the National Board of Fire Underwriters shall be strictly observed.

14. A Board of Wiring Examiners is hereby constituted, to consist of the City Engineer and City Electrician. The Board shall be called together by the City Eugineer (who shall be Chairman of the Board) at such times as he considers necessary.

15. No person shall carry on the business of interior wiring anless he is duly licensed to carry on the same and is registered as such in the office of the Clerk of Works. The person obtaining such license shall pay to the Clerk of Works the sum of ten dollars for the same.

16. To entitle any person to a license under the next preceding section of this Ordinance he shall be of the full age of twenty-one years and have a place of business as an electric wireman in the City of Halifax, and shall agree as a condition of obtaining such license to carry on business in compliance with the rules, regulations and requirements of this Ordinance.

17. Every person before doing any interior wiring for or on account of himself or any licensed wireman shall be a practical and experienced wireman and furnish the Board of Wiring Examiners sufficient evidence that he is capable of properly doing and performing interior wiring work, and if the Board is satisfied of his competency to perform such work it shall cause his name to be registered in the office of the City Electrician and the City Electrician shall give him a certificate of competency as a journeyman wireman, after which he shall be at liberty to do such wiring work, but not before.

18. Every person desiring a license as a licensed wireman or a certificate as a journeyman wireman shall file a petition in writing with the Clerk of Works, giving the name of the applicant, and if the applicant is applying for a licensed wireman's license he shall state in his petition his age and place of business in the City and such petition shall be accompanied with the bond hereinafter referred to.

19. Any change in the location of the business of any licensed wireman shall be promptly reported to the Clerk of Works.

20. Any journeyman wireman desiring to become a licensed wireman shall first comply with these rules and regulations as to licensed wireman, and no jouneyman wireman shall do business as a licensed wireman until he has obtained a license, notwithstanding anything in these rules and regulations.

21. Any journeyman wireman who furnishes satisfactory evidence to the Board of Wiring Examiners that he has been engaged as a practical and experienced journeyman wireman for four years next previous to January 1st, 1906. shall be entitled to receive registration without examination.

22. Every licensed wireman shall be held responsible for everything done by any person in his employ in connection with the wiring work in respect to which a license is granted.

23. Every licensed wireman shall employ only certificated journeymen wiremen to

do wiring work, but the work may be done and performed by any practical wireman under the guidance and direction of a certificated journeyman wireman then present directing the work. He see al news in flate at north stars with it , play also ad links

# TERMINAL FACILITIES.

MAYOR'S OFFICE, Feb. 8th, 1906.

Members City Council :

GENTLEMEN, -In the report of the Commercial Committee made to the Council on May 26th last, among other matters attention was drawn to the necessity of removing the car and locomotive sheds from their present location at Richmond in order to provide additional track facilities. By resolution of Council the report of that Committee was forwarded to the Minister of Railways and Canals The Railway Department has decided that in order to provide the additional accommodation required it will be necessary to remove the car and locomotive sheds as suggested and to locate them either within or just outside of the City limits, wherever the best site can be obtained. Con-siderable difficulty has been met with in the search for a desirable location within the City limits. I have all along endeavored since this matter has been under discussion to press upon the Minister and the officials of the department the desirability from a Halifax standpoint of locating the works in the City that the men employed in such works should not be compelled to move out of the City in order to reside in the vicinity of the car and locomotive sheds should they be located outside. I am in receipt of a letter from the Minister of Railways in reference to this question which I transmit herewith for your consideration.

I would suggest that the whole matter be now referred to the Committee on Works for investigation and report.

DEAR MR. MAYOR—For some time my Department has been considering the advisability of purchasing additional property at Halifax to extend the terminal facilities of the I. C. R. and for the erection of car and locomotive sheds It has been pointed out that a desirable location can be had at Richmond, extending from the old station house in a northerly direction a distance of about 1600 feet. The land available between the side line of Campbell Road and the present property of the I C. R. is hardly sufficient for our purposes. If, however, the City would give to the I. C. R. that portion of Campbell Road extending from a point opposite the old station house at Richmond northwardly to where Campbell Road crosses the tracks this would give us sufficient room t or our immediate requirements.

I should be glad if you would lay this matter before your Council and favor me with their views at an early date, so that my Department may take the matter into full consideration.

SIR,—In accordance with the accompanying resolution of Council, I beg to report on the probable cost of widening Jacob Street on the south side from Brunswick Street to Barrington Street.

A survey and plan has been made shewing the property that would be taken to make the street a legal width between the points named. I have estimated the land damages taking into consideration the assessed value of the property, the quantity of land that would be left in each block and the cost of work to be done in widening. #### To His Worship the Mayor and City Council:

GENTLEMEN,-Your special Committee appointed by resolution of Council of the 10th November last to consider and report upon the advisability of combining in one tender the quantities of the same commodity required by different committees, beg to report as follows :-

A meeting of the Committee was held on the 15th day of February last, there being present Alderman Gastonguay, Halliday and Cawsey. Alderman Gastonguay was appointed Chairman. The Committee had before them for consideration statements prepared by the secretaries and superintendents of the different committees and instutions showing the probable quantity required of each commodity used in their respective departments, and after carefully going over the various items your Committee are of the opinion that it would not be in the interest of economy to recommend any change in the mode of purchasing supplies, except in the item of coal.

Your Committee recommend that all coal required for city purposes be advertised for in one tender and that the Chairman of each Committee send in to the Chairman of the Special Committee on Tenders a detailed report of the quality of coal required for their respective services, not later than the end of June in any year.

# REPORT LAWS AND PRIVILEGES COMMITTEE.

COMMITTEE ROOM, CITY HALL, Feb. 20th, 1906.

To His Worship the Mayor and City Council:

GENTLEMEN, -Your Committee on Laws and Privileges beg to report that at a meeting

of Committee held this day, there being present Alderman Geldert (Chairman) Johnson, Gastonguay and Hubley, they had under consideration a number of matters referred to them for consideration and report, as follows :---

1. Application of John T. Murphy for refund of deposit made by him with his application for liquor license

Your Committee recommend that the amount deposited less the cost of advertising be refunded Mr. Murphy.

2. Re Chief License Inspector's Bond :-

Your Committee having reported on this matter at the last meeting of the Council and the same having been referred back to them for further consideration, after carefully looking into the matter recommend that as it is not in their opinion expedient at the present time to abolish the offlice of Chief License Inspector that the amount of the bond furnished by the Inspector remain as at present, but that each applicant on making application for his license be instructed to pay to the City Treasurer the amount of the license fee and that the license shall only be issued upon production by the applicant of the City Treasurer's receipt therefor, and not otherwise.

Further, that the fees payable by applicants for lists of the License Inspector be paid to the City Treasurer the same day they are received and that no lists be furnished until such fees are paid.

That all fines and costs in connection with prosecutions be paid fo the City Clerk and be deposited by him to the credit of the License Fund.

3. Re borrowing of \$150,000.00 for permanent pavement :

Your Committee have instructed the City Recorder to prepare the draft Act in accordance with the resolution of Council and recommend that the City Engineer be instructed to report to the Council on what streets the money is to be spent.

4. Re Notice of Action and Writ of Summons: E. L. Fenerty et al vs. The City of Halifax :--

Your Committee recommend that this matter be left in the hands of the City Recorder with instructions that he protect the City's interests in the matter.

Read clause 2 re License Inspector's Bond.

Read clause 3 re borrowing \$150,000.00 for sidewalk paving-Passed.

Also read notice of action (submitted this meeting) by E. L. Fenerty et al against the City.

Moved by Alderman Hawkins, seconded by Alderman Murray, that said clause be adopted. Motion passed.

Moved by Alderman Geldert, seconded by Alderman Johnson, that said report as amended be adopted. Motion passed.

Read letter R. E. McKav, Pictou, N. S., covering circular notice of application for incorporation of Grand Trunk Pacific Branch Lines Co.

Moved by Alderman Doyle, seconded by Alderman Lamphier, that the same be referred to the Committee on Laws and Privileges for report. Motion passed.

Read petition for concrete sidewalk and other improvements on the south side of Spring Garden Road.

Moved by Alderman Powell, seconded by Alderman Murray, that the same be referred to the Committee on Works for report. Motion passed.

Read report Board of Fire Wards recommending the borrowing ot \$3700.00 on short term debentures for the purchase of hose and \$26,700.00 on long term debentures for improvements in the Department.

# REPORT BOARD OF FIRE WARDS.

#### COMMITTEE ROOM, CITY HALL, March 6th, 1906.

#### His Worship the Mayor and City Council:

GENTLEMEN, — There is a growing feeling in the community that the city has not in the past dealt as generously in the matter of placing the Fire Department on a sound footing as the citizens are now in the mood to do.

A tangible expression of this view was given last year when the sum of \$30,000 was borrowed for improvements so urgently demanded that they could no longer be denied. Further evidence was also given last December when the appropriation for running expenses was increased about \$3,000 over the previous year.

The Chief Engineer has condemned the two steam fire engines which have been forty-five years in service; the residental portion of the city is rapidly spreading, and generally the necessity for the most improved fire extinguishing appliances is becoming universally recognized.

The populous south-western part of the city requires better protection than is at present furnished and a combination chemical and ladder truck is recommended as most suitable for this service.

The City is now under contract to purchase one new steam fire engine of 1000 gals. capacity, but another one of smaller capacity—650 gals —must be procured to take the place of one of the old engines to be put out of commission.

For years the Department has been endeavoring to obtain an aerial ladder and the Board believe the time is now ripe to press for the installation of this equipment. The great net-work of telephone and electric light wires in the front of buildings, always increasing, makes the old-fashioned ladder of little or no use in the business sections and those of the so-called aerial design are the only kind that can be erected in a modern city.

The City is short of  $2\frac{1}{2}$  inch hose, 2000 feet being required, and the new water front engine will require 1000 feet of 3 inch hose and a waggon to carry it on.

The Bedford Row house absorbed about \$8000.00 of what otherwise would have been used for the new west end house and this amount will have to be restored.

In order to insure the arrival at fires of the call men with the apparatus, it has

been found necessary to place tappers in the houses of nearly all of these men and this will require \$500 in addition to the amount already outlayed for a portion of this equipment.

In the present report the Board is asking for loans amounting to \$30,400-\$3,700 on Short Loan Debentures and \$26,700 on Long Term Debentures. These figures without close inspection might lead to the belief that a very great deal is being done in a short period for the perfecting of the Department, but an analysis does not warrant the first impression. In the first place, \$28,000 is for the erection of two new engine houses in which to store the apparatus and does not count at all in the actual fighting of fires ; and secondly, \$25,000 is to purchase four pieces of apparatus in place of two engines condemned and to properly equip the ladder and chemical departments. For these reasons the Board requests that legislation be sought to enable the City to borrow the amounts given below :

# AN ACT TO AMEND CHAPTER 89, THE REVISED STATUTES "OF FIRES AND FIREWARDS."

# Be it enacted by the Governor, Council and Assembly as follows :--

Sections 26 and 27 of Chapter 89 of the Revised Statutes "Of Fires and Firewards" is hereby repealed and the following substituted therefor :--

26. When any building or property is injured or destroyed by fire; and the cause or origin of the fire is unknown :--

- (a) The Mayor of any City in such City;
- (b) The Mayor of any incorporated town in such town, or
- (c) Any justice of the peace in any other part of the Province,-

may, and on the passing of a resolution by the Council of the City, town or municipality within which the fire occurred, or on receiving a request in writing from any Board of Trade or from the Nova Scotia Board of Fire Underwriters, or from any person or Company who has insured the building together with security for the expense of the investigation,—shall cause an investigation to be made into the cause or origin of the fire, and the person, if any, profiting thereby.

Section 27 of the said Act is amended by striking out the words "the City of Halifax by" in the third line, and substituting therefor the words following :

"Any city by a judge of a county court."

Moved by Alderman Cawsey, seconded by Alderman Powell, that the capacity of the engine proposed to be purchased be amended to read "about 650 gallons" instead of "650 gallons" as recommended. Motion passed.
