The City Council met this afternoon at the above named hour, pursuant to adjournment. Present, His Worship the Mayor and Aldermen Archibald, Johnson, Powell, Murray, Gastonguay, Taylor, Doyle, Lamphier, Hubley, Martin, Campbell, Cawsey and MacKenzie.

Moved by Alderman Johnson, seconded by Alderman Murray, that the Order of the Day be suspended to permit the reading of the papers submitted at this and the last meetings. Motion passed.

Read by title "An Act to provide a Superannuation Fund for the City Officials or employees of the City of Halifax."

Moved by Alderman Murray, seconded by Alderman Powell, that said Act be now considered clause by clause.

Motion put and lost, 3 voting for the same and 7 against it on a show of hands.

The said Act is now read.

# AN ACT TO PROVIDE A SUPERANNUATION FUND FOR THE CITY OFFICIALS OR EMPLOYEES OF THE CITY OF HALIFAX.

Be it enacted by the Governor, Council and Assembly as follows :-

1. There shall be established a Fund for the Superannuation of the officials and employees (except those of the Fire and Police departments), of the City of Halifax, to be constituted and employed as specified in this Act, and to be known and designated as the Halifax Officials Superannuation Fund.

2. The Mayor, the Auditor, the Treasurer and the Chairman of the Committee on Public Accounts of the City, shall be the trustees of the fund, and the Treasurer shall be the Treasurer thereof. The fund and all accounts in connection therewith, shall be kept separate from the other moneys and accounts of the City, but shall be audited by the Auditor of the City in like manner as the other accounts of the City, and shall be managed by the trustees subject to the control of the Council. The fund may be invested in any investment authorized by the Trustees Act. 3 - (1). The moneys of the fund shall not be drawn out except on the cheque or order of the trustees, or any two of them, one being the treasurer.

(2). Such cheque or order shall not be made except upon the authority of a resolution of the Council passed upon a report of the Committee of Public Accounts, recommending the payment.

4. The trustees shall make an annual report to the Council respecting the amount and state of the fund, showing how the same is invested and the name of every person receiving payment from the same, with the amount of the payment.

5. If the fund in any year is not sufficient to meet all the claims against it the sum required to meet any deficiency shall be paid out of the revenues of the City and shall be provided for specially in the estimates and raised with the other rates

6. Every official or employee of the City, at the passing of this Act, who is appointed for life or good behavior, or who is annually reappointed, and who is, at the passing of this Act, under the age of fifty-five years and every official or employee who is hereafter appointed to any office of the City held for good behavior or which is annually filled by appointment, shall contribute to the fund an amount equal to four per cent. of his salary, such amount to be deducted monthly from his salary.

7. Any such official or employee of the City, who at the passing of this Act, is over the age of fifty-five years, may, at his opinion, contribute such amount of four per cent. on his salary to the fund, and in such case, shall be entitled to receive an allowance from the fund as hereinafter provided.

8.-(1) Any of the employees of the City in connection with the department of City Works named in the Schedule hereto, or at any time designated by resolution of the Council, who is in the employ for the City from year to year, but not continuously, and who is not paid a uniform salary or wages, may at his option contribute to the fund and be entitled to receive an allowance therefrom

(2) The contribution paid by any such employee shall not be less than twelve dollars a year, necessarily in monthly instalments and shall entitle him to an allowance based on a yearly salary or wage of three hundred dollars, but if any such employee contributes a larger yearly amount than twelve dollars he shall be entitled to receive an allowance based upon such salary or wages as will yield at four per cent. such increased contribution; provided the total allowance does not exceed three hundred dollars per annum.

9. Every official or employee who has contributed to the fund for ten years or more, and who has reached the age of sixty-five years may be premitted by the Council to retire from his employment, and to receive from the fund an annual allowance for the remainder of his life, such allowance shall be determined by the average amount of the yearly salaries on which he has contributed, and shall be equal to one-fiftieth of such average amount for each year in which he has contributed provided that in no case shall the amount of such allowance exceed thirty-fiftieths of such average amount.

10. Every official or employee who has contributed to the fund for thirty years or more and who has reached the age of sixty-five years shall be entitled to retire from his employment and to receive from the fund for the remainder of his life an annual allowance equal to thirty-fiftieths of such average amount of his salary.

11.—(1) Every official or employee who has contributed to the fund for ten years or more, and who has been declared by the Council on the report of two physicians, one of whom shall be the City Medical Officer, unless he is personally interested, to be incapacitated or unfit for the discharge of his duties, and is retired from his office or employment, by a two-thirds majority vote of the whole Council, shall receive from the fund an annual allowance computed as hereinbefore provided until the amounts so paid by way of allowance, equal the amounts which he has contributed to the fund with interest thereon at three per cent. per annum, and that thereafter he be paid from the general revenues of the City, to be raised by taxation, such allowance as the Council determines. (2) Nothing in this section shall apply to any official or employee who is dismissed by the Council for misconduct or other cause.

12-(1) An official or employee who is permanently appointed and who has contributed to the fund for not less than two years, and who voluntarily retires from employment by the City without being permitted to receive an allowance on retirement as hereinbefore provided, or who is dismissed by the Council for cause, shall be entitled to receive from the fund in one payment, one-half of the total amount which he has contributed, without interest.

(2) Any official or employee who is appointed from year to year, and any official whose office is abolished by law and who contributed to the fund for not less than two years, and who fails at any time hereafter to be reappointed or whose office is abolished, shall be entitled to receive from the fund, in one payment, an amount equal to the total of his contribution, without interest.

(3) In no case shall any official or employee, who has contributed to the fund for less than two years, be entitled to receive any allowance or payment whatever from the fund.

13. If any official or employee, who has contributed to the fund, dies before being superannuated, leaving a wife or child, who is a minor or who is dependent upon him; such wife or child shall be entitled to receive from the fund, in one payment, an amount equal to his total contributions, without interest.

14. If any official or employee who has been superannuated, dies before he has received in allowances, an amount equal to his contributions, leaving a wife or child who is a minor or who is a dependent upon him, such wife or children shall be entitled to receive from the fund, in one payment, an amount equal to the difference between the amount which he has received and the total amount of his contributions, without interest.

15. In either of the cases specified in the next two preceding sections, if the official or employee leaves at his death no wife or child, but leaves a mother or father, or sister or other near relative, dependent upon him, the trustees of the fund may in their discretion pay to such relative the amounts in such sections directed to be paid to such wife or child.

16. Any person who has been in the employ of the City for not less than thirty years, and who has contributed to the fund for not less than ten years, and who has reached the age of sixty-five years, may be permitted by the Council to retire from his employment, and to receive for the remainder of his life an annual allowance equal to thirty-fittieths of his average salaries, as hereinbefore specified, and the difference between the amount of the allowance which he is entitled to receive from the fund, and the amount of such thirty-fiftieths, shall be paid out of the general revenue of the City raised by taxation.

17. All allowances paid under this Act shall be paid quarterly in advance.

HALIFAX, April 4th, 1906.

#### To His Worship the Mayor and City Council:

GENTLEMEN,—The Charities Committee met this day and beg to submit the followng report; Members present—Alderman Gastonguay (Chairman) Powell, Halliday, Lamphier and Campbell.

The Superintendent's report for March shows that during the month there were 41 persons admitted into the Poor's Asylam, 3 born, 44 discharged and 4 died. ROYAL ENGINEERS OFFICE, LUMBER YARD, HALIFAX, N. S., 4th April, 1906.

SIR,-I have the honor to refer to a letter dated 21st April 1904 from the Mayor which was delivered personally by him to Sir Charles Parsons who handed it to the Commanding Royal Engineer.

This letter refers to the Clock Tower on the Citadel Hill, and stated that if it was put into repair the City Council would take it over and keep it at the expense of the City. The Mayor subsequently informed the Commanding Royal Engineer that the repairs alluded to referred to the building generally.

The clock itself required no repair, and is now going correctly.

The Militia Council has authorized an expenditure of \$500 (five hundred dollars' on the building if the City Council will then take it over and keep it in order in the future.

The \$500 will be sufficient to place the building in good repair externally, including painting. The building contains several rooms, and if an additional sum was expended ;t could be made available for occupation.

It is suggested that if they wish to use it as a residence the City Council would provide this additional sum in consideration of obtaining a building which could be made very useful for such a purpose. If the Imperial Troops had not been withdrawn, it would have been converted into a residence for a warrant officer.

At one time the building was used by the Military Police and before that as a hospital for women and children.

The clock tower is of historical intererest to Halifax. Owing to the uncertainty about the future, it has not recently been occupied; and the building has become unsightly from want of painting, etc. The proposal now made seems the best solution of the question of its proper maintenance.

Should the City Council be in favor of its acceptance it is possible that they may prefer to receive the \$500 and carry out the repairs themselves—there is not likely to be any objecton to this course being taken.

Will you kindly let me know if the City Council is in favor of the proposal now made, which is briefly that they will accept the responsibility for the future care and maintenance of the clock, clock tower and buildings attached if \$500 is spent on repairs; or, if they prefer it, they may receive the \$500 on the understanding that this sum is spent on the repairs.

On hearing from you it will be necessary to draw up an agreement and communicate with the Militia Council

### HALIFAX, N. S., March 30th, 1906.

### His Worship the Mayor and Honorable Members of the City Council :

GENTLEMEN,—Some time ago the Halifax Rifles Armouries Association purchased the Downs property on the corner of Agricola and Cunard Streets for the purpose of erecting thereon regimental headquarters. As you are aware, a portion of this property was expropriated by the.City of Halifax for the widening of Agricola Street. The loss of this strip of land left the Association without sufficient land for their proposed building, and, in order to carry out their scheme, they have been compelled to purchase the adjoining property on Cunard Street, owned by the late Alex. McDonald. There is a dwelling house on the McDonald property and our plans provide that the new building will run to the rear of this dwelling. It is proposed, now that the corner lot is cleared, to begin construction very shortly, and after the building is constructed it will be impossible to move this dwelling house to any other portion of our property. The Association is advised that the City intend in the near future to widea Cunard Street at this point, and it has been suggested that if Your Worship and the City Council were approached with an offer to sell to the City a portion of this property which they might eventually have to expropriate, the City might make a purchase at this time, as it could be bought now for a much smaller amount of money than were it to be expropriated after the new building has been erected.

The Association is prepared to offer the strip of land necessary for the widening for the amount of money which would cover the necessary removal of the above mentioned dwelling house and the value of the land to be taken. Expert valuators have placed the cost of removal and the value of the land at \$800.00, and the Association has instructed me to offer you this strip of land for that sum. You will understand that this offer is made upon the condition of its being accepted before the Association begins its building operations.

### OLD EXHIBITION PROPERTY AS SITE FOR C. OF E. CATHEDRAL.

#### HALIFAX, N. S. April 12th, 1906.

#### To His Worship the Mayor and Councillors of the City of Halifax :

SIRS,—Presuming that the application regarding the selling of a portion of the old Exhibition Grounds as a site for a Cathedral is to receive consideration at to-day's meeting of the Council, we beg leave to draw your attention to the following points:—

The Cathedral Committee has been awaiting for some time the decision of the Council, and the delay is very seriously interfering with their operations, inasmuch as they are unable to take any definite action until the question of a site has been settled.

The chief objection so far as we have been able to ascertain against the sale of this property is that it would entail the expenditure of a considerable sum of money to replace the present City sheds. To meet this objection we would say that while six lots making a depth on Morris Street of 300 feet have been applied for, that the Cathedral Site Committee would be quite satisfied for the present to secure five lots or 250 feet depth on Morris Street, with the option on the sixth or adjoining lot, at the same pro rata price, said option to take effect whenever the City is in a position to remove the portion of the sheds on that lot. By selling as above only a very small part, if any, of the main sheds would have to be removed, so that the guestion of providing new sheds need not at present be considered. It seems to be the general opinion that it is only a question of a few years when these sheds owing to their dilapidated condition will have to be renewed; and as it will probably take from two to three years to build the Cathedral, the question of the removal of the sheds can be left for at leas. that length of time.

There is also the objection made respecting the necessity of removing the City stables situated on College Street. In regard to this we would say that no doubt if it is found that these stables are on the rear end of the lots applied for as a Cathedral site, an arrangement can be made allowing the City to use the necessary portion of the lot or lots until such time as it is desirable to remove the stables.

The objection in regard to the loss of income from the old Exhibition Building is not a very formidable one. Taking the value of the six lots at \$2500.00 each, which appears to us a high valuation but which we are quite willing to pay, the interest at 4% would

be \$600.00. The St. Luke's site and property at the corner of Spring Garden Road, excepting St. Stephen's Church which is not to be closed until the Cathedral is completed are to be put on the market. Putting the assessment at \$10,000.00 would mean about \$175 00 per year in taxes. There can be no question that the balance between the \$775.00 as above and the net income from the Rink would be more than offset by the increased assessable value of said real estate, owing to the erection of residences.

The proposed removal of St. Stephen's Church to the Cathedral site during the erection of the Cathedral has been abandoned. It is however, the intention to dispose of same as soon as the Cathedral is completed.

The question of giving a proper title has been raised. We do not think that this need stand in the way. If it is found that the City cannot give a satisfactory title, we presume it is only necessary to have an Act put through the Legislature giving the necessary authority, in which case the Site Committee is willing to buy subject to such legislation being obtained either at this or the next session of the House.

It must be acknowledged that the public sentiment is strongly in favor of the City selling the proposed Cathedral site, as indicated by the petition presented to you signed by a large number of the ratepayers. We therefore trust that the matter will meet with your immediate and favorable consideration.
