#### REPORT CITY PRISON INVESTIGATING COMMITTEE.

#### HALIFAX, N. S., Oct. 14th, 1907.

#### To the Mayor and City Council :

GENTLEMEN,—The special committee appointed at the meeting of the City Council, held on the 16th day of September last, to make inquiries into certain accounts of Mr. George F. Brady for work done and materials provided for the City, beg to report as follows :—

The Committee first met and organized on September 17th, 1907. On Sept. 18th, the members of the committee met at the City Prison (with the exception of Alderman Archibald, who was absent from the City at the time) with Mr. Brush, the City carpenter, and Mr. Murray, the Governor of the prison, and made an examination of the work done by Mr. Brady and mentioned in his accounts, except a small portion of the same which had been destroyed by the fire on August 1st, 1907. The Chairman made a second inspection of the work in company with Alderman Archibald and the City Carpenter.

The Committee was advised by the City Solicitor that it had no power to enforce the attendance of witnesses, or to administer an oath to any witness who voluntarily attended. Consequently, the only course open to the committee was to request the attendance of the parties whose names were submitted as witnesses and to take their unsworn statements. Of those whose assistance was so sought, three only, namely, Mr. Brady, whose accounts were under examination, and Aldermen Hawkins and Martin, declined to appear or make any statement before the Committee, and the Committee was, in consequence, obliged to proceed without their aid in making the investigation ordered by the Council.

The Committee had several sittings and examined some sixteen witnesses.

According to the terms of the reference, the investigation divides itself into four subjects of enquiry as follows :

1. To enquire whether the City received value for the amount of Brady's account of \$450.00;

2. To enquire whether the City received value for the amount of Brady's account of \$467.00; and if not, who is responsible ?

3. To enquire as to the quality of the material used by Brady and the work done ;

4. To enquire as to the persons by whom the said several services were performed.

#### I.

#### BEADY'S ACCOUNT FOR \$450.00.

According to the minutes of the Prison Committee, held on February 8th, 1907, a motion was adopted requesting the City Engineer to prepare a specification of the repairs necessary to the prison, and to get prices for having the work done.

At the meeting held on April 19th, the report of the Engineer was received and it was moved by Alderman Hubley, seconded by Alderman Douglas, that the matter of effecting the repairs be left with the Chairman (Alderman Hawkins), and that he be authorized to have the work done. At a meeting of the same Committee held on May 7th, 1907, Alderman Hawkins reported that he had engaged Mr. Brady to do the necessary repairs to the prison property.

With respect to the proceedings of both those meetings, it is to be noted that they were not reported up to the council in so far as they related to the repairs. Mr. Rhind, the Assistant City Clerk, says it was an omission on his part, and as he was entrusted with the preparation of the report of the Committee, he must be held responsible for the omission.

There is a difference between some of the members of Prison Committee as to what took place at the meetings of the Committee above referred to.

Alderman Hawkins, as appears from the minutes of the meeting of September 9th, stated that he acted under the authority of the resolution of April 17th, and arranged with Mr. Brady to do the work for \$450.00. Alderman Douglas appears to have taken the same view, while Alderman Shaffner and Alderman Hubley allege that in leaving the work with the Chairman (Alderman Hawkins) they understool that the work was done under the supervision of the City Carpenter. At any rate the work was done and so far as we can learn, without any supervision on behalf of the City, and without such specifications as would be likely to ensure good and proper work for the City.

It must be added that most of the work was done after Alderman Hawkins had ceased to be a member, and after Alderman Hubley became chairman of the prison committee, and when the latter could have intervened in the City's interest, and his explanation that he supposed the work was being done under the supervision of the City Carpenter, cannot discharge him from all responsibility.

The experts who were called to give their opinions, gave various estimates, all of them far below the amount claimed by Mr. Brady.

- The estimate of the City Carpenter for the work is \$237.00 without a profit, and adding 25% for profit we have \$296.25. The Committee are of opinion from their enquirics that \$300.00 would be a fair price to pay an outside contractor for the work for which Mr. Brady claims \$450.00.

#### II.

#### BRADY'S ACCOUNT FOR \$467.00.

This was for work done in 1906, Mr. Brady having been engaged by the Chairman (Alderman Hawkins,) to do the work. The Chairman's action in this matter was approved by the committee after the work was done, and it was ordered by the Council to be paid, and was paid. The lapse of time and the destruction of a small portion of the work represented by this account, present difficulties in forming an estimate of the value of the work done. The estimate of the City Carp enter, o \$177.00 for carpenter work, painting and glazing; with \$40.00 added for repairing plaster and papering dining room, making a total of \$217.00 we take to be as safe an estimate as can now be made. To that amount must be added a profit of, say 25%, which would bring the amount up to \$271.25. The bill was not certified when it was moved in Committee by Alderman Johnson, and seconded by Alderman Hubley that it be paid.

With respect to this work we find that the City did not get value for the amount of Mr. Brady's bill of \$467.00.

# OCTOBER 17TH, 1907.

We are asked also to designate who are responsible for the loss to the City. The whole Committee is responsible. We cannot undertake to make an exact division of the responsibility as between the Chairman and the other members of the Committee, although we see some force in the contention that other members frequently feel obliged to look to the Chairman for guidance in matters of this kind.

#### III.

#### AS TO THE QUALITY OF THE MATERIAL AND THE WORK DONE.

We beg to report with respect to the work included in the amount for \$450 00, that after inspection we find that some of the stock used was poor and some of the workmanship was inferior.

# IV.

# THE LAST ENQUIRY IS AS TO THE SEVERAL PERSONS BY WHOM THE SAID SERVICES WERE PERFORMED.

In this enquiry we are handicapped by the fact that Mr. Brady declined to appear before us. We are informed that he and his son were engaged in the carpenter work done in 1907, and Alderman Martin stated in his place at a meeting of the City Council that his firm (Martin & Moore) painted the Fire Escapes. This last statement receives some coroberation from the statements of Messrs. Keating and McDonald, employees of the City Prison, that Martin & Moore's team took delivery of the paint pots, &c.

In both cases under investigation the work was given to Mr. Brady without competition, and in neither case were the bills itemized so as to show the amount of material or labor supplied.

With the respect to the unpaid account of \$450.00 the Committee desires to state in fairness to the Prison Committee, that the latter were liable to believe from the estimate of the City Engineer that the work would cost about \$500.00.

The City Solicitor submits the opinion attached hereto that there is no contract between George F. Brady and the City covering this bill of \$450.00.

To safegard the interests of the City and to prevent the recurrence of circumstances similar to those under investigation, your Committee have prepared and now submit herewith some recommendations which are supplementary to this report, and for which they solicit the favorable consideration of the Council.

That all work required to be done for the various City services that is not performed by City employees, be subject to competition through tender and contract, except in cases where the work is of such a nature that this is not practicable, and when the work is of such an nature that it is not practicable to have it done through tender and contract, that all bills for such work must be itemized so as to show the exact quantity of any materials used with the price charged for each item ; also the names of the men who perform the work, with the rate charged per day or hour for each man.

#### CHARGE AGAINST ALDERMAN SHAFFNER.

#### HALIFAX, N. S., Oct., 17th, 1907.

#### To The Mayor and City Council,

GENTLEMEN,—The Committee appointed to investigate and report upon the matter of teams of I. B. Shaffner & Co., delivering goods at civic institutions according to a resolution moved by Alderman Hawkins, seconded by Alderman Shaffner, and passed at a meeting of the City Council held on the 12th day of September, 1907, begs to report as follows :—

Alderman Hawkins was requested to attend the meeting of the special Committee, and he wrote the letter which is annexed hereto in which he declined to attend, and expressed his intention of proposing a different line of action, in the Council, with respect to the matter.

Alderman Shaffner appeared, and made a statement before the Committee, as did also Mr. J. J Skerry, merchant of this City Mr. Skerry stated that he had never purchased any goods from Alderman Shaffner and had them sent to the City Prison; that on one occasion he had asked Alderman Shaffner's teamster to deliver some molasses and soap at the Prison for him; and that the teamster did so. The molasses he thought was purchased from N. & M. Smith. He stated furthermore that the articles were delivered without charge to him.

Mr. Gladwin, Alderman Shaffner's book-keeper was called and said that there was no record of any sale of molasses to the prison on the books of the firm, and that he had no knowledge of any such transaction.

Mr. Frank Adams who has charge of 1. B. Shaffner's teams stated positively that no goods went from the firms' warehouse to any city institution, and that he was of the opinion that Mr. Skerry made a mistake and got Shaffner's and Shatford Brothers' teams confused.

Alderman Shaffner who courted the fullest enquiry into the matter, declared that he had no knowledge of his firm or himself selling any goods directly or indirectly to the City; that he had no knowledge of his teams delivering at the City Prison any goods; and that in any event no charge was made for the truckage. He further stated that the City Auditor was at liberty to inspect his books at any time.

The only difference in the statements made by the parties who appeared before the Committee occurs where Mr. Skerry states that the molasses and goods were delivered by Shafiner's team, and Mr. Adams states that Shafiner's teams could not, without his knowledge, and as a matter of fact did not, deliver those articles.

DEAR SIR,—I am in receipt this evening of a notice of this date from Mr. Rhind as secretary of a special committee, appointed by resolution of the City Council to investigate an account of George F. Brady's for repairs to the City Prison, on Wednesday, the 18th day of September, 1907, at 2.30 o'clock p. m., at the City Prison and requesting my attendance thereat, and at a resumed investigation thereon at eight o'clock to-morrow evening at the City Hall.

I have already attended before the City Prison Committee last week and explained to and satisfied it of the City's liability to Mr. Brady, as the work for those repairs was given last year to Mr. Brady by me, on the authority of that committee, on Alderman Hubley's resolution when I was its Chairman, and he was a member of it. The committee at the last meeting of the Council recommended payment of this bill, and with that I beg to respectfully say that I consider my connection with it properly ceases.

If, however, further investigation is necessary, it is, I am advised by the learned City Solicitor, a matter for the learned County Court Judge here, under the provisions of Sections 135-138 of the City Charter, where evidence can be taken under oath, and if that course be adopted, which I submit is the only proper one, I will gladly co-operate with any movemont to have a thorough and legal enquiry made.

#### RECORDER'S OFFICE, September 12th, 1907.

His Worship the Mayor :

SIR,-I have delayed making my report to the Council on the result of this action until I had obtained from Ottawa the reports of the judgment of the Supreme Court.

The action arose out of the assessment on the defendant Company for the \$100 license tax imposed by section 313 of the old charter on all companies doing business in the City. From this the Company appealed to the Court of Tax Appeals. The only question before that Court being whether or not the Company was doing business in the City. That Court was unanimously of opinion that it was. From this judgment the Company appealed to the Supreme Court of Nova Scotia by way of a case stated to which it was entitled under section 343 of the charter. On the hearing a new point was raised by the Company—namely : That the only companies liable to the tax were those of the same class as the Insurance Companies and others specifically mentioned, or what is termed in law the doctrine of idem genus and to the contention our Court acceded. As this was to my mind manifestly wrong and would have had most serious effects for the City, I felt obliged to recommend an appeal. The judgments of the Supreme Court of Canada it will be observed are unanimous in declaring that the judgment of our Court was erroneous.

There still remained the original point in the case—namely—whether as a matter of fact the Company was doing business in the City, and on this the Court was divided in opinion, the Chief Justice and Iddington and Duff, J. J., being of opinion that it was not and Davies and McLennan, J. J., that it was. The result of course is that the City has lost, but it has succeeded in getting rid of a judgment which would have been most unfortunate in its effect and the only practical effect of the judgment will be to somewhat determine the question as to what companies can legally be said to be doing business in the City.

I beg to submit herewith copies of the judgments at Ottawa and also of the case on appeal and of my factum.

Resolved, That the Mayor enter into communication with Mr. McDougall, late Auditor General of Canada, or some other equally qualified gentleman, and ascertain from him on what terms he will undertake to examine the methods of the various departments of this City, and particularly the financial methods practiced in them; and if improvements can be made he suggest the same, and in making such investigation an audit of each department be made, and that the Mayor report to the Council the result of his correspondence.

And Further resolved, That if it is decided to engage such person that the cost of same be included in the next year's estimate.

Your Committee had under consideration a letter of the Board of Trade re letter of F. S. Wright, agent of the London Times in reference to advertising Halifax in the London Times.

Your Committee cannot make any recommendation in this matter as there are no funds available to meet the expenditure, but recommend that a sum be put in next year's estimate to meet such expenditure in the future.

SIR,—Mr. W. B. MacKenzie, Chief Engineer of the I. C. R., asks for the extension of the main from Windsor Street from the end of the pipe north of Young Street to the new railway yard. The estimated cost of the extension is \$1556.80. It will be advisable to extend the high service main to the railway property for fire protection, but it would not be advisable to allow them to draw the supply which they will require from the high service in its present condition. If the low service were in a satisfactory condition it would be better to pump the required supply from the 27 inch main which passes the property. Pumping from the low service main in the present condition of the low service will injure that service almost as much as drawing the supply from the high service will injure the latter. I would recommend that the high service main on Windsor Street be extended to the property for fire protection, but that the supply be taken from it at night only, and that as soon as improvement is made in the low service they be required to take their whole supply, except for fire purposes, from the 27 inch main.

GENTLEMEN, — Your Committee on City Prison beg to report that at a meeting held on the 28th ult., at which there were present Aldermen Hubley (Chairman) Shaffner, Johnson, Martin, Douglas, Hayward and His Worship the Mayor, they had under consideration the matter of effecting repairs to the chimney, which was referred back to them by the Council for specification and estimate of cost.

SIR,-1 beg to report on the accompanying letter and plan from A. M. Bell, Trustee, with reference to property bounded by Windsor St., North St. and Chebucto Road.

Mr. Bell proposes to deed to the City free of charge the land necessary for the widening of Windsor Street, as shewn on the plan on consideration that the City will alter the sidewalk and roadway on Windsor Street, and set out a row of trees on the west side, and further that they will agree to accept the plan for the extension of Willow and Charles Streets so that these streets can be deeded to the City and opened at any time that the owners may consider it in their interest to open them.

With reference to Windsor Street, the proposed alteration is desirable, in fact, absolutely necessary, and will be shewn on the official plan now being prepared. It is not unreasonable to ask the City to move the fence and sidewalk and to plant a row of trees.

The proposed extension of Willow and Charles Streets is in line with the existing streets and on the location already laid down in our draft official plan. These streets cannot be accepted by the City until they have been graded as required by the City Charter. The location of Willow Street will be satisfactory. Charles Street at the west end where it should make the junction with Chebucto Road is obstructed by buildirgs erected within the last few years, and it is not desirable that these obstructions should be permitted to alter the street design in this block. Mr. Bell proposes to make an abrupt turn in Charles Street when it reaches these buildings in order to reach Chebucto Road. Charles Street could not be opened or accepted unless it opens at the west end on Chebucto Road and the junction proposed by Mr. Bell will comply with the Act, but will not comply with the official street design. Mr Bell and the owners of the property are not prepared to go to the expense of moving back the obstructing houses, but offer to agree to give sufficient land in the rear to permit the moving back of the houses.

Under the circumstances I think their proposition is a fair one, and I therefore recommend that it be approved with the exception that the ultimate location of Charles Street shall be in accordance with the official design whenever the City sees fit to carry it out.

Whereas, Nicholas Power, Chief of Police of the City of Halifax, has expressed his wish to resign from that office and from the Police Force of the City;

Resolved, That this Council accedes to the request.

Further resolved, That this Council desires to place on record its appreciation of the long and valuable services rendered to the City by Mr. Power.

He entered the Police Force of the City in the year 1864 as policeman and was made a sergeant in the year 1871. In both positions he evinced the same excellent qualities which became so conspicuous in the higher position to which he afterwards attained. In the year 1882 he was appointed Detective which position he retained until appointed Chief in the year 1905. In all positions, from the lowest to the highest, Mr. Power uniformly displayed all the qualities which make up the ideal police officer dauntless courage in the discharge of his duty, the most complete integrity and recttade of life, industry and zeal that never spared himself in the discharge of his duty, and a ready submission to discipline when in the lower ranks of the service with a firm yet kindly enforcement of it when he had risen to the higher. As a detective the skill and untiring capacity for work with which he unravelled the many difficult problems submitted to him made his name familiar not only in the City but throughout the Maritime Provinces. The term of his officeas Chief has been only too brief, but the admirable condition of the force, in which the citizens can justly take pride, is the best proof of the

manner in which the duties of the office have been discharged. With all the members of the Council both past and present, with the citizens at large and with the members of the force Mr. Power's relations have ever been of the most pleasant. Inflexible in the discharge of his duties in the detection and suppression of crime he has never failed to be at all times and to all persons a gentleman, kindly, courteous and dignified. It is with the most genuine regret that this Council accepts Mr. Power's resignation, but it is most gratifying to them that though long in service Mr. Power is still in full vigor of manhood and the Council expresses the hope that many years of a pleasant and useful life are still in store for him.

SIR,—Since the report of the Committee on Works respecting meters was referred back to the Committee by the Council, I have made a new and careful test of several of the meters submitted, and beg to report the result :--

# NOVEMBER STH. 1907.

In the first freezing the Nash, Empire and Worthington were frozen. The Nash was warped so that the joint opened and leaked. The Worthington was affected in the same way, but the joints were made tight so that the meters could be tested. The Empire meter had the bottom broken and one of the screws holding the piston chamber also broken. Unfortunately in thawing this meter met with an accident and could not be re-tested. The Hersey Company submitted a new meter all bronze, and the National Meter Co. sent a new Empire meter. The Hersey, Trident, Empire, Lambert and Keystone were tested under half pressure and full pressure with the following result :--

The above test was made for the purpose of ascertaining whether any of these meters would register a dribble, but it is not usual to require such a fine test. The specification for meters in the City of Cleveland makes the minimum flow for testing purposes at the rate of about 10 2/3 gallons per hour.

After the foregoing test the Hersey, two Tridents, Lambert, Empire, American and Keystone were frozen The Lambert was provided with a cast iron top, supplied by the makers. The top on the Lambert was broken, but no other damage done to it. The Hersey was opened in the joint, which was afterwards made tight, so that it could be re-tested. The Worthington (formerly frozen) was damaged so that it would not register, and the American and Nash (formerly frozen) to such an extent that they would not register correctly. The injury to the Hersey also destroyed its accuracy. The other meters were uninjured. The result of the test after the freezing was as follows :--

The two Tridents, the Empire and Keystone were frozen the second time, and this time the Empire broke in the bottom and the screw was broken off as before. There was no apparent injury to the Tridents or the Keystone, but the accuracy of the Empire was seriously affected. The broken screw was replaced before testing by a screw from another Empire meter.

The result of the last test after the second freezing was as follows :--

The result of these tests in my opinion justifies the recommendation made in the former report. The Lambert and the Empire show the same percentage of accuracy on the full pressure test, while the Lambert is closer on full pressure test in the first instance. In the dribble test none of the meters registered accurately, some registering too little, others over-registering, which is always objectionable. In the freezing test the Keystone is the only meter besides the Tridents which were not affected by the freezing. As the Keystone has a cast iron top close to the gear wheels as mentioned before, I could not recommend it. My opinion formed as a result of the tests made in 1898, that the Trident was the only meter which is likely to stand the frost without injury has been confirmed by these tests. For houses properly heated, where there is no probability of the meter being frozen, the Lambert makes the best showing for an all bronze meter, considering price, and I therefore adhere to my former recommendation.

A claim has been made by one of the selling agents that disc meters are not as good as piston meters. Piston meters are older than disc meters, which accounts for the number of piston meters in use, but the sales of disc meters in recent years are much larger than those of the piston meters, and companies making meters have been obliged to make disc meters to comply with the demand. In the annual report of 1906 to the Commissioner of Public Works of Chicago, by Walter A. Shaw, Engineer in charge of the Bureau of Engineering, it is stated that the results of the annual tests in 1905 and 1906 was that the disc meter is more durable than the piston type.

I made an effort to get the result of the United States Government test at Washington, but was informed by the Engineer Commissioner that they did not send the information away from the office, but that it would be open to anyone visiting the office. I have also tried to obtain the result of tests made at Cleveland, Ohio, but have not been successful.

#### CANADIAN MUNICIPALITIES CONVENTION.

# HALIFAX, N. S., Oct., 1907.

#### To the Members of the City Council :

GENTLEMEN, — Your delegates to the Seventh Annual Convention of the Union Canadian Municipalities have to report that pursuant to resolution of the Council they attended the Convention which was held at the Twin Cities of Port Arthur and Fort William.

The attendance of delegates was very large, embracing representatives from cities and towns from the East to the West of Canada, and the Convention was most successful.

# NOVEMBER 11TH, 1906.

From the various reports presented it was clearly demonstrated that the Union is on a solid basis and is recognized by both Federal and Dominion Governments as well as by the Railway Commission, as a power to be listened to in reference to matters of municipal government and municipal rights and franchises.

Your representative on the Executive Committee attended all the sessions of the Executive, and both of your delegates were present at all meetings of the Convention.

Amongst the most important matters considered was the question of municipal ownership and operation. On this subject there was considerable diversity of opinion among delegates to the Convention whether or not it is the best course to adopt in every case. Hence no declaration either for or against municipal ownership was made. The following series of resolutions, based on the report of findings of a strong United States Commission, were submitted to the Executive by your delegates and were approved, and were afterwards unanimously adopted by the Convention :--

Moved by Mayor MacIlreith, of Halifax :

Resolved unanimously :--

That in the opinion of this Convention, as public utilities are so constituted that it is impossible for them to be operated by competition, that—

(a) They should be controlled and regulated by the Government, or

(b) That they should be operated by the public; and that they should not in any event be left to do as they please.

Resolved unanimously :---

That in the opinion of this Conventiou, municipal ownership should not be extended to revenue producing industries which do not involve the public health, the public safety, public transportation or the permanent occupation of public streets, and pounds, and similar principles; and that municipal ownership should not be undertaken solely for profit.

Resolved unanimously :--

That in the opinion of this Convention, all future grants to private companies for the construction and operation of public utilities should be determinable at a fixed period, and that meanwhile at certain stated times during such period cities should have the right to purchase the property for operation, lease or sale, paying its fair value.

Resolved unanimously :--

That in the future provision be made for a competent public authority with power to require from all public utilities a uniform system of records and accounts, giving all financial data and all information concerning the quality of service and the cost thereof; data to be published and distributed as official reports.

Resolved unanimously :--

That in the opinion of this Convention, no stocks or bonds for public utilities should be issued without the approval of some competent public authority, thus settling the capitalization by official investigation.

That a standard rate of dividend should be fixed, which may be increased only when the price of the commodity sold or the rate of transportation has been reduced.

Resolved unanimously :--

That in the opinion of this Convention, where the management of public utilities is left with private companies the City should retain in all cases an interest in the growth and profits of the future, either by a share of the profits, or a reduction of the charges; the latter being preferable, as it enures to the benefit of those who use the utilities, while a share of the profits benefits the taxpayers.
