"RESOLVED, That the School Board be requested to adopt the following regulations for protection from fire in the public schools.

1. That all junior or primary classes be held on the ground floor of al school buildings.

2. That an alternative exit be provided from all storeys in schools above the ground floor, except the stairway be fire proof.

3. That all entrance doors in school buildings open outwardly, and be provided with double action bolts instead of locks, and that no door be locked or fastened during school hours.

4. That a fire gong be placed in all school buildings, in such a position as to be heard all over the school, and in cases of the larger buildings, a second gong to be installed, and others if necessary. These gongs to be sounded only in case of fire or for fire drill.

5. The Board to insist on teachers having fire drill at least twice a month, from August to end of October, and once a month during the balance of the year. Fire drills to be reported monthly to the Secretary of the School Board.

6. The School Board to instruct the janitors of all schools to keep the fire escapes clear of ice and snow and other incumbrances.

7. That sheet iron boxes or barrels be provided for ashes, in all cases where the receptacle for holding ashes is not fire proof.

8. That all teachers should be instructed where the nearest fire box is, and how to pull the alarm. And, also that a key to the nearest fire alarm box be kept in the Principal's room, of each school."

ACADIAN SCHOOL.

The Board recommend that primary classes be put on the ground floor, and that a ramp be erected on south side of second storey of the school to the girls' playground on the east side of the school. The pipes of the three stoves being within half an inch of the wood work, should be protected by tin from the woodwork.

ALEXANDRA SCHOOL.

The Board unanimously considered that this school was all right, save that one stove has a crack in its side, and there is no tin under it. They recommend that tin be placed under this stove.

BLOOMFIELD STREET SCHOOL.

The Board unanimously considered that this school was all right, but that the fence erected on the east side of the entrance should be removed, and that the thirteen stoves should be carefully inspected, some of them not being very safe. The Chairman of the School Board and the Supervisor being present, concurred with the above recommendation.

COLLEGE STREET SCHOOL.

The Board unanimously considered this school safe, except that the sheet iron on wall has no air space. It should have an air space between it and the woodwork. The Chairman of the School Board and the Supervisor were present and concurred with this recommendation.

INDUSTRIAL SCHOOL.

The Board unanimously considered this school safe, but unanimously recommended that the hydrant be attached to service pipe. The Chairman of the

A PROPERTY OFF

School Board and the Supervisor were present, and concurred with this recommendation.

MANUAL TRAINING SCHOOL.

As the school in the upper storey of this building is soon to be removed, the Board thought it advisable not to make any recommendation save that the exit door of the building be made to swing out.

MORRIS STREET SCHOOL.

The Board accompanied with the Supervisor of Schools, carefully went through this school house, and think it safe when the following, recommendations are complied with:

1. That all spring doors of the building through which pupils might pass in case of fire be fastened when swung open, by means of a spring catch.

2. That the doors of the cap rooms off the front hall be changed to open into the cap rooms.

3. That all the doors of the building be examined and eased, so as to open and close without catching at the top or bottom.

PROTESTANT ORPHANS' HOME SCHOOL.

The Board, with the Chairman of the School Board and the Supervisor, unanimously considered this building all right.

ROMAN CATHOLIC ORPHANS' HOME SCHOOL.

The Board, with the Chairman of the School Board and the Supervisor, unanimously considered this school all right.

QUINPOOL ROAD SCHOOL.

The Board, with the Chairman of the School Board and the Supervisor, unanimously considered this building safe.

RICHMOND SCHOOL.

The Board unanimously considered this building safe, as there are two independent stairways by which the scholars can reach the ground.

YOUNG STREET SCHOOL.

The Board, with the Chairman of the School Board and the Supervisor, unanimously considered this building safe, save that some of the twelve stoves are not very safe, especially the two in basement with holes in pipe and stoves.

ST. JOSEPH'S SCHOOL.

The Board, with the Chairman of the School Board and the Supervisor, unanimously considered this building safe.

ST. MARY'S BOYS' SCHOOL.

The Board, with the Chairman of the School Board and the Supervisor, unanimously considered this building safe, except that the garbage barrel under the stairs should be removed.

ST. MARY'S GIRLS' SCHOOL.

The Board, with the Chairman of the School Board and the Supervisor, considered this building safe, except that two more sheets of iron should be placed over two of the furnaces.

24

ST. PATRICK'S BOYS' SCHOOL.

The Board visited this school, and found that the Board's recommendations contained in their report to the Mayor and City Council dated June 25th, 1907, had been carried out.

ST. PATRICK'S GIRLS HIGH SCHOOL.

The Board visited this school and found it safe in case of fire save that the ceilings over the pipes should be covered with tin sheathing.

ST. PATRICK'S GIRLS' SCHOOL.

The Board visited this school, and found it safe. They, however, unanimously recommend, owing to the dangerous condition of the furnaces, that the woodwork over the top and around the sides of the furnace be covered with tin sheathing.

ST. PATRICK'S HOME.

The Board, with the Chairman of the School Board and the Supervisor, unanimously considered this building safe.

TOWER ROAD SCHOOL.

The Board unanimonsly recommended that a ramp be erected from the North side of the centre of the building to the ground, and rooms upstairs be connected by doorway, and that a larger area of zinc should be placed under the stove in the hall. The Chairman of the School Board and the Supervisor of Schools concurred in the above recommendation.

JOE HOWE SCHOOL.

The Board visited this school, and found it in a very satisfactory condition, and have no suggestions to make, save that spring catches be put on the spring doors at the exhits, so that when opened to the full extent, they will catch and remain open.

LE MARCHANT STREET SCHOOL.

The Board unanimously considered this school safe, except that there is only one half a pot in one stove, while another stove has a bad crack. The Chairman of the School Board and Supervisor, concurred in the above recommendation.

The Chairman of the Board notified the authorities of the School Board of the above recommendations in regard to all the above named school buildings.

The Chairman was requested, by an unanimous resolution of the Board, to notify the Chairman of the Police Committee, to carry out Sections 6 and 7 of the Third Section of the Building Act. The Chairman complied with this resolution.

QUEEN HOTEL.

The Proprietor of the Queen Hotel has complied with the Board's report addressed His Worship the Mayor and City Council, dated January 12th, 1904.

ST. GEORGE'S CHURCH.

None of the recommendations of the Board contained in their report to the Mayor and City Council dated January 12th, 1904, have been carried out. The Chairman of the Board according to the Provisions of Chapter 90, of the Revised Statutes, asked them to comply with the Provisions of the said report.

Your Committee, in closing this report, wish to express their appreciation of the services rendered to the Board by City Engineer Doane, and also by Chief Broderick. The constant assistance which Chief Broderick has given to the Board has been of infinite service to them.

ALFRED WHITMAN.

Chairman Board of Fire Escapes.

SIR SANDFORD FLEMINGS PARK.

Read letter April 11th from Sir Sandford Fleming to Ex-Mayor MacIlreith, confirming telegram of same date offering part of the Dingle property at the North West Arm as a rublic park for the City of Halifax; also read letter April 22nd, Ex-Mayor MacIlreith in reply.

YOUR WORSHIP,-I have just received your letter of April 8th in reference to the matter of the City of Halifax obtaining a portion of the Dingle property for the purpose of a public park.

I am quite in favor of the movement, but I am afraid, if the legislature is not likely to be in session later than the 16th there is not now time to arrange terms and conditions for any special legislation. If however, as you indicate, a short Act in general terms can be obtained the details may be worked out later.

DEAR SIR SANDFORD,—I have to acknowledge the receipt of your telegram of the 11th instant and your letter of the same date,

On receipt of your telegram I at once sent a message to the City Council, a copy of which I enclose herewith, and they unanimously adopted the suggestion made therein that an Act in general terms should be at once introduced in the Legislature. The Legislature passed the Act in question and I now enclose copy herewith for your consideration. It is modelled after the Act respecting Point Pleasant Park in this City and I trust will meet with your approval. You will notice that the Commission is to be made up of three persons to be aominated by you, the Mayor for the time being and three Aldermen of the City to be appointed yearly by the Council. In the case of a vacancy occurring by the resignation or otherwise of any of the three persons nominated by you the vacancy so created is to be filled by a person to be nominated by you. In the case of Point Pleasant Park the appropriate a sum not less than \$750.00 for the maintenance of the proposed park to be established through your generosity on the southern portion of your property. I would be glad to hear from you as to whether the Act meets with your approval and if it does would suggest that you nominate the three persons to be named by you as members of the proposed Commission. At the same time, if you so desire, if you will have the deed of dedication prepared.

My reason for dealing with this matter so expeditiously is that my term of office as Mayor expires on the 30th instant and knowing your views on this matter I am anxious to have effect given to the same before my retirement

MY DEAR SIR,—My absence from town and my engagements in connection with Queen's University have prevented me sooner writing you on the subject of your letter of April 22nd which with enclosures you were good enough, as Mayor of Halifax to send me.

Possibly I should send my acknowledements to the new Mayor, but for the present allow me to address you personally. The truth is I attach so much importance to some points that I feel I should run down to Halifax to confer about the proposed park with geutlemen in authority and others. I fear however that I shall be unable to do so for some weeks. Meanwhile there is a matter on which information, and possibly action is desirable without much delay.

I have reference to the fact that the present year is the semi-tercentenary of the establishment of popular government in any part of the outer empire as it stands to-day, and that the first House of Representatives of the people, who were elected under instructions from His Majesty the King, assembled in Halifax on October 2nd, 1758. Arrangements having been made by Governor Lawrence representing the King, the previous May—this very month 150 years ago.

The fact alluded to is of great significance and it has an intimate relationship to the developement of the Empire. To day Representative Government, essentially an outgrowth of the love of justice and liberty inherited from the races forming the British people, reached its present stage through centuries of conflict dating back to the conquest of 1066. The spirit of representative government is inherited from England and it is worthy of notice that the first Legislative Assembly in the Dominion,—the first in the whole Empire outside of England, was assembled under instructions from the British King in Nova Scotia in 1758.

After the lapse of a century and a half, when representative government is becoming co-extensive with civilization, is it not fitting that Nova Scotians should in some marked manner denote an historical fact in which they are so much interested and directly associated. Should they see the way to erect a memorial tower or other building there is no site more admirable than the elevated point of land in a line between the "Arm" village and the Club Houses on the opposite shore. A lofty tower on this spot would be seen from the entrance of the "Arm" to its head. There is no better site anywhere. It would remind every visitor and coming generations of the part which Nova Scotia has played in history, and the spirit of liberty which her sons have inherited.

If the idea be favored could it not be arranged that the proposed new public park be inaugurated by laying the foundation stone of such a memorial, on the most beautiful spot on either side of the "North West Arm ?"

The houses on this street have no means of disposing of their sewerage and as the land in this vicinity is flat the construction of a sewer is advisable.

The estimated cost of extending the water to supply four houses, independent of the sewer is \$657.00 and if the extension is made in this way there should be a special rate of \$8.21. GENTLEMEN, —Your Committee on Laws and Privileges beg to report that a meeting of the Committee was held this day, there being present Aldermen Chisholm (Chairman), Archibald, Douglas and Hubley.

The following matters referred to the Committee were dealt with, and the Committee report as follows :--

1. (a) Application of W. A. Doyle for a license to operate a moving picture show and illustrated song theatre in the building corner Buckingham and Barrington Streets formerly occupied by the Globe Laundry.

E. L. FENERTY'S CLAIM.

CITY ENGINEER'S OFFICE, Jan. 9th 1908.

His Worship the Mayor :

SIR,—The accompanying letter from Mr. E. L. Fenerty was handed to me by Your Worship some months ago, but owing to pressure of work I have been unable until recently to obtain the information necessary to enable me to report upon it.

Thirteen or fourteen years ago, as stated by Mr. Fenerty, the City laid a 27'' pipe from Chain Lake to the north end, the route followed from Chain Lake to the Arm being the same as that traversed by the old 24'' and 15'' mains. I am not aware that the city workmen trespassed on Mr. Fenerty's property, but I take it that he means that the trespass was the act of laying the pipe through his property. I consulted His Honor the Recorder at the time and he instructed m. that the City had a right-of-way through Mr Fenerty's property. As a matter of fact the City has had its water pipes running through Mr. Fenerty's property since it purchased the water works system from the Company and the pipes were there before Mr. Fenerty owned the property. As Mr. Fenerty states, I told him that if the City had taken anything that did not belong to it or were doing anything that it had no right to do he would be treated justly. In the meantime the Recorder looked into the matter and advised me that we had a perfect right to carry on our work. I have heard nothing further from Mr. Fenerty in reference to it until he found a few months ago a record of a document in the Registry of Deeds office which had been obtained from Mr. Kehoe. Mr. Kehoe was not paid at that time for the right-of-way as the City already possessed a right-of-way through his property the same as through Mr Fenerty's. In laying the main through Mr. Kehoe's property the work prevented Mr. Kehoe from obtaining access to his stone quarries and the City workmen without authority took stone from Mr. Kehoe's land to use along the pipe trench. Mr. Kehoe brought the matter to my attention and I consulted His Honor the Recorder in reference to it. The City employees were clearly wrong in taking the stone and Mr. MacCoy was of the opinion that Mr Kehoe might als have a claim for interruption of his stone quarrying business. We offered Mr. Kehoe one hundred dollars (\$100.00) in settlement of his claims, and in order to prevent the possibility of a similar claim from Mr. Kehoe in case of future operations on the pipe line we obtained the document referred to by Mr Fenerty containing special conditions prepared by the Recorder The one hundred dollars (\$100.00) was not paid for the right-of-way, which Mr. MacCoy advised me we already owned, but was paid to prevent an action for damages from Mr. Kehoe which the Recorder believed the City would lose There was no such damage done on Mr. Fenerty's property, and as he bought the land with the pipes through it, I am unable to see any injustice in the City's treatment of his case.

IN RE E. L. FENERTY'S CLAIM IN RESPECT TO PIPE LINE.

OFFICE OF CITY SOLICITOR, CITY HALL, March 30th, 1908.

Chairman of Committee on Laws and Privileges :

SIR,--I have consulted with Mr. Doane and Mr. Johnston in this matter, and the facts appear to be as follows :--

The property was originally that of Mr. Hosterman, and the 12" pipe was laid through his property by the old Water Company in 1848. It is immaterial at this date whether this was done by agreement or otherwise. In 1856 a second pipe (15'') was laid alongside of the first one. In 1861 the 12" pipe was replaced by a 24" pipe. Mr. Fenerty purchased the property in 1874. In 1893 the 27" main was laid directly alongside of the other two pipes There has been ever since 1848 a defined pipe line on the ground which was somewhat increased when the second pipe was laid in 1861, and has not been materially increased since that date. If anything, the roadway has been improved, and the land is wilderness of very little, if any, value.

Under these circumstances it appears clear to me that the laying of the third pipe in 1893 alongside of the other two could not possibly have occasioned any loss to Mr. Fenerty as the right-of-way had already been acquired. At most it could only have given rise to a claim for nominal damages for trespass. Any action for this would of course be now barred by the Statute of Limitations, and I do not see any reason for a claim for compensation where no possible loss can have arisen.

SIB,-I am directed by the Provincial Secretary to invite your attention to Section 24 of Chapter 90, Revised Statutes 1900, the Fire Escapes Act, which provides as follows :--

"The Chairman of every Board shall report annually to the Provincial Secretary on or before the fifteenth day of January.

(a) the number of fire escapes erected during the year,

(b) the alterations made in buildings by order of the Board,

(c) the name of persons who have neglected and refused to comply with the orders of the Board,

(d) the proceedings taken to enforce such orders, and the result, including the amount of the penalties paid."

The provisions of this section have not been complied with by practically any of the Chairmen of the Boards of Fire Escapes throughout the Province, and the Provincial Secretary thinks that it is very important that the information called for by the section should be furnished in accordance with the statute. I am therefore to request you to be kind enough to instruct the Chairmen of the Boards of Fire Escapes appointed by your Council to furnish reports for the past year, and in future to report annually to the Provincial Secretary as required by the Section above referred to.

SIR,-When the Lords Commissioners of the Admiralty withdrew the men-of-war and Dockyard staff from the Halifax station they gave the necessary notice and terminated the agreement under which the dockyard was supplied with water. Since the termination of the agreement they have been supplied on the same basis, being charged only for that portion of the premises which was in use. At the time the change was made a draft agreement was under consideration, under which water was to be supplied through meters and charged for accordingly with a fixed sum in lieu of fire protection. During the last year the Marine and Fisheries Department have again taken the matter up, and have now approved of the draft agreement submitted to them. The agreement is on the lines of the existing agreement between the City and the Railway Department. It has been approved by the Minister of Marine and Fisheries, but was sent to the Department with the understanding that it had not been approved by the City, and must first be submitted to the Committee on Works and City Council. I would recommend that the draft agreement submitted be approved, and that when signed it come into force on the first day of May, 1908.

SIR,—I beg to report on the attached petitions asking for permanent sidewalks on the north and south sides of Prince St., between Hollis St. and Bedford Row, and on the west side of Granville St. between Sackville and Blowers Sts.

This block of Prince Street is in the centre of the business district and is not in a creditable condition. Adjoining, as it does, one of the principal streets in the City, it should be put in good order at an early day. The estimated cost is \$1,285.00.

The Granville Street sidewalk is also in the heart of the business district, and is not in keeping with the streets in its neighborhood. The property owners are anxious for improvement and I think the work should be carried out. The estimated cost is \$1,520,00.

I would recommend that these two sidewalks be ordered to be constructed under the Halifax Permanent Sidewalk Act.

SIB,—I beg to report on Mr. A. P. Calnen's petition for water extension to a dwelling house which he proposes to erect on Atlantic Street. It is not probable that the City will require a main pipe in either of the streets leading to this property for a

good many years. if at all, and I could not recommend the expenditure of any money for such work. I have explained the matter to Mr. Calnen and told him that the City would in all probability lay a pipe to the line of Young Avenue as they would have to do for any property owner who erected a building on any property fronting on that street. He proposes to carry the pipe from the street line of Young Avenue to his house at his own expense, and I would recommend that the City lay the pipe to the line of Young Avenue and instal a meter at that point. Mr. Calnen to be liable for all water registered by the meter so located.

His Worship the Mayor :

SIR,—I beg to report on the accompanying petition asking that some effort be made to intercept the surface water from Agricola Street and Longard Street which runs eastwardly through the Hennessey property across Gottingen Street.

The petitioners ask that a trench be dug along Agricola St. to a catchpit at Young St. In order to carry the water to Young Street it will be necessary to open a trench along the side of the street into the sewer in Young Street. While it is practicable to conduct the water to this point, it will leave a dangerous open ditch, as in order to get the fall to Young Street the ditch must be deep at the Young Street end. I cannot promise the petitioners or the Council that it will prove to be a satisfactory remedy for their complaint and to construct a culvert would be the same as building a sewer. There should be a sewer in this portion of Agricola Street to carry off the surface water from the Hennessey swamp and I would recommend that a sewer be constructed from Young Street to the culvert across Agricola Street. The estimated cost is \$1740.00.

FARES DARTMOUTH FERRY.

APRIL 22nd, 1908.

GENTLEMEN,-The Committee on Works have now to report in reference to Minute of Council 5th day of March last referring a letter of County Councillor S. W. Lydiard in reference to the Dartmouth Ferry, that they met with the representatives from the Dartmouth Town Council and the Dartmouth Ferry Commission and agreed on a basis for the future operation of the Dartmouth Ferry, a memo. of which is hereto attached.

The whole plan hinged on the Provincial Government agreeing to subsidize the ferry. A conference was held by the representatives of the different bodies interested with the Local Government, and at the conclusion of the interview the delegation was informed that the Government was not prepared to recommend a subsidy at this time. The whole matter is therefore off for the present.

REPORT OF SUB-COMMITTEE.

Your committee appointed to obtain information as to the working of the ferry and to suggest a basis for the reorganization of the Commission along the line of joint ownership and control by the town of Dartmouth, City of Halifax and County of Halifax, and the assumption by the two latter corporations of a fair share of the responsibility now altogether carried on by the town of Dartmouth, beg to make the following suggestions :--

1. That all commutation tickets be abolished.

2. That a rate of two cents be charged for all foot passengers, and a further reduction made at the earliest possible day to a one cent rate.

3. That all other fares be reduced by forty per cent.; a further reduction to be made as soon as possible.

4. That an application be made to the Local Government for subsidy.

5. That legislation be obtained permitting the organization of a new Commission composed of seven members. two of whom shall be elected by the Council of the City of Halifax, two by the Council of the town of Dartmouth, one by County Council, one by the Government and one from Dartmouth by the Chief Justice. The Councils of the City of Halifax and town of Dartmouth shall each elect one of their members from outside the Councils.

6. That the qualification of a member of the Commission be an assessment of five hundred dollars on real estate.

7. That the Chairman of the Commission be elected by the Board.

8. That the property actually used by the Commission for ferry purposes not be assessed.

9. That the Commission assume the bonded debt and other liabilities of the present Commission and take over at a valuation to be determined the dock in Halifax now used by the Ferry Commission and the Stayner property at the cost of same to the City.

10. That the deficits, if any, be borne by the three corporations in following proportions:-Forty per cent. each by the City of Halifax and the town of Dartmouth and twenty per cent by County of Halifax.

11. The change proposed to be subject to ratification by the Councils of the three corporations and the approval of the ratepayers of Dartmouth.

12. That provision be made for refund of fares of pupils using the ferry attending the High School upon certificate of attendance by teacher.

13. That commissioners cross free under regulations to be made by the Commission.

Moved by Alderman Hoben, seconded by Alderman Whitman, that said report be filed. Motion passed.

To His Worship the Mayor and City Council:

GENTLEMEN,-The Charities Committee met this day and beg to submit the following report. Members present-The Chairman, Aldermen Shaffner, Chisholm and McManus.

The Superintendent's report for February shows that during the month there were 36 persons admitted into the City Home, 3 born, 27 discharged and 8 died. Of the number admitted 18 were chargecable to the Province and 18 to the City. The total number of inmates February 29th was 415, made up of 267 men, 146 women and 2 children.

INSTALLATION OF METERS.

APRIL 9TH, 1908.

To the City Council :

GENTLEMEN,—For the information of Council the Committee on Works beg to report that on April 2nd, tenders for the installation of Water Meters were opened when it was found that the tender of J. E. Myers was, in the opinion of the City Engineer, the lowest, and it was decided to make a contract with him for the performance of work not to exceed \$500. At a later meeting of the Committee held on April 4th the Engineer reported that Messrs. J. McFatridge, Jr., W. S. Craig and M. F. Burns were likely to agree to do the work at the same rate named by J. E. Myers and it was thereupon decided to make contracts with them on the same 'terms as with J. E. Myers. Messrs. Myers and Burns have not yet signed contracts, while contracts have been executed between the City and Messrs. Craig and McFatridge.

The Committee being fully alive to the necessity of improving the fire pressure as quickly as possible, are of opinion that contracts should be entered into with all plumbers willing to undertake the work at once, and that all meters ordered should be installed as speedily as possible. While under the Charter the Committee is, in the opinion of the City Solicitor, empowered to make contracts up to \$500.00, they think that the Council should authorize them to make contracts with all plumbers willing to undertake the work of installing all the meters ordered.

In conclusion, it may be pointed out that no one-firm can instal the number of meters ordered under six months, and it is therefore desirable that the work should be given to all plumbers willing to undertake it.

WATER METERS.

HALIFAX, N. S., March 10th, 1908.

His Worship the Mayor and City Council of Halifax:

GENTLEMEN,—I have the honor of enclosing you herewith copies of resolution unanimously adopted at a mass meeting of citizens held in St. Patrick's Hall on Monday the 9th inst.

JAS. S. EDWARDS, Chairman of Meeting.

Whereas, on the 8th day of November, 1907, the Board of Works of the City of Halifax reported to the Council in favor of purchasing and installing three thousand water meters at a cost of \$42,000.00;

And whereas, after a discussion of said report the Council voted that the consideration of the matter be indefinitely deferred;

And whereas, on March 3rd, 1908, the water meter question was again suddenly brought before the Cauncil in a Message from His Worship the Mayor, the whole of which Message has not yet been placed in the hands of the Aldermen;

And whereas, in view of the fact that the price of metals had greatly declined since the November tenders were submitted the Board of Works was at this meeting instructed by the Council to call for new tenders;

And whereas, said tenders were not publicly advertised for ;

And whereas, at a meeting of the City Council held only two days afterwards, namely, on the 5th of March, the matter was again brought before the Council on a report of the Works Department, of which Department His Worship the Mayor is Chairman, reporting that the meters could not be bought at a less price than that before quoted;

And whereas, on a vote for the adoption of the report of the Board of Works in favor of the purchase of 3,000 meters two members of the Council, namely, Alderman Hayward and Alderman Hawkins, were absent, the vote on the motion resulted in a tie;

And whereas, His Worship the Mayor gave a casting vote in favor of the report of the Board of Works recommending the purchase of said 3,060 meters ;

And whereas, in cases of the it is customary on a large money vote for the presiding officer to vote against the expenditure;

And whereas, notwithstanding the fact that a notice of reconsideration of the motion was made at the meeting it is generally believed that the entire order for these meters was placed by telegraph within twenty-four hours after the vote was passed;

And whereas, as a result of the vote carried by the casting vote of the Mayor nearly one-third of the entire order for these meters has been placed with his own father-in-law;

Now therefore resolved, that the citizeus and ratepayers of Halifax here assembled do most emphatically condemn the action of Mayor MacIlreith in his casting vote forcing the above large and nnnecessary expenditure upon the ratepayers of the City under such questionable circumstances;

Further resolved, that if the orders for these meters have been placed that the Mayor be requested to take immediate steps to cancel the same;

Further resolved, that a copy of this resolution be promptly placed in the hands of our Mayor and City Council.

Seconded by Richard Flinn.

Whereas, A strenuous effort is being made by His Worship the Mayor, by the City

Engineer and by certain Aldermen to have meters placed on all service pipes in the City as a means of preventing waste of water;

And Whereas, If this course is adopted it will entail a large annual charge upon the citizens equal to an increase of about 50% on the present water rates;

And Whereas Other cities throughout the Dominion are able to successfully manage their water system without the general use of meters, the following cities having a smaller precentage of service pipes metered than Halifax has, viz : Montreal, Toronto, Quebec, Ottawa, London, Hamilton, Kingston, Charlottetown, St. John.;

And Whereas, There is sufficient water entering the mains at the lakes to supply the citizens of Halifax with an abundance of water if underground leaks were stopped and the system properly managed and controlled;

And Whereas, The City Charter contains ample provision for the adequate inspection and control of water which has not been carried out but has been grossly neglected;

Therefore Resolved, That it is the opinion of this meeting that there is absolutely no justification whatever for imposing upon the taxpayers the additional burden which a general installation of meters will made necessary.

Therefore Resolved, That this meeting express its strongest disapproval of the action of the Mayor, Aldermen and officials who were unstrumental in attempting to press this further burden upon the citizens.

And Further Resolved, That a copy of this resolution be mamediately sent to the Mayor and City Council.

GENTLEMEN —At a meeting of the Committee on Works held this day the attached Minute of Council in re water rates, etc., was read and it was decided to concur in the draft Act as submitted by City Solicitor.

470 A..

To The City Council :

R. T. MACILREITH, Mayor and Chairman ..

1. Subject to the conditions hereinafter provided the Council may make a reduction of the amounts charged to any person for water which has passed through a meter.

2. No such reduction shall be allowed unless the Committee is of the opinion

- (a) that the amount of water charged for was in excess of that which was tairly required by the owner or occupant of the premises in respect to which the same is charged, and
- (b) that such excess has passed through the meter by reason of unavoidable accident or otherwise, without the negligence, default or failure to use proper care and precaution on the part of the owner or occupant of such premises.

3. Any claim for any such reduction shall be made in writing to the Committee on

Works within one month after the record of water consumed for the month in respect to which the reduction is claimed has been delivered to the owner or occupant of the premises, or the agent of either, and such writing shall set out fully the nature of the accident or other cause on which the claim is founded.

4. The Engineer shall investigate the matter of such claim and report in writing whether the same is well founded, and whether or not the same should be allowed, and the extent of such allowance.

5. Upon such report the Committee may

(a) refuse to allow the claim, or

(b) recommend the allowance of it in whole or in part and on such terms and conditions as the Committee may see fit to impose.

6. If the Committee unanimously resolves not to allow the claim in whole or in part, such resolution shall be final, but if such resolution is not unanimous the matter shall, on the application of the claimant, be referred to the Council, and the Council may make the reduction asked for in whole or in part.

7. Any resolution of the Committee recommending the allowance of any claim for reduction in whole or in part shall be sent by the Committee to the Council, and the Council may confirm the same in whole or in part or disallow the same, or may attach such terms to any allowance as it deems fit.

8. Any claim for reduction which might be allowed under this section, but which arose within one year before the passing of the Act, may be dealt with and allowed under the section, provided that a claim therefor has been made in writing before the passing of this Act, or is made within one month thereafter.

9. Nothing in this section shall authorize the remission in respect to any premises of the amount rated thereon for fire protection.

10. Except as is in this section provided no reduction or allowance in respect to any water rates shall be made or given.

Alderman Fdwards asked permission to submit a series of questions.

The Council declined to grant permission at this stage of the meeting.

USE OF MUDDY MATERIAL ON THE STREETS.

CITY ENGINEER'S OFFICE, Dec. 4th, 1907.

His Worship the Mayor :

SIR,-With reference to questions asked by Alderman Kelly and Alderman Campbell, attached hereto, I beg to report:

Alderman Kelly's question probably originally referred to the use of material removed from Gottingen Street by the Paving Company and deposited on North Park Street. This street was worn out and required a good deal of material to round it up so that the water would be thrown off to the side. It was not the intention to use this material as a wearing surface, and when properly compacted it will be covered with broken stone so that a good roadway can be made.

The roadway on Tower Road between Morris Street and South Street was made in this way and it is generally agreed that it is one of the best roadways in the City.

In answer to Alderman Campbell's question, the Foreman was instructed to use such material from Lockman Street as was suitable for repairing Brunswick Street. Instead of selecting material it was taken just as it came and in consequence the greater part of it is mud totally unfit for any such use. It will have to be scraped off and removed as soon as the weather is suitable.

LOCKMAN STREET PAVEMENT.

CITY ENGINEER'S OFFICE, Dec. 4th, 1907.

His Worship the Mayor :

SIB,—In reply to Alderman Hoben's question, attached hereto, I beg to report that the paving of Lockman Street to the north side of the King Edward Hotel will not be completed this year, as such work cannot be done during cold weather.

With reference to the material hauled to the City Yard, it is very difficult, in fact almost impossible, to obtain suitable material for binding and for repairing sidewalks. We have on one occasion paid \$1,600 for a property on Wellington St. solely for the purpose of obtaining the material on the property. While the material hauled to the yard is not the best, it is as good as we can get. We use all the ashes that we can in repairing sidewalks, but householders object to the use of such material unless a sprinkling of gravelly soil is covered over it. On sidewalks on hills ashes wash out, and no other material, except permanent material, will stand the rains. The same applies to the binding of broken stone in the roadway on hills. Screenings will wash out, while the gravelly soil will stand the rain longer. The material stored in the field will probably be used for such purpose. The material must necessarily be moved twice as it has to be screened, and this work cannot be done on the street without delaying pavement work.
