QUESTIONS BY MEMBERS.

Alderman Edwards submitted the following questions :--

1. Does the license law of the City of Halifax permit any person or persons to keep for sale or sell intoxicating liquor without a license granted by the Halifax City Council? If so, give Act and Section.

2. Does the fact of any certain number of men becoming incorporated under the Joint Stock Company's Act of Nova Scotia empower these men to open a bar room? If so give Actand Section.

3. Does an Act of Incorporation under the Nova Scotia Joint Stock Company's Act enable the Company so incorporated to ignor the license law of Hallifax and take to itself the power to dispose for a money consideration intoxicating liquors to shareholders or others?

4. If the License Inspector enters the premises of a Joint Stock Company and finds intoxicating liquor there and can prove that shareholders or any other persons buy and pay for any portion of the stock of intoxicating liquor located on the premises, has the Inspector the right under the law to raid such premises and confiscate the stock of liquor.

Alderman Edwards also submits the following questions :--

1. How many persons were liable for poll tax last year?

2. How many persons paid the poll tax ?

3. What steps (if any) have been or are being taken to recover the tax from the persons who did not pay ?

Alderman Edwards also submits the following question :--

Are there any buildings on Gottingen Street not connected with the sewer? If so, how many, who were the owners and why were connections not made before the permanent street and sidewalks were laid down?

Alderman Shaffner asked in the newspaper reporters were allowed to attend meetings of the Committee on Works and if it was true as stated in the *Evening Mail* that reporters were turned out of the meeting of the Committee on Works to-day.

His Worship the Mayor stated that while the Committee on Works was in session to-day a reporter called but there was not space enough in the room in which the meeting was being held for reporters. As long as he could remember the reporters were excluded from the meetings of the Committee on Works. The minute book of the Committee on Works was always open to the inspection of the reporters or any ratepayer immediately after the meetings of the Board.

Alderman Hebb asked what had become of the petition for catchpits Edward Street.

His Worship the Mayor stated that he had received a letter from the Officer Commanding in which he was informed that the Military authorities had an appropriation for the purpose and that in a few days he would know what was to be done.

GENTLEMEN, —A meeting of the Committee of Fire Wards was held this evening at eight o'clock. Present—Aldermen Hubley (Chairman) Edwards, Whitman, Thompson and McManus.

The following report of the Chief was considered clause by clause, and recommended for adoption by the Council :--

HALIFAX, N. S., June 1st, 1908.

To the Chairman and Board of Fire Commissioners :

GENTLEMEN,-I beg leave to make the following report :--

- a. That John Wells, Captain No. 4 Hose, resigned May 1st.
- b. That John Tobin, Callman No. 2 Hose, resigned May 1st.
- c. That John Toomey, Driver No. 1 Truck, resigned May 15th.
- d. That John Moir, Engineer No. 1 Engine, resigned May 16th.

e. That Richard Stone, Captain No. 2 Engine, who was injured at fire April 19th, reported for duty May 26th.

f. James Merlin, Callman No. 2 Engine, was suspended on May 16th for using unbecoming language to the Chief.

g. John Lemas, Callman No. 3 Engine, and Wm. McDonald, Callman No. 1 Engine, are reported for not sleeping in their engine houses when ordered to do so.

h. In the resignation of Captain John Wells of No. 4 Hose, caused by an accident which happened while on duty at an alarm of fire from box 73, Oct. 3rd, 1906, the Fire Department loses a good fireman and one of its best officers, which the entire Department very much regret.

RECOMMENDATIONS.

1. That the Quinpool Road Engine House be connected to the sewer.

2. The ('hief Engineer recommends that No. 1 Fire Engine, Columbia, Amoskeag, stationed at Central Engine House, and now out of commission, be stripped and her boiler examined, as she has been in service for sixteen years.

3. It is recommended that James Keefe, Lieutenant on No 4 Hose, be appointed Captain of No. 4 Hose, vice Capt. John Wells, resigned

4. That Alex. Clarke, Hoseman on No. 4 Hose, be appointed Lieutenant on No. 4 Hose, vice Lieutenant Keefe, promoted to Captain.

5. That William McGuire, Callman No. 2 Engine, and Thomas Power, Callman No. 4 Hose, be appointed Drivers on the permanent force.

6. That the following Supernumeraries be appointed Callmen : Bingham Johnston, Jeremiah Shea, John Verity, John Sullivan, George Gallaghan, John Lynch, John McAskill.

7. That John Brooks be appointed Supernumerary on No. 4 Engine.

P. J. BRODERICK, Chief Fire Department.

The following recommendations in respect to the Chief's Report are submitted to the Council for approval :--

Clause (f). The Board investigated the charge in Merlin's presence, and found the matter to be one directly affecting the discipline of the Fire Department. The circumstances surrounding the incident were graver than the actual language used, but quite a number of the callmen being present at the meeting who would be likely to spread the facts amongst the other members of the Department the Committee felt that exemplary punishment was unnecessary. It is recommended that the action of the Chairman and Chief in suspending Merlin be sustained, and that he be reinstated from this date.

Clause (g). Lomas and McDonald failed to obey their notices to attend the meeting of the Board. From the statements made by the Chief the Committee felt they had no other course to pursue than to recommend that these men be asked to resign from the Department. The Committee's recommendation is that they be given until June 5th to resign, and failing to do so their pay be stopped from that date.

Clause (h) The Board approved of the Chief's report in respect to Captain Wells, and instructed the Secretary to send him a letter in acknowledgment of his services as a fireman

In respect to the account of J. P. Esdaile in connection with the Shand, Mason & Co. engine "Alexandra," the Committee concur in the recommendation of the late Board, and recommend that he be paid \$75 00.

The suggestions in the following report of the City Electrician were unanimously concurred in.

DEAR SIR, — Will you kindly call the attention of the Board to the matter of F. A. box keys. It has been the custom to furnish each member with a set of keys, and some rule should be established by which these keys would be returned at the expiration of the term of office of each member, otherwise in the course of time box keys will be scattered around town, with no trace of them, and should they fall into the hands of mischievous persons false alarms will be of frequent occurrence.

I also beg to recommend that the signal boxes be painted, and a new 6-inch gong be purchased for the Chief of the Department. The one now in use in his house, while giving good satisfaction most of the time fails regularly in the Spring and Fall of the year. In a less important place it would give sufficiently good service, and I would like to use it as a spare gong. The cost would be in the neighborhood of \$25.00.

P. R. COLPITT, City Electrician.

The report of the late Committee referred to this Committee by the Council for further consideration, is recommended for adoption, with the exception of the clause relating to the purchase of hose.

Regarding the matter of purchasing 2000 feet of hose, both the late Board and the present went very carefully into the consideration of the subject. Your Board had the benefit of letters from the Fire Department Chiefs of a large number of Cauadian cities regarding their experience with different brands of hose used by them previously submitted to the Council, and at this meeting your Committee devoted a good deal of time to hearing the arguments of agents representing various kinds of hose, as well as to this City's own officials. The Board found it difficult to determine from the conflicting evidence of other Canadian cities that any particular make of hose would be the best for Halifax to purchase. Our own officials having had practically no hose in service other than Maltese Cross this City's experience was of little avail to the Committee.

Therefore, in order that Halifax may obtain a practical guide for future purchases, the Committee unanimously recommend that the 2000 feet of hose to be purchased be divided amongst four brands in 500 ft lots. The Chief assured the Board that these four lots of hose can be given practically similar tests at fire duty, and in this way merits or dements may be ascertained.

The recommendation is that the City purchase 500 feet Dreadnaught rubber hose at \$1.10 per ft. from Stairs, Son & Morrow, (Can. Rubber Co. manufacture); 500 feet Keystone Double Cotton Jacket wax and gum treated hose at \$1.00, less 3% for cash in 20 days, from Guildford & Son (Can. Rubber Co. manufacture); 500 feet Paragon Cotton Jacket hose at \$1.00, and 500 ft. Carbolized Maltese Cross rubber hose at \$1.15 from Austen Bros. (both Gutta Percha and Rubber Co. manufacture). All of the said hose to be purchased under the terms and conditions of the tenders submitted.

WATER METERS.

OFFICE OF CITY SOLICITOR, June 4th, 1908.

His Worship the Mayor and City Council :

GENTLEMEN,-In reply to the questions submitted to me by Alderman Hubley, I beg to say as follows :

1. Q. What authority, if any, had the City to purchase or pay for the 3000 meters recently ordered by the City? If under the City Uharter give section or sections thereof, and if under special Act or Acts of the Legislature give Act or Acts and sections.

A. The power of the City in this respect, as in most others, must necessarily be

expressed in general terms. Section 610 of the Charter vests the lakes, mains, etc. of the water supply in the City. Section 611 provides as follows :

1. "The management and supervision of the water works, and the maintenance thereof in a good condition of repair and efficiency, shall be performed and discharged by the committee on works, and any improvements thereto or extension thereof ordered by the Council shall be executed by that committee."

The mode of discharging these powers and duties must necessarily be left to the discretion of the Council, and it is for them to say what apparatus shall be from time to time acquired in order to enable it to be done. In addition to this general power, the powers and duties conferred and imposed by the sections dealing with water meters, sections 462 to 470 could not be discharged without the purchase of meters,

2. Q. What authority, if any, had the City or Committee on Works to instal said meters or any of them? And, if any, how many, and under what terms or instructions? If under the City Charter give sections thereof. If under special Act or Acts of the Legislature give Act or Acts and sections.

A. Section 465 makes it compulsory on the Engineer to place a meter on any premises where waste is taking place, but under this section not more than 50 meters can be placed in one year. Section 464 is, however, a permissive one, and under it the Engineer is empowered to place a meter on every service pipe. Section 479 provides a penalty, both pecuniary and by stoppage of water, for any person refusing to allow the City access to his premises for the purpose of fixing a meter therein.

His Worship the Mayor :

SIR.—Since the resolution of Council authorizing the installation of meters in the low service district there have been five hundred and thirty-three (533) meters installed. About forty (40) were put on by John McFatridge and the remainder by W. S. Craig. On the 2nd of May Mr. Craig had a contract to instal about three hundred (300) meters and he had put in about (30) under his contract. I have not the exact figures as the returns have not come to me yet from Mr. Morrison. Under Your Worship's instructions I told Mr. Morrison not to issue any more to Mr. Craig, and the work was stopped. Under instructions from Your Worship I telegraphed the Neptune Meter Co., on the 4th of May, as follows :— "I am instructed by the Mayor to notify you not to make any father shipments of meters to Halifax."

At that time we had received all the Lambert meters from H. B. Clarke & Son —nime hundred and one (901)—including one meter especially ordered for test. We had received seven hundred (700) Trident meters from the Neptune Meter Co, and we have invoices for five hundred and five (505) more which we have not taken delivery of. Five of these were a special order of 2-inch meters for use at the Silliker Car Works and similar places. Of the meter opened about one in fifty were tested and found satisfactory. The meter tester has, however, tested a good many more since the meters were delivered The later shipments have not been opened yet owing to the cramped accommodation in the basement. They will be tested in the same manner as the previous shipments before bills are certified.

RE CONTRACTS FOR PURCHASE WATER METERS.

OFFICE OF CPTY SOLICITOR, CITY HALL, May 13th, 1908.

His Worship the Mayor, Chairman Committee on Works :

SIR,—The purchase of water meters is undoubtedly a thing which comes within the general powers of the City. The only questions to be considered are whether the officials by whom the contracts were made had authority to enter into them and whether or not the the requisite formalities of a contract were complied with.

The subject of the purchase and installation of meters was brought before the Council by the report of the Committee on Works submitted at the meeting of 22nd July 1907, in which, after a discussion of the subject, the Committee use the following language \rightarrow

"Your Committee estimate that the sum of fifty thousand (\$50,000) dollars should be provided for the installation of meters and that that sum should be borrowed and the meters installed this year; that the Committee on Works should be instructed to call for tenders at once for the supplying of the meters and that the kind of meter to be purchased should be settled by the Committee."

A motion was made that the consideration of the matter be deferred to which an amendment was moved that "the report be adopted and the sum of \$50.000 borrowed "for the installation of water meters on the same terms as the balance of the \$380.000" required for other purposes as authorized by a previous vote of this meeting, and that "bonds sufficient to realize the said amount of \$50.000 be sold to Messrs J. C. Mackintosh "& Co., and F B. McCurdy & Co., in equal parts."

The matter again caure before the Council at the meeting of August 30th when the Committee on Works submitted a report of the Engineer giving the tenders for meters and his criticism on the same. The Committee recommended the purpose of two thousand half-inch Trident meters, one hundred three quarter inch Trident meters and nine hundred half-inch Lamberts. On resolution the matter was sent back to the Committee for some further enquiries.

On the 8th November the Committee again reported, stating the result of further enquiries. and recommending the purchase of two thousand $\frac{1}{2}$ -inch Tridents, one hundred $\frac{3}{4}$ -inch Tridents and nine hundred $\frac{3}{2}$ -inch Lamberts at prices mentioned in the report. The consideration of this report was deferred.

The consideration of the matter was again taken up at a special meeting held on the 3rd March when a resolution was carried referring the reports back to the Committee on Works to call for new tenders and report. At the regular meeting held on the 5th March the Committee on Works reported giving the results of the call for new tenders and again recommending the purchase of three thousand as before. It was then moved that the report of the Committee be adopted and that the meters when delivered be placed on the low service. This resolution was on request divided into two parts, i. e.,

(a) That the report of the Committee be adopted ; and

(b) That the meters when delivered be placed on the low service.

After several amendments and motions to adjourn had been put and lost the original resolution was put and carried 'as divided, the first clause by the casting vote of the Mayor and the latter clause by a vote of eleven to five. A notice of reconsideration of the resolution was given, but no stay of proceedings was granted.

This resolution being for the purchase of definite articles at stated prices unquestionably constituted an authority to enter into a contract in conformity with the resolution, and the notice of reconsideration without a stay could not by the express language of our own rale relating to reconsideration have any effect in delaying or impeding the action necessary to give effect to the resolution.

The contracts for the purchase are under the hand and seals of the contractors and the hands of the Mayor and City Clerk and the seal of the City as required by Sec. 5 of the City Charter. They are for the articles specified in the resolution and for the prices, —the smaller amounts named in the contract for the Trident weters being the prices named in the tender less the duty, the tender for them being without duty paid as in the case of the Lambert meters.

In my opinion the contracts are valid and binding ones, for breach of which either of the parties to them would be liable in damages.

We are holding up the balance due under our contract until we hear from you as to the reason of the telegram.

also the five 2" which you ordered a week or two ago. These, of course, went forward. IN RE WORKSHOP CONTRACT.

OFFICE OF CITY SOLICITOR, May 13th, 1908.

His Worship the Mayor, Chairman Committee on Works :

SIR,—The general power of the City to enter into a contract for the construction of a building for the use of the City such as the workshops and stables is beyond question. The only question in each case can be whether the officials by whom the contract was made were duly authorized and whether the requisite formalities of a contract have been complied with.

In this case the Committee on Works in their report read at the meeting of Council held on 25th November last, recommended chat tenders for the construction of the stables be called for, and this recommendation was adopted. Tenders were called for, and at the meeting of Council held on 30th April, the Committee recommended the adoption of the tender of Mr. G. B. Low for \$13,216, and this recommendation was adopted. A notice of reconsideration was given, but no stay of proceedings was granted. Our Rules of Order (Sec. 18) provide that "No motion to rescind or reconsider shall have the effect of delaying or impeding the action necessary to give effect to any resolution unless the Council otherwise order,' and this, as I pointed out in my opinion read at the meeting of Council of March 26th, is the established law as to reconsideration, even in the absence of such a provision. The notice consequently had no effect in preventing the execution of a contract in compliance with this resolution, and this was done on the first day of May, instant. I have examined the contract. It is on the usual and proper form, under the seals of the contractor and the City, and signed by the Mayor and City Clerk as required by Sec. 5 of the Charter; it is for the sum named in the tender accepted, and, in my opinion, undoubtedly constitutes a valid contract binding upon both parties, for breach of which either party would be liable for damages.

CITY WORKSHOPS AND STABLES.

CITY ENGINFER'S OFFICE, June 3rd, 1908.

His Worship the Mayor :

SIR,—I beg to make a report on the estimated cost of the City workshops and stables.

The original estimate for a building to suit our requirements was from \$20,000 to \$25,000, as stated in a report contained in the Minutes of Council Feb. 8th, 1906.

When the Cathedral Committee decided to take over the site they were given an assurance that the City stables and that portion of the workshop adjoining the Cathedral property would be removed by the time the Cathedral was erected. Last year the then Mayor informed me that he was desirous of taking steps to carry out the assurance given, before his term of office expired, and directed me to complete the plans and specifications for the building. There was at that time only \$18,000 available for this structure. As the sum on hand would not finish the building an estimate was prepared to ascertain if the building could be put up and roofed in, so that it would be available for the purposes of the City Works Department. The estimated cost of putting on the roof and closing it in so that plant and materials could be stored was \$5,250. It was estimated that for \$2,000 or \$2,500 additional the stables could be moved and that portion of the equipment which it would be absolutely necessary to transfer, leaving the blacksmith shop and carpenter shop to be moved when more money was available. When the City Carpenter made his estimate for the carpenter work, it was the intention to cut down the provisions of the specification in order to economize as much as possible. For instance, the specifications provided for clear pine in the roof trusses, the same as in similar trusses at the new Exhibition buildings. If this work were done by the City Carpenter it was intended to use selected spruce at an estimated saving of \$843.00. A number of other changes could be made which would effect a similar saving. It was intended if the City Carpenter did the work to use the sound material in the old buildings for partitions, &c., taking down such portions as could be spared from time to time, and the material of one building already taken down has been stored in the City Yard. We also began to make window and door frames, and have a considerable number on hand.

We have made an estimate on the specification on which tenders were taken the other day, and adding contractor's profits at 20%, find that the lowest tender is a fair price. As the amount of money available, however, is limited, we cannot put up a completed building. The excavation made shows that the bottom is bad, and the foundation will have to go deeper than the limit fixed by Mr. Low in his tender, and that consequently there will be extra work on his contract. It is impossible to estimate how much this will be nntil all the excavation is made, and as the balance of the appropriation is only \$20,860.83, is is possible at present only to finish Mr. Low's contract, and the roof, doors and windows, leaving the partitions and finishings for the future.

The first part of the resolution relating to the investigation is put and passed unanimously.

The second part of the resolution in rediscontinuance of construction is put and passed.

Moved by Alderman Hoben, seconded by Alderman Shaffner, that the resolution as a whole be now adopted. Motion passed.

Moved by Alderman Hubley, seconded by Alderman Whitman, that Aldermen Shaffner, Bligh, Smith, Hoben, Thompson and Edwards be the special committee to investigate the matter of the City Workshops and Stables. Motion passed.

DEAR SIR,—With reference to your letter of the 8th inst., in re discontinuance of work on buildings of City Workshop and Stable, I beg to state :

That I will discontinue work at once and cancel contract, leave cement and gravel at present on site, but removing all my own tools and plant, for the sum of four thousand two hundred and seventy dollars (\$4270.00).

For every day after date in which the matter remains as at present I shall make an additional charge of fifty dollars per day.
