#### HIS WORSHIP THE MAYOR'S ADDRESS.

#### MAYOR'S OFFICE, CITY HALL, HALIFAX, N. S., May 7th, 1908.

#### Gentlemen of the City ('ouucil :

In looking over the short address made to the City Council on my first election as Mayor I find it commencing with the following:--

" As the day set apart for the civic election by the Act is the last Wednesday of April, and as the last Wednesday of April happens on the last day of April this year, it places us in rather a hurried position, consequently some of us have hardly taken office before we are called upon by the Statute to appoint the civic officials. I would therefore recommend that at the next session of the Legislature the Act be changed so as to make the third Wednesday in April election day instead of the last Wednesday, which would give us more time for any contingency that might arise in the meantime."

In quoting the above I might say that it holds good to-day, and I regret that the Council has not seen fit to make the change then suggested because this time we had electron day on the 29th of April, consequently there was just one day between that and the first day of May, on which day the Mayor and Aldermen-elect are supposed to take office so you will see the necessity for the change suggested, and I trust that this Council will take the matter up and bring about a somewhat better condition with regard to the time for election day.

No doubt many of us differed as to who should fill the different positions that have been allotted to us up to the time the ballots were counted, but now that the contests are over and the will of the people ascertained I trust that you will join me in a unanimous effort to safeguard, protect and promote the best interests of our City and citizens who have done us the honor to place us in the position of responsibility which we now occupy, forgetting all prejudice or ill-feeling that is usual in a hotly-contested campaign.

#### TAXATION

is a very important question with the citiz ns and to keep the present rate, or perhaps to reduce it, I invite your earnest consideration and attention. It seems poor encouragement for our citizens that the taxes should go on increasing from year to year without their being able to point to any material advantage or accommodation. We can in some parts of the City boast of good sidewalks and some progress has been made in the improvement and paving of streets, but still not sufficient, to my mind, to account for the very large and increasing expenditure and increased debt upon the City. I regret to say that in the western and north-western parts of our City the good people have not the advantage of permanent streets and sidewalks, not to speak of other disadvantages, and this is one thing that will always be brought to the notice of any man aspiring for a position in the City Council. If he run his election at the regular time it gives him a good opportunity of realizing the disdavantages from the want of street accommodation and sidewalks that he will meet with in travelling through the the north, north-western and western parts of the City, for it is frequently very difficult to get from one house to another without going ankle-deep in the soft mud on the sidewalks.

I would therefore ask the assistance and co-operation of this Council with a view to trying to improve those streets that have been so long neglected and that really require the prompt attention of the City Council.

I would also ask your earnest assistance in every reasonable effort to get established within the Harbor of Halifax the

#### SHIPBUILDING INDUSTRY

of which we have heard so much in the past and now hear so little.

In conclusion, there is nothing that helps the progress and prosperity of a City like labor. Let us have plenty of labor, with fair pay, and we will at once have a progressive community. There is no limit to the advantages that would accrue to the working class

through the establishment of ship building in our midst and the many other manufactures that must as a natural consequence follow. Put our working class in possession of plenty of work and prospecity is ours.

#### REPORT BOARD OF FIRE ESCAPES.

#### His Worship the Mayor and City Council:

#### HALIFAX, N S., April 28th, 1908.

GENTLEMEN,—The Board of Fire Escapes for the City of Halifax, appointed under the Provisions of the City Charter, and Chapter 90 of the Revised Statutes of Nova Scotia, 1900, beg to report as follows :—

#### THE HALIFAX INFIRMARY.

The Board visited the Halifax Infirmary in June, 1907, and went carefully over the building. The Board recommended that iron shutters be put on the four back windows of the main building, and a platform fire escape on the south side of the building, and also that the ceiling over the furnace be covered with tin sheathing. Notice in compliance with the Statute was given to the Sister in charge of the Infirmary, shortly after our visit, but nothing has been done. A communi. cation, however, has been made to His Grace the Archbishop, who, I understand, has promised to see that the recommendations of the Board will be carried out.

#### ACADEMY OF MUSIC.

Great improvements have been made in this building, in compliance with the order of the Board, in the precautions taken against danger by fire. They have put two doors in the south, opening from the ground floor to the lawn. They had already two doors opening on the lawn north. The metal sheathing has been taken

from the centre window of the top gallery on front of building. The Board recommended that a fire escape from the top gallery on the south side be erected. All the requirements of the Board, except this fire escape, have been complied with, and preparations are now being made to comply with this recommendation.

#### UNGAR'S LAUNDRY.

The proprietors of Ungar's Laundry have complied with all the recommendations of former Boards. The present Board visited the property last summer and recommended that a platform and a gangway with hand rails be placed on each of the two back windows to reach the next roof in the rear. They also recommended that the ladder leading to the roof of the building, through the hatchway, be extended so that a person can reach the roof from within with ease. All of these recommendations have been complied with.

#### A. & W. MACKINLAY'S BUILDING ON GRANVILLE ST.

The Board visited this building, and recommended that the ladder on the top floor be made secure to the opening leading to the roof, and that the employees be trained to the use of this ladder. The recommendations of the Board have been complied with.

#### HIGH SCHOOL ON SOUTH BRUNSWICK ST.

The Board, last summer, recommended that a platform fire escape be placed on the north side of the building. This recommendation has been complied with, in a way satisfactory in every respect to the Board.

#### ST. PATRICK'S BOYS' SCHOOL.

The Board visited this school, and found the fire escape on the west side of this building in very bad repair. They recommended that it be repaired immediately, and that pupils on the third floor be drilled to the use of the fire escape, and that the escape be kept clear of obstructions. The recommendations of the Board have been complied with.

#### HALIFAX HOTEL.

All the recommendations contained in the Board's report to the Mayor and City Council, dated January 12th, 1904, have been complied with.

#### METROPOLE BUILDING.

None of the recommendations of the Board contained in their report to the Mayor and City Council, dated January 12th, 1904, have been complied with. On the 1st day of April, 1908, the Chairman of the Board, under Chapter 90 of the Revised Statutes, gave Mr. Sutcliffe notice to comply with the requirements of the Board's report, dated January 12th, 1904.

#### W. & C. SILVER.

Resolved on the motion of Alderman Hoben, seconded by Alderman McManus, that a ladder be connected with the hatchway through the ceiling of the workroom to the room above, and that it be attached to the hatchway constantly ready for use; also that a passage be kept clear for them to pass from that room to the main stairway on the western side of the building, and that the ladder always be kept in place to reach the hatch over the workroom; also that the ladder always be kept in place to reach the hatch on top of the ell, and that a railing be placed around the ell on the north side of the main building, and that the window be kept in condition, so that a ready escape can be made through it to the roof of the ell.

#### MESSRS. CLAYTON & SONS.

The recommendations of the Board, contained in their report to the Mayor and City Council, dated January 12th, 1904, have been carried out.

#### KING EDWARD HOTEL.

All the recommendations of the Board, contained in their report to the Mayor and City Council, dated January 12th, 1904, have been carried out.

#### GLENDALE HOTEL.

None of the recommendations of the Board, contained in their report to the Mayor and City Council, dated January 12th, 1904, have been carried out. The Chairman of this Board on the 1st day of April, 1908, gave a notice in compliance with said Chapter 90, requiring the Proprietor of Glendale Hotel to comply with the recommendations of the said Board.

#### EXCHAGNE BUILDING.

All the recommendations of the Board, contained in their report to the Mayor and City Council, dated January 12th, 1904, have been carried out.

#### ACADIAN HOTEL.

All of the recommendations of the Board have been carried out.

#### ST. PAUL'S PARISH HALL.

All of the recommendations of the Board, contained in their report to the Mayor and City Council, dated January 12th, 1904, have been carried out, except the construction of the fire escape on the back. On the 1st day of April, 1908, the Chairman of the Board notified the Rector of St. Paul's Church to comply with the recommentations of said Board.

#### ROYAL HOTEL.

All of the recommendations of the Board, contained in their report to the Mayor and City Council, dated January 12th, 1904, have been carried out.

#### DEAF AND DUMB INSTITUTION.

All of the recommendations of the Board, contained in their report to the Mayor and City Council, dated, January 12th, 1904, have been carried out.

#### CONVENT OF SACRED HEART.

All of the recommendations of the Board, contained in their report to the Mayor and City Council, dated January 12th, 1904, have been carried out.

#### SCHOOL FOR THE BLIND.

All of the recommendations of the Board, contained in their report to the Mayor and City Council, dated January 12th, 1904, have been carried out.

#### CITY HOME.

All the recommendations of the Board contained in their report to the Mayor and City Council, dated, January 12th, 1904, have been carried out.

#### ST. PAULS' HOME FOR GIRLS.

The Board recommended that a man be appointed to take charge of the furnace instead of girls, and that the furnace room be sheathed with metal sheathing; also that a hand rail be placed on top of porch at front of building. On the 28th day of April, 1908, the Chairman of the Board gave the Statutory notice, requiring the above recommendations to be carried out.

#### MOIR'S BUILDING.

The Board have resolved to visit this building, and see if fire escape is adequate.

#### TAYLOR'S SHOE FACTORY.

This building is in course of repairs, and should be visited as soon as therepairs are completed.

#### TENEMENT OPPOSITE HALIFAX HOTEL.

The Board have resolved to visit this tenement.

#### DREAMLAND NICKLE THEATRE.

On the 1st of April, 1908, the Chairman of the Board notified the President of the Board of Directors of the Dreamland Nickel Theatre ordering them to make the doors open out, or to take the outside doors down; also to place a three gallon fire extinguisher close to the machine for developing moving pictures; also one on the main floor.

#### ORPHEUS HALL.

The Board recommended that one or two electric lights be placed in the passage leading to and from the gallery, and that the aisles be kept clear during a performance. The recommendations of the Board have been complied with.

#### ST. MARY'S HALL.

The Board have recommended and ordered that the ceiling over the top of the furnace and smoke pipe be covered with asbestos and tin sheathing, and that a fire escape ladder be put from the back window on the west side of the building leading from the gymnasium to the top of a flat roofed building in the rear; also that the aisles be kept clear during a performance. On the 1st day of April, 1908, the Chairman of the Board gave the Statutory notice, requiring the above recommendations to be carried out.

#### UNIQUE THEATRE.

The Chairman of the Board, in compliance with the request of the Board, notified the Unique Theatre, 52 Barrington Street, prohibiting the use of any oil stove in the room which they occupy for the Theatre. This has been carried out.

#### BRITANNIA MANUFACTURING CO., KEITH BUILDING.

The Board unanimously recommended and have ordered the Britannia Manufacturing Company in the Keith Building to put steps from the fire proof window on the South side to the roof of Seriven's property on the South side; and that an iron fire escape be placed from a window in the office now occupied by Messrs. Murray & McKinnon on the North side to the roof of the flat roofed building on the North, and if possible, a railing be placed on the back of the building on Scriven's property South of the Keith Building. The Board found the floor space much two crowded by benches and tables. They recommended and ordered that the employees be drilled in the use of the fire escape, and that more roomy passages be provided on the floor space of the room. The Chairman of the Board on the lst day of April, 1908, notified the Britannia Manufacturing Company to comply with the above. The Chairman subsequently received a letter from the Britannia Manufacturing Company, in which they state they do not own the building, and in their opinion Mr. Donald Keith should put on the fire escapes. The other part of the recommendations they promised to carry out. On the 20th day of April, 1908, the Chairman notified him also of the contents of the letter received from the Britannia Manufacturing Company, and requested Mr. Keith to put up the fire escape as required by the Board, and also to put the railing on the back of the building on Scriven's property.

#### OLD LADIES' HOME.

The Board found that nothing had been done since the report of the Board, dated January 12th, 1904. They recommended that the fire escapes now there be taken down as they are dangerous, and that platform fire escapes be placed on the north and south sides of the building, and also on the ell at the back, and that the windows at the north and south of the main halls on the second and third floors be cut down level with the floors of the halls. On April 1st, 1908, the Chairman gave the Statutory notice to the matron of the Old Ladies' Home to comply with the above requirements of the Board.

#### KING EDWARD THEATRE.

The Board recommended and ordered that the three front doors be all made to open out. On the 28th of April, the Chairman of the Board notified the proprietor of the King Edward Theatre to comply with the above recommendations.

#### ACADIA SUGAR REFINERY, RICHMOND.

The Board report that this building was found satisfactory.

#### IMMIGRATIO& BUILDING, DEEP WATER.

On examining this property, the Board were of the opinion that the portion of the building in which detained immigrants sleep is dangerous. They recommend that the doors be fastened on the inside by double action bolts instead of by locks and keys, and that red lights be placed to show the way of exit from these sleeping appartments, and that communication be made between the two halls where the immigrants sleep ; also that all doors leading to the fire escapes be kept unlocked ; and that during the time when the immigrants are detained and landing, that proper night watchmen, who are acquainted with the building, and with the fire apparatus, and with the means of escape, in case of fire, be put on duty ; and that shut-off fire doors be placed near the centre of the passenger shute leading from the landing pier to the immigrant's building. The Chairman of the Board gave the Statutory notice to Frederick W. Annand, Immigration Agent, of the above requirements of the Board. Notice was given on the 25th of April, 1908.

#### HOME FOR AGED MEN.

The Board went through this building, and are of opinion that there is no means of escape from the top storey in case of fire. The Board unanimously resolved that a platform fire escape be erected on the back of this building from the third story to the top of the window on the back of the building on the 2nd storey. The Chairman gave notice according to the statute of the above recommendation.

#### EXPRESS HOTEL.

The Board visited this property, and unanimously recommended that a platform fire escape be erected on the rear of the building, the approach thereto being from the window next to the north hall, taking in the said window and the said hall window on the top floer, the said fire escape to be carried down to the ground.

#### INFANTS' HOME.

The Board unanimously considered this building all right.

#### HOME OF THE GOOD SHEPHERD.

The Board recommends that a fire escape be put on the back of the building, immediately leading from the dormitories.

In regard to the school buildings of the City of Halifax, the Board have passed the following resolution, namely :--
