## REPORT COMMITTEE ON LAWS AND PRIVILEGES RE FURNITURE AND CHAIR MANUFACTORY AND OTHER MATTERS.

### COMMITTEE ROOM, CITY HALL, Nov. 11th, 1908.

#### To His Worship the Mayor and City Council :

GENTLEMEN,—Your Committee on Laws and Privileges beg to report that they had under consideration the matter of establishing a furniture and chair manufacturing company in the City of Halifax.

A delegation of prominent business men from the Board of Trade waited on your committee and urged that some assistance be given to this proposed new enterprise, which, it is believed, will be very beneficial to the City, giving employment to a large number of mechanics.

Your committee have gone very thoroughly into the matter with the promoters, three meetings of your committee having been held, with the assistance of the City Solicitor. They have prepared the accompanying memorandum of proposed terms of agreement to be entered into between the City of Halifax and the proposed company.

Your committee recommend the adoption of this agreement, also that the charter as set forth in the schedule submitted by the promoters to the City Council be approved of by the Council.

#### November 13th, 1908.

Your Committee on Laws and Privileges beg to report further that at a

meeting of the committee held this day, there being present Aldermen Chisholm, Chairman, Whitman, Douglas, Hoben, Thompson and Edwards, the following matters referred to the committee were dealt with, and report as follows :--

lst. In re application of Charles E. Neville for a license to exhibit a deformed child. It is recommended that this application be not granted.

2nd. In re application of James A. McDonald for commutation of a certain common lot on Spring Garden Road. Under Section 663 of the City Charter it is necessary for the Council to pass an ordinance fixing the terms and conditions of such commutation.

It is recommended that the City Solicitor be instructed to prepare the . necessary Ordinance so that this matter may be dealt with.

3rd. In the matter of application of Nathan Komarsky for a junk store license already passed by the Council subject to certain conditions being complied with.

Mr. Komarsky has notified your Committee through his Solicitor that he has rented a property on Cronan's Wharf where he will open his Junk Store. This location being satisfactory to your Committee the Clerk has been instructed to issue a License to Mr. Komarsky.

4th. Your Committee further report that they had under consideration a letter from the Halifax Trades and Labor Council in re a fair wage clause being inserted in any bonusing or loan proposition entered into between the City and any projected industry.

The Committee submit the letter for the consideration of the Council without recommendation.

Also read by title "Memorandum of proposed terms of agreement between the City of Halifax and the Anderson Manufacturing Company", a copy of which had been furnished each member of the Council.

## MEMORANDUM OF PROPOSED TERMS OF AGREEMENT BETWEEN THE CITY OF HALIFAX AND THE ANDERSON MANUFACTURING COMPANY.

The City agrees to aid the Company by the loan of \$40.000 which amount is to be secured by a first mortgage upon the lands, buildings and machinery of the Company, on which sum the Company will pay interest at five per cent. per annum. the diffence in the interest paid by the Company to the City and that payable by the City on the bonds or stock issued to raise the sum loaned shall be applied to a sinking fund for the redemption of the stock or bonds at maturity.

The Company also agrees to pay the City a sum which together with the said difference in interest will be sufficient when compounded at three and one-half per cent. to redeem the bonds or stock issued by the City in connection with the loan at maturity.

The period of redemption expressed in the mortgage shall be one year, but the City will give an undertaking by a separate agreement that in the event of the interest and other payments being regularly made and the other conditions observed by the Company the City will not demand repayment of the sum advanced for thirty-three years. The Company may at any time during the said period of thirty three years pay off any portion of the money so loaned by the City, any amount so repaid to be applied to the sinking fund, provided that :--

(a) Any amount so repaid shall not be less than one thousand (\$1000) dollars; and

(b) In addition to any amount so repaid the Company will also pay to the City therewith a sum sufficient to produce a yearly amount of interest equal to the difference between the interest payable by the City on so much of the bonds issued by the City as produced the amount so repaid and the interest on that amount realized by the City after repayment.

The amount to be loaned by the City to the Company shall be paid to the Company at the times and in the sums following :--

When the Company has \$40,000 of its Capital Stock subscribed and \$20,000 paid up in cash and invested in land, buildings and machinery the City will pay the Company \$10,000, which shall also be forthwith invested in lands, buildings and machinery. When the Company has of its own moneys exclusive of any moneys received from the City invested a further sum of ten thousand (\$10,000) dollars additional in land, buildings and machinery the City will pay a second sum of ten thousand (\$10,000) dollars, which shall also be forthwith invested in lands, buildings or machinery. When the Company has in like manner invested a further sum of ten thousand (\$10,000) dollars of its own moneys, exclusive of any money contributed by the City, the City will pay over the remaining sum of twenty thousand (\$20,000) dollars. The amounts so required to be subscribed and invested by the Company shall be established to the satisfaction of the City Auditor and the City Engineer.

The Company will keep its buildings, plant and stock insured against loss by fire in an amount not less than \$40000.00 in some insurance company or companies to be approved by the City. Loss, if any, payable to the City.

Before being entitled to receive any portion of the money hereby agreed to be loaned to it the Company shall obtain a Charter of Incorporation under the Nova Scotia Companies' Act with a memorandum of association specifying as the objects of the Company those set out in the memorandum attached hereto and no other, and also specifying that the Company shall not open or conduct any shop in the City of Halifax for the sale of goods at retail; or engage in the business of retailing lumber or building material, and if the Company at any time applies for any amendment or addition to such objects or engages in any business not comprised and included in such objects or in any of the businesses so agreed not to engage in without in either such case having first obtained the consent of the City Council of the City of Halifax the agreement as to the valuation of the property of the Company for the purpose of taxation hereby contained and the agreement not to enforce payment of the mortgage shall at once cease and determine and the amount then due on such mortgage shall be immediately payable and may be recovered by foreclosure or other appropriate remedy.

The City agrees that for the first year after the incorporation of the Company and the passage of an Act ratifying this agreement the property of the Company, real and personal, shall be assessed for rates and taxes at the amount of the assessed value at the last preceding assessment of the land acquired in the City for the erection thereon of the factory or workshops of the Company for the next succeeding five years. The property of the Company real and personal shall be yearly assessed at the value of fifteen thousand (\$15,000) dollars and the next five years thereafter such property real and personal shall be yearly assessed at the value of twenty five thousand (\$25,000) dollars. After such second period of five years all property of the Company in the City both real and personal shall be assessed in the same way as other property in the City.

The City agrees togive the Company the minimum water rate for manufacturin purposes.

In the event of the Company wishing to connect their property with the railway the City will grant permission to place a siding across any street subject to approval by the City Engineer and on condition of the Company erecting proper gates and assuming the charge of the same.

The books and affairs of the Company shall at all times during the currency of the said loan be open to the inspection of any auditor the City appoints.

The City will endeavor to secure legislation to enable this agreement to be carried into effect.

## MEMORANDUM OF OBJECTS OF PROPOSED COMPANY.

### PLANS.

It is proposed to organize a Company called "The Anderson Manufacturing Company" to carry on the manufacture of furniture and chairs at Halifax on an extensive scale for the domestic and export markets.

The Company is to be incorporated under the Nova Scotia Joint Stock Companies' Act, with the following powers :--

To manufacture, buy, sell and deal in all kinds of furniture and upholstery, goods and timber, lumber, woods and products thereof and all articles entering into or usually dealt with in or in connection with the furniture or upholstery trade or kindered trades or the manufacture as aforesaid, and all material (now or otherwise) and all commodities, machinery, plant, patterns, designs, mechanical devices, articles and property which may be used for or in connection with any of the aforesaid objects, and generally to carry on business as a furniture plant and upholstery manufacturer and merchant, and all business apportaining to any or all of the matters aforesaid.

In connection with the foregoing to carry on and operate a general lumber business in all its branches, including the logging, driving, sawing, manufacturing and shipping of lumber of every description and kind, and the buying and selling and dealing in lumber of every kind manufactured and unmanufactured.

To acquire, erect, maintain and operate saw mills and factories for the sawing and manufacturing of lumber of all kinds and for the manufacture of furniture and other similar goods.

To build, lease, purchase or otherwise own hold and possess in fee simple or otherwise lands, grants, licenses, lumber lands, lumber tights, timber limits, options, mills, mill machine shops, boiler shops, blacksmith shops, waterways and rights, buildings, plant, machinery, marine slips, vessels, tugs, scows, barges, wharves, booms, dams, driving rights, franchises and privileges, and such other real and personal property as may from time to time be required or deemed necessary for all or any of the purposes of or incident to the business aforesaid, or any part of the same, with power, from time to time to encumber the same or any part of the same, and from time to time to dispose of any property, real or personal, at pleasure, and to do any or all things considered for the accomplishment of the objects for which incorporation is sought as aforesaid.

The Local Legislature will be asked to confirm the above.

## MINORITY REPORT.

#### COMMITTEE ROOM, CITY HALL, Nov. 13th, 1908.

## His Worship the Mayor and City Council:

GENTLEMEN,—The undermentioned members of the Laws and Privileges Committee, to which Committee the application of a proposed Company, The Anderson Manufacturing Company, for assistance was referred, beg to report as follows:

The proposed Company, among other things, ask the City to loan them \$40,000.00 for the period of thirty-three years, at the rate at which the City can borrow the same, on the security of their land, buildings and machinery, such land, buildings and machinery to cost Sixty Thousand Dollars. The Company by means of a sinking fund is to repay said sum of \$40,000,00 in thirty-three years. The Company is to raise at least another \$40,000.00 by the issue of their own stock. They also want some exemption from taxation for a period of years.

After having given the above matter most careful consideration, we think it would be very unwise for the City of Halifax to grants the proposed Company's requests. We think such a loan and tax exemption are wrong in principle, and if so, cannot be made otherwise in practice.

This concern asks for the following powers :

To build, lease, purchase or otherwise own, hold, and possess in fee simple or otherwise lands, grants, licenses, lumber lands, lumber rights, timber limits, options, mills, mill machine shops, boiler shops, blacksmith shops, waterways and rights, building, plant, machinery, marine slips, vessels, tugs, scows, barges, wharves, booms, dams, driving rights, franchises and privliges, and such other real and personal property as may from time to time be required or deemed necessary for all or any of the purposes of or incident to the business aforesaid, or any part of the same, with power, from time to time to encumber the same or any part of the same, and from time to time to dispose of any property, real or personal, at pleasure, and to do any or all things considered for the accomplishment of the objects for which Incorporation is sought as aforesaid.

Thus the City of Halitax by loaning this concern 40,000.00, at say  $4\frac{1}{4}$ , and exempting them from taxation, submits to unjust and unequal competition any other persons or companies now engaged or who hereafter may be engaged in any business in which this concern may have power to engage, and every person and every business in Town will be compelled to contribute towards the taxes of this concern, and also made pro rata responsible for the \$40,000.00 so loaned. The granting of this loan and tax exemption would tend to destroy public confidence, interfere with vested interests, create monopolies, and tend to discourage any legitimate enterprise from locating in the City.

The knowledge that these exemptions and bonuses exist deters people from settling here, and if continued, will soon increase the rate of taxation and impair the credit of the City.

The adaptability of the place for the industry is to the only potent factor which should decide its location, and if the the industry will not pay without the help asked for, it should not be established, as it is taking capital from other channels which would be productive, and thus cause a distinct loss to the community.

This policy of making loans and giving tax exemptions will tend to stir up in the towns of the Province, on which Halifax depends for its business, a spirit antagonistic to us.

It would be proper to embody in this report a letter received by one of the undersigned, and dated at Hamilton, Ontario, 6th November, 1908, from one of the leading and most capable men there. It gives valuable information, and discusses the principle of bonusess and tax exemptions. and is as follows:

DEAR SIR :-- I have your letter of the 3rd inst. The only form of bonusing which the City of Hamilton has given in many years is in the way of agreeing for a term of years to a fixed assessment for tax purposes to industries proposing to settle in Hamilton, on condition that they will settle within a certain district, which has been specially set aside for manufacturing locations. If one will follow the history of bonused industries in this Province, one will discover, I am satisfied, that most of them had but a short career. The argument advanced to a municipal corporation to influence a bonus is usually that unless a bonus is given the industry will be established elsewhere. I think this argument in effect is selfdestructive. No bonus which could reasonably be looked for would ever justify an industry in settling in one site, if another site was available and economically more desirable. A concern, which, having the whole country to choose from, would elect for the sake of a municipal bonus, to settle in a place which it would not otherwise have selected, must be financially unsound; in fact must be depending upon the bonus for existence, otherwise it would not voluntarily come under conditions which would prove a perpetual handicap in its struggle for existence. Hamilton, a good many years ago, gave a bonus of \$200,000 to a Railway Company to induce it to run through the middle of the City and spoil a great many streets. I think it would now give about as much to relieve its citizens of the danger and nuisance and interruption of traffic which has thereby been created. The Railway would have come in due course without a bonus and taken a route less objectionable. Before then, a bonus was voted for the establishment of a Steel plant here. These are the only two cash bonuses given in recent years. What has attracted industries to Hamilton in large number during the past ten years has been the belief that here they could obtain unlimited electric power at a lower rate than could be obtained anywhere else in the Province. Where a concern can see an economy of several thousand dollars per annum in its expenses for power as against what the same power would cost elsewhere, it naturally unless it is on its last legs for money will rather accept that benefit than a few thousand dollars in cash.

Another thing which has helped Hamilton has been the readiness of its citizens to become stockholders in industries coming here which held out reasonable prospects of being profitable. The ordinary bonus such as you refer to I look

upon as being indefencible except it is to supply a general public want which will not be supplied otherwise.

The following letter from N. Curry the President of Rhodes, Curry & Co., and one of the ablest business men in the Maritime Provinces will be instructive.

DEAR SIR,—In reply to yours of the 7th, the people of Amherst have always declined to grant either tax exemption or a bonus of any kind to industries either new or old. From all information I can get Towns and Cities that have made a practice of offering inducements in the way of bonuses and Tax exemptions, have in after years been disappointed in the results. No doubt there are exceptions where an industry of an entirely new character not conflicting with anything existing in the place, might be assisted with advantage to all concerned, but cases of this kind, I think are very rare.

If there is an opening for a industry in any given territory, and the right people are behind it, it is very apt to go ahead, and I think more apt to succeed than if bonused.

One reason why bonusing has gotten into ill-repute is on account of numerous industries being started by irresponsible promoters, using the bonus as a inducement to get people into the enterprise, and in many cases they get something out of the promotion, and are really more interested in that than the final success of the business.

## PURITY OF WATER SUPPLY.

#### OFFICE OF CITY HEALTH BOARD, December 10th, 1908.

### His Wurship the Mayor and Members of the City Council:

GENTLEMEN,—At a meeting of the City Health Board held yesterday I was directed to forward for your information the enclosed copy of a report from the City Engineer on the possible contamination of the Chain of Lakes, and to request that your Council take some action to carry out the recommendations contained therein.

## Chairman City Health Board :

SIR,—In compliance with your request to report on the possible contamination of the Chain of Lakes from Beech Hill Settlement or from any other source I beg to submit the following :—

There is a possibility of contamination of the low service water supply from houses on the water shed, from the highway and from the railroad, although in most cases the possibility is more remote than in those which we have been watching. In the case of the Halifax and South Western Railway the line runs a short distance north of the upper and lower Chain Lake and crosses water courses which are dry in summer but which during and immediately after rains carry the surface When the line was under construction I used every effort to water to the lakes. prevent contamination of the water in consequence of the number of men employed along the hill side above the lake. Now that the line is open there is still a remote possibility of disease germs being dropped from a passing train and carried in the water courses already mentioned to the lakes. Typhoid fever is a waterborn disease, and while there is a possibility, no matter how remote, every precaution should be taken to guard against infection of the water. In large cities the lavatories and closets are closed while the trains are within the City limits for purposes of cleanliness principally. The doors are not unlocked by the brakemen until the train has passed beyond the City limits. I can see no reason why the closets on the Halifax and South Western trains should not be kept locked between Beech Hill and Halifax. While there is no cause for alarm, yet the precaution should be taken. The nearest house to the lakes on the slopes draining to them is Mr. John Umlah's at the forks of the Prospect and Margaret's Bay Road. Mr. Umlah keeps pigs on his property and has a stable. There is no water course running from his premises to the lakes, but during rains and when the snow is melting off the water runs over the surface from his property to the lakes, which are not far away. This property is a menace to the purity of the water in the lakes, and the City should purchase it at the first favorable opportunity. In the meantime it should be closely and carefully inspected at frequent intervals, and the City Health authorities should be notified at once of any disease in the house. Section 617 of the City Charter gives the City power to deal with certain conditions which might impair the quality of the water for domestic uses. While this house and premises is nearer to the lakes than any other on the water shed there are a number of others from which the water supply might be injuriously affected more easily. In Beech Hill there are several instances in which the barn and privy are very close to the surface water course running directly to Long Lake, from which the City's water supply in the low service district is drawn through the Chain Lakes. If the City could afford it there should be no residences allowed on the water shed. If, however, they must be allowed to remain the same rigid inspection and enforcement of the regulations is necessary in Beech Hill as in connection with Mr. Umlah's property. I did not ascertain the names of the owners of properties in Beech Hill which are near the water course, but could point them out to the Health Inspectors.

DEAR SIR,—During 1906 the rates of Insurance on certain risks in the Uity of Halifax were reduced, in accordance with a previous promise to your Council that the reduction would be granted "When provision was made by law for a fire inquest whenever called for by either the civic authorities, the Board of Trade or the Board of Fire Underwriters" We were given to understand that this legislation had been obtained and the rates were consequently reduced as promised.

Quite recently, however, at least two fires in the City of "unknown origin" have occured and which it was felt should be investigated. His Worship the Mayor apperred quite willing and anxious that the origin of these fires should be investigated, but on consulting with His Honor the Recorder it was found that the necessary machinery to enable His Worship to have such an investigation held was deficient in as much as no provision was made for the payment of the expenses attending such an investigation when ordered held by the Mayor of the City.

It is felt by our Board that this ommission was an oversight on the part of the City when the Act was being prepared, and as we carried out our promise and reduced the rates, while in reality they should not have been reduced, it is felt that the City should at once make provision to have the necessary legislation obtained to made the Act effective, by providing for he payment of the expenses attending such investigations when ordered held by the Mayor of the City.

I will be obliged if you will kindly place this communication before the Council at the earlist opportunity and advise me what action is taken towards having the oversight remedied.

GENTLEMEN,—Your Committee on Finance beg to report that at a meeting held this day, there being present Aldermen Hoben, (Chairman), Bligh, Smith and Edwards, a number of matters referred to the Committee for report were considered and dealt with as follows :— lst. In re report City Solicitor on award of B. A. Weston, Esq., Commissioner oppointed under Chapter 75 of the Acts of the Legislature of Nova Scotia, 1908, to hold an inquiry on claim of Patrick Kehoe for land taken for Halifax and South Western Railway right-of-way.

It is recommended that the accompanying resolution, prepared by the City Solicitor, be adopted.

2nd. Re letters of the Montreal Standard and The Standard of the Empire (London, Eng.), re advertising the City of Halifax in these papers.

The Committee decided to consider these applications when dealing with the estimates for 1909-10, as there are no funds available for this service this year.

3rd. In re application Governors of Dalhousie College for a piece of land belonging to the City, facing the College Grounds.

It was decided to defer consideration of this matter until the Committee have an opportunity to get further information as to the value of the property commercially or otherwise.

4th. Your Committee further report that the City Treasurer had, by letter, informed the Council that it will be necessary to borrow the sum of \$5,000.00 to pay one-half of the Dry Dock subsidy for 1908, due Ist December inst., and suggested that a stock certificate Consolidated Fund, 1880, bearing interest at 4 per cent. be issued for this purpose, and that the trustees of the Sinking Fund be asked to advance the money on this security.

It is recommended that the City Treasurer be authorized to issue to the trustees of the Sinking Fund stock certificates to produce \$5,000.00 (at not less than 95 per cent. of par) Consolidated Fund, 1880, at 4 per cent. interest per annum, for one-half Dry Dock subsidy, 1908.

5th. Your Committee further report that they had under consideration a report from the City Auditor on the deficit of the Nova Scotia Provincial Exhibition, 1908, covering a statement of expenditure and income, also a further statement of expenditure on capital to date.

It is recommended that before the money is provided for the Exhibition deficit the Finance Committee be furnished with a detailed statement of receipts and expenditures, properly signed by the Exhibition officials, and vouched for by the City Auditor; also that the Finance Committee have access to the books of the Commission.

## His Worship the Mayor and City Council:

GENTLEMEN, — Your Committee on Laws and Privileges beg to report that at a meeting of the Committee held this day, there being present Aldermen Chisholm, (Chairman), Whitman, Douglas, Hoben and Edwards, the Committee had under consideration a letter of the Halifax Arena Company asking for a hearing by the Committee on the matter of license fee charged the Arena. Mayor A. B. Crosby, (President of the Arena Co.), John W. Brockfield, a Director, and Wm. Glassey, Secretary of the Company, attended. His Worship the Mayor, on behalf of the Company, asked that the license fee (\$250.00) be waived for the present year. The Arena pays about \$400 in taxes and about \$250 in water rates. The management were willing to give the school children the free use of the Arena, if it were required for that purpose—for massing the children.

On June 1st, 1908, this Committee fixed the fee at \$250, and the report was adopted by the Council on June 8th, 1908. The Arena Company later asked for a reduction of this fee, and this Committee decided on July 16th, 1908, that the fee was not excessive. That determination was confirmed by the Council on August 6th, 1908. Your Committee after again considering the matter have decided not to change their previous recommendations.

Your Committee further report that they had under consideration the application of the Warren Bituminous Paving Company for payment of money held by the City for fines on paving contract.

Mr. J. J. Ritchie, Solicitor, appeared before the Committee on behalf of the Company.

The Committee decided to adhere to the report of the Committee on Works adopted by the City Council at a meeting held on 4th April 1907—by a vote of 13 to 3 that the sum of one thousand dollars be tendered to the Company without prejudice in full of all demands in order to avoid litigation.

To the City Council :

SIR,—I am requested to report on the advisability of extending the Agricola Street sewer now under construction to Stairs Street. The construction of this sewer is being carried out to take the surface water which accumulates so rapidly on the flat between Young St. and Kane St. As this would necessitate the collection of all the surface water at one entrance to the sewer it would be much easier to take it at two or three points and less likely to cause trouble. In addition the extension to Stairs St will drain a number of houses, and as the water pipe has been laid up this street, the sewer becomes a greater necessity. The estimated cost of extending it to Stairs Street is \$5,250.00. Fstimated assessment, \$1,425.00.

I would recommend that the work be put on the order book to be done when possible to get the material ready, and that it shall be constructed in continuation of the work now in hand.

Six.—I beg to report on the accompanying petition referred to me. The petitioners complain of the dangerous condition of the chimney standing on the site of the recently burnt distillery. The petitioners state that the chimney is liable to fall at any moment. I have examined the chimney carefully—first immediately after the fire, and the last time the day after the wall fell. I can see no signs of weakness or failure in the chimney which would justify me in forming the opinion that the chimney was liable to fall at any moment. At the same time the chimney is more liable to be weakened during the frosty weather from now until the first of April than during the summer season. There is danger, however, of bricks falling or being blown off the top of the chimney, as that part of the chimney has begun to go to pieces, and steps should be taken to provent what might easily be fatal injuries.

#### His Worship the Mayor :

SIR,-I beg to report on two petitions asking the Council to consider what the petitioners claim to be an improvement in communication between the north and south ends of the City.

One petition, bearing 132 signatures, proposes the opening of a street from the corner of Duke and Argyle Streets to the corner of Brunswick and Jacob Streets.

The other petition, signed by 390, proposes the opening of a street from the middle of the block on Grafton Street between Buckingham and Duke Streets to Brunswrick Street at Hurd Street, and also the extension of Brunswick Street through the Admiralty property and Wellington Barracks to North Starr Street.

This is really three different propostions and they must be considered separately.

Taking up the first one, namely : the proposal to open a Street from the head of Jacob Street to the corner of Duke and Argyle Streets, the plan proposed is the same as that formerly proposed and which under the law-the City ingineer was required to lay down on the official plan when preparing it. The sentiment of the Council when this matter was before them seemed to be in opposition, especially at this time

Considering the grades, relieving the traffic not only on the roadways but on the street railway and the location of the street so that it would cost the least land damages I think the plan accompanying this petition is the best proposal.

The plan accompanying the second petition shows a street which would terminate in the middle of the block on Grafton Street, which, in my opinion, is decidedly objectionable. It also lays down a line which cuts off a long frontage on Brunswick Street, which would add largely to the cost, and in my opinion unnecessarily. There would be no corresponding advantage that I can see, except making a straight street, while the disadvantages and extra cost would very much outweigh any advantage to be obtained by making the street straight. In fact, I can see no advantage but that the lines would be straight, which is not absolutely necessary.

The object of the petitioners seems to be to provide an easier grade for traffic between the North end and the South end than the existing streets give. The opening a street from Brunswick Street to Grafton Street will not solve the problem. Traffic going from the north end to the south end would reach Spring Garden Road at its junction with Grafton Street and from that point would go farther south via. Pleasant Street or Queen Street. Pleasant Street traffic need not be considered as it can reach its destination by way of Lockman Street and Barrington Street by easy grades or down hill from the higher streets. Heavy traffic from south to north in very limited. For points farther west in the south end the extension of Brunswick Street to Hastings Street promises a much cheaper, straighter and more direct route with much better grades

As the individual members of the Council in discussing this matter in connection with the official plan have practically decided against it at the present time, and as the Laws and Privileges Committee have decided against it, I would recommend that further consideration be postponed unless the Council are prepared to face the expenditure which the adoption of the proposal means.

The extension of Brunswick Street through the Admirality property and Wellington-Barracks property would no doubt receive the opposition of the Military authorities as it would from their standpoint destroy both properties until they are prepared to open them up for other purposes than those for which they are now in use. The extension of Brunswick Street as proposed would be a desirable improvement and in considering future street plans it should not be lost sight of. I think this street should not only be laid down on the official plan, but should be approved when the plan is approved ; otherwise the time does not seem to be opportune for making any definite move in the direction of the adoption of either proposal. It might be wise, however, to obtain the riews of the Militia Department on the proposed changes as far as they affect Military property.

## **ESTIMATES 1909-1910**

### COMMITTEE ROOM, CITY HALL, Dec. 30th, 1908.

To His Worship the Mayor and City Council:

GENTLEMEN,—The subscribing members of the Finance Committee beg to lay before you the Estimates for the year 1909-10. They recommend the same for adoption by the Council.

The total salaries last year of City officials amounted to \$35,675.00. This year the total is \$35,975.00. The increased \$300.00 is in the salary of the City Auditor, which was made last year, and fixed by a statute of last winter's local legislature.

The Police Department estimate is increased by 6,700.00, which is almost entirely due to the increase in pay granted last winter and sanctioned by last session of Legislature and paid this year, but not included in the last estimates, so we have to include in our estimates for next year the amount of the two years' increase in pay, which is about \$5,900.00, and also about \$800.00 for new ulsters.

We are pleased that the City Prison Committee have been able to cut down the estimate for Rockhead Prison \$835.00 (from \$6,050.00 to \$5,215.00) and that
