after providing for the deficit of 1907-8 of \$215.00. They have reduced the staff by one underkeeper, and have made other reductions.

The estimate for Department of City Works is \$90.00 less than last year.

The sum of \$5500.00 allowed for cleaning paved streets is about the amount expended on those streets before they were paved for both repairing and cleaning. To get a correct idea of what the luxury of paved streets cost we have to add the interest (\$3450.00) on the City's half of the cost and \$1590.00 paid yearly into the sinking fund, making a total yearly cost to the City for our paved streets of \$10,540.00, as against a total yearly cost of about \$5,500.00 for their up-keep and cleaning before they were paved. To this must be added the cost to the ad joining owners, being about \$80000.00.

The increased pay of laborers granted last spring means an equivalent to a reduction of about \$3,000.00 from the \$25,000.00 for streets, and of about \$2,500.00 from the \$17,000.00 for Internal Health, so that the \$25,000.00 for streets and \$17,000.00 for Internal Health under the present rate of pay is about equal to \$22,000.00 for street and \$14,500.00 for Internal Health under the rate of pay is about equal to \$22,000.00 for street and \$14,500.00 for Internal Health under the the street the rate of pay prior to this year. If the finances of the City would permit, we think these two items should be considerably increased.

We regret that we cannot add to the estimate of \$22,800.00 for lighting streets, but we have to let this sum remain at the same figure as last year. There are many places where additional lights should be placed.

There is a small decrease in the Fire Department estimates of \$221.00. We had hoped that this decrease would have been greater owing to the cutting out of the sum of \$1,157.00 included in the last estimates for aerial ladder; but an increase of \$400.00 to the Union Protection Company and \$200.00 for furnace in Grafton Street House, and \$180.00 for plumbing in Quinpool Road House prevented a further decrease in this department.

Under "Extra Assessments" we find an increase of \$1,862.46 for the "County of Halifax." This increase is in consequence of the construction of the addition, &c., &., to the Court House.

The estimate for Public Schools is \$159,806.14—an increase of \$9,259.69 over the last estimates. We consider that the cost of our public schools is increasing out of all proportion to other City services and the School reports show that this increased expenditure is not warranted by the average increased attendance of scholars. We think the City Couucil should have more control over this expenditure as the City contributes all but \$18,400.00 of the total cost of maintenance of the schools.

There is an increase of \$396.63 in the estimate for the "City Home" caused by having to provide the sum of \$431.53 for the deficit incurred during the year 1907-8.

The Board of Health estimates are increased \$2,773.16 (from \$13,403.29 to \$16,176.45.) This increase is largely due to epidemic diseases 1908-9 and deficit of \$576.45 made in the year 1907-8.

We can congratulate the City that this is the last year we will have to estimate \$50c0.00 for one-half subsidy to Dry Dock. The British Government, the Dominion Government and the City of Halifax each granted a subsidy of \$200,000.00, making \$600,000.00 in all for this Dock. The City each year for twenty years has paid \$5000.00 in cash and borrowed another \$5000.00 to pay this twenty-year subsidy of \$10,000.00 per year. The yearly interest on this subsidy of \$200,000.00 would amount at $4\frac{1}{2}$ % to the sum of \$9000.00 per year. The Dock was also exempted from taxation for fifteen years. We understand the assessment is now fixed at \$200,000,00 from which we get in taxes under \$4000.00 per year. In the year 1902 the Dry-Dock was assessed at the sum of \$600,000.00. The Legislature by Chapter 75 Acts of 1903 exempted from taxation this Dock for the years 1909-10 and 1910-11 and thereafter permanently fixed the value for assessment at \$200,000.00.

We think that steps should be taken to give the City Council control over the expenditures made by the Board of Health and more control over the expenditures made by the Exhibition Commission.

Appended hereto marked "A" is a statement of the assessment for Real Estate, Personal Estate and Banks and Companies for every year from 1884-5 to and including 1908-9; and also marked "B" a statement shewing the "Estimates," "Income" "Total expenditure" and "Rate of Taxation" for every year since 1884 to and including 1908-9. A perusal of these statements will show that while, the assessable property in the year 1908-9 has increased over the assessable property of 1884-5 to \$566,124 in 1908-9—an increase of more than 110 per cent., and the rate of taxation has increased from \$1.10 to \$1.91 and next year will probably reach \$1.99.

This increase in expenditure has apparently gone on without any regard to the amount of taxable property until the point has been reached when all thoughtful people are called upon to sound the warning that our credit will be imperiled unless we call a halt in the increase in our expenditure.

COST OF PUBLIC SCHOOLS.

The estimate for the schools for the coming year has been prepared by the school commissioners. They have asked for and obtained the necessary formal approval of the estimate by the Governor-in-Council, so now it cannot be altered.

But it deserves the attention of this Council for two reasons :-

1. Because for the first time in the history of the City the school estimate has been prepared by a school board, the majority of whom are aldermen;

2. Because it is overgrown and disproportionate, as some comparisons will show.

A brief survey of school matters covering the short period of four years is instructive.

This four years' growth of 34 per cent. in the cost of the schools, coupled with only ten per cent. increase in the enrolment and one per cent. increase in daily attendance continues unchecked.

There is no abatement in the yearly demand for increased appropriations, although they are out of all proportion with the growth in population, with the increase in assessable property, and with civic expenditure in other directions.

About half of the entire increase in the civic budget this year is for the schools.

If we may make a forcast for the next four years, based upon the record of the last four, we will have an increase in the cost of the schools in eight years of 68 per cent., a twenty per cent increase in the enrollment, and only a small increase in the average daily attendance.

This alarming growth in school expenditure has been developed by a school board, one-half of whom ware appointed by the local government, and the other half by the City Council for terms of three years.

But as the law now stands, after their appointment they are not responsible for their acts as a body, either to the City Council or to the people whose money they expend.

Twice during the present year the City Council has passed resolutions disapproving of expenditures the School Board were about to undertake.

But these resolutions had no effect whatever.

The expenditures were made against the protest of the people's representatives, and the people's representatives were obliged to tax the people for money to pay the bills and bear responsibility for the expenditure.

This is a condition that is totally devoid of even the shadow of responsible government and should not continue.

A means must be found by which moderation may be reinstated and the school expenditure brought within its proper limits. This can be accomplished by an amendment to the City Charter, reducing the number of government appointees on the Board to, say, four members, and increasing the number of aldermen to eight; and by requiring all proposed expenditures of the Board to be approved by the City Council before they become binding upon the citizens.

It is my purpose at the proper time to introduce a resolution in this Council requesting the legislature to pass such an amendment placing the expenditure for schools under the control of representatives of the people who furnish the money.

GENTLEMEN, — Under an Act of the Provincial Legislature, 1907, Chap. 70, amended by Act of 1908, Chap. 73, the Silliker Car Company, Limited, were entitled to receive from the City of Halifax the sum of \$125,000 when they themselves had expended \$185,000 of their own moneys exclusive of the money furnished by the City of Halifax on the purchase of land, erection of buildings and purchase of plant in connection with their business within the City of Halifax.

In re the account of Messrs. Ritchie & Robertson (\$287 90) law expenses in suit Fenerty vs. The City of Halifax, it is recommended that this amount be referred to the Committee on Works, as it is a charge against the Water Department.

GENTLEMEN, — At a meeting of the Committee on Works held this day, the attached report of the City Engineer in re remedying a defect in the Maynard St. Sewer was read and recommended to Council for adoption.

CITY ENGINEER'S OFFICE, Jan. 16th, 1909.

SIR, —I beg to report on the accompanying petition asking for relief from back flow of sewage on Maynard Street between Cunard St. and Woodill St. The sewer in this block is a crock pipe. While it is large enough to carry the drainage, there is some doubt whether it is in good condition or not. A light cannot be seen from one end to the other, which would lead to the conclusion that the sewer must be laid crooked or that the pipe has given away in some part of the sewer. It is probable that there is a bend in it rather than that it has given away as it carries a good deal of water from time to time. The strongest reason for believing that the sewer is not defective is that during the last heavy rain, which was one of the heaviest we have had for some time, there was no complaint or backflow. The Foreman, Mr. MacDonald, is of the opinion that the stoppage in the manhole at Cunard Street has been the cause of the trouble whenever it has occurred. The sewer makes a right angle at Cunard Street and I would recommend that a diagonal connection be made, the new part being laid at the grade that would be required if it is decided later to lay a new sewer in this block. It is probable that this new connection would prevent any further trouble. If it does not I would then recommend the reconstruction of the sewer in this block.

SIR.—I beg'to report on the accompanying petition asking for the construction of a concrete sidewalk on the eastern side of Robie Street from Spring Garden Road to the Cemetery. The petition I am informed is signed by all the property owners. The gutter is practically level and the water does not run off properly while the sidewalk is an ordinary mudsidewalk. It is proposed at some time in the future to boulevard Robie St. as it is 100 ft. wide. Some thing of the kind will be required in this block as the west side is much above the east side and the difference in level could be connected in a park way or sodded strip in the middle.

I would recommend that a 5ft. concrete sidewalk, concrete curb and gutter and sodded parking be constructed on the east side of Robie Street from the concrete sidewalk at Spring Garden Road to the Cemetery.

His Worship the Mayor :

SIR,-In compliance with the instructions of your Committee, I beg to report on the amount required for the construction of sewers and water extension

The estimated cost of sewers already ordered is about \$30,000, while we have only about half that amount on hand. Other sewers have been asked for, and there is no doubt that from time to time they will be required in streets from which no petition has yet been received.

I would recommend that authority be obtained to borrow \$50,000 or \$100,000 in such sums as the Council may consider advisable from time to time.

In water extension work it has been customary to borrow from \$10,000 to \$15,000 at a time. Previous to the last year we have been renewing old mains that were no longer capable of good service and replacing small pipe with larger where it was required We have made provision when paving Lockman, Barrington and Pleasant Streets to put in several larger pipes to improve the distribution. The cost of putting in these pipes should be charged to maintenance, but the cost of the pipe itself should be charged to Capital Account. The estimated cost of the pipe necessary to do the work contemplated in the report made to the Council in July, 1907, is \$17,000.

I would recommend that authority be obtained to borrow the sum of \$30,000 for this work and the ordinary extensions next year, and that the pipes previously recommended for Morris Street, Proctor Street, Gerrish Street, North Street and Oxford Street be laid as soon as a proportion of the cost to be taken from maintenance account can be afforded.

The resolution referred to in the report of the Committee on Works as follows is read.

Whereas, by an Act of the Legislature of Nova Scotia, passed on the 25th day of April, 1907, the City of Halifax was authorized to borrow "for the further extension and improvement of the water system" a sum "not exceeding \$135,000.00."

And Whereas, on the said 25th day of April, 1907, the water construction account of the City of Halifax was overdrawn in the sum of \$21,612.89;

And Whereas, on the 30th day of April, 1908, said account was overdrawn in a further sum of \$6,822 94, making the complete overdraft existing on the 30th day of April, 1908, \$28,435 83;

And Whereas, no portion of the \$50,000.00 of the zmount borrowed under said Chapter 71 of the Acts of 1907 could be applied to the payment of said overdraft of \$21,612.89;

Now Therefore Resolved, that the City Solicitor be instructed to prepare legislation authorizing the City of Halifax to borrow the sum of \$28,438,83 to pay off said overdraft existing on the 30th day of April, 1908, and that said sum of \$28,438,83, when borrowed, reduce the amount empowered to be borrowed u der said Act authorizing the borrowing of said sum of \$135,000.00;

And Whereas, doubts have arisen as to whether the City of Halifax has exhausted their power to borrow further sums of money under the provisions of the second clause in the schedule under Section 2 of Chapter 71 of the Acts of the Legislature of Nova Scotia for the year 1907, providing for the borrowing of \$135,000.00 for the further extension and improvement of the water system, after having already once borrowed under said provisions the sum of \$50,000.00;

And Whereas, it is advisable to remove all doubts in the premises ;

Therefore Resolved, that the Legislature be asked to amend the second clause in said Schedule to Section Two of Chapter 71 of the Acts of the Legislature of Nova Scotia for the year 1907, so as to read as follows, viz. :--

"From time to time in sums as may be required for the further extension and improvement of the water system, not exceeding in the whole \$135,000.00," and that the City Solicitor at once prepare legislation to carry out the intention of the above resolutions.

Moved by Alderman Hoben, seconded by Alderman Smith, in amendment to the original motion that this matter be referred to the Finance Committee, the Laws and Privileges Committee and the City Solicitor for report.

For the Amendment. Against it. Aldermen Smith, Hoben, Aldermen Wilson, Whitman, Kelly, Thompson, Hebb, Hubley, Rankine—5. MacKenzie, Edwards—6.

The original motion is put and passed.

Alderman Whitman now submits a draft to enable the City of Halifax to borrow money for Water Department on the lines of the resolution above recited.

AN ACT TO AMEND CHAPTER 71 OF THE ACTS OF 1907, ENTITLED AN ACT TO ENABLE THE CITY OF HALIFAX TO BORROW MONEY.

Whereas, by Chapter 71 of the Acts of 1907, the City of Halifax was authorized to borrow, among other sums for other purposes, a sum not exceeding 50000 for the construction of new sewers, and also a sum not exceeding 135,000 for the further extension and improvement of the water system:

And Whereas, the Council of the said City did on the 27th day of June, 1907, duly resolve to borrow, under authority of the said Act, the sun of \$25,000 for the construction of new sewers:

And Whereas, the said Council did also under the same authority on the 22nd day of July 1907, resolve to borrow the sum of 50,000 for the installation of water meters, that being in the opinion of the council at that time a further extension and improvement of the water system.

And Whereas, on the 25th day of April, 1907, that being the date of the passage of the Act hereby amended, the water construction account of the City was overdrawn in the sum of \$21612 89, which amount was on or before the 30th day of April, 1908, increased to the sum of \$28435.83.

And Whereas, doubts have arisen

(a) As to the right to apply any part of the said sum of \$50,000 so borrowed to the discharge of the said overdraft, and also

(b) as to the power of the City to borrow any further sum under the authority of the said Act for the construction of new sewers, and

(c) As to the power of the City to borrow any further sum under the authority of the said Act for the construction or improvement of the water system and it is desirable that such doubts should be set at rest.

BE IT THEREFORE ENACTED by the Governor, Council and Assembly as follows :---

1. The schedule to Chapter 71 of the Acts of 1907, is hereby amended by striking out, in the first item in the said schedule the words "not exceeding \$50,000" and inserting in lieu thereof the words following, "snch sum or sums as the Council from time to time determines not exceeding in the whole \$50,000," and the said Act shall be construed as if it had originally read as amended.

2 The said schedule is further amended by striking out in the second item the words "not exceeding \$135,000" and inserting in lieu thereof the words following. "such sum or sums as the Council from time to time determines not exceeding in the whole \$135,000," and the said Act shall be construed as if it has originally read as amended.

3. The City is hereby declared to be authorized to borrow from time to time in such sums as it deems fit the remaining part of the said sum of \$135,000, and may apply out of the moneys so borrowed the sum of \$28435.83 for payment of the said overdraft, and may apply the remainder of such moneys to any purpose which it deems to be for either the construction or improvement of the water system or both.

4. Nothing in the Act shall

(a) Affect the pending litigation between the Neptune Meter Company and the City of Halifax, or

(b) Be held to be a declaration that the Act herebyamended did not previously have the meaning and operation which it is hereby declared to have
