# RE MARLBORO WOOD ROAD.

# OFFICE OF CITY SOLICITOR, May 12th, 1910.

#### His Worship the Mayor :

SIR,—I understand the point on which my opinion in this matter is asked is whether the City can legally acquire the road offered by Mr. Pearson, in view of section 548 which provides that "no street shall be dedicated or conveyed to the City until the same has been properly graded," which is to be done "in accordance with a plan to be furnished by the City Engineer and under his supervision and to his satisfaction, to be manifested by his certificate filed in his own office." "Grading" is a very indefinite engineering expression, and the sufficiency with which it is done is to be determined by the Engineer. In his report he states that a part of the road is graded and the rest is made and in use as a road. Whether he means by the latter to say that the grade is satisfactory is for him to say. I can understand how a road might be satisfactory as to grade without heing made satisfactory as a road, but if it is made and in use as a road it must at least have a grade that admits of such use. Whether it is satisfactory to the Engineer depends on him.

I should be sorry, however, to rest my opinion on this ground only, or to cast any doubt on the right of the City to acquire by agreement any land required for a street, whether graded or not. The language of the section manifestly is intended only to deal with dedications or conveyances to the City of land for streets without any resolution of the Council to acquire them or even against the wish of the Council. It was intended to prevent a former not uncommon practice of owners of vacant lands, who wished to put them on the market, of opening streets and dedicating them, without any regard for the wishes of the Council. It never was intended to prevent the City acquiring by agreement and resolution of Council any street which the Council deems to be required by the City. Section 620 expressly confers such a a power in the widest terms, and it would be most unfortunate if no such power existed or if anything were done to impair it. In this case there is a good consideration for the purchase of the land, namely, the release of the owners from their liability to grade Inglis and Robie Streets. It would be perfectly competent for the Council to expropriate the road and to give a release of the obligation as compensation, and what can be done by compulsion can be done by agreement.

I am therefore of opinion on both these grounds that nothing in section 548 prevents the resolution of the Council from being effective.

I assume that section 531 requiring a width of sixty feet will be complied with.

SIR,—With further reference to your letter of the 22nd March respecting the transfer of the "Large Fuel Yard" at Halifax, to your City as a site for a public market, I beg to state that the conditions upon which this property was handed over by the Imperial Authorities to the Canadian Government where that should it be required for military purposes it would revert to the War Office.

#### His Worship the Mayor :

SIR,—The City Charter, section 867, provides for the measurement of salt by weighers appointed by the City and for a compensation to be paid to the weighers for their services. It enumerates certain weighers holding office at the time of the cominginto force of the Charter and provides that when they have ceased to hold office nofurther weighers shall be appointed and the section itself shall cease to have effect. The difficulty on which my opinion is required as I understand it is that one of the weighers has been for some time unable through illness to discharge his duties, but has been performing them by means of a deputy or as the weighers term it, a supernumerary, and some difficulty has arisen as to whether or not he is entitled to receive any remuneration. The weighers I understand have an arrangement amongst themselves, similar to that which prevails amongst the coal weighers by which their fees are pooled and divided among themselves, but it is entirely a matter among themselves. Prima facie each weigher is entitled to be paid for the work he does, and it is entirely a matter for themselves whether a weigher who is unable to perform his duties shall receive anything or not.

The Committee concur in the report of the Chief and recommend that the Agents be requested to replace the hose according to contract.

SIR,- I beg to report as follows on the accompanying letter from the Nova Scotia Fire Insurance Company claiming compensation for a strip of land taken on the east side of Granville Street between Prince and Sackville Streets.

The street line was laid down on this street on the official City Plan as near as could be judged from existing records, at its original location, and is back from the front of the Nova Scotia Fire Insurance Company's properties about 1 ft. 8 in. on the north end and 1 ft. 9 in. on the south end, which would take about 60 square feet of the property claimed and occupied by them However, I do not think that there is enough evidence to prove this original location in a Court, and the Nova Scotia Fire Insurance Company and their predecessors in title have been occupying a portion of what is now the street.

The circumstances are similar to those of Mr. Allison's properties at the corner of Water and Duke Streets. in which case the new building was erected to the adopted line and the owner paid compensation for the land taken.

I would recommend that the Nova Scotia Fire Insurance Company be paid for the land taken and that the amount be fixed, if possible, by an agreement between themand the Board.

Sim,—If it could be shown that the property now required by the City for straighten ing Granville Street was originally a part of the street, and that the building recently erected was an encroachment, our Charter provides that the length of time would not prevent us claiming the ground without paying compensation for it

However, I understand from the City Engineer's letter and also from conversation with him that we are not in a position to establish any encroachment and the line of this street, as in the case of many of the older streets, is uncertain. In that case all that has happened is that the line laid down on the Official Plan has straightened the street by throwing into it a part of what is presumably the property of the adjoining owner.

The effect of the Official Plan is merely to prevent streets being opened not shewn upon it and to prevent any claim for compensation for buildings erected on what is shewn as a street after the approval of the Plan It does not and never was intended to operate as an expropriation of land without compensation.

Under these circumstances I am of the opinion that the City cannot legally take this land without compensation and that payment will have to be made therefore.

SIR-I beg to report on the accompanying petition from residents on South Park Street.

The partion of South Park Street between South and Inglis Street on the east side has a cobble stone gutter and in parts of the street the grade is so flat that the water does not run off. It is impossible to keep the gutter clean and the water lies in stagnant pools. A tar concrete sidewalk has been laid and we were unable to lay the curb and gutter until the sidewalk law was amended. It was amended at the last session of the Legislature and I would recommend that a concrete curb and gutter be laid on the east side of Park Street from South to Inglis Street.

The estimated cost is \$1658 00
